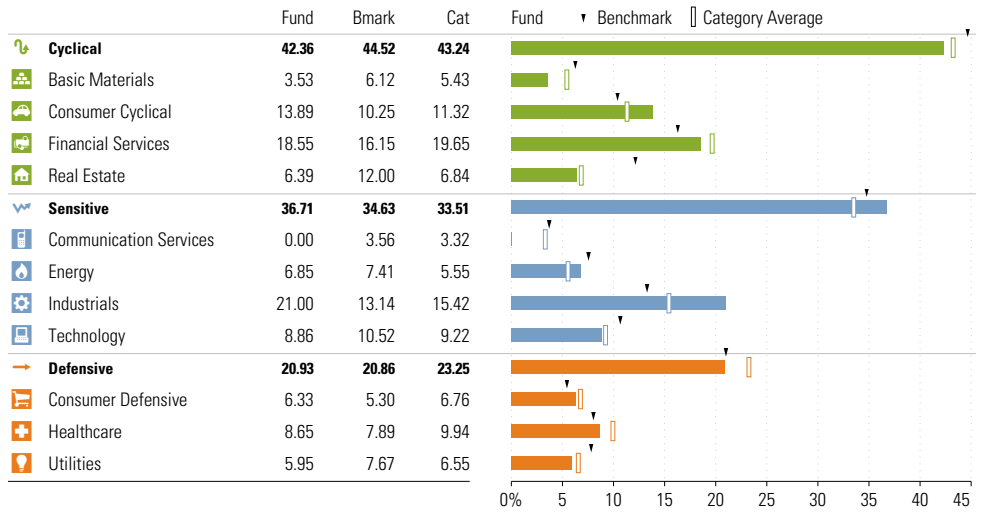

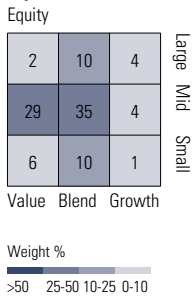
**Asset Allocation** as of 03-31-2022
