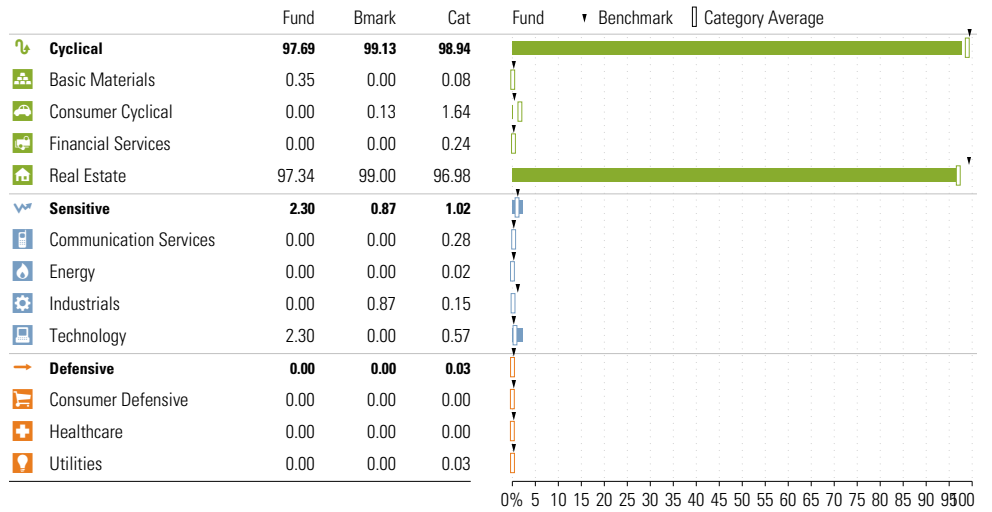

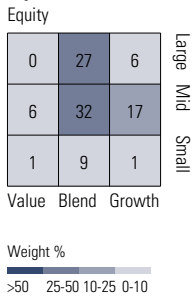
Asset Allocation as of 03-31-2022

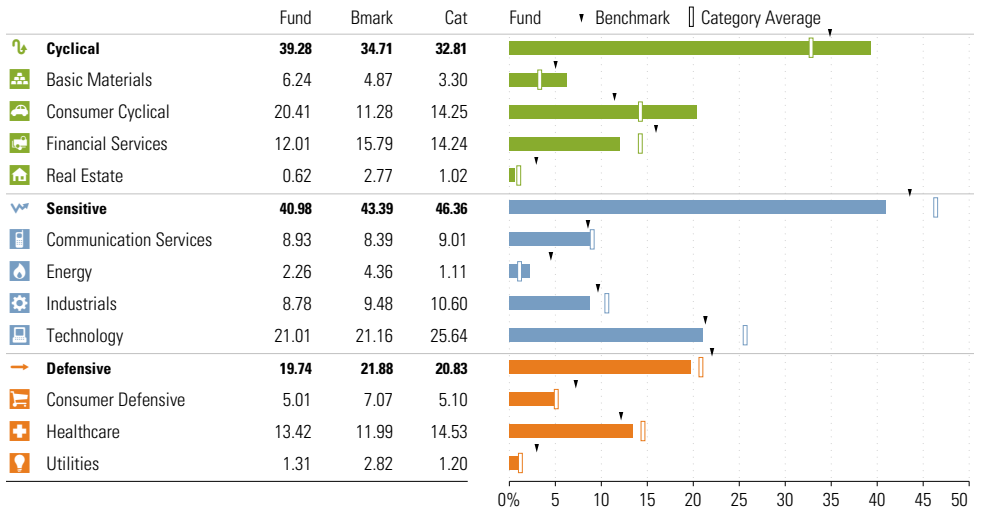

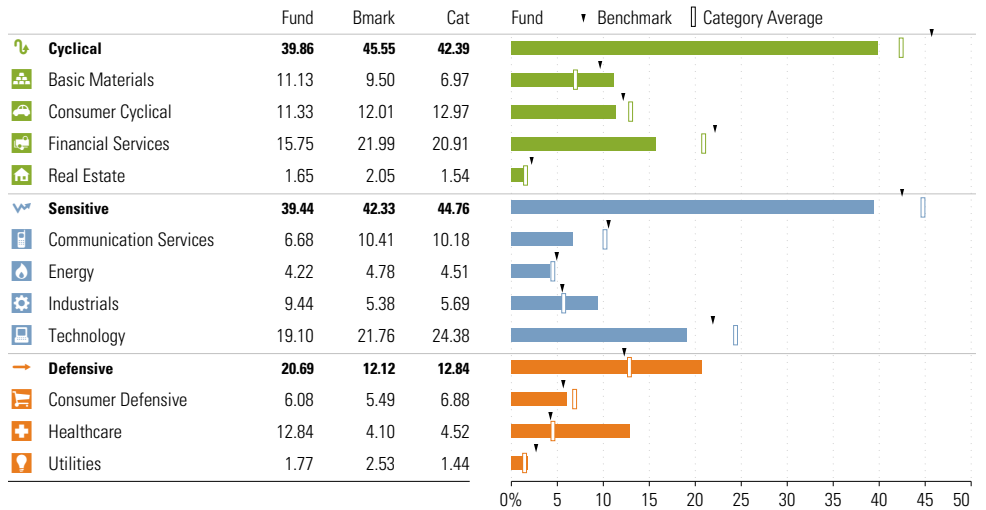

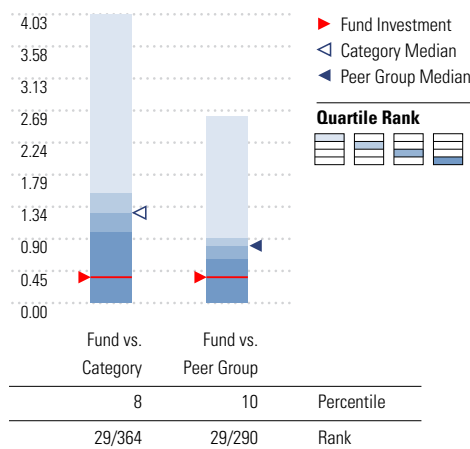
Growth of \$10,000

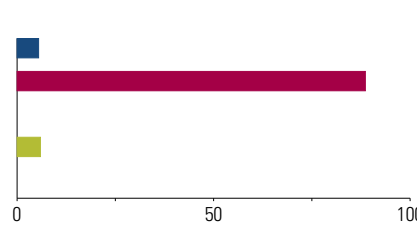

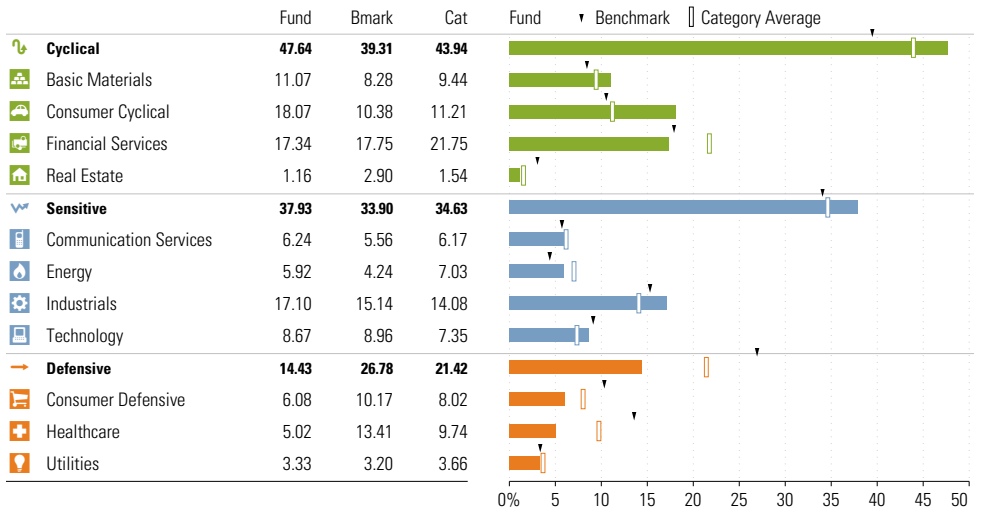

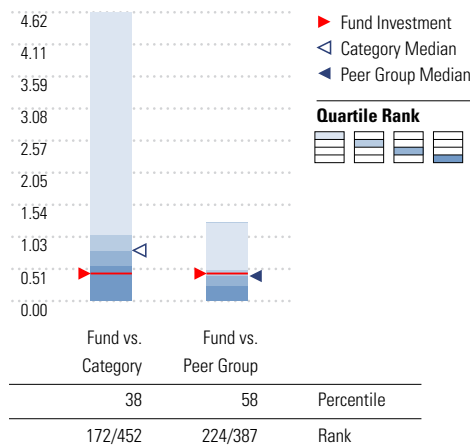

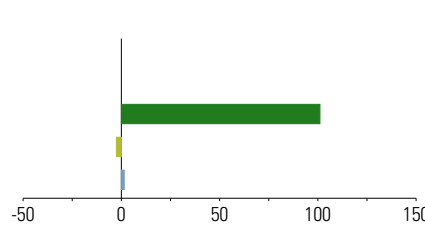
