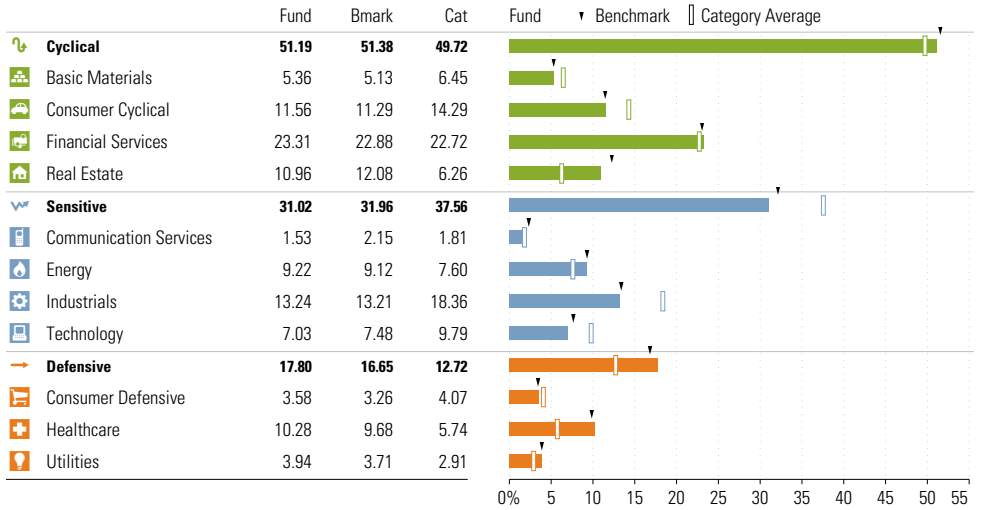
Style Breakdown

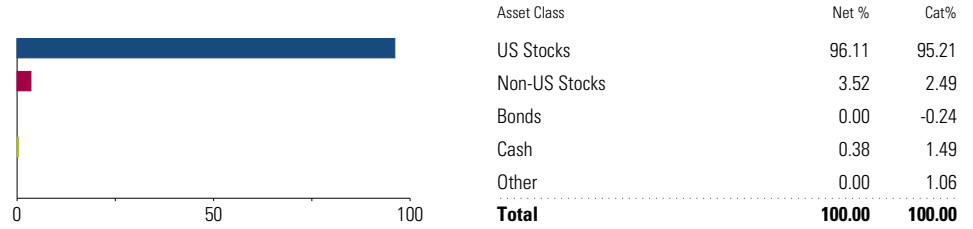

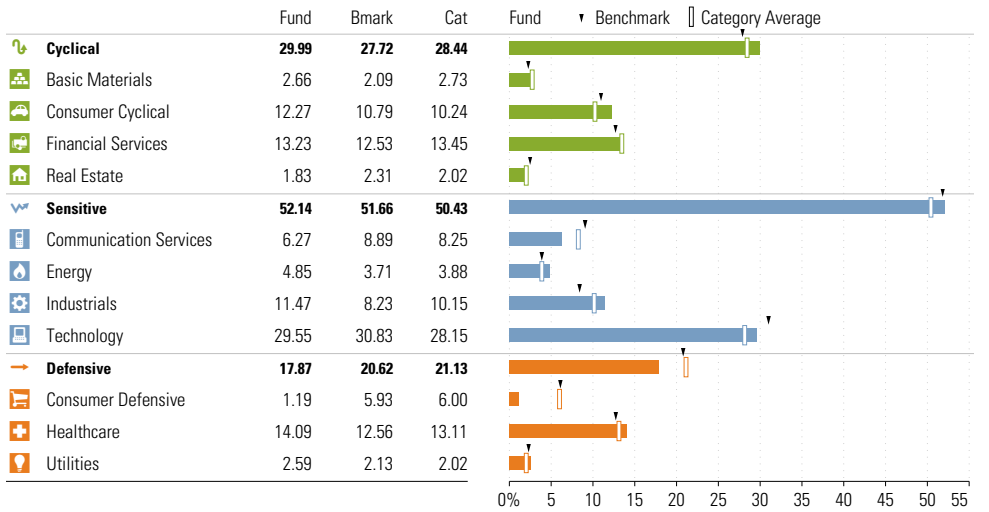
Style Breakdown

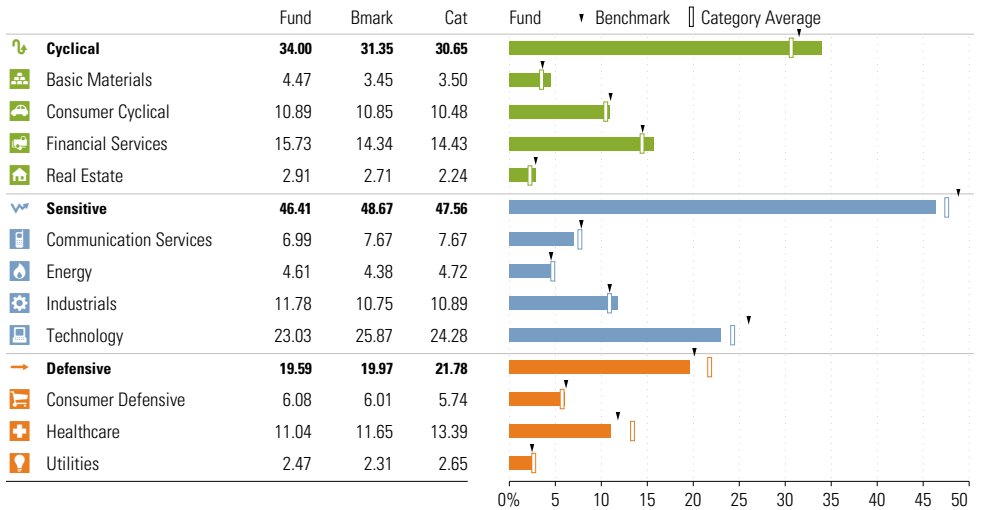

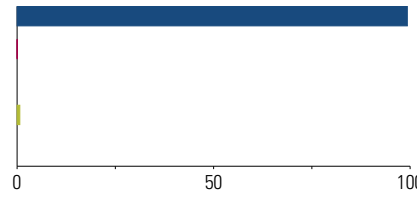
