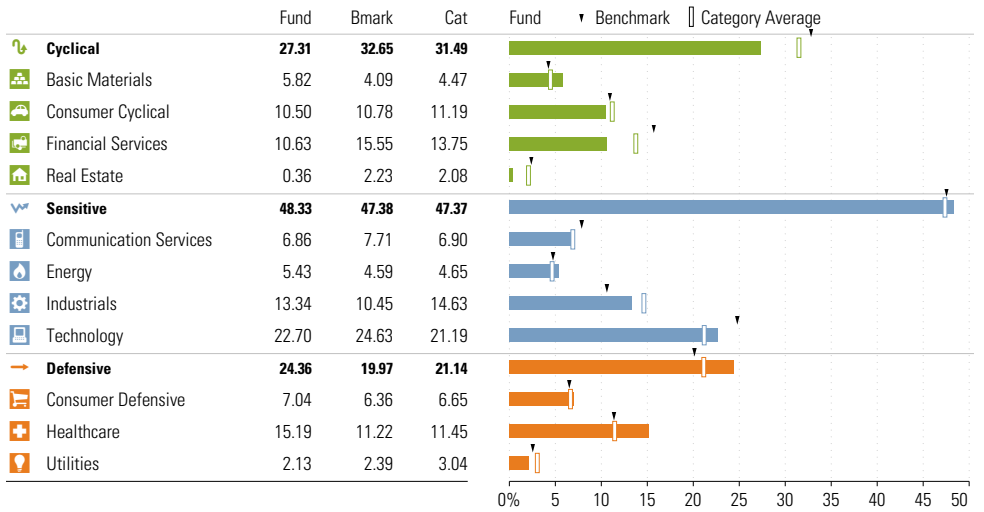

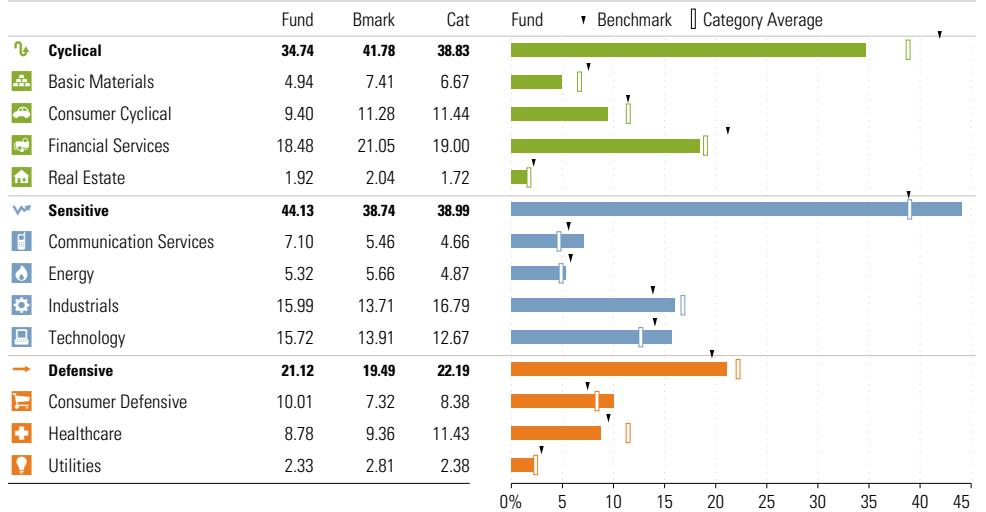

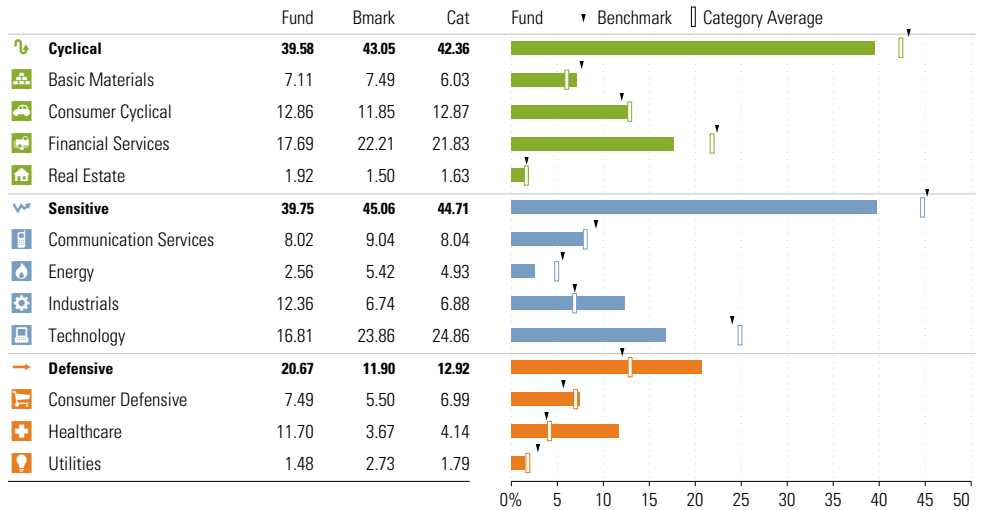

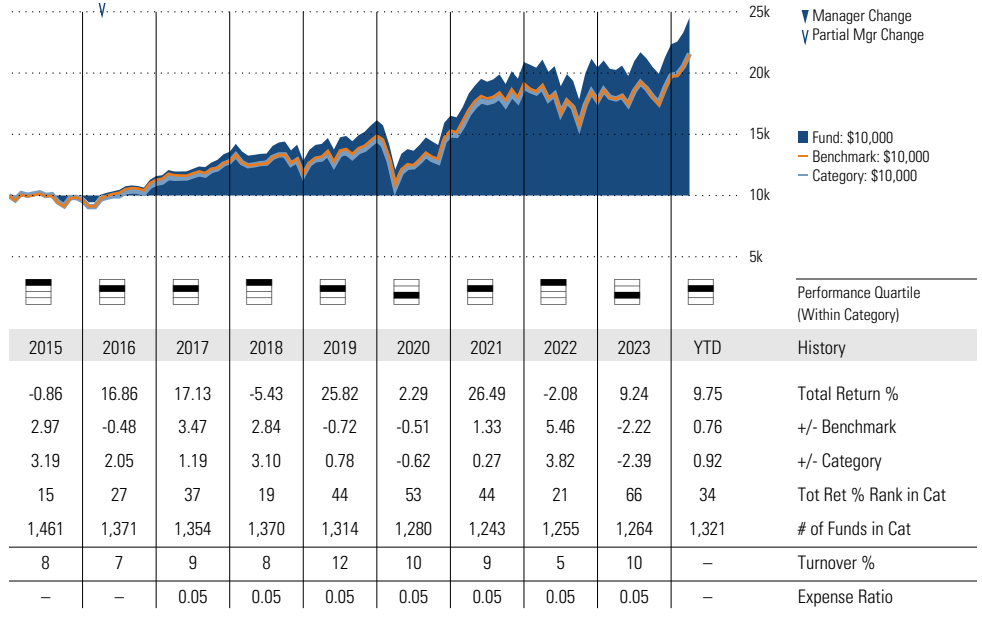

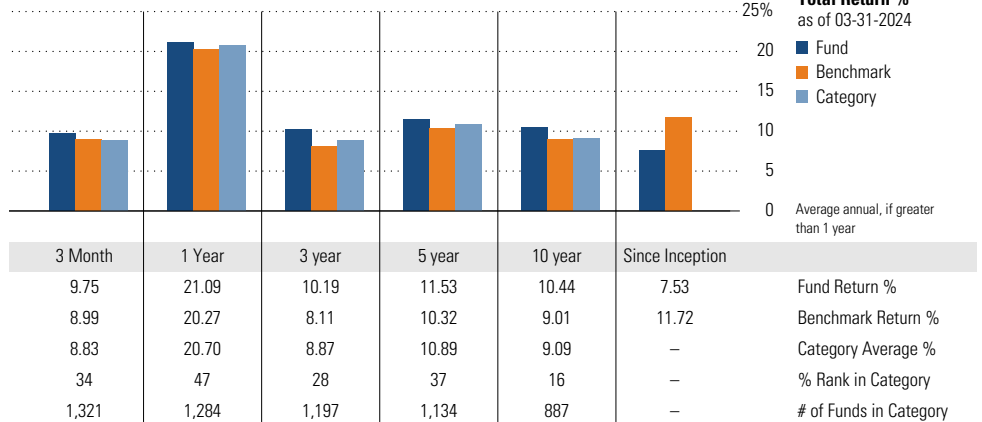

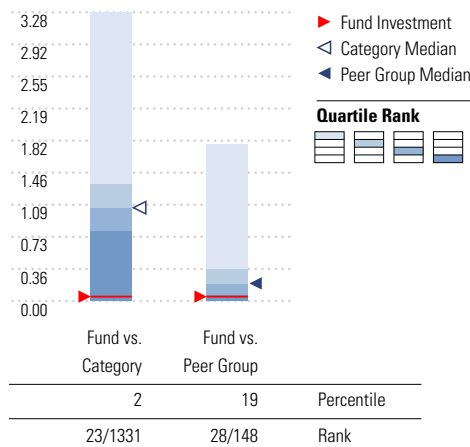

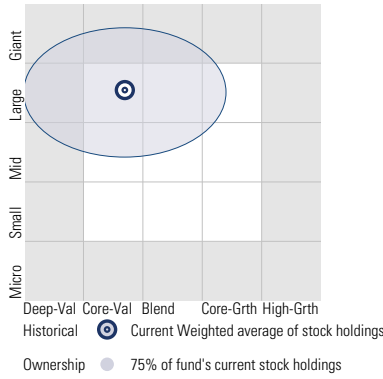

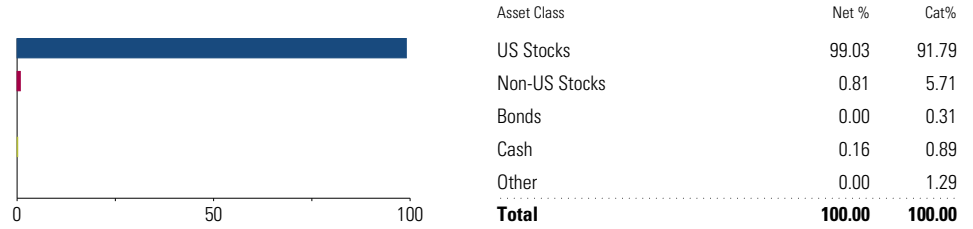

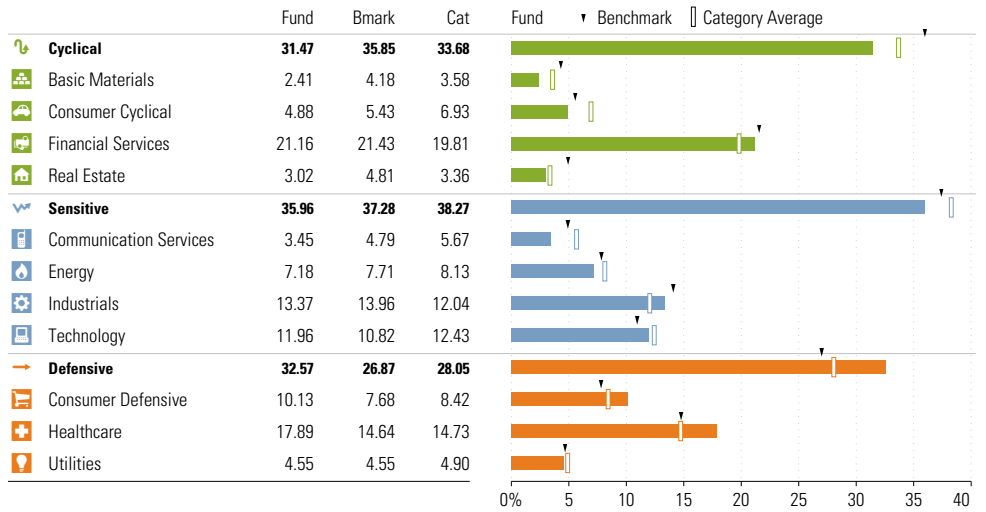
Style Breakdown
