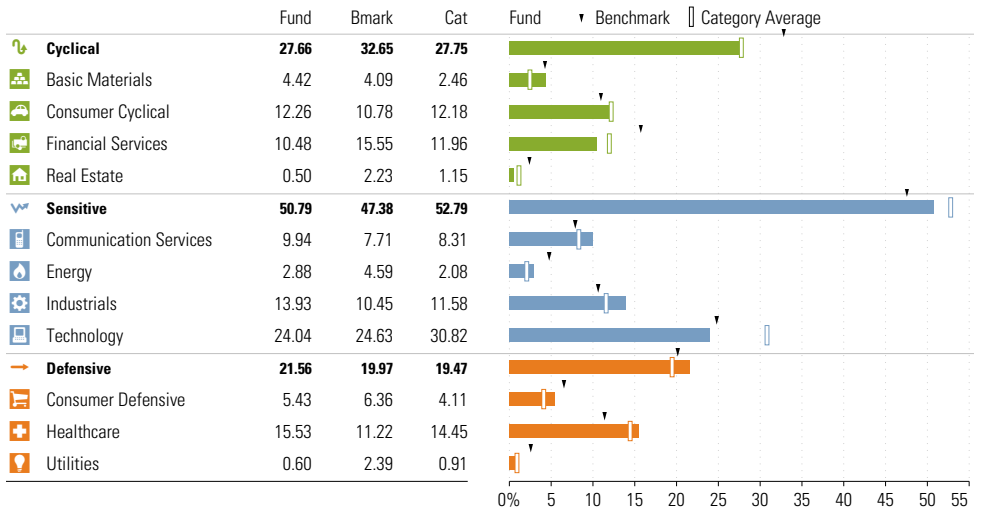

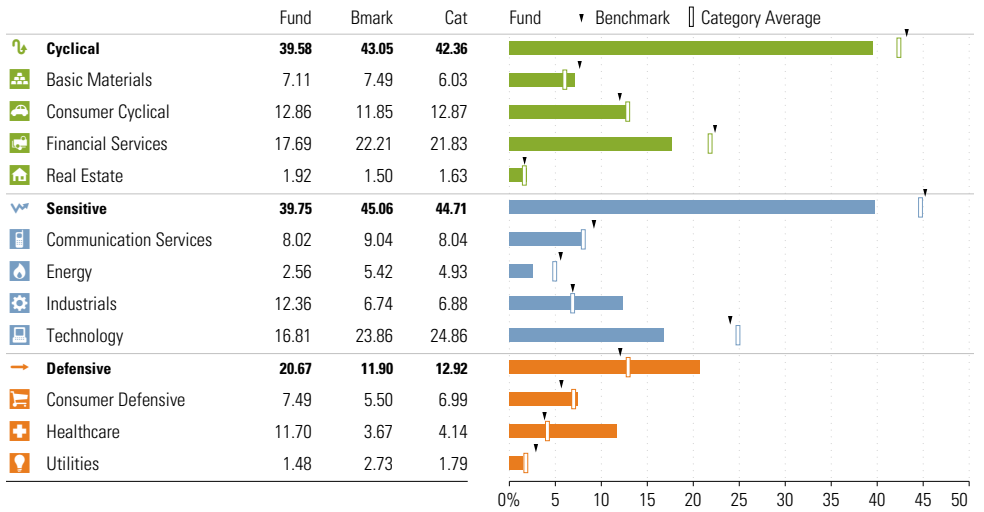

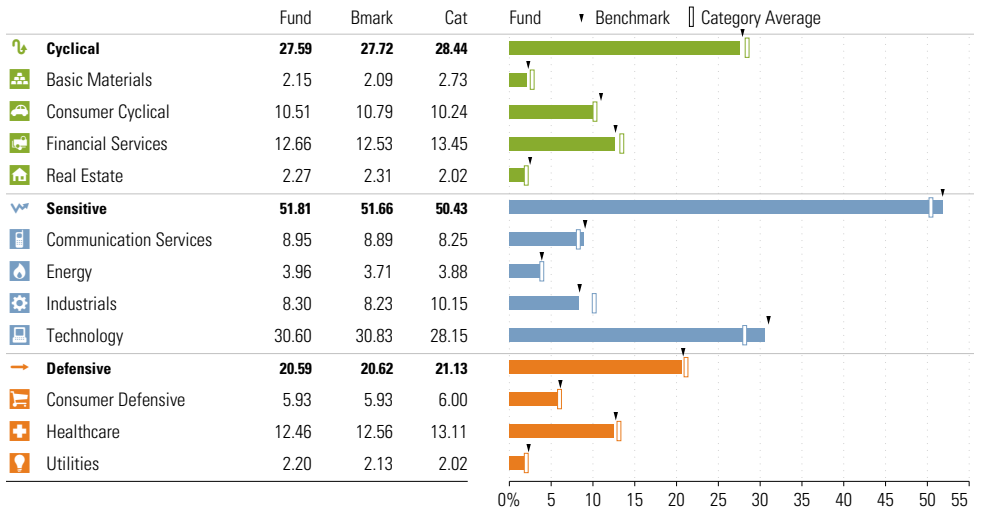

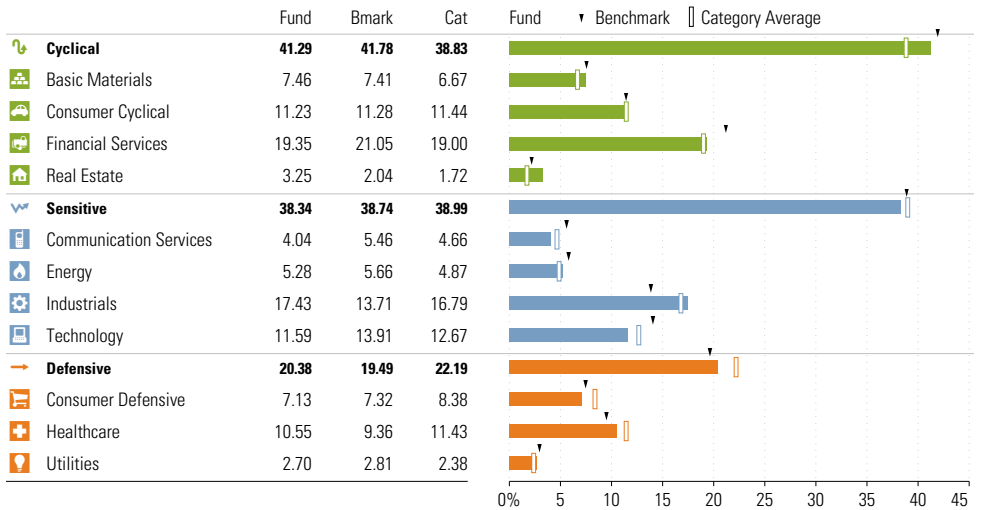

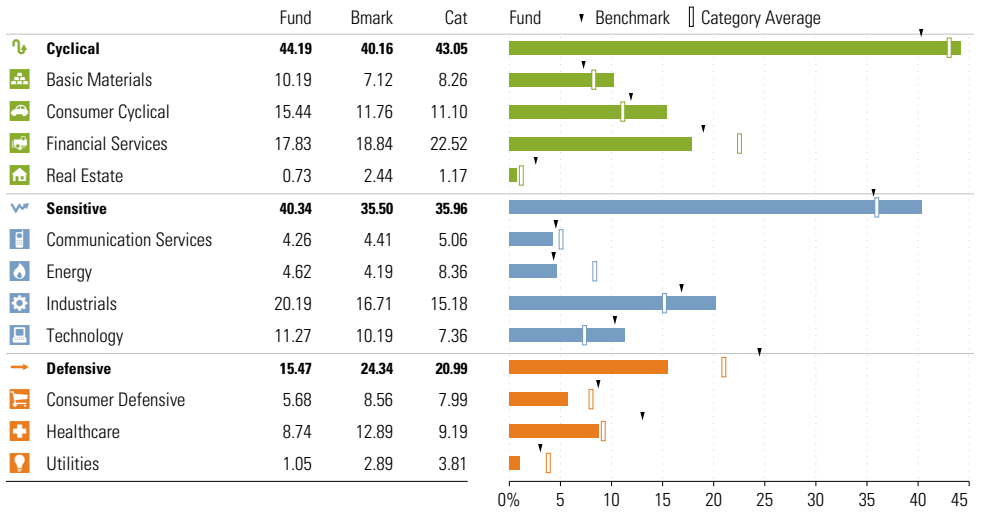

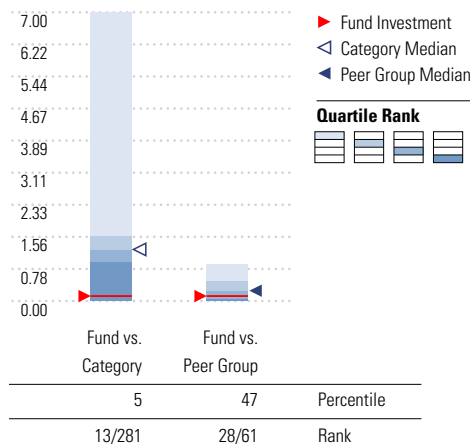

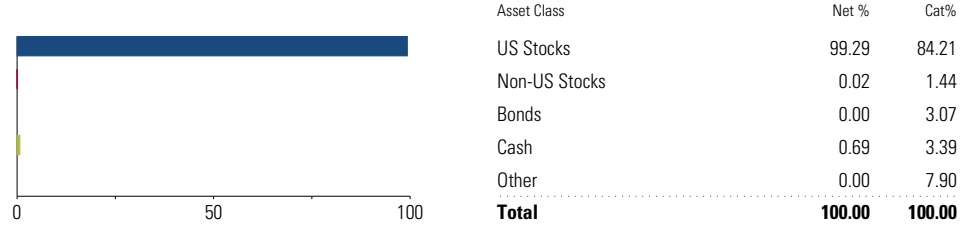

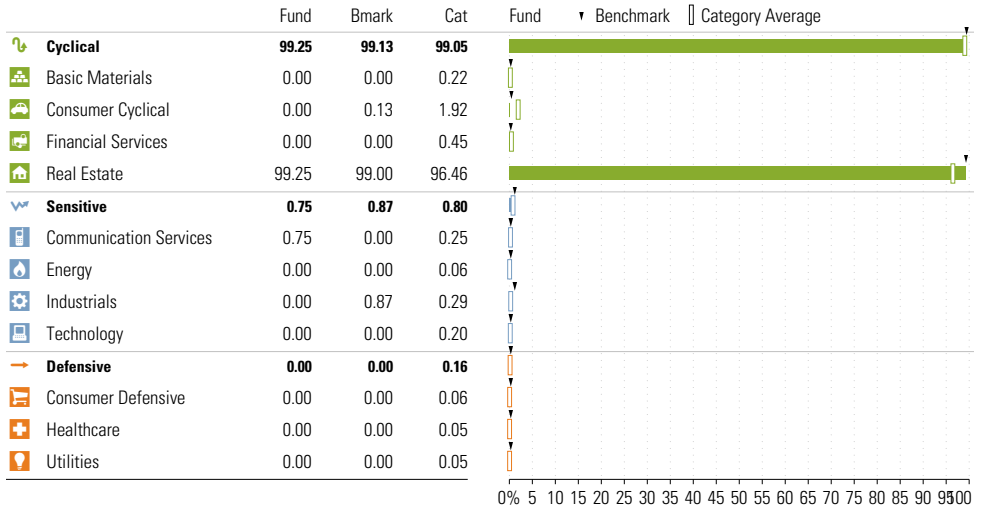
Style Breakdown
