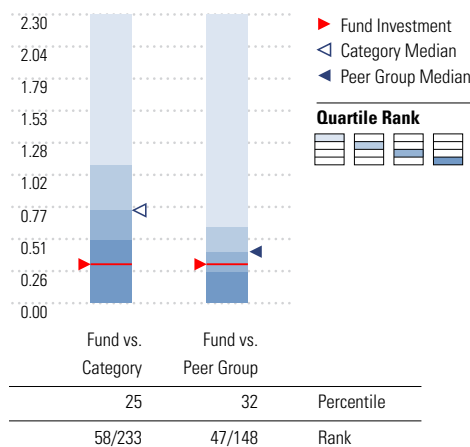

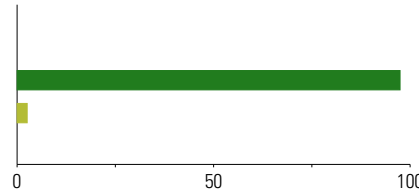

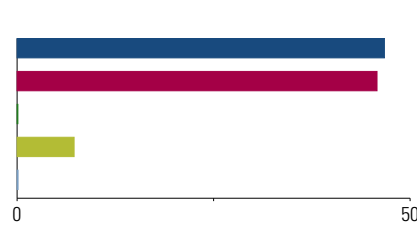

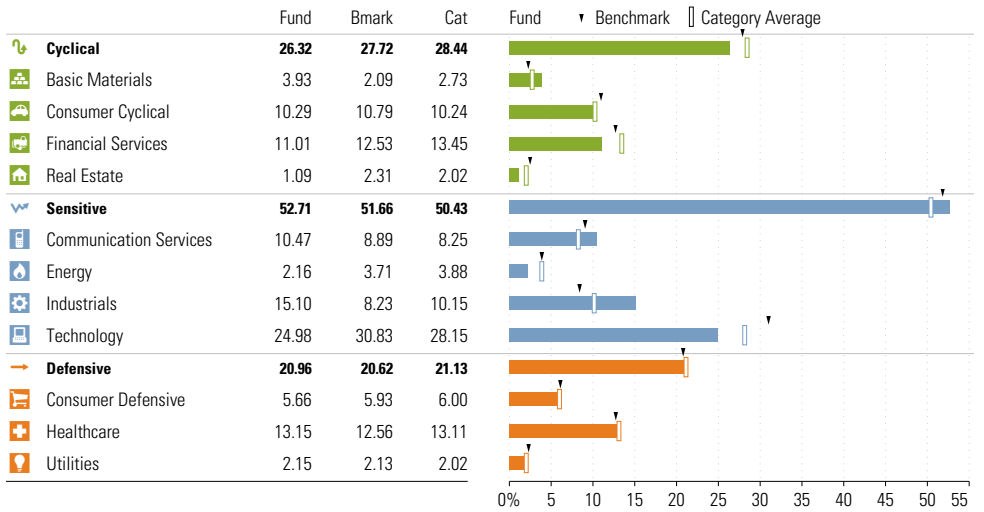

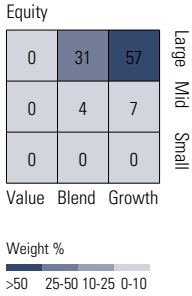
Asset Allocation as of 03-31-2024

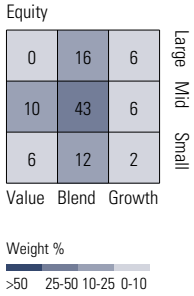
Asset Allocation as of 03-31-2024

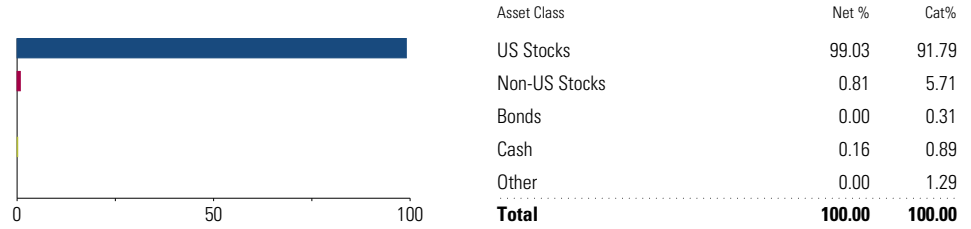

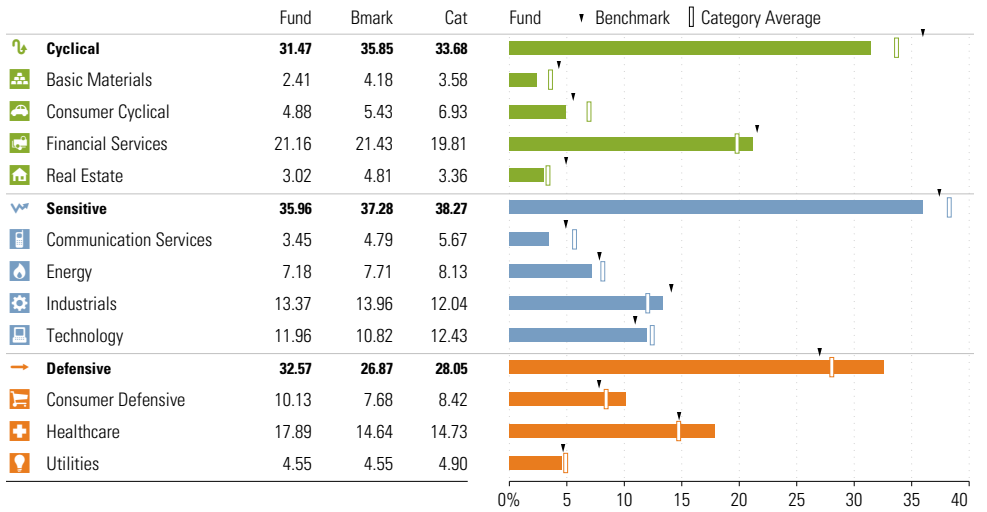
