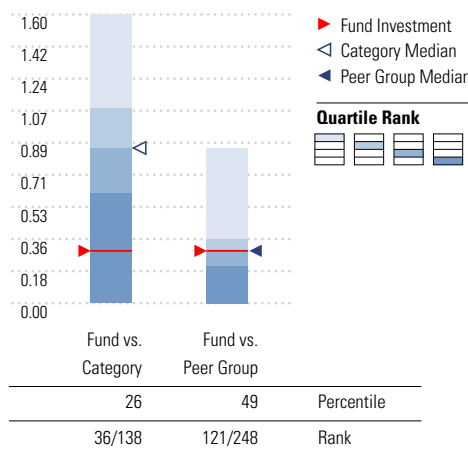

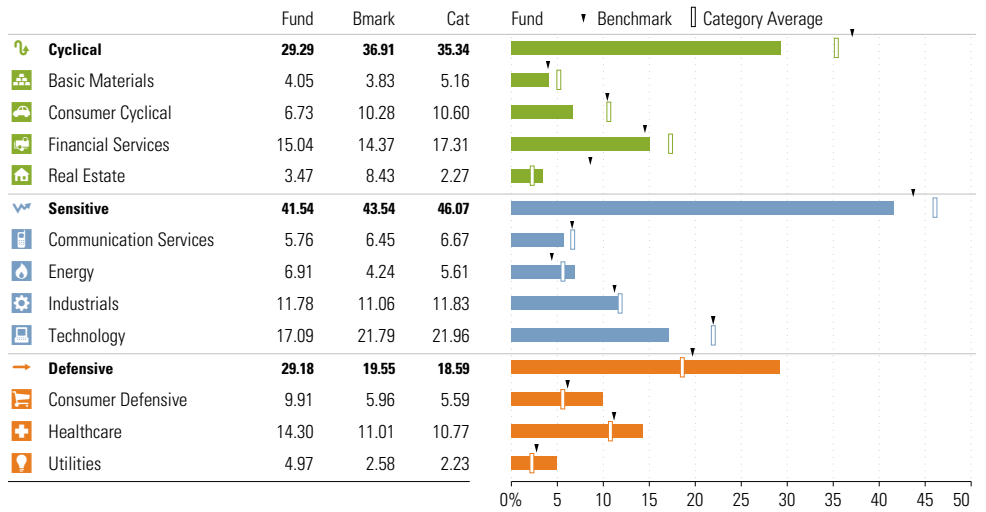

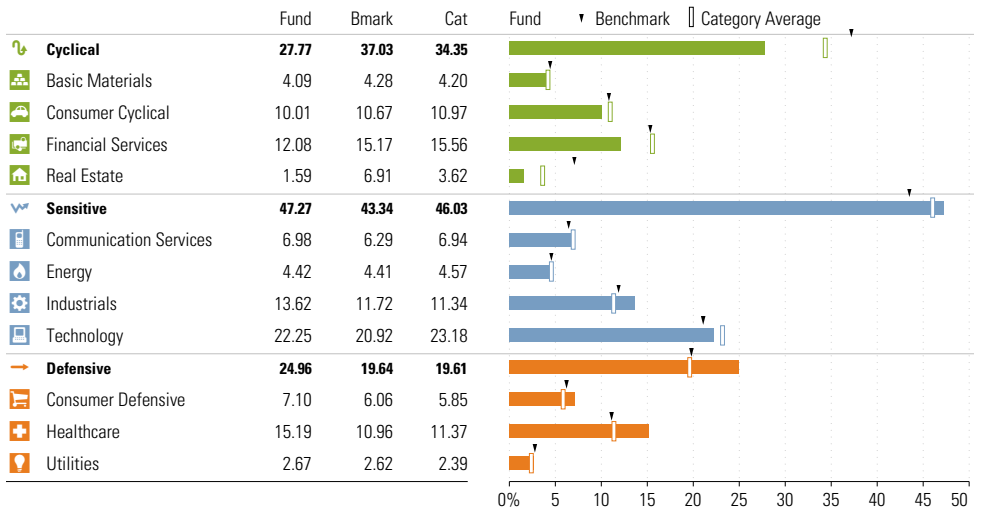

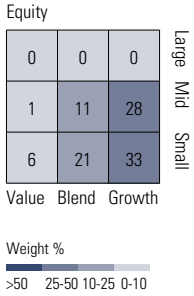

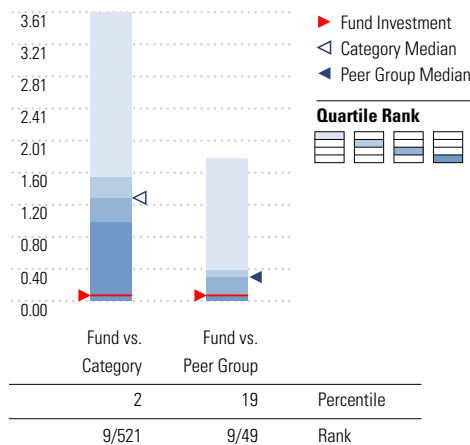

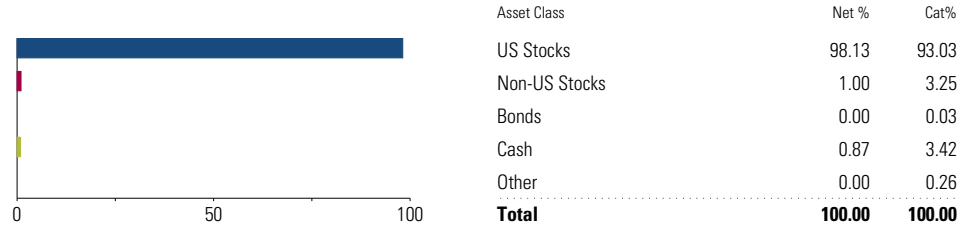

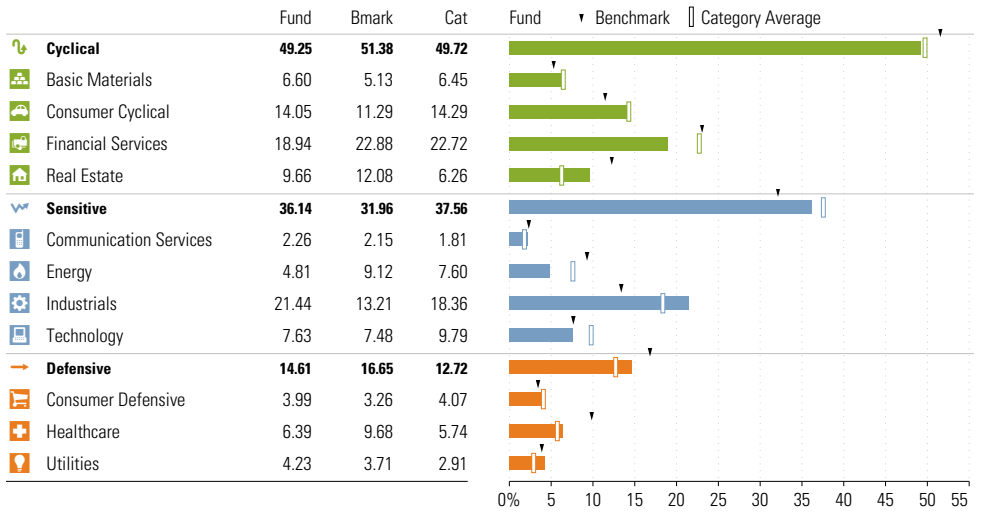
Style Breakdown

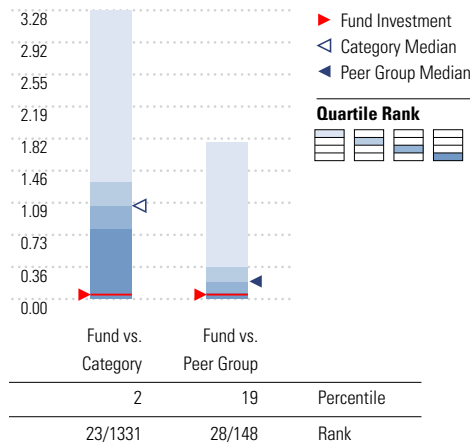

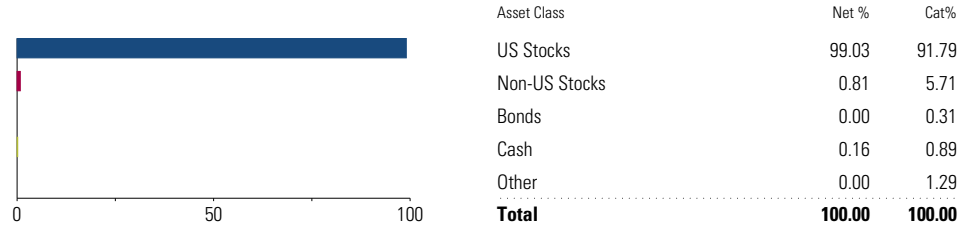

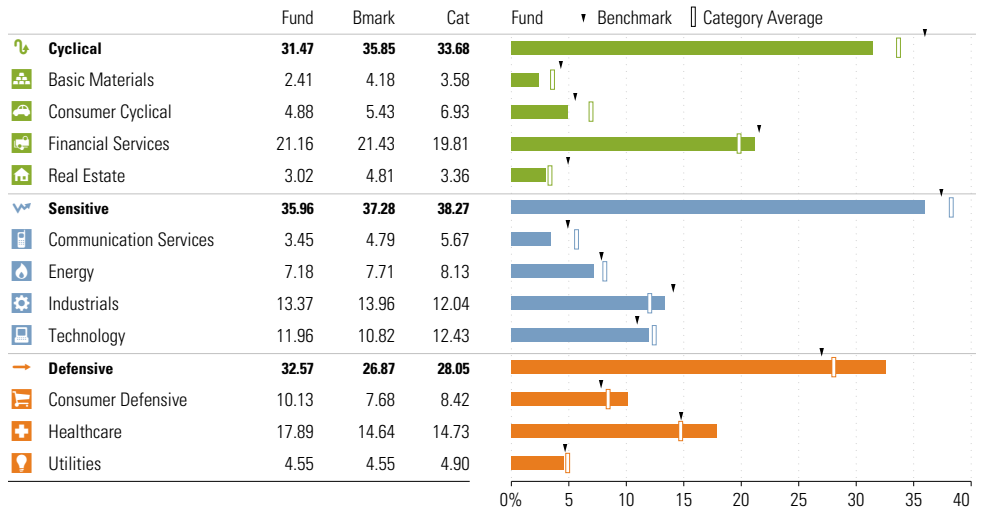
