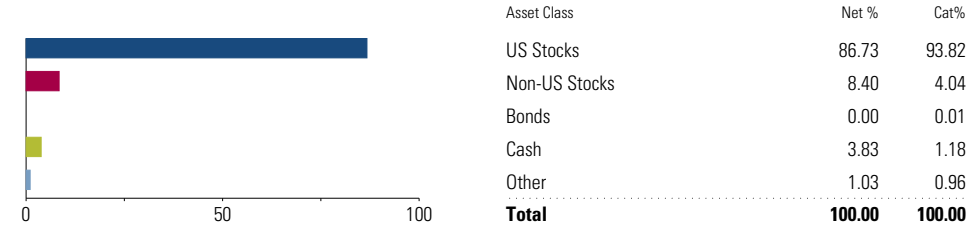

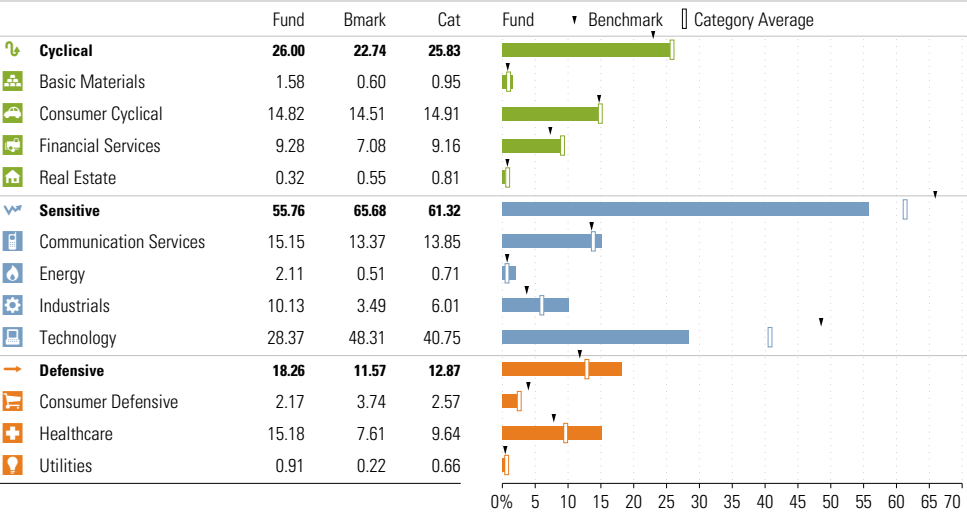

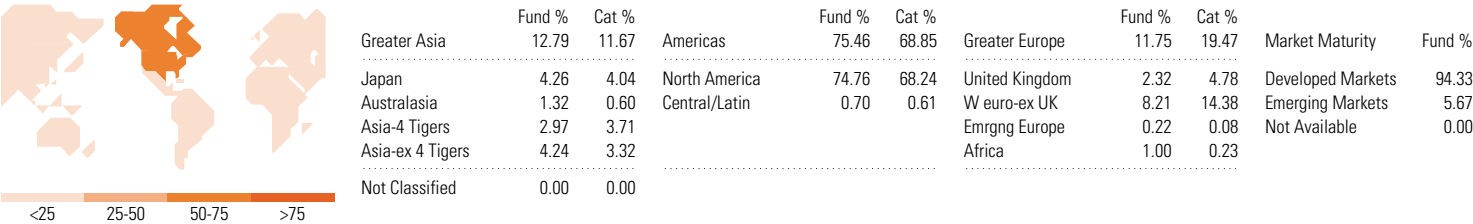

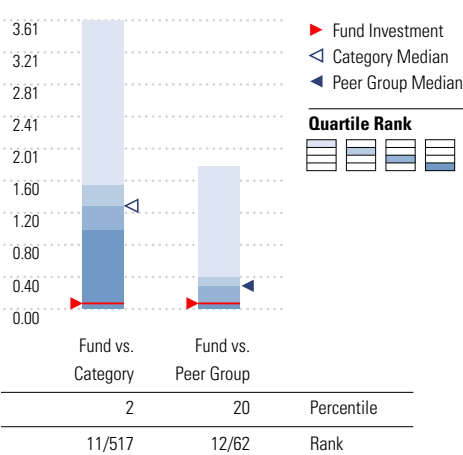

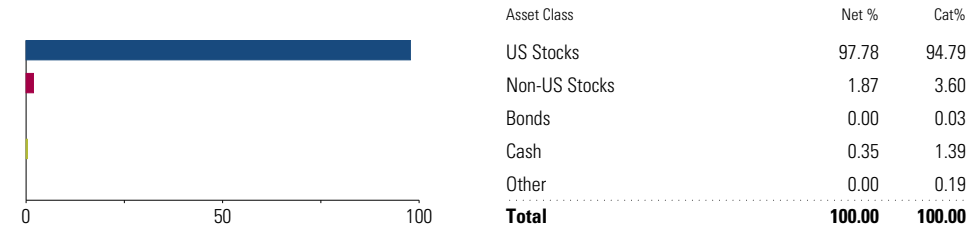

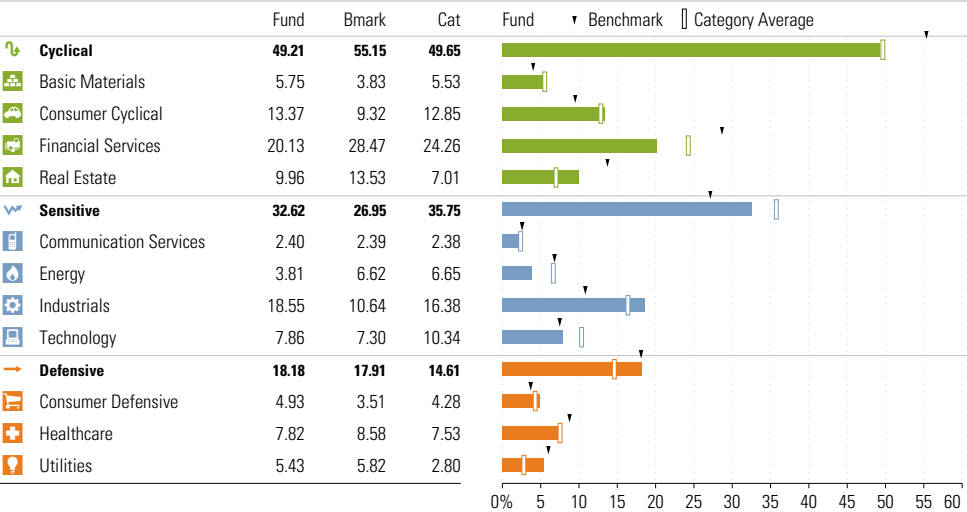
Style Breakdown

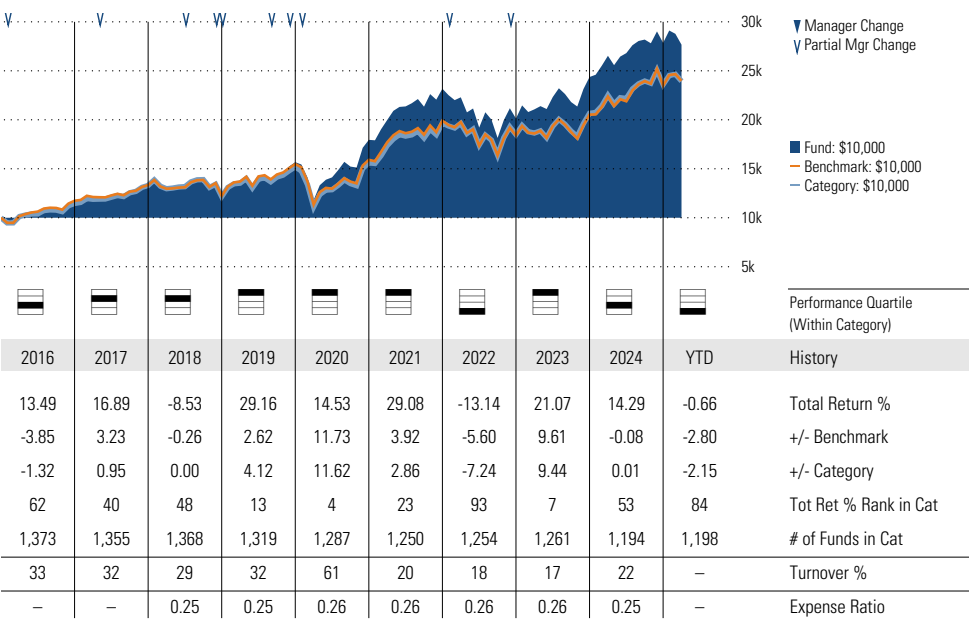
Morningstar Investment Management LLC Analysis

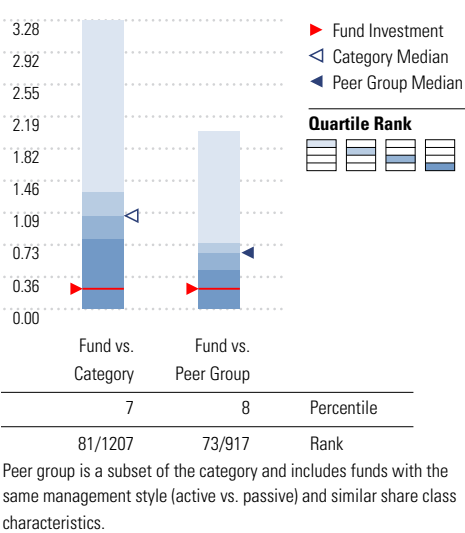

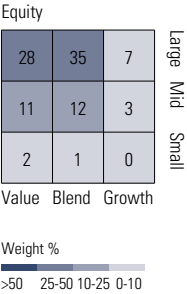

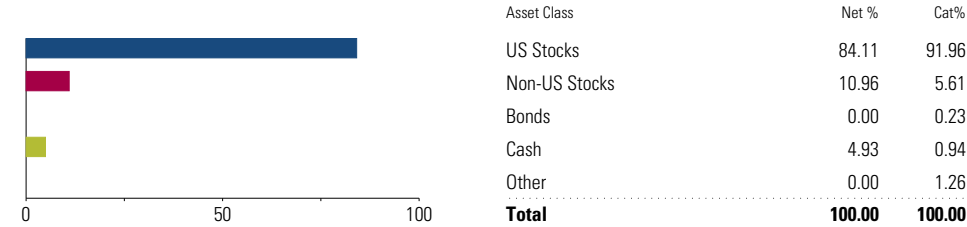

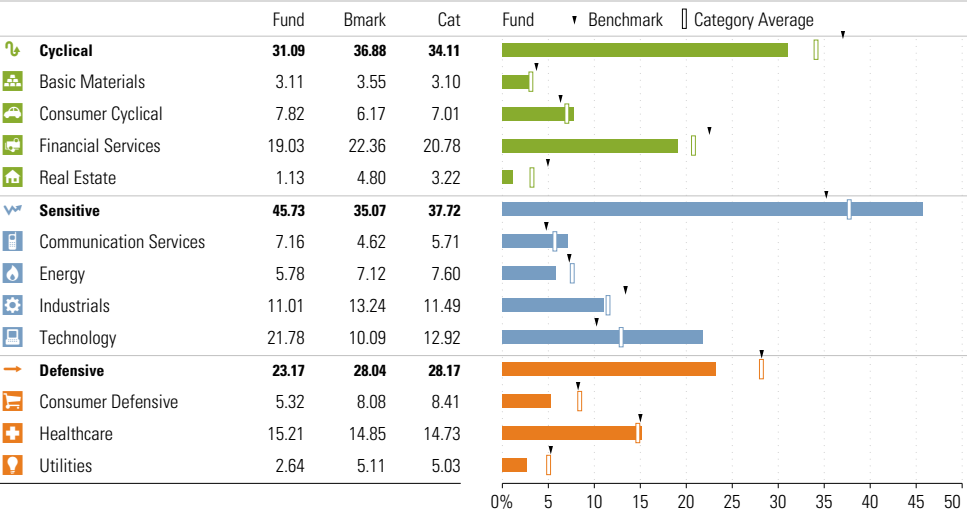
Style Breakdown
