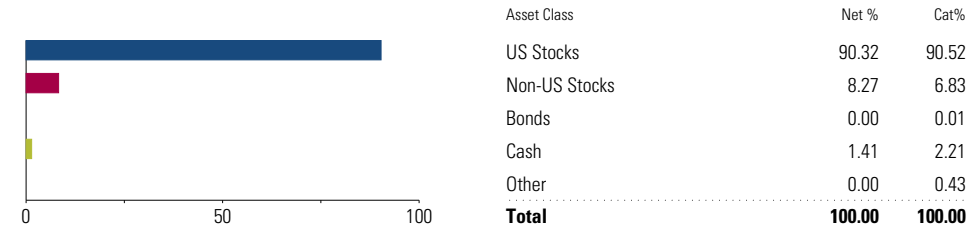

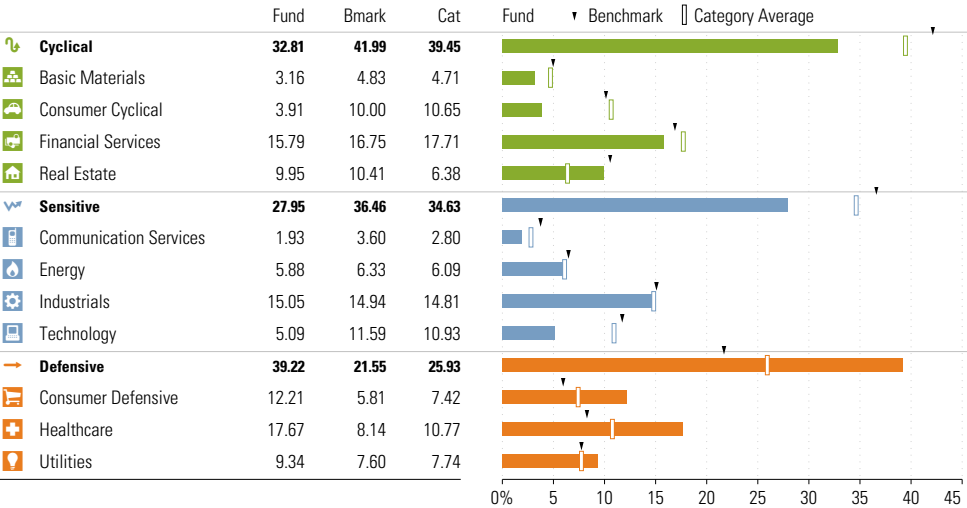

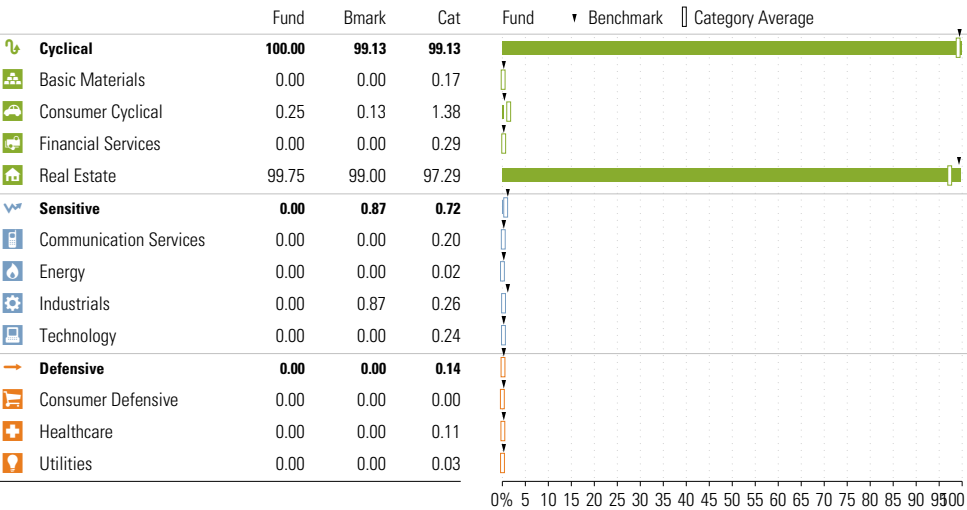
Style Breakdown

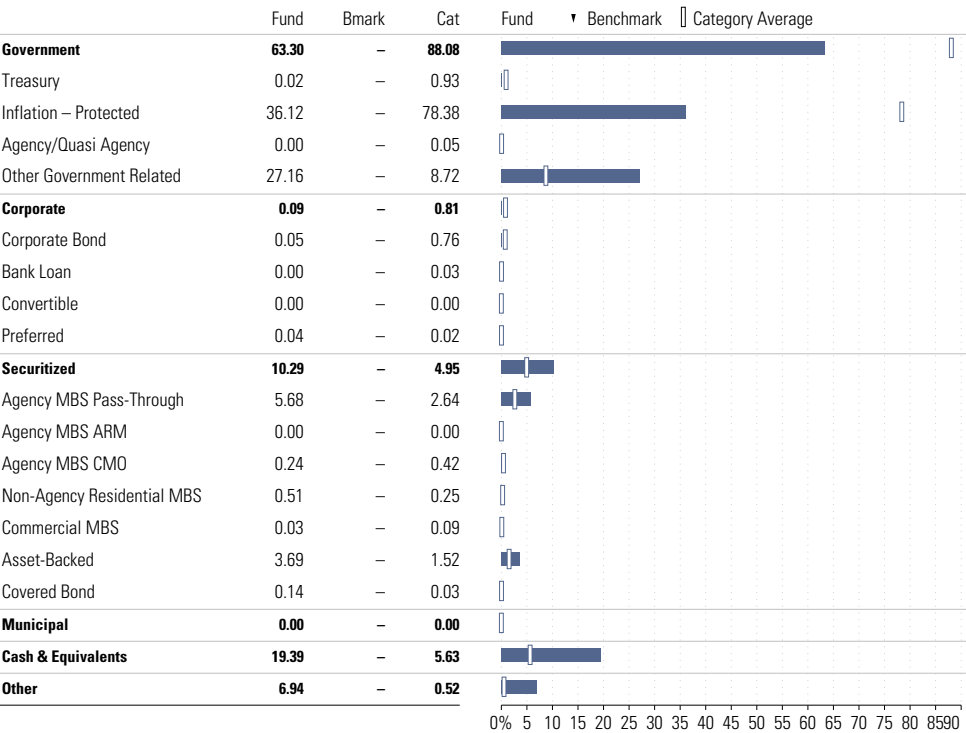

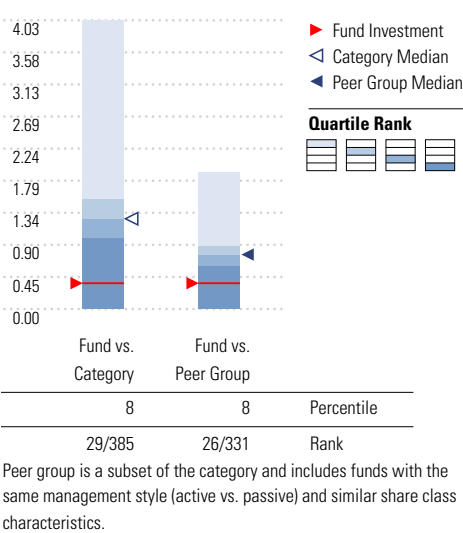
