Asset Allocation as of 03-31-2025






Asset Allocation as of 03-31-2025

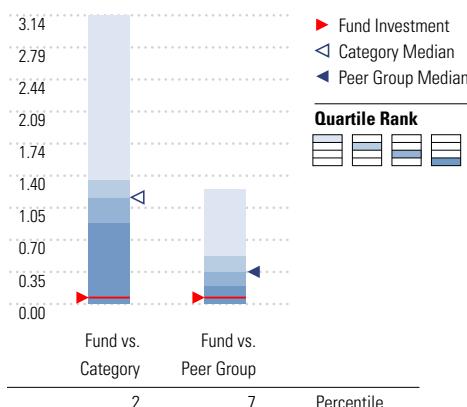

Asset Allocation as of 03-31-2025







Asset Allocation as of 03-31-2025




