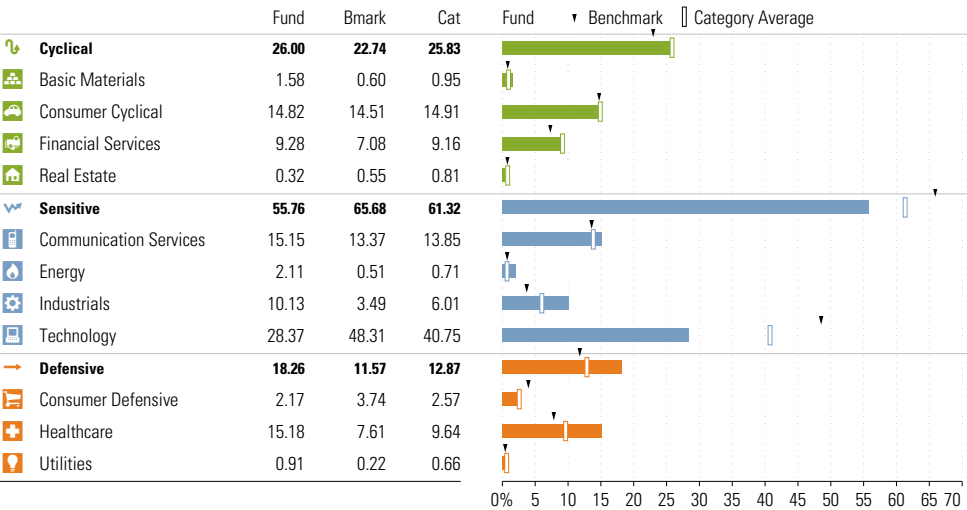

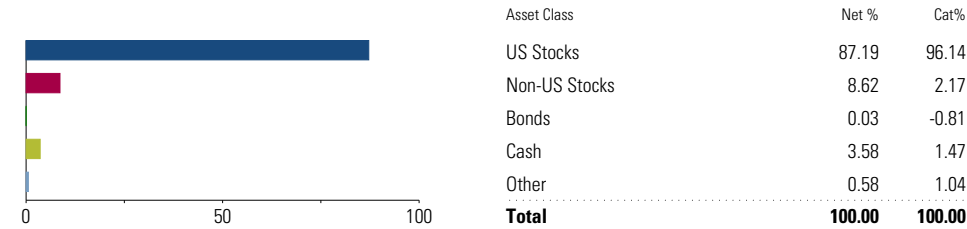

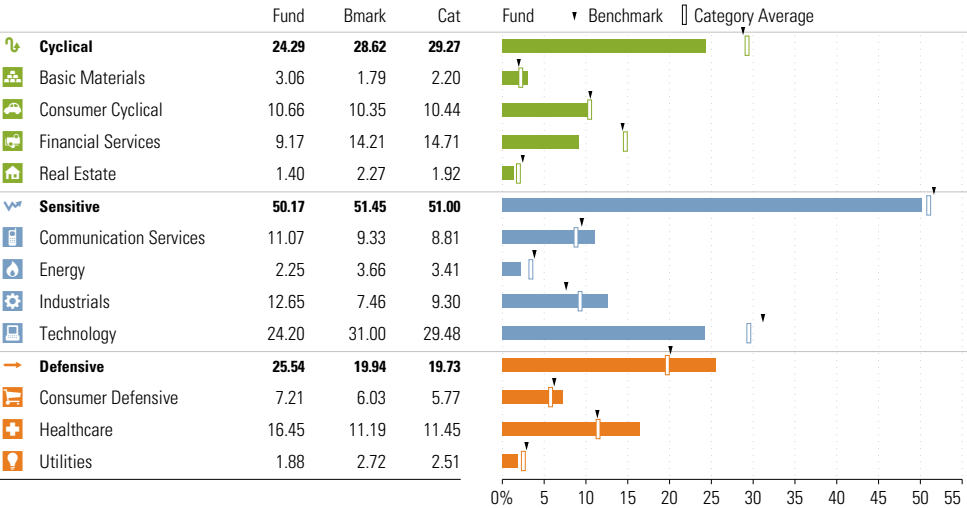

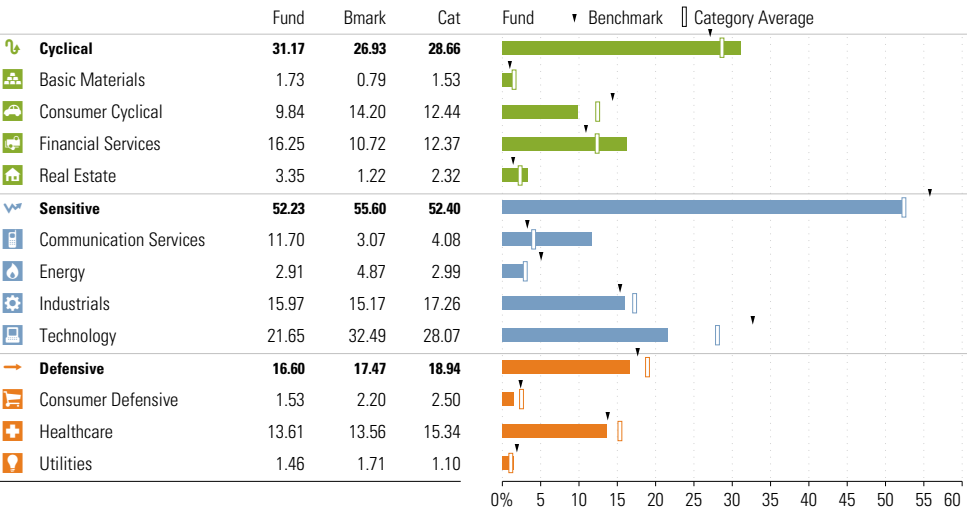

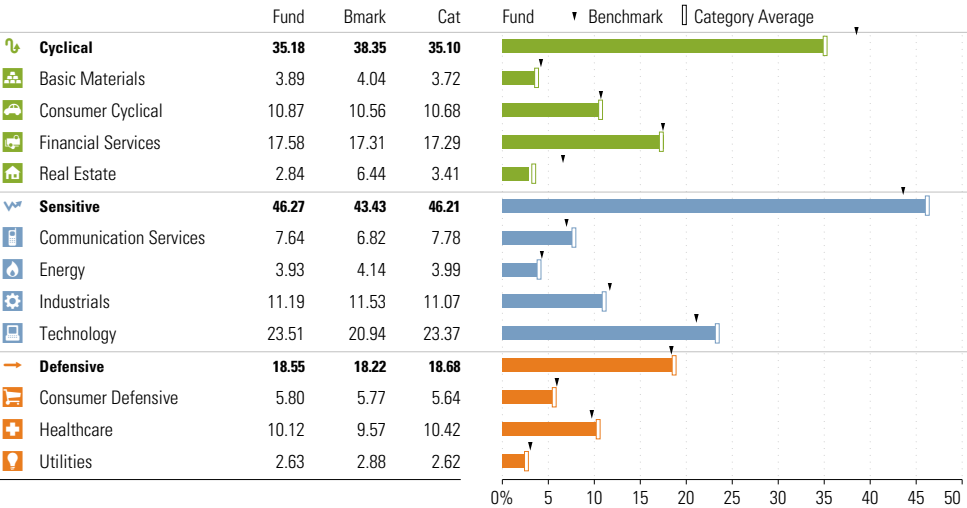

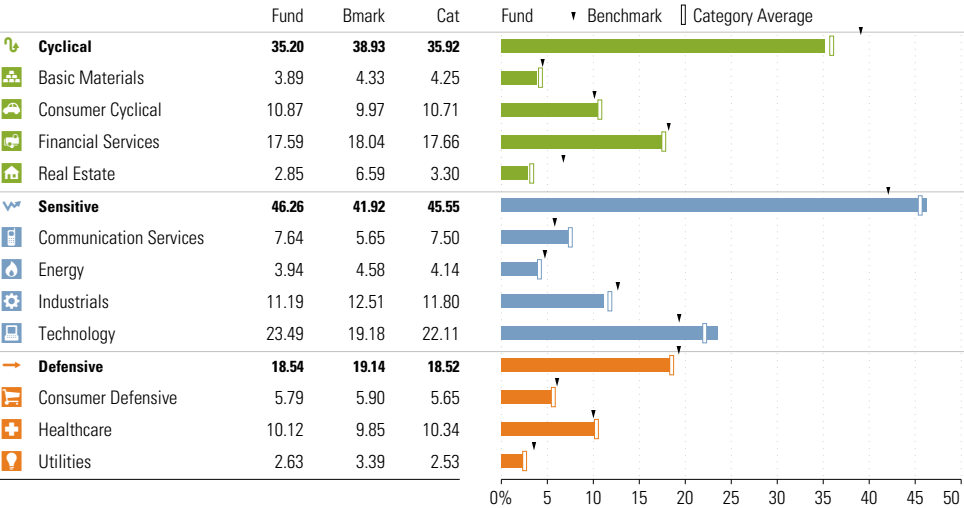
Style Breakdown

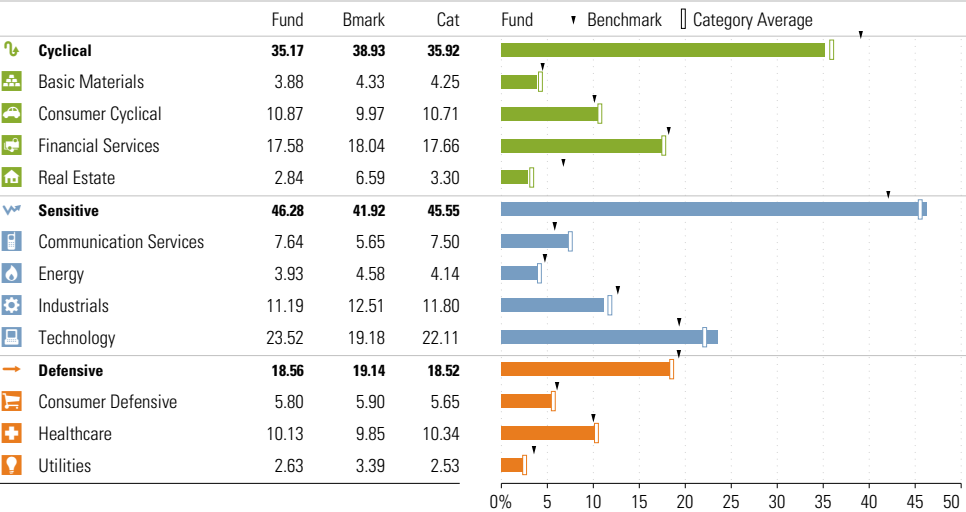
Style Breakdown
