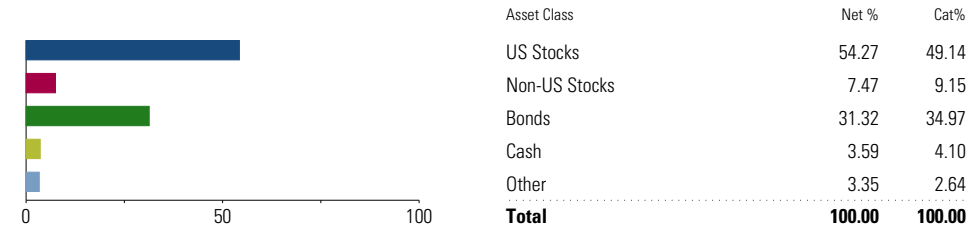

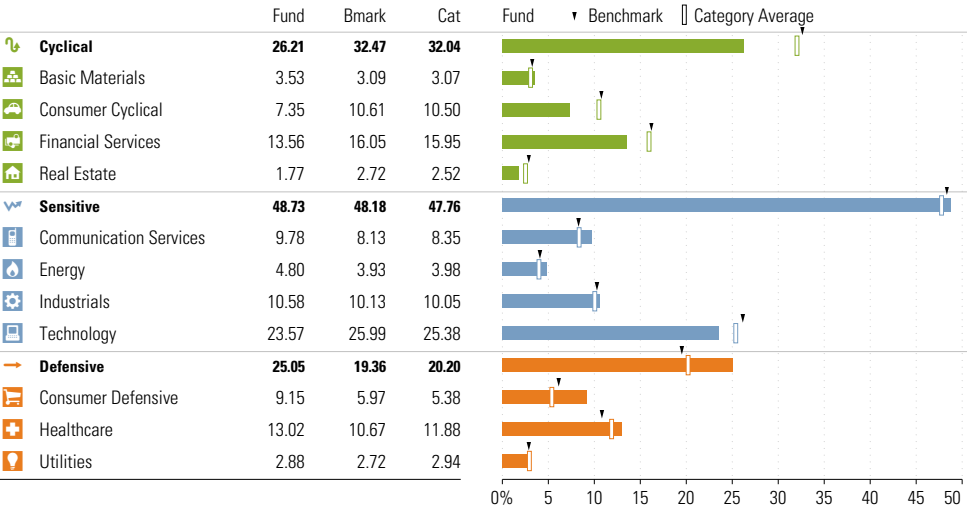

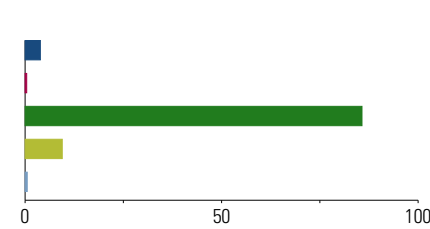

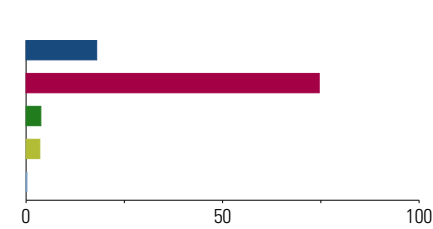

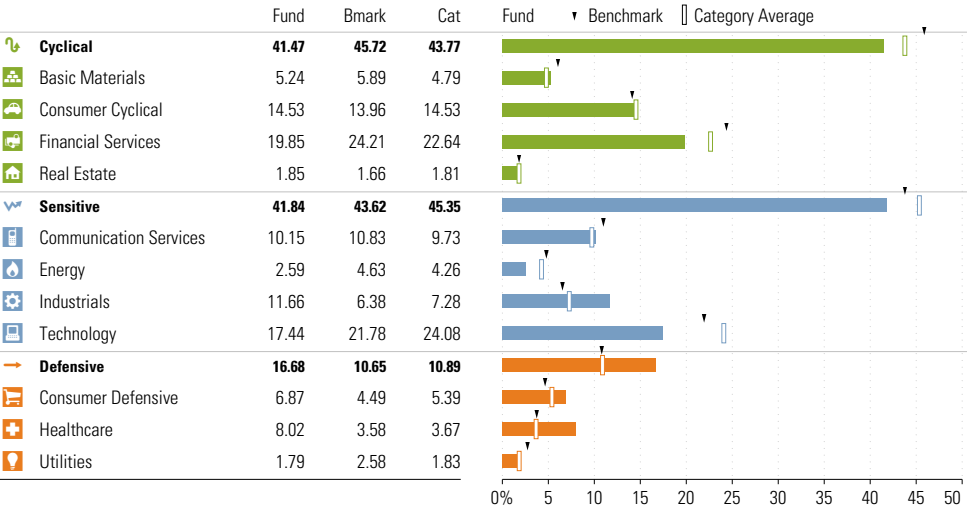

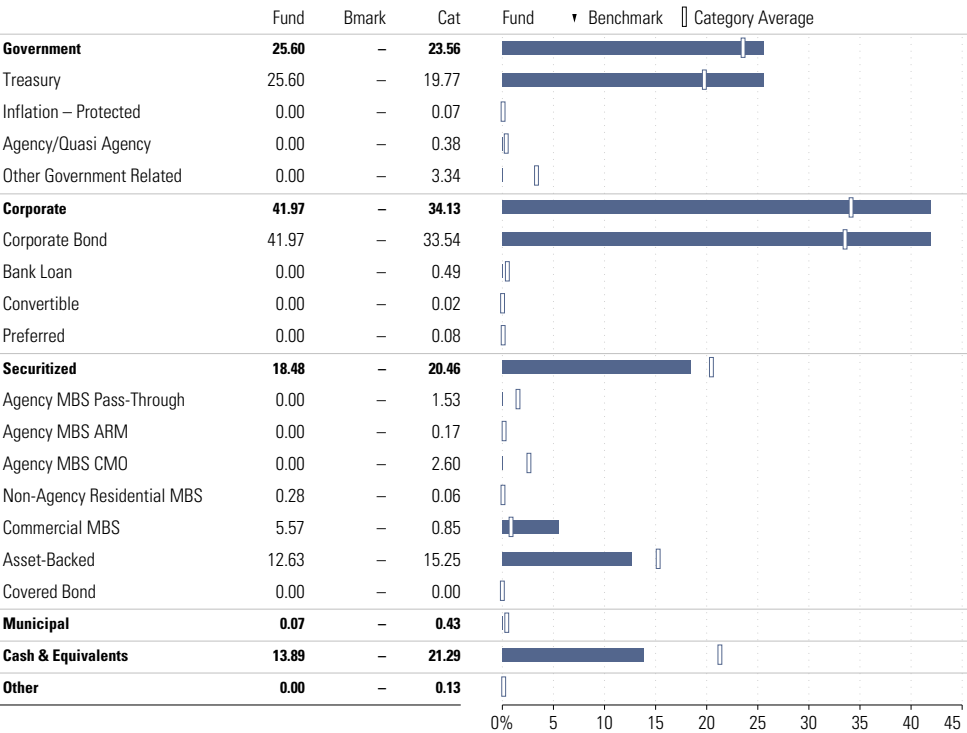

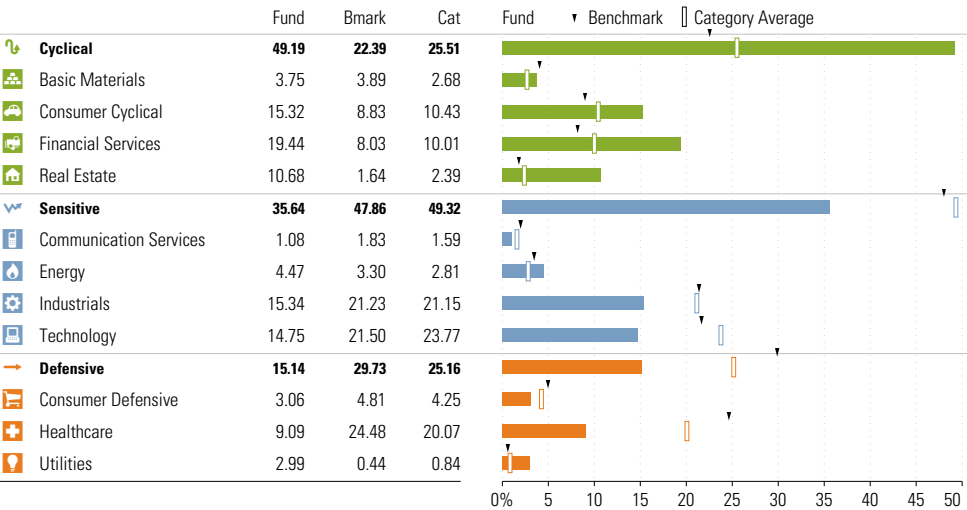

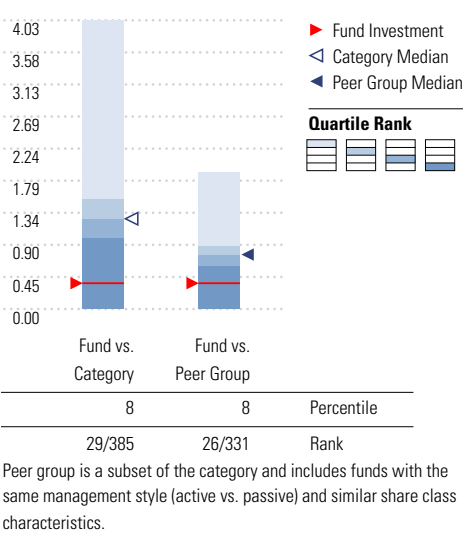

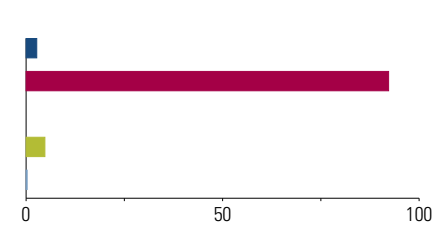

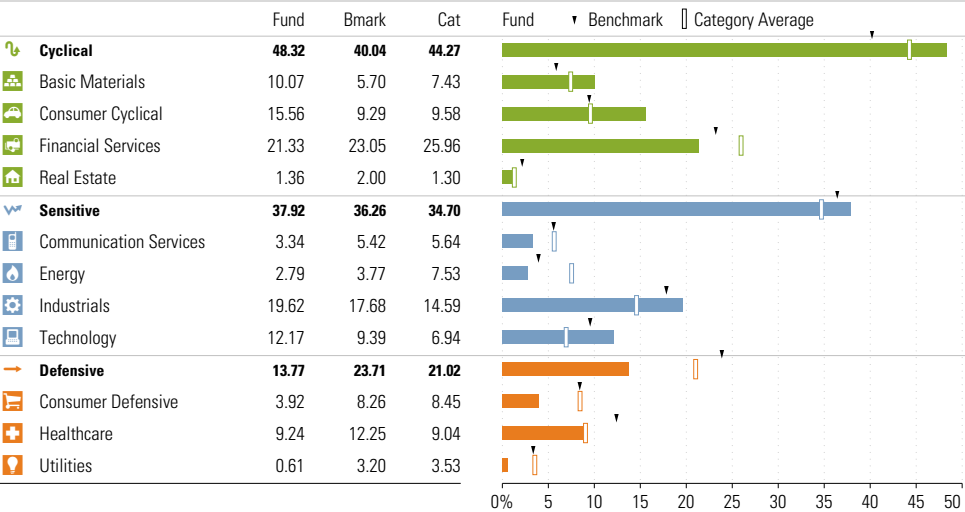

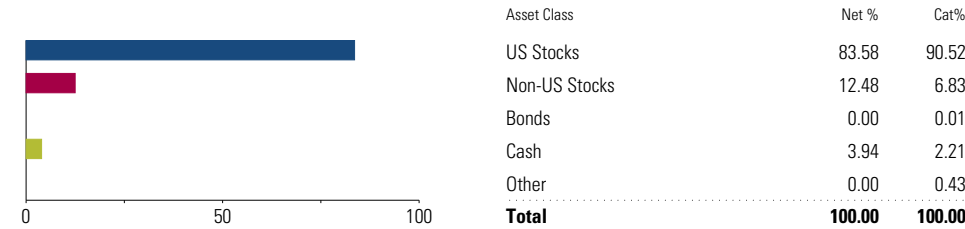

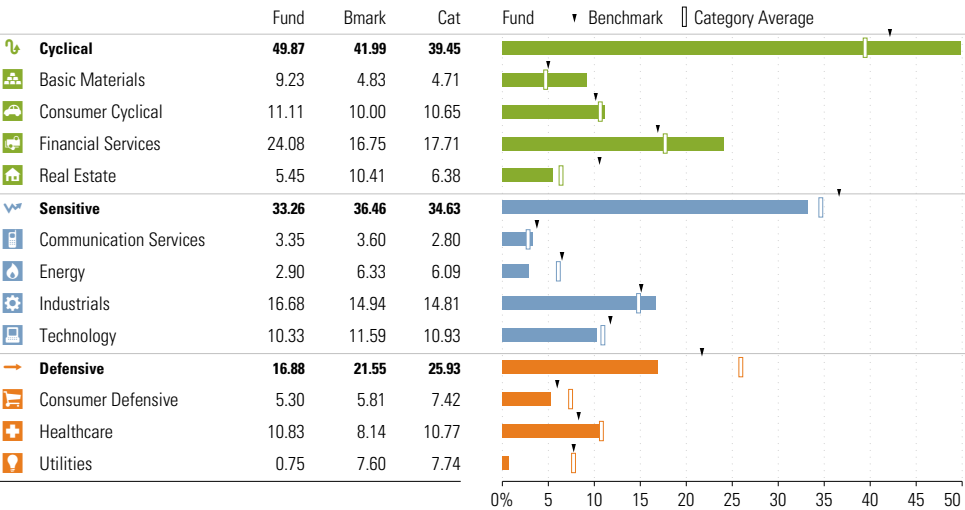
Style Breakdown
