

We are placing this fund on watch due to the departure of lead PIO (Principal Investment Officer) and sleeve manager James Terrile from the fund. Terrile's departure marks the sixth sleeve manager departure since 2020 and coincides with a period of weak relative performance for the strategy. Seven sleeve managers remain, including new lead PIO Cheryl Frank, who has managed assets here since 2018 and been a co-PIO since 2021. We are placing the fund on watch while monitoring the transition of lead PIO.





Asset Allocation as of 03-31-2025







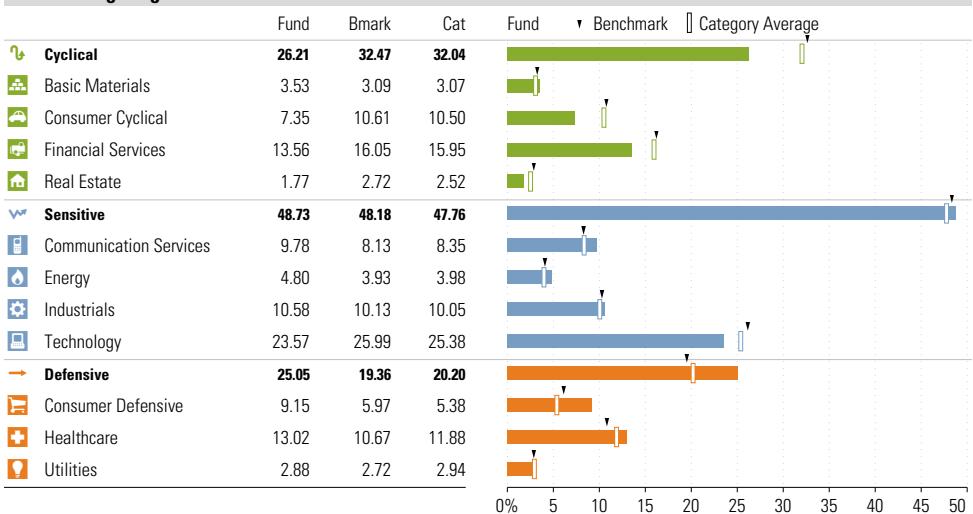
Asset Allocation as of 03-31-2025








Asset Allocation as of 03-31-2025
