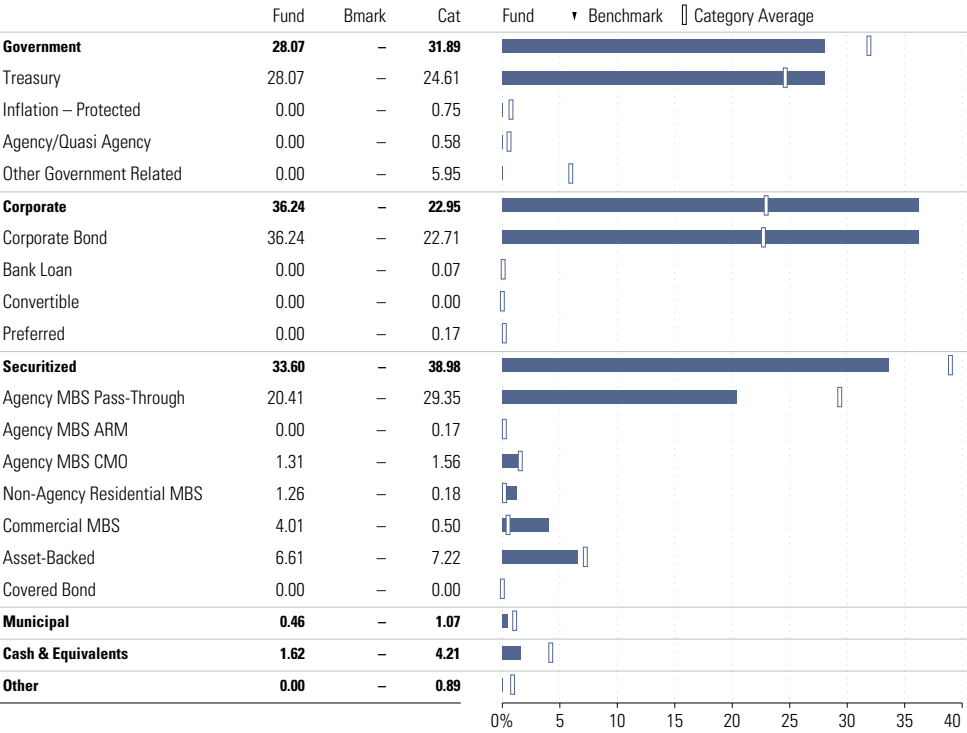

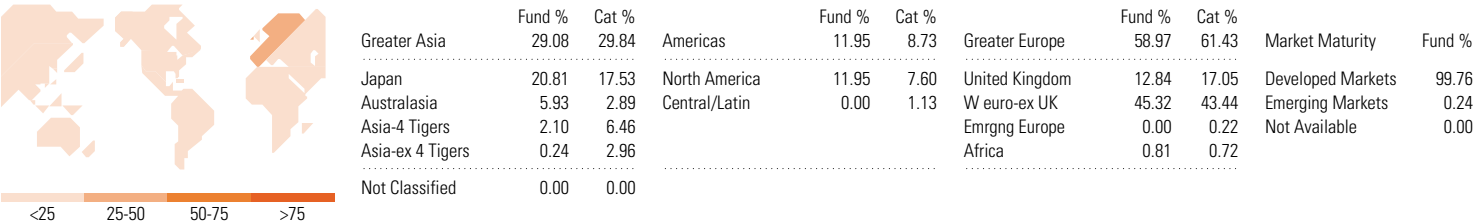
Asset Allocation as of 03-31-2025

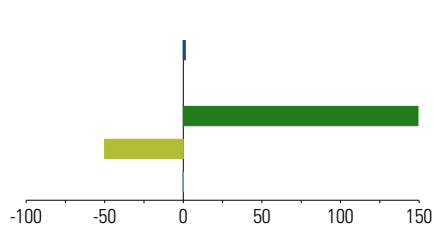

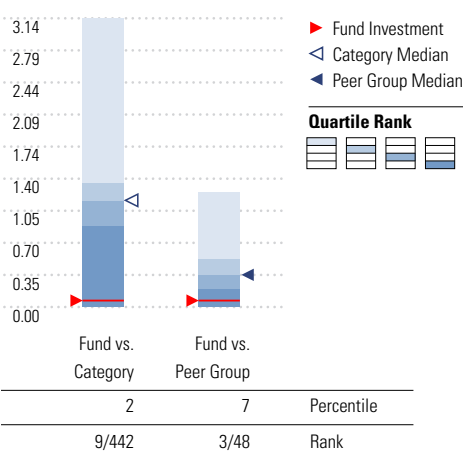

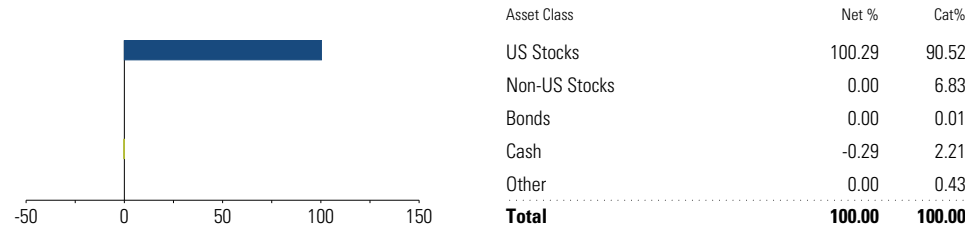

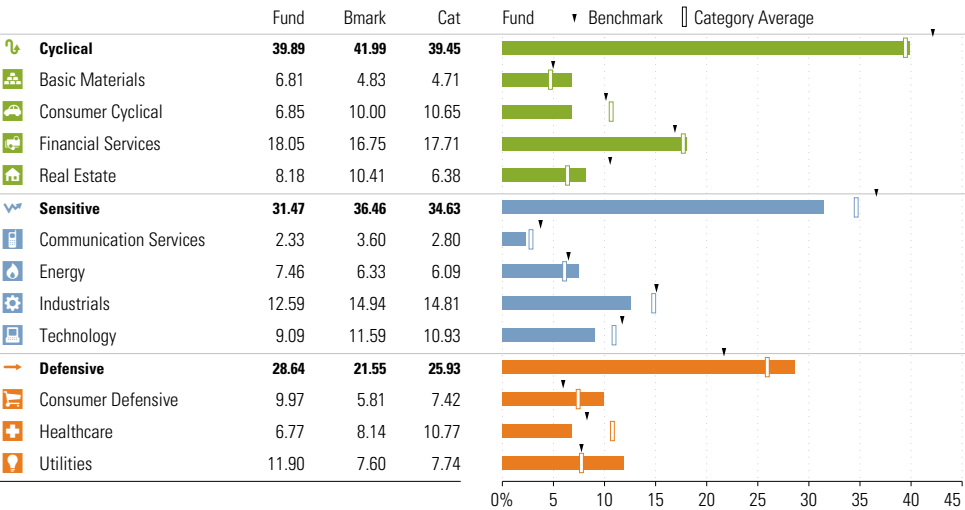
Style Breakdown

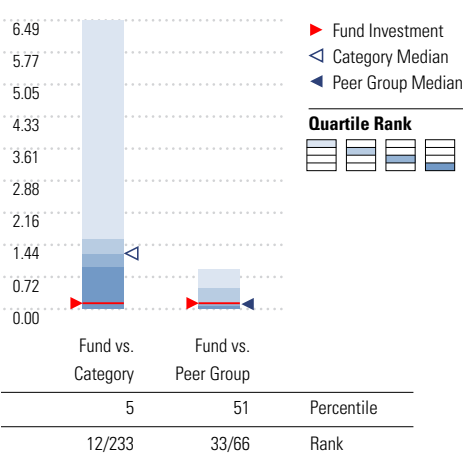

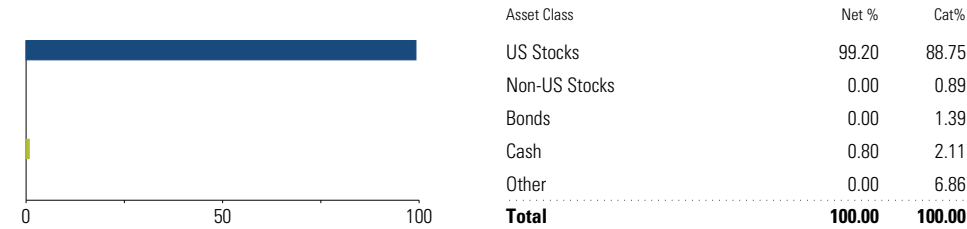

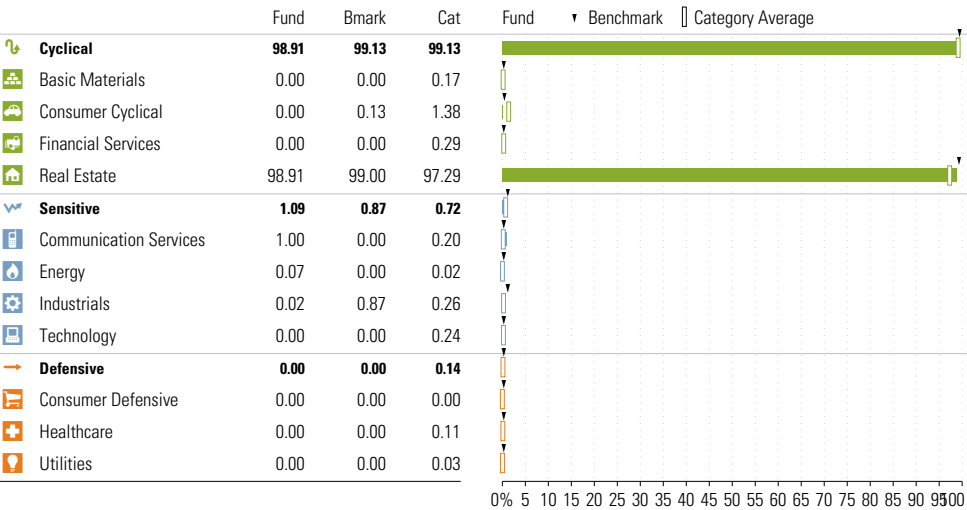
Style Breakdown

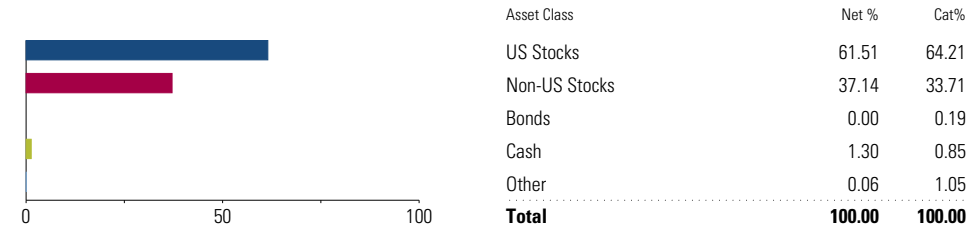

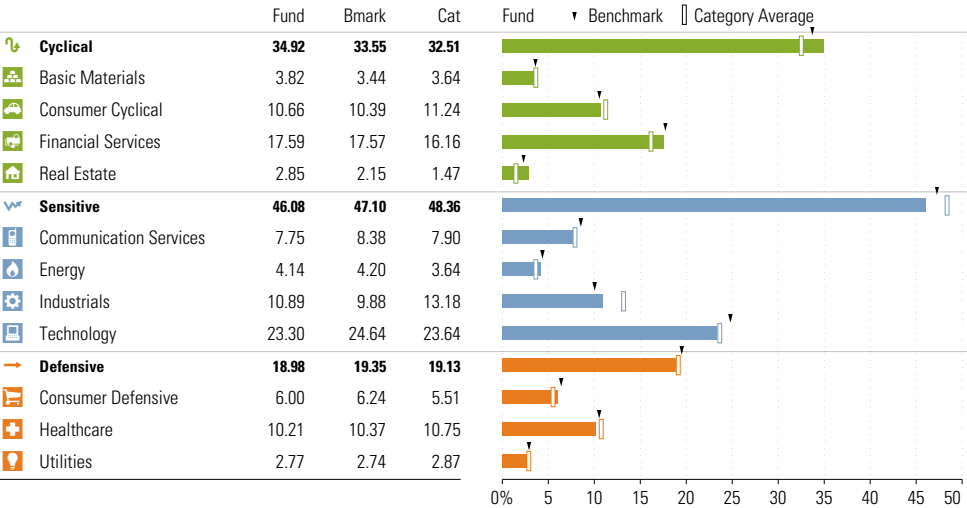

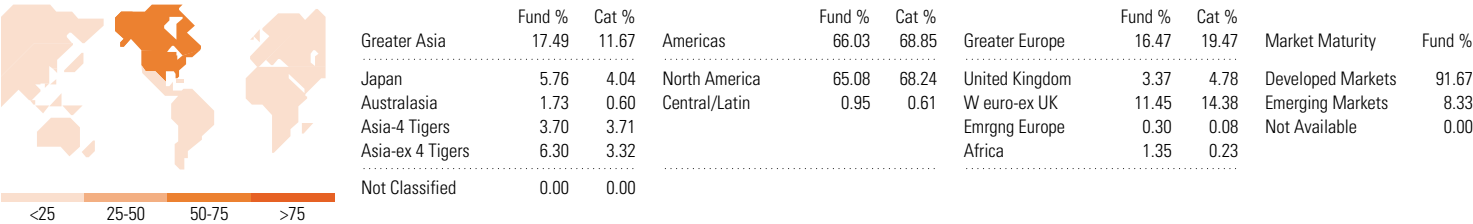
Asset Allocation as of 03-31-2025
