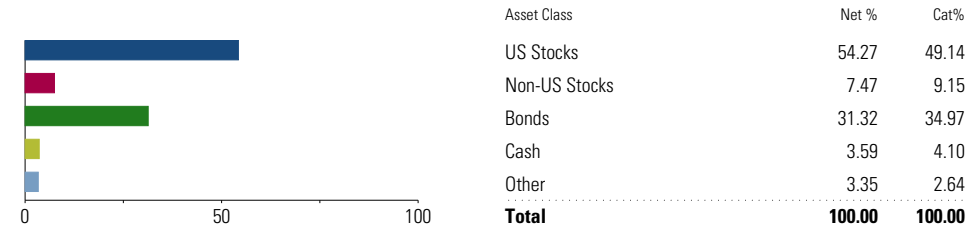

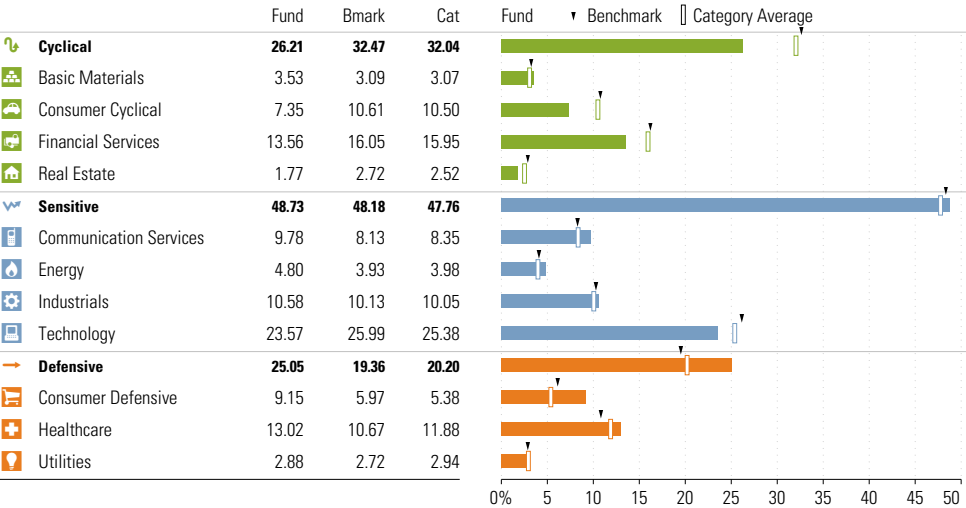

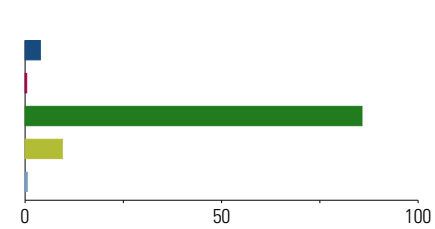

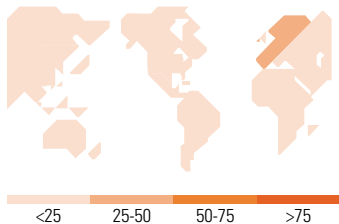

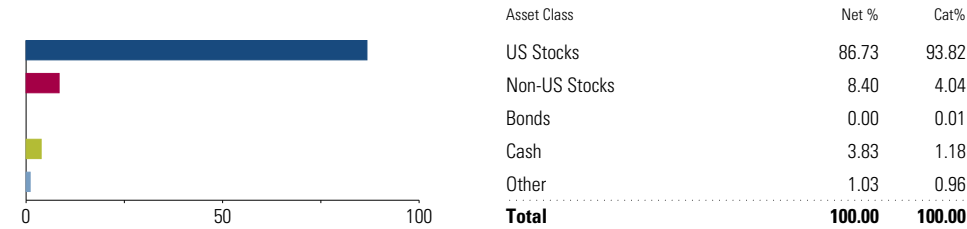

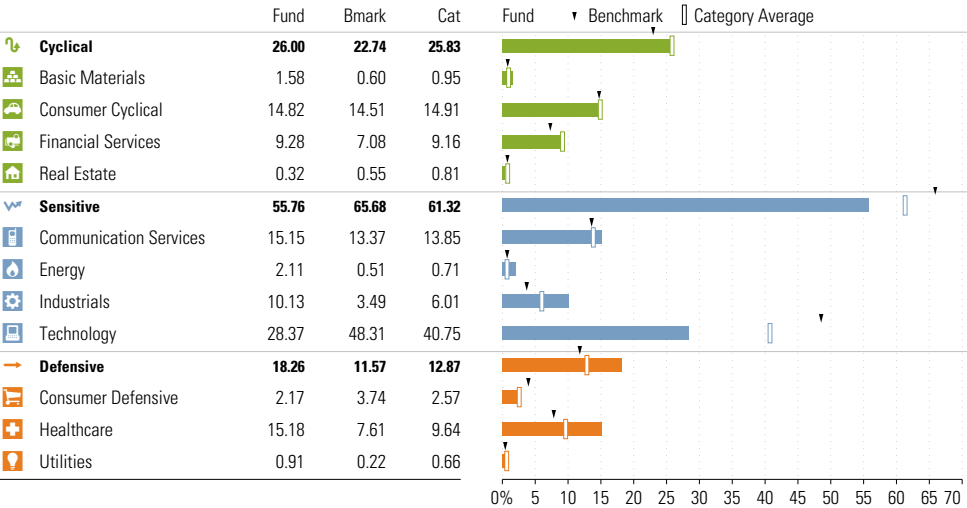
Style Breakdown

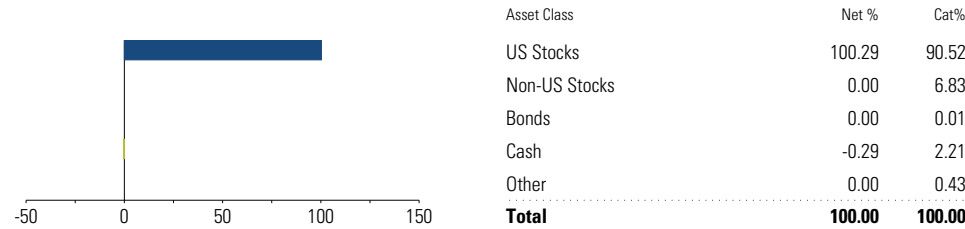

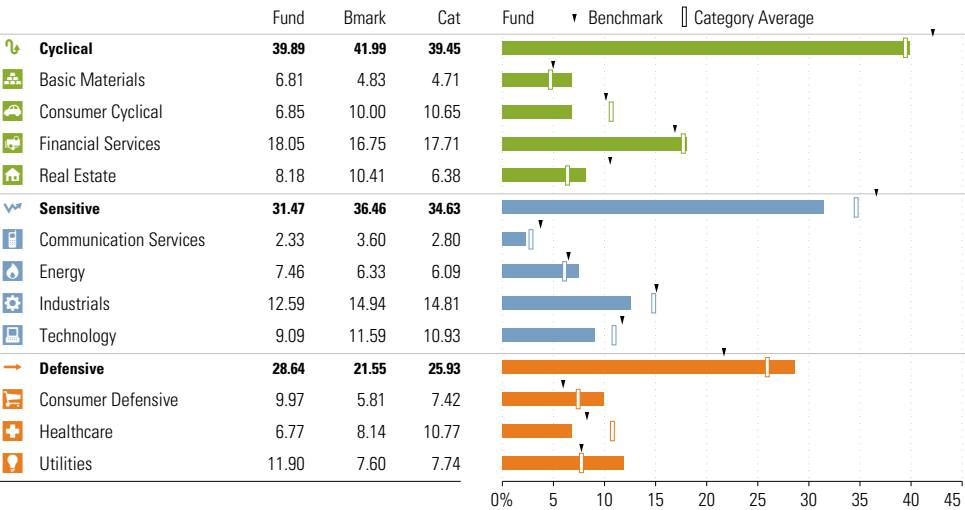

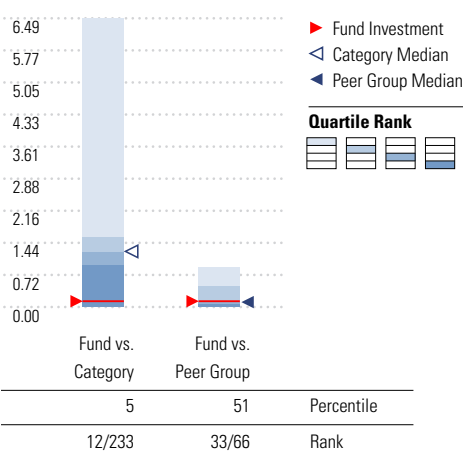

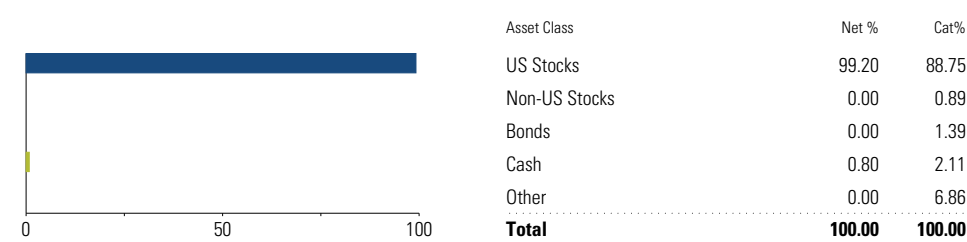

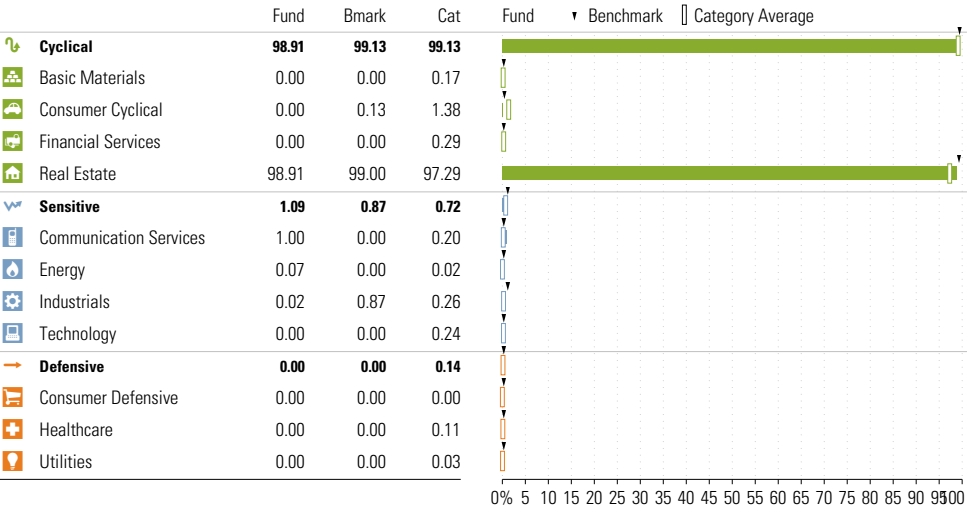

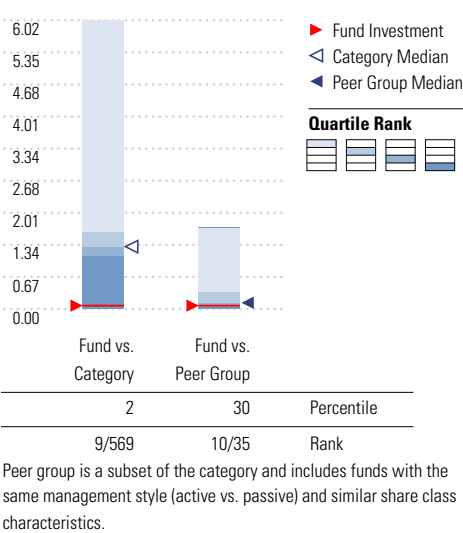

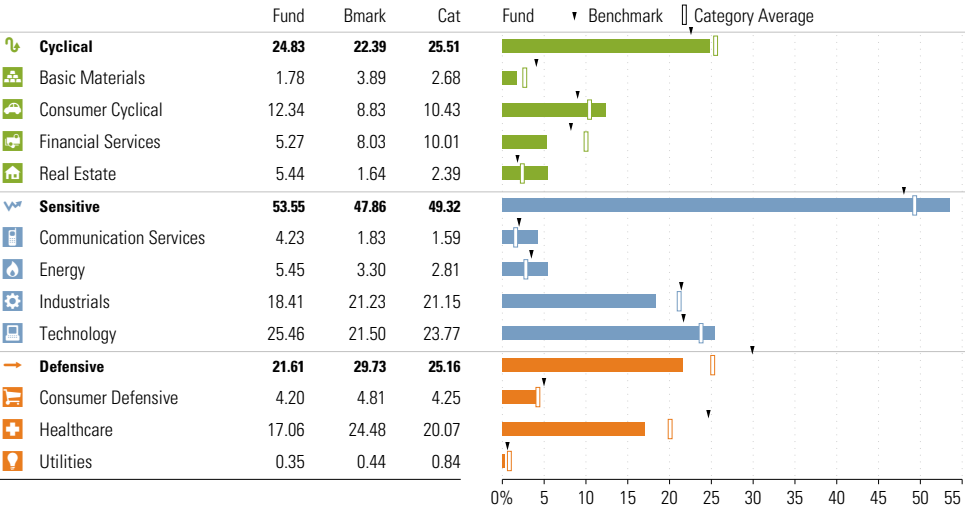
