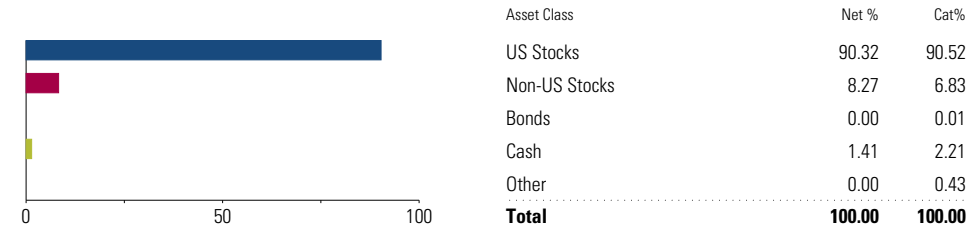

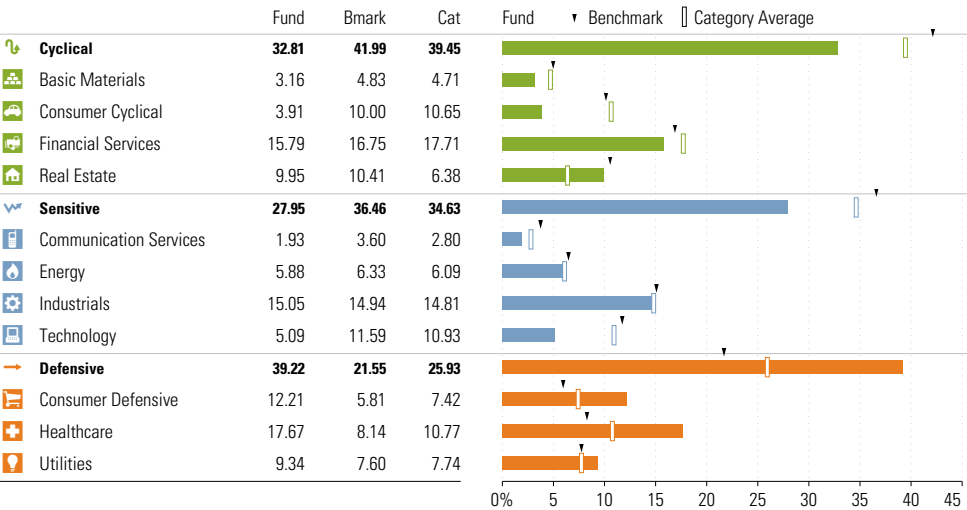

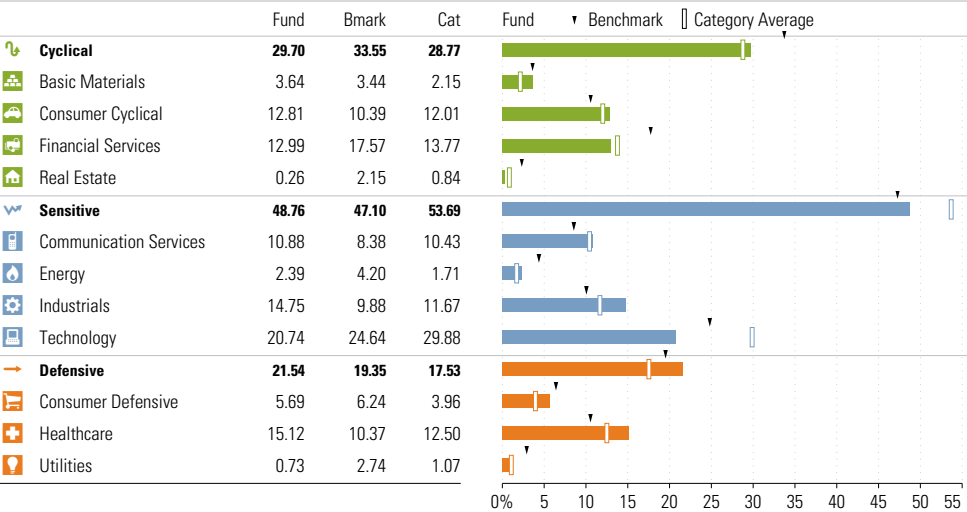

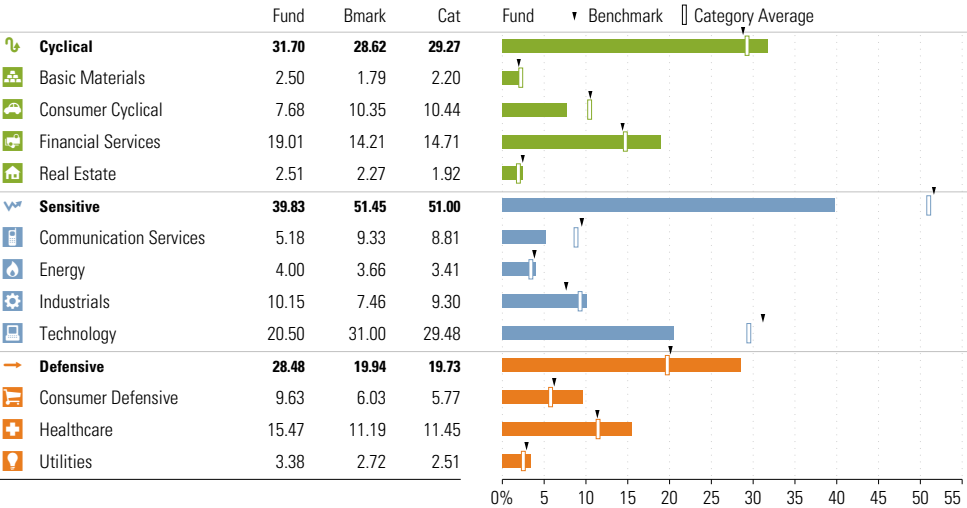

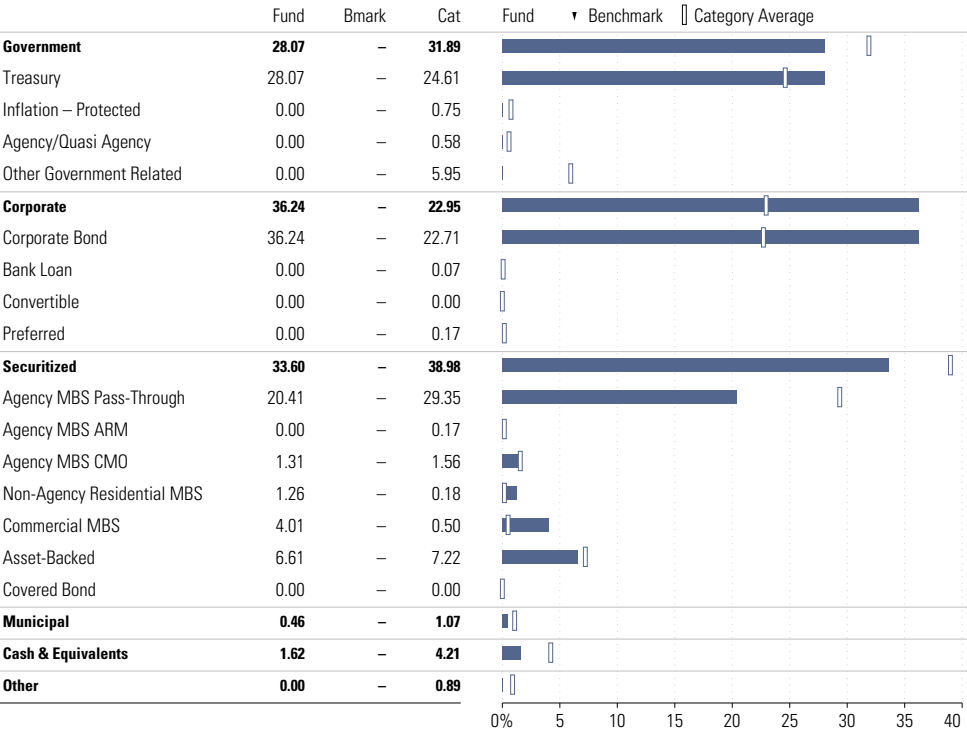

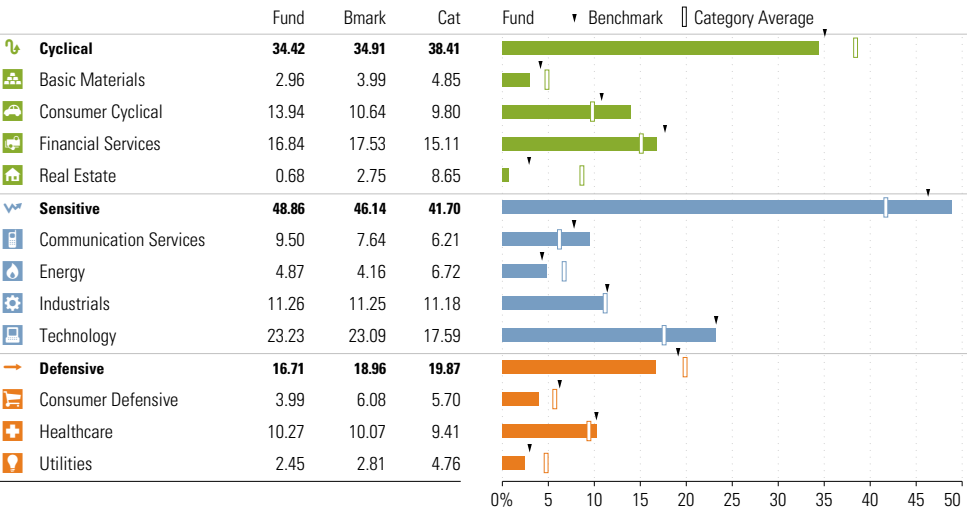

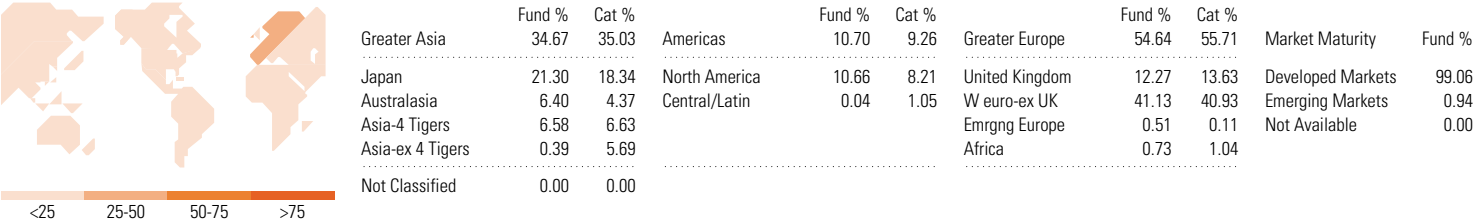

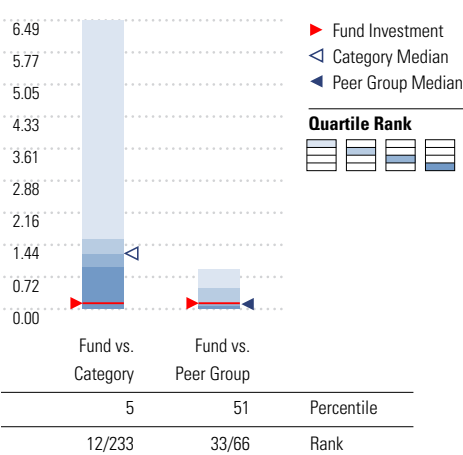

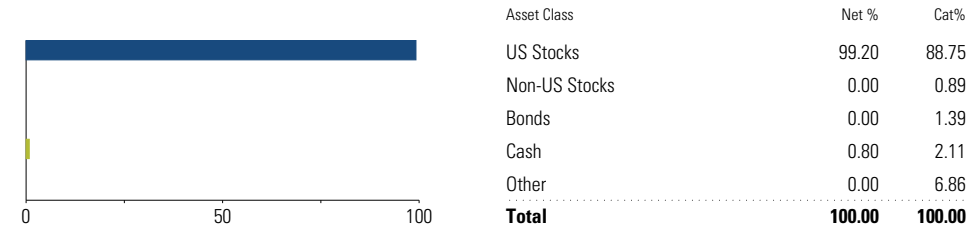

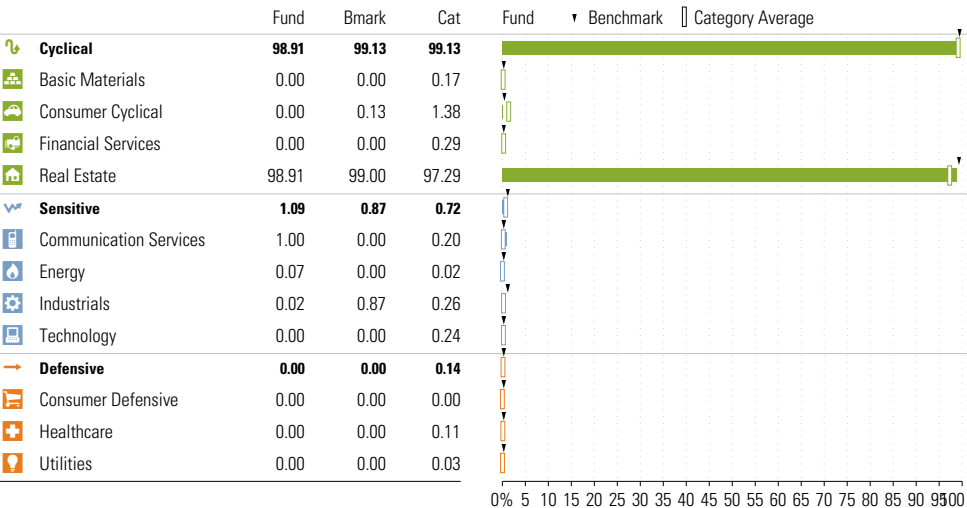
Style Breakdown
