




Asset Allocation as of 03-31-2025

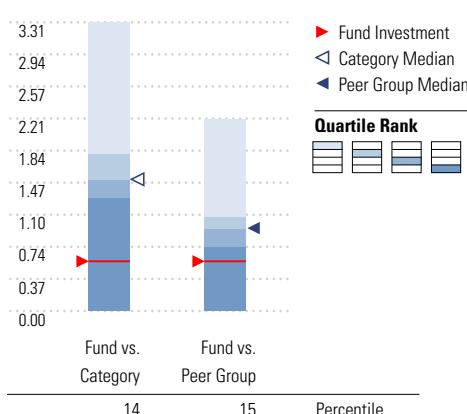

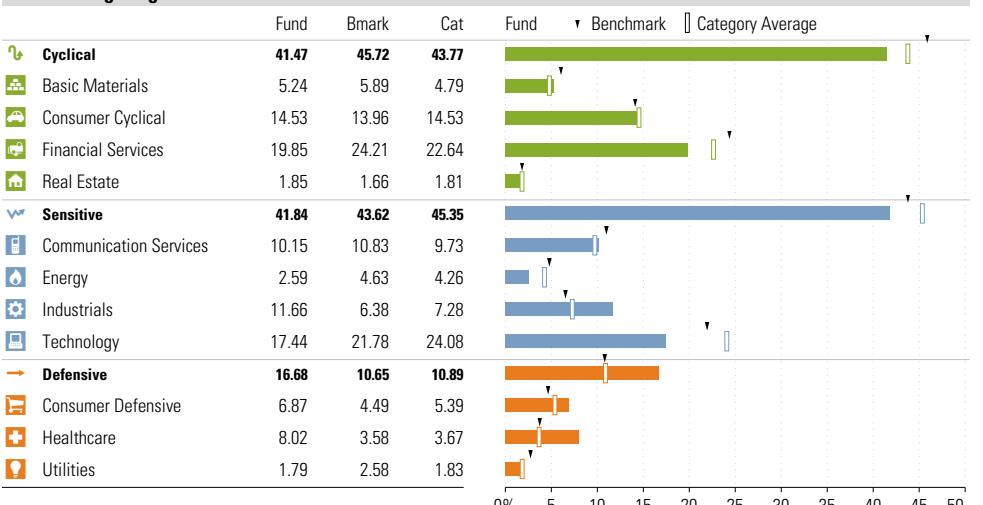


Asset Allocation as of 03-31-2025

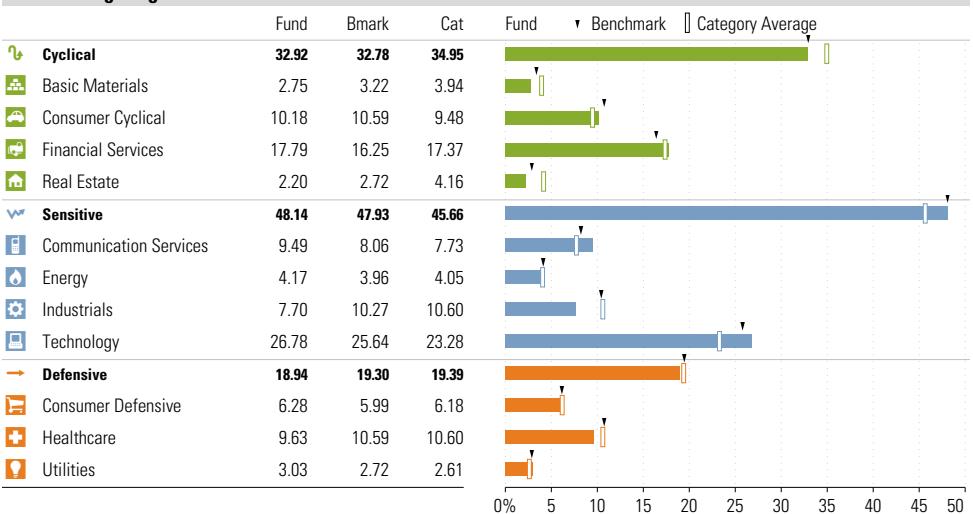

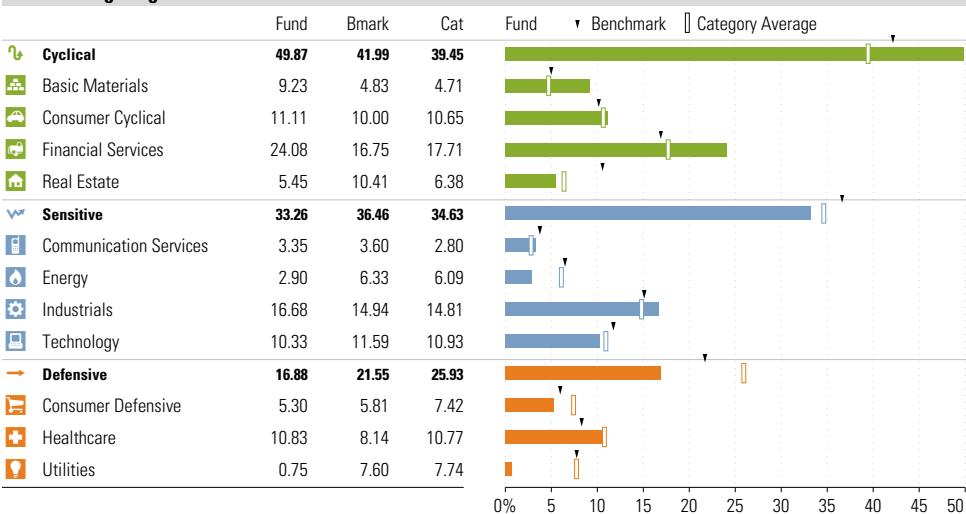



Asset Allocation as of 03-31-2025



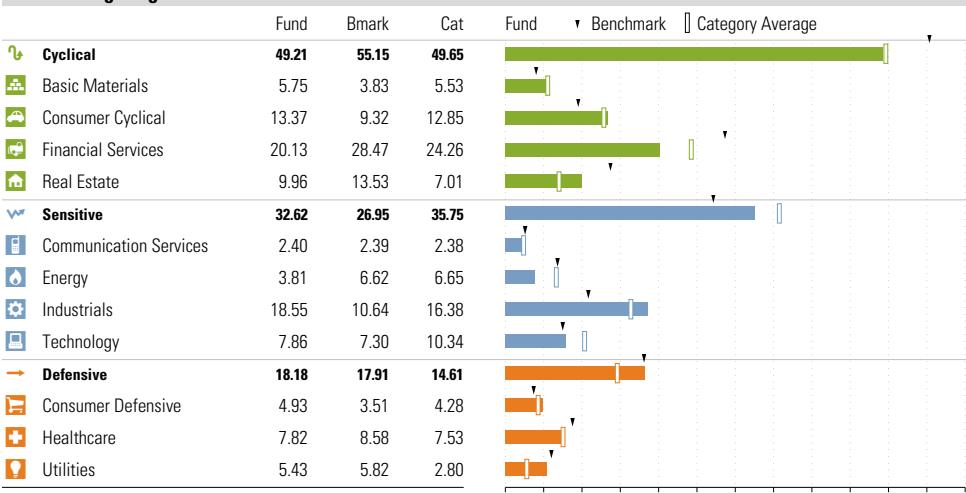

We are not concerned with this screen failure but will continue to monitor the fund's strategy and category assignment.
