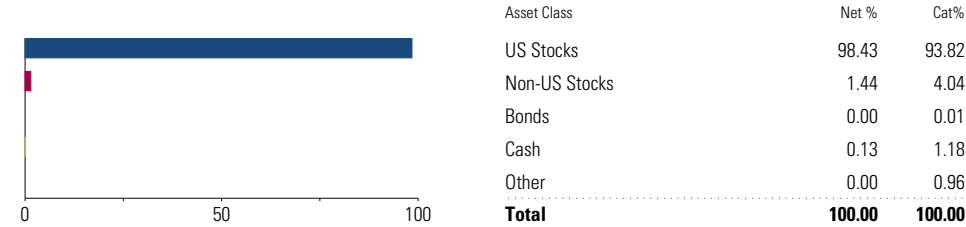

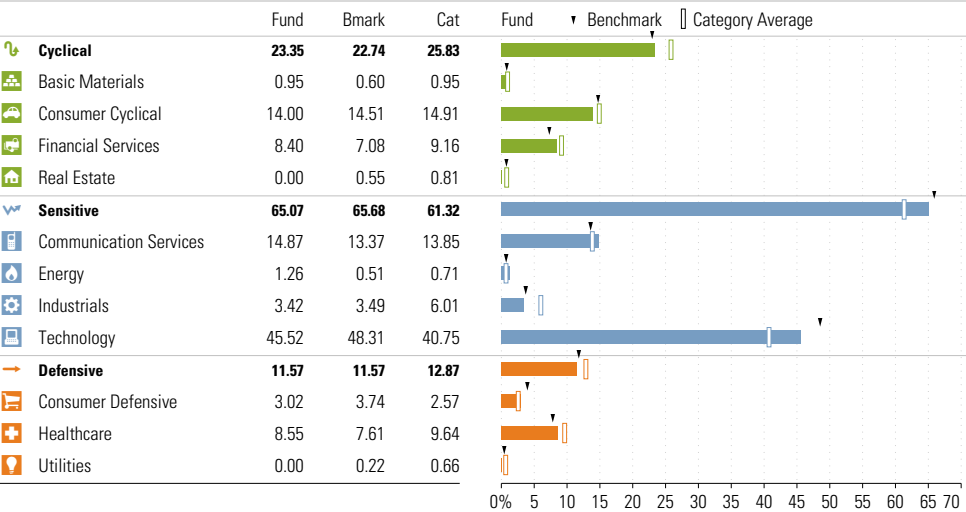
Style Breakdown

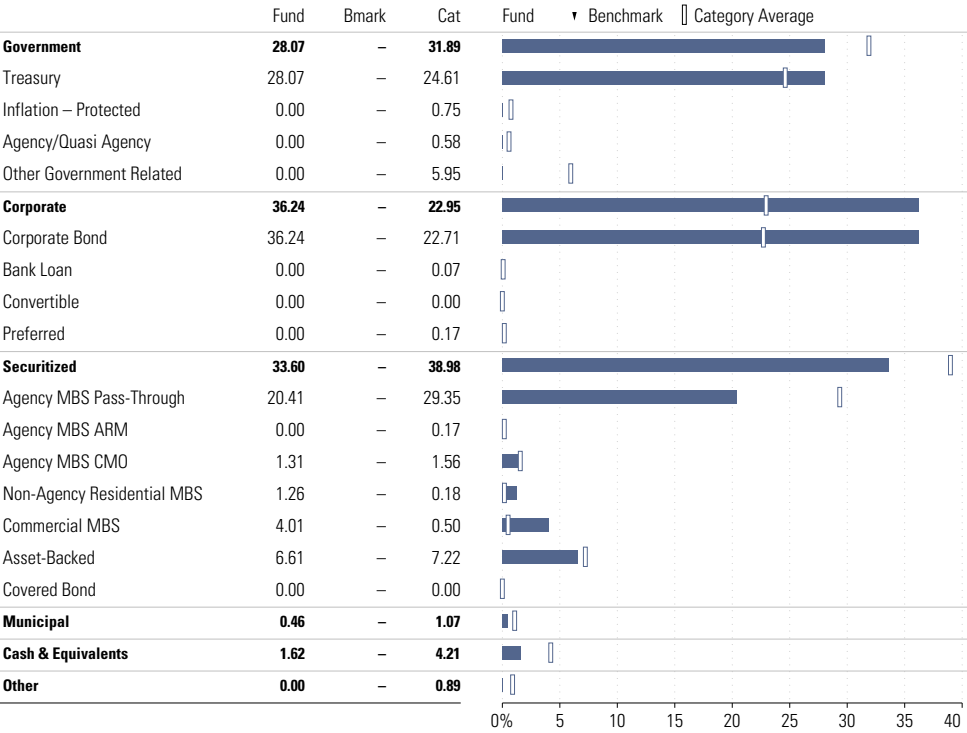

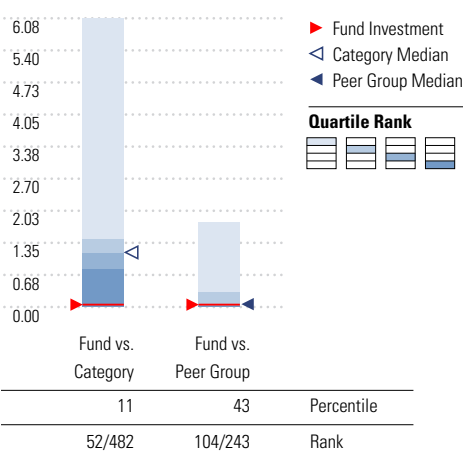

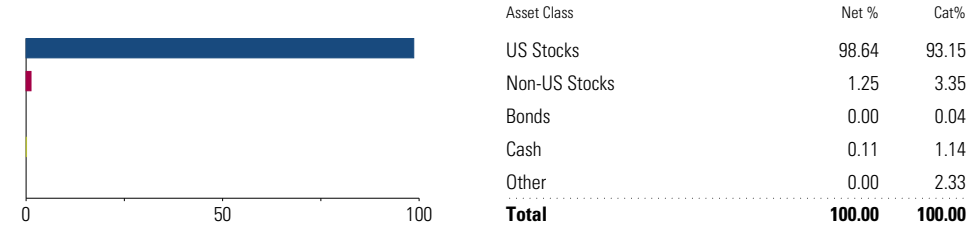

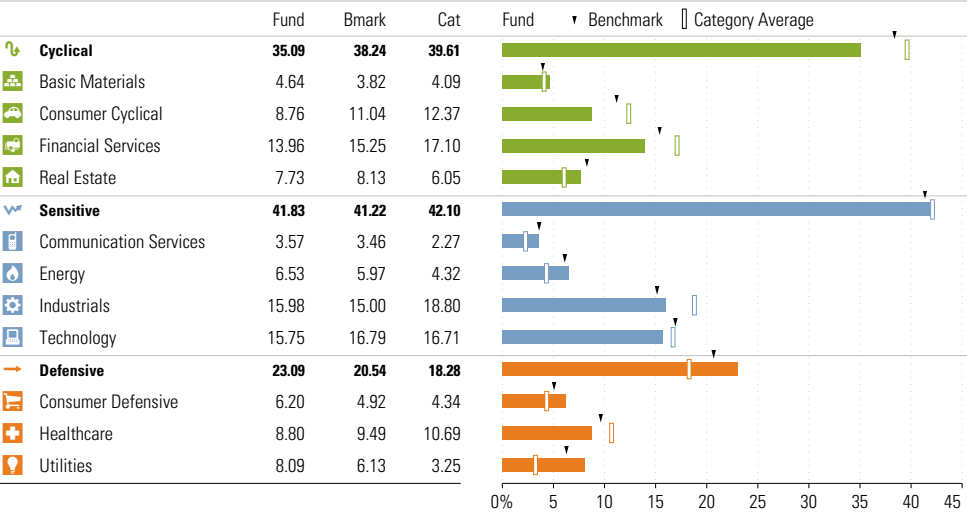
Style Breakdown

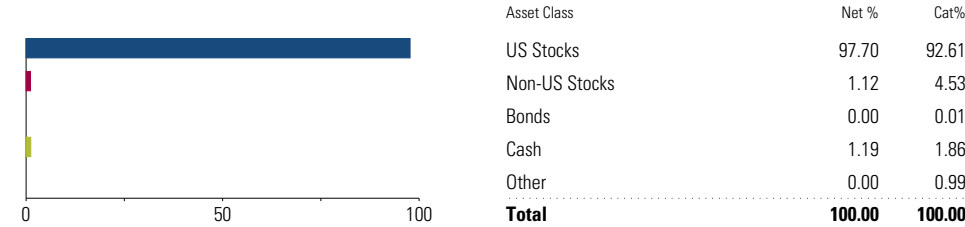

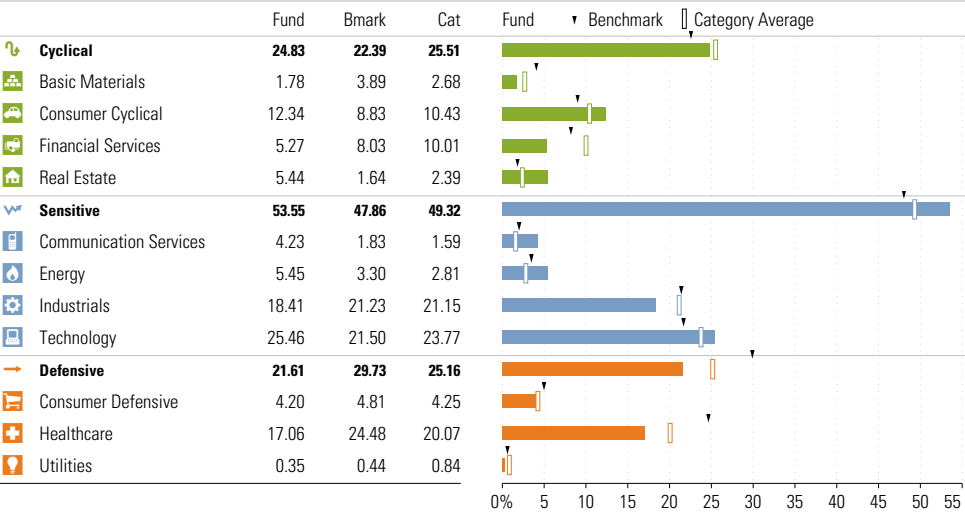
Style Breakdown

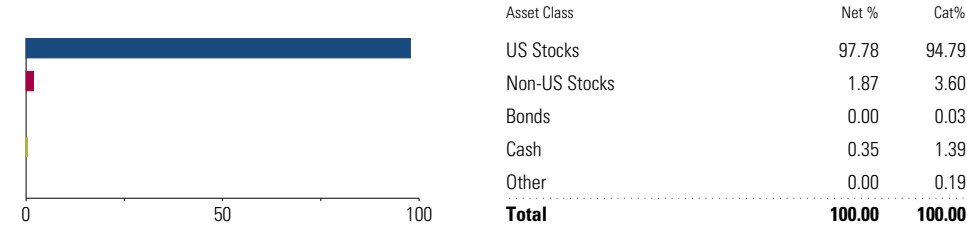

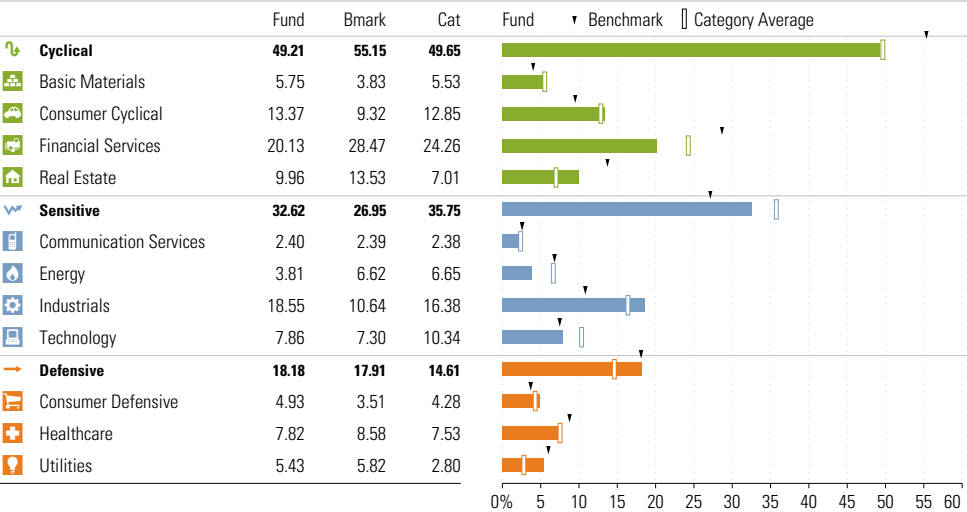
Style Breakdown
