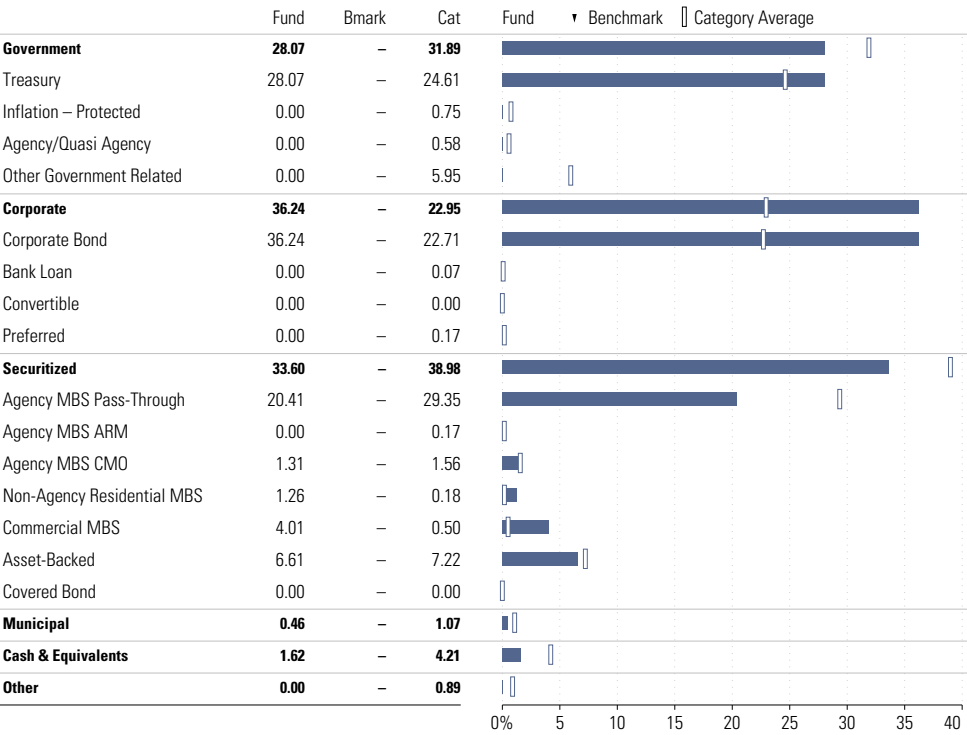

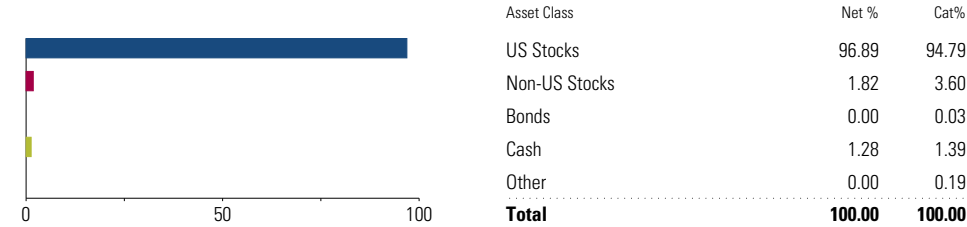

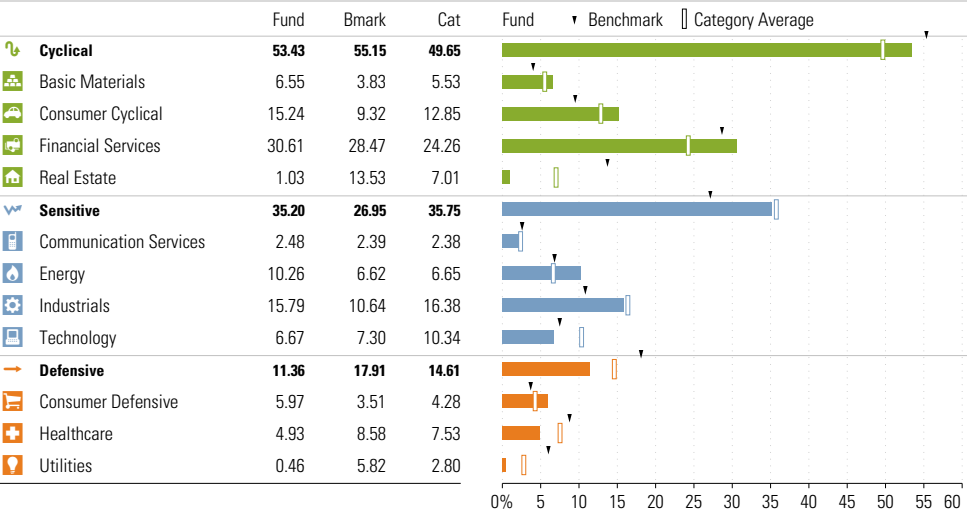
Style Breakdown
