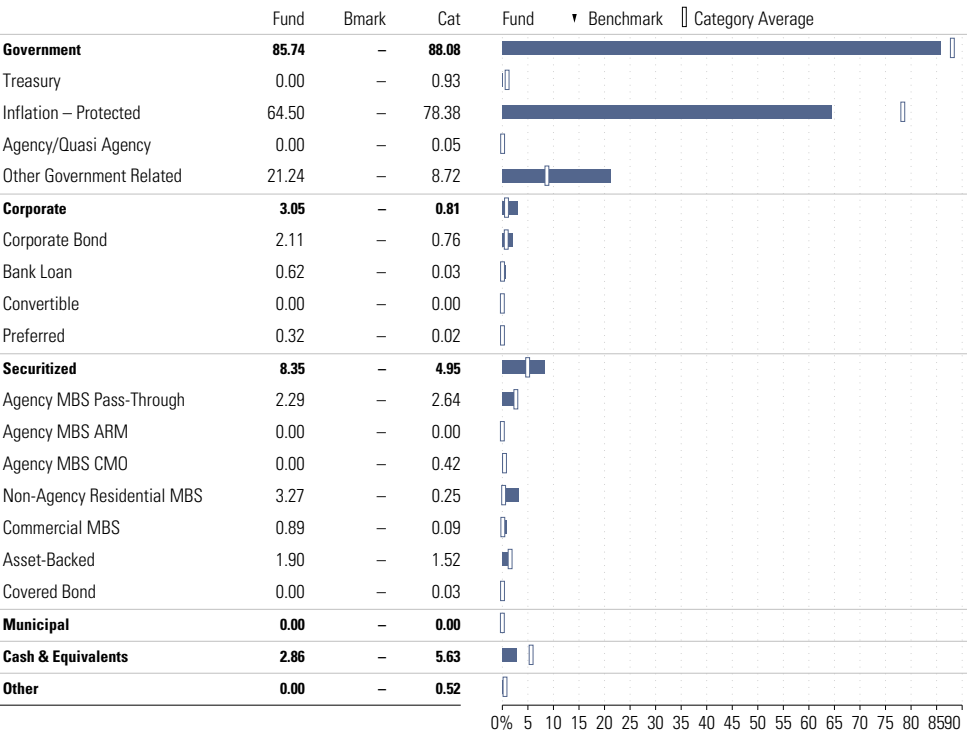

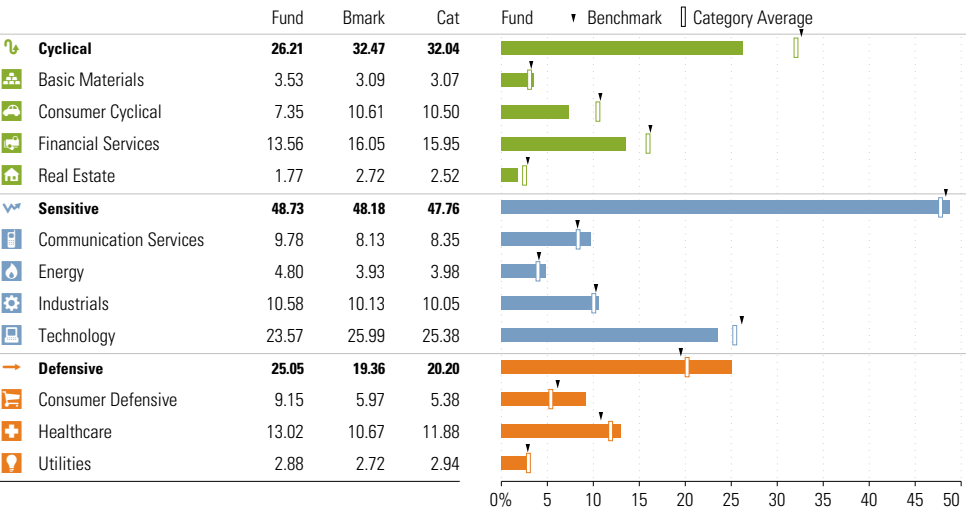

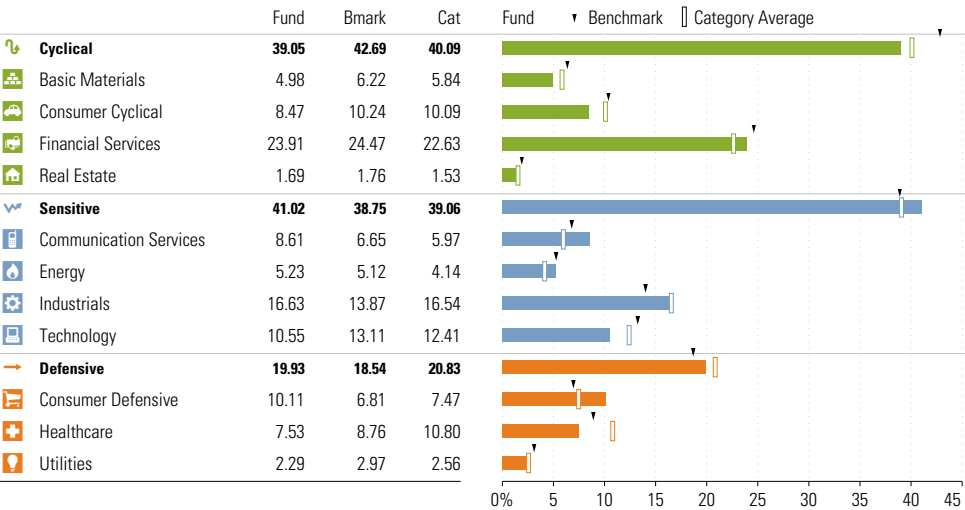

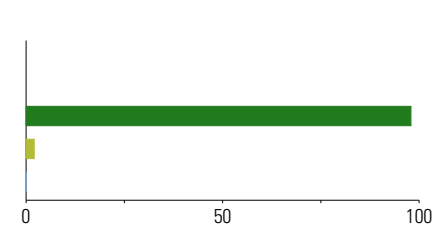

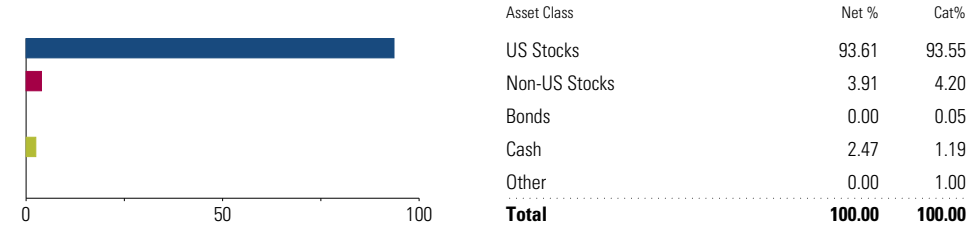

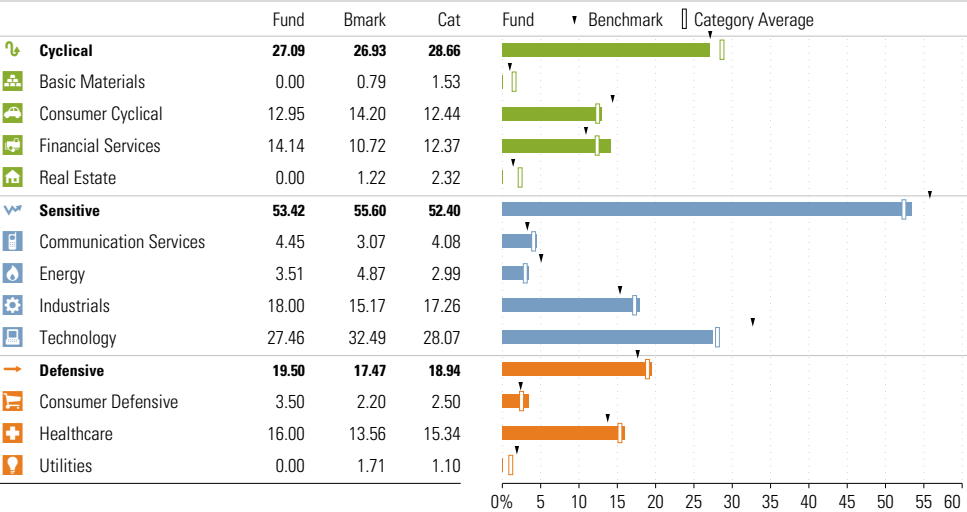

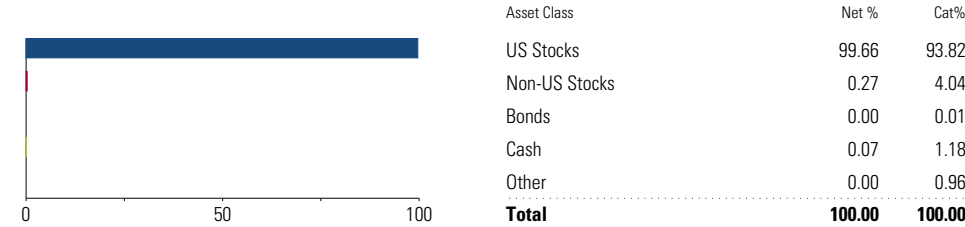

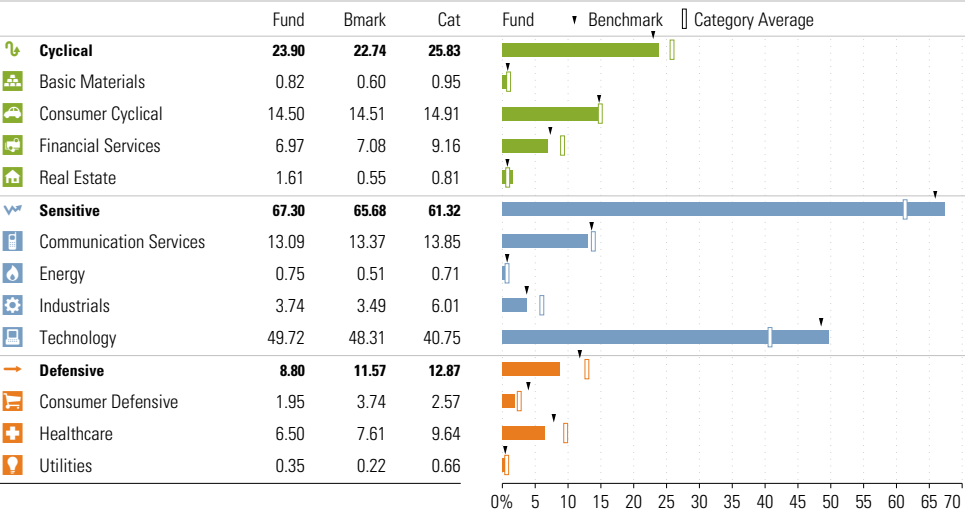

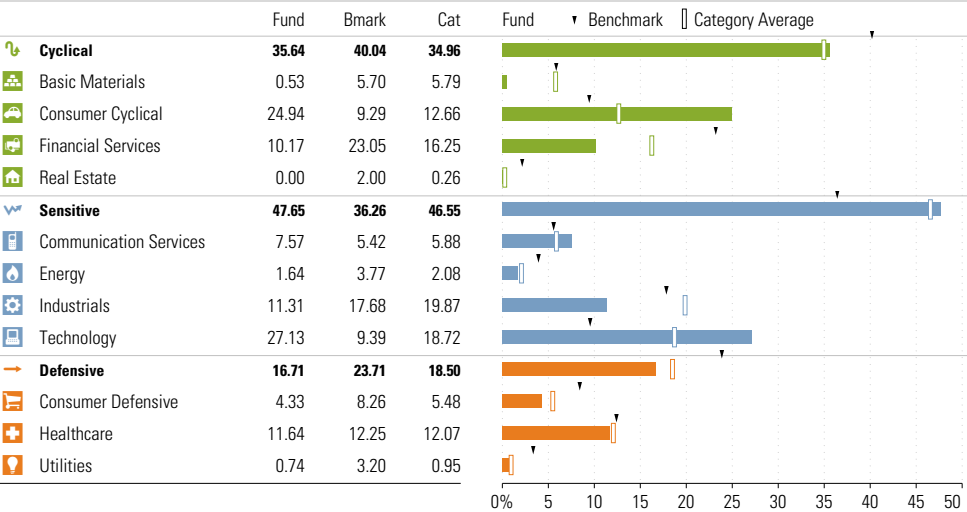

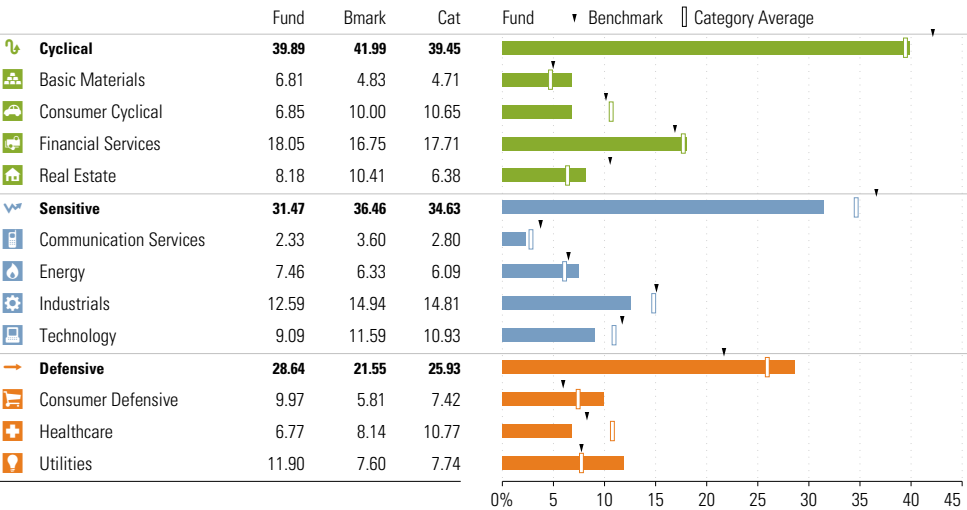

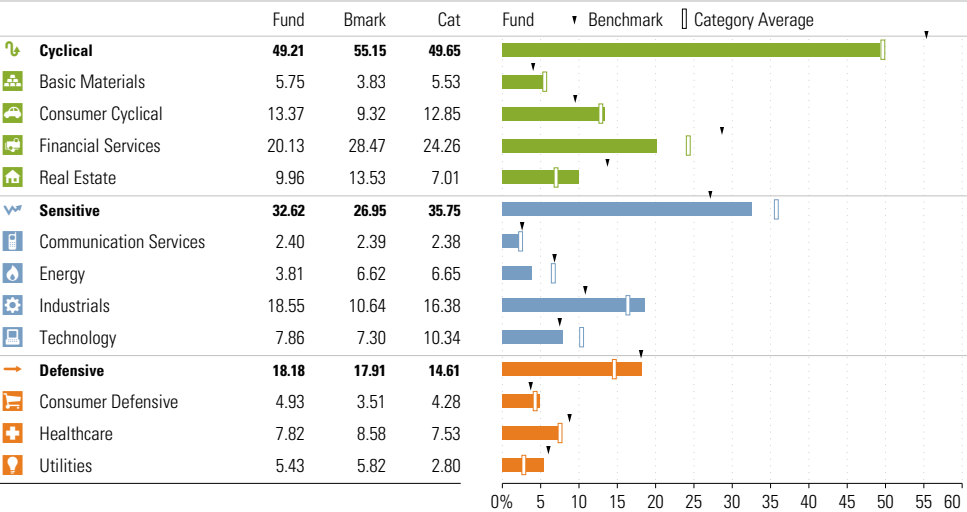
Style Breakdown
