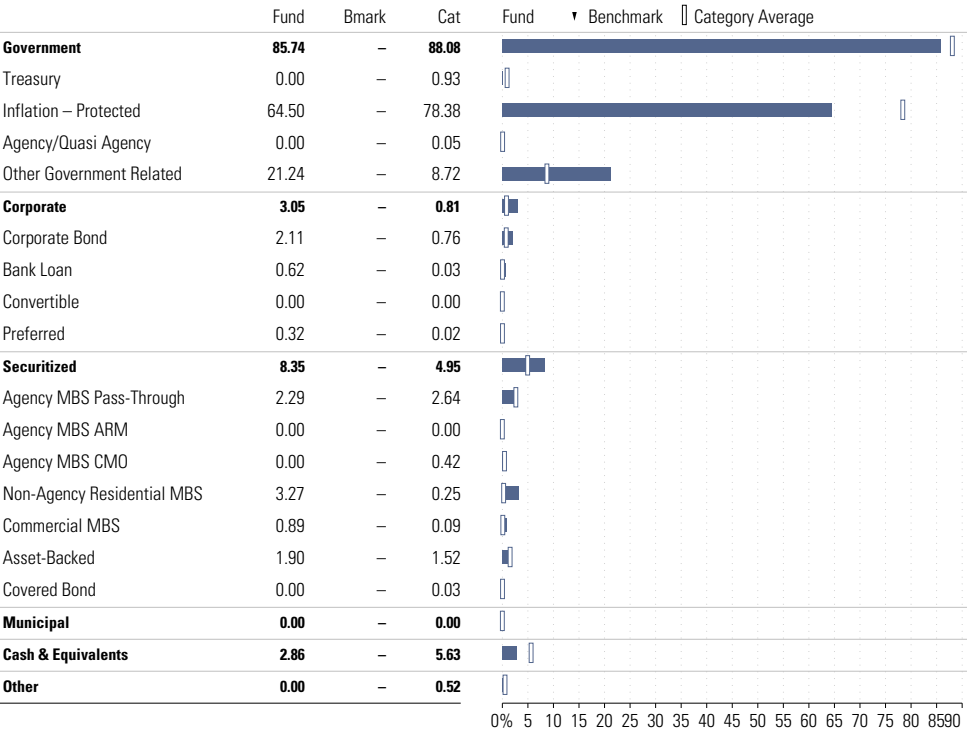

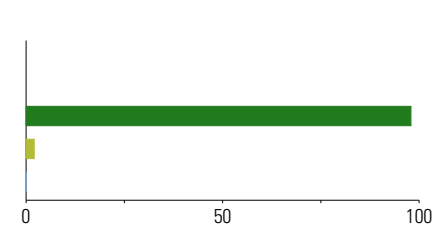

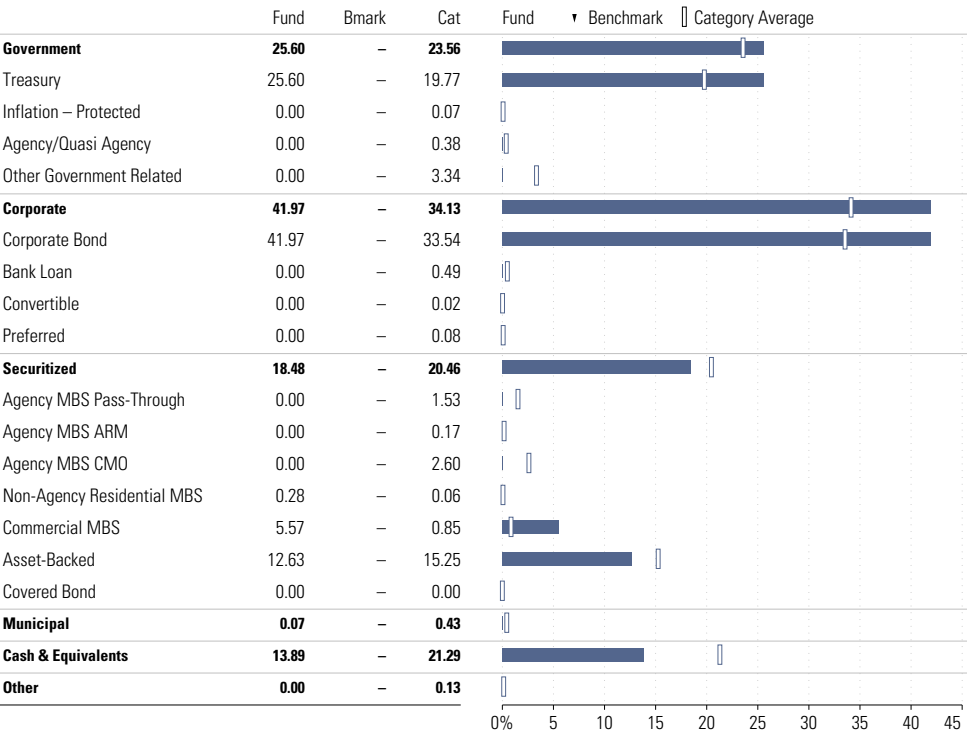

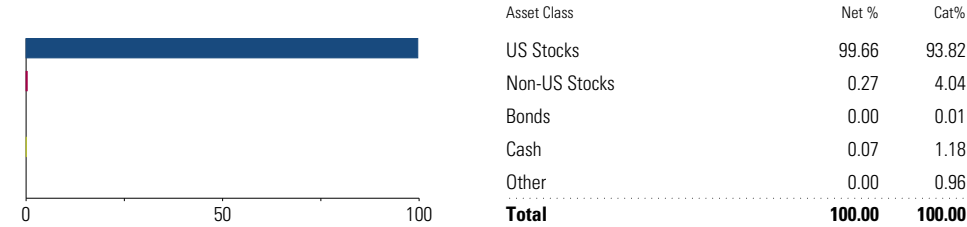

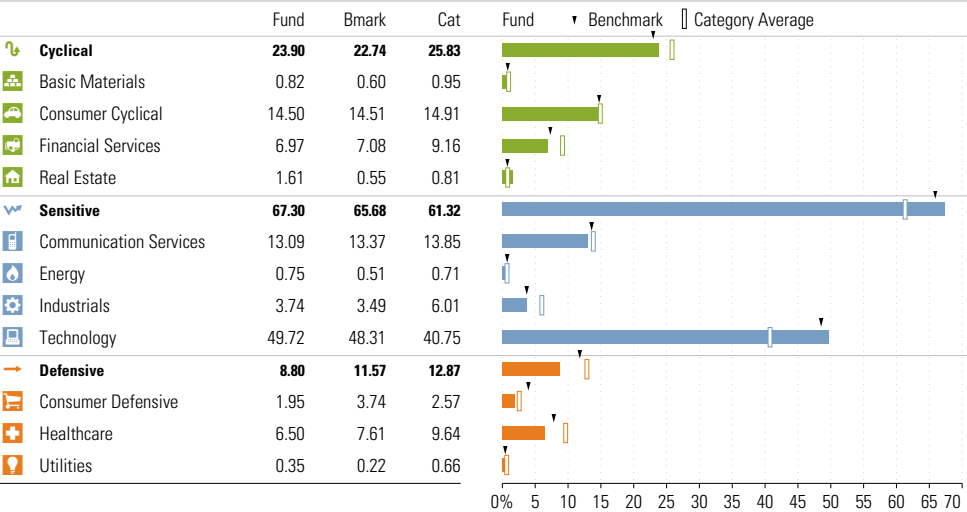

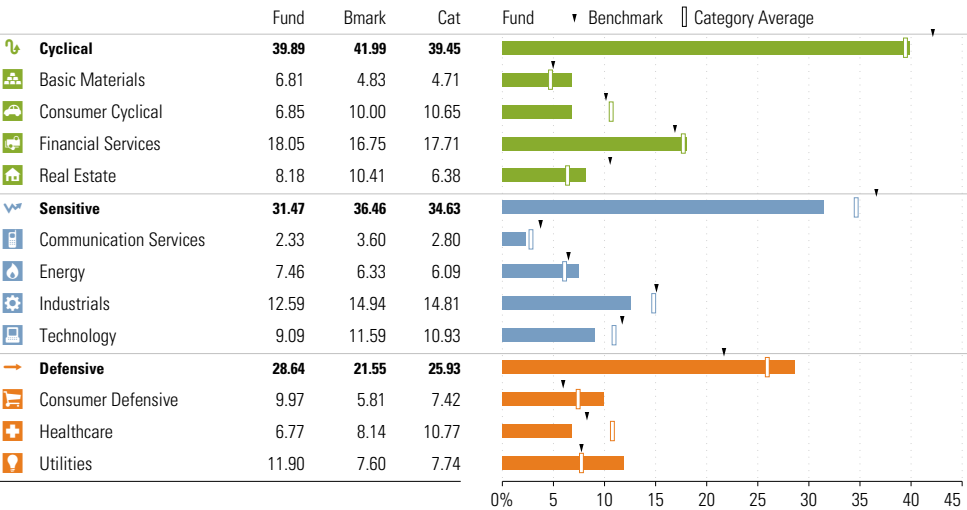

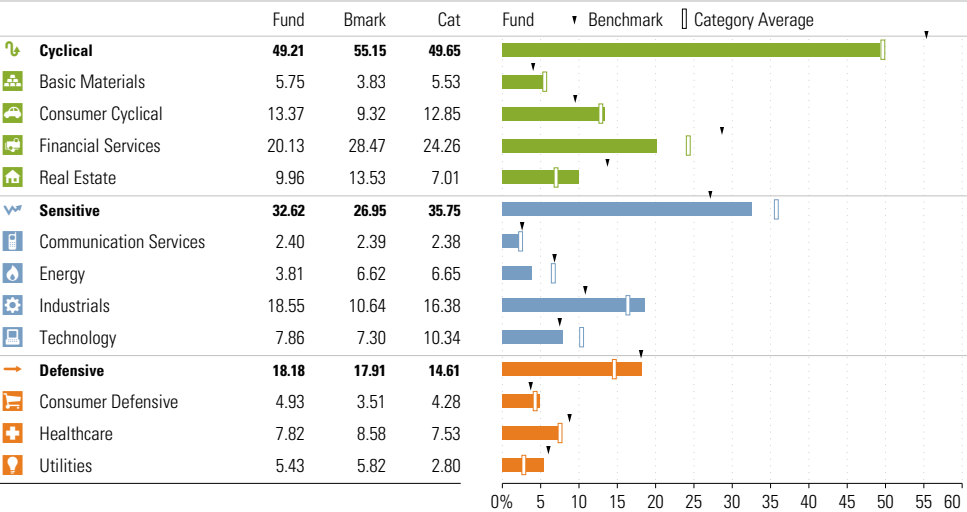
Style Breakdown
