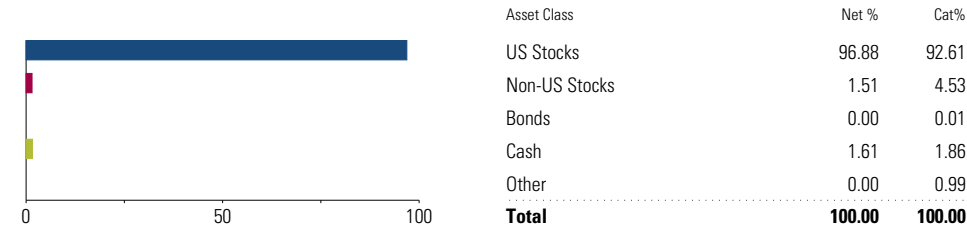

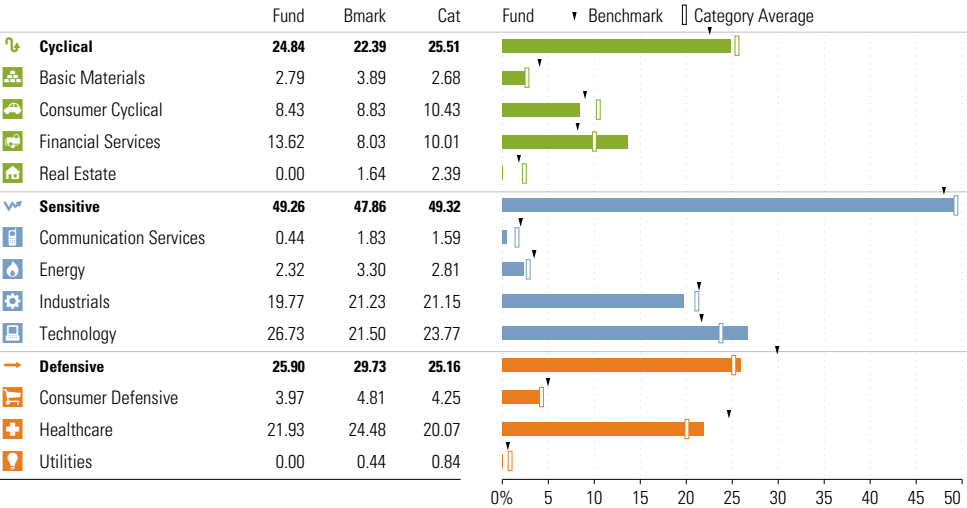

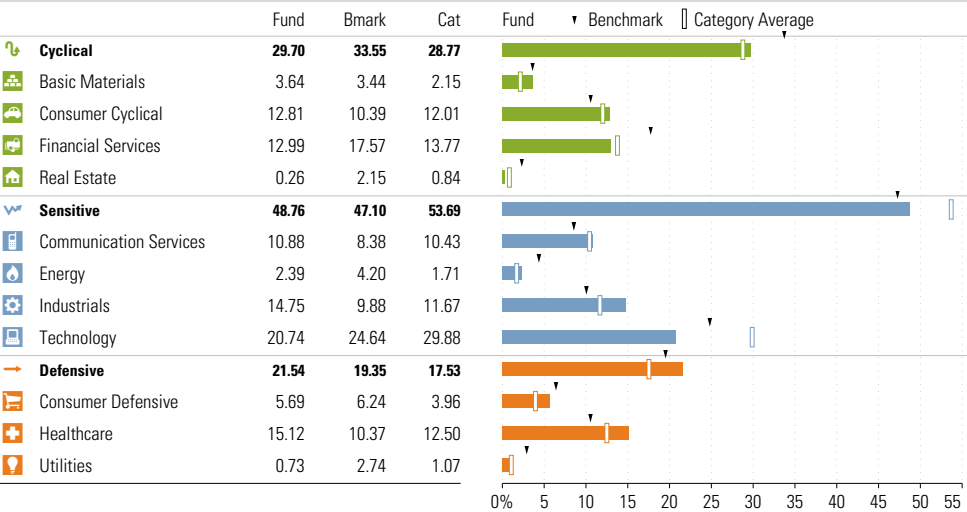

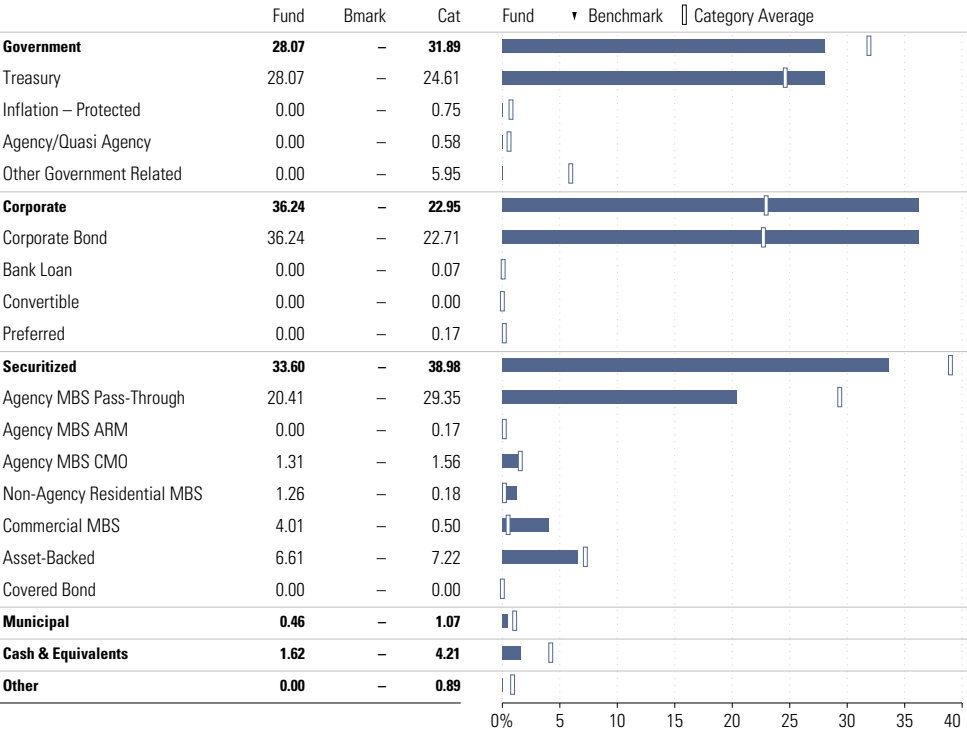

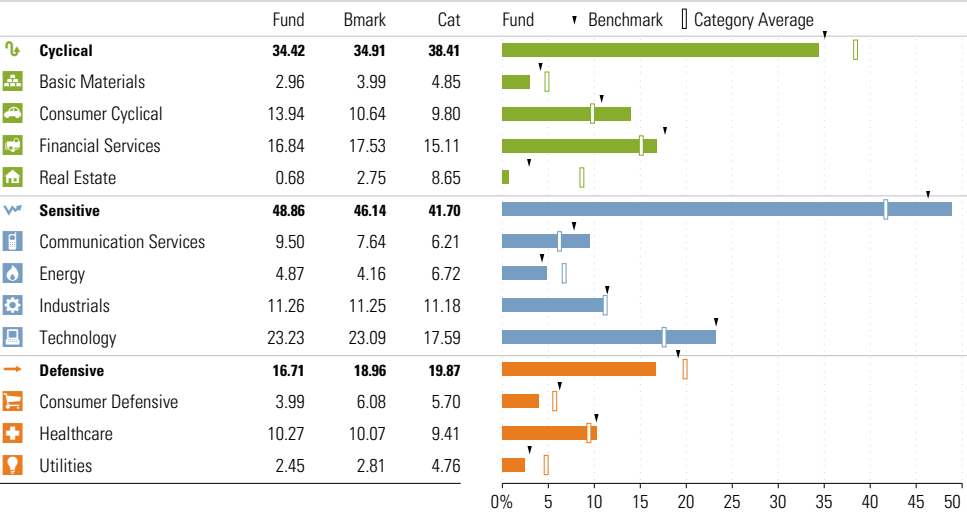

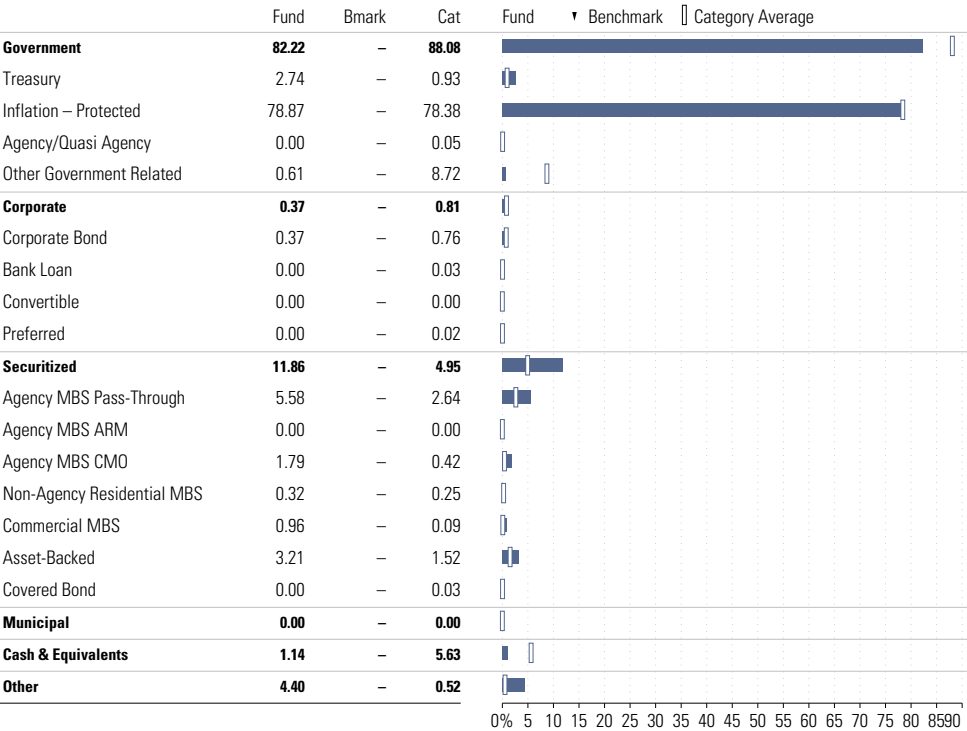

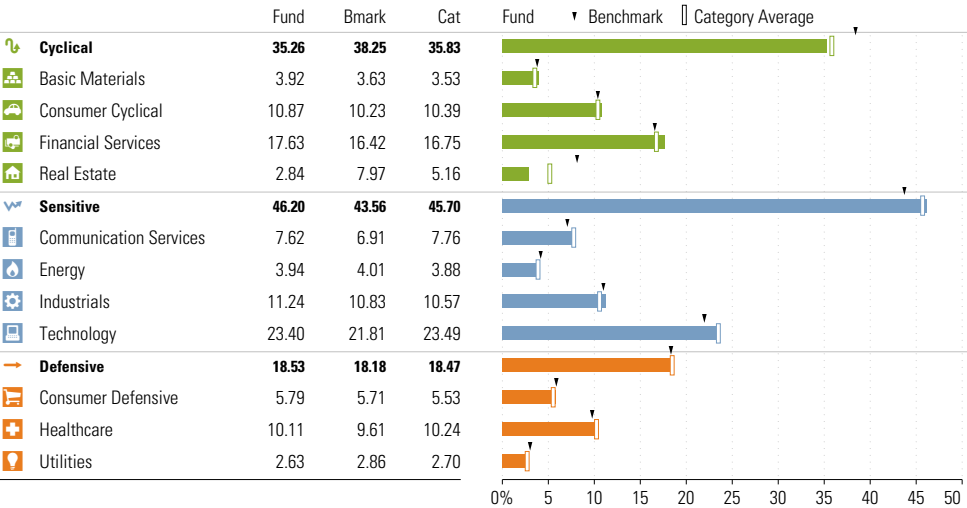
Style Breakdown

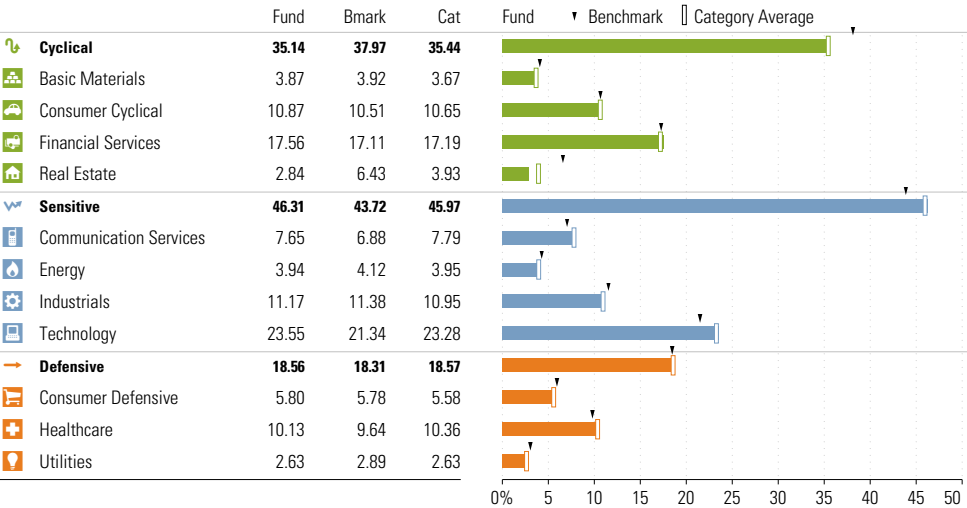
