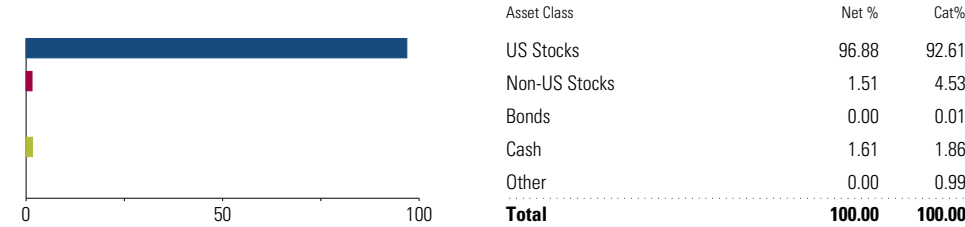

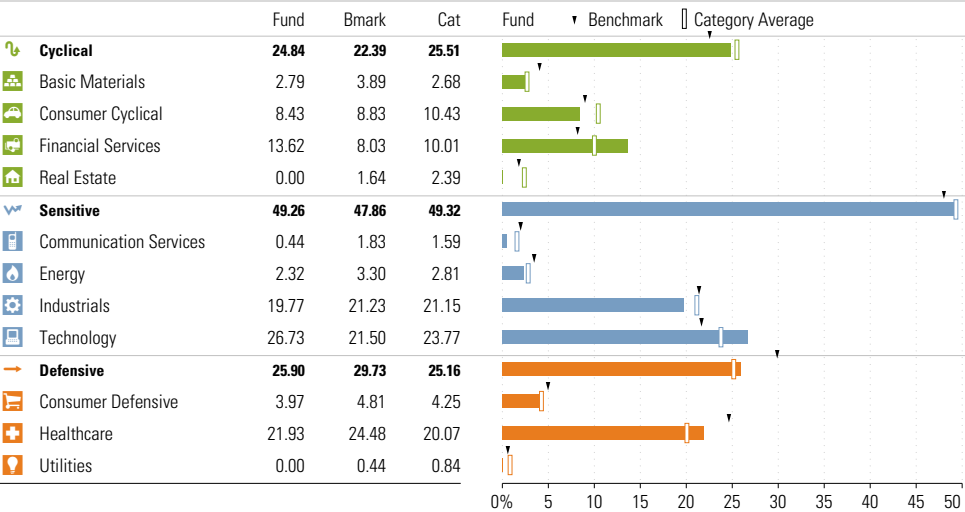

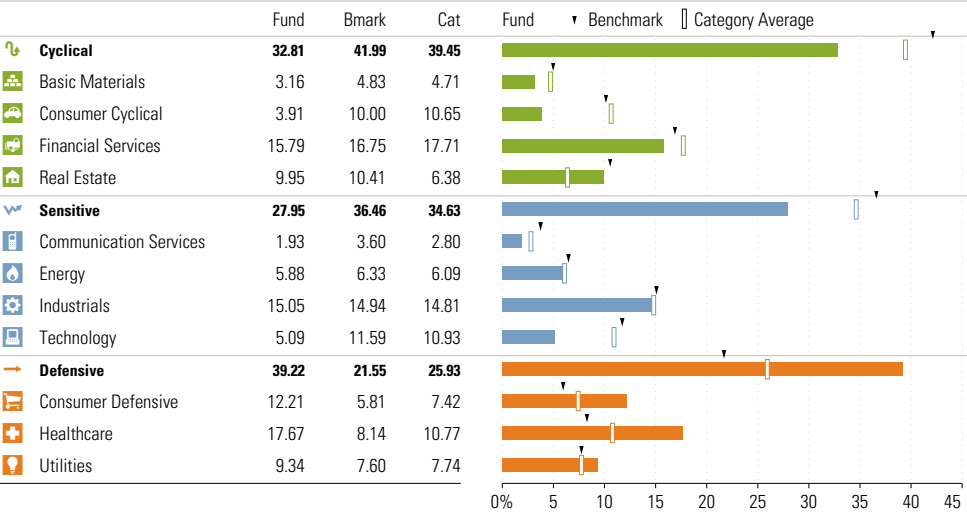

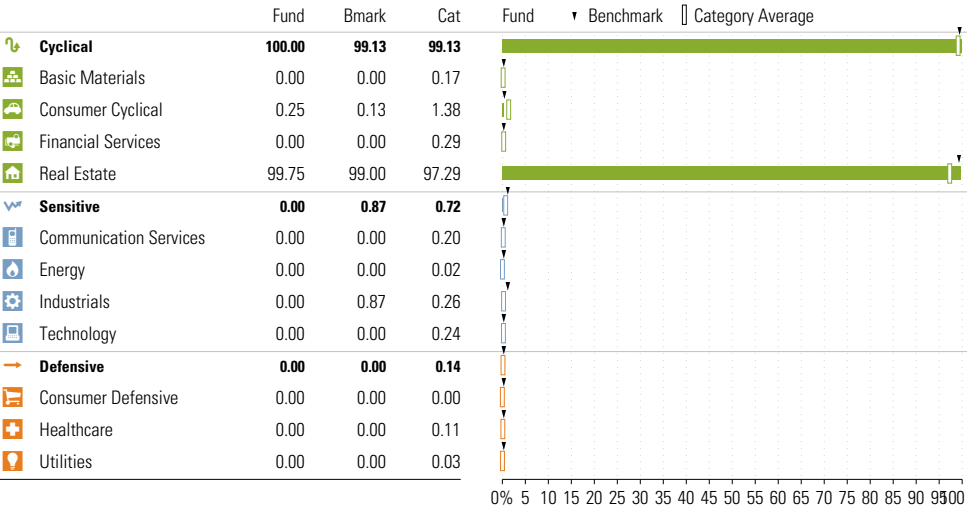

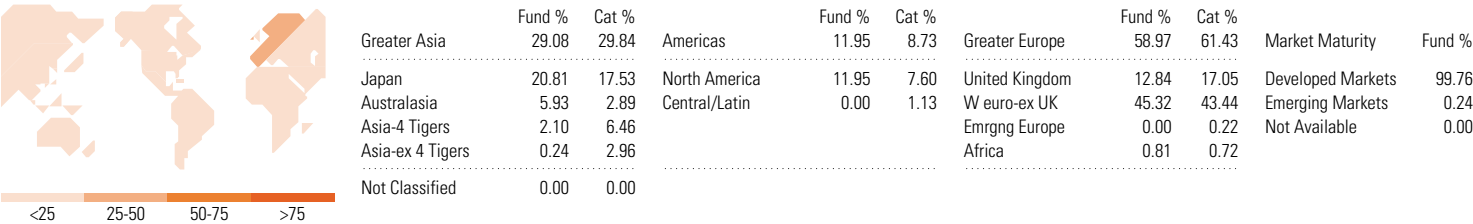

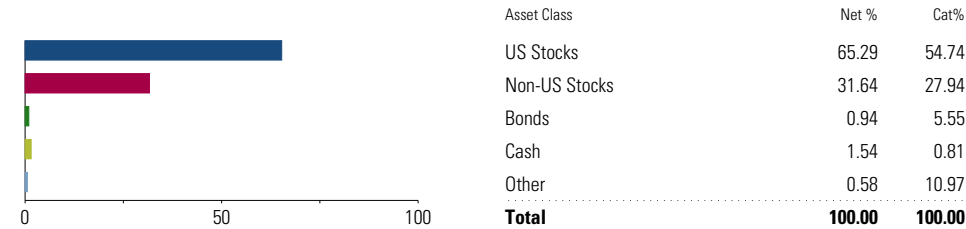

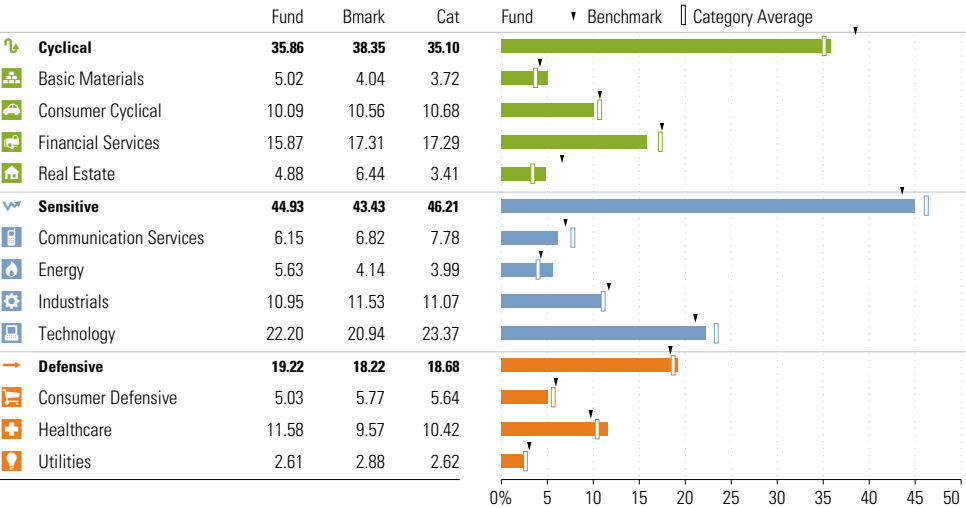
Style Breakdown

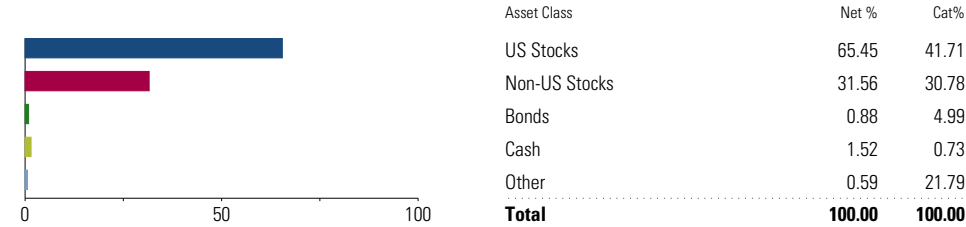

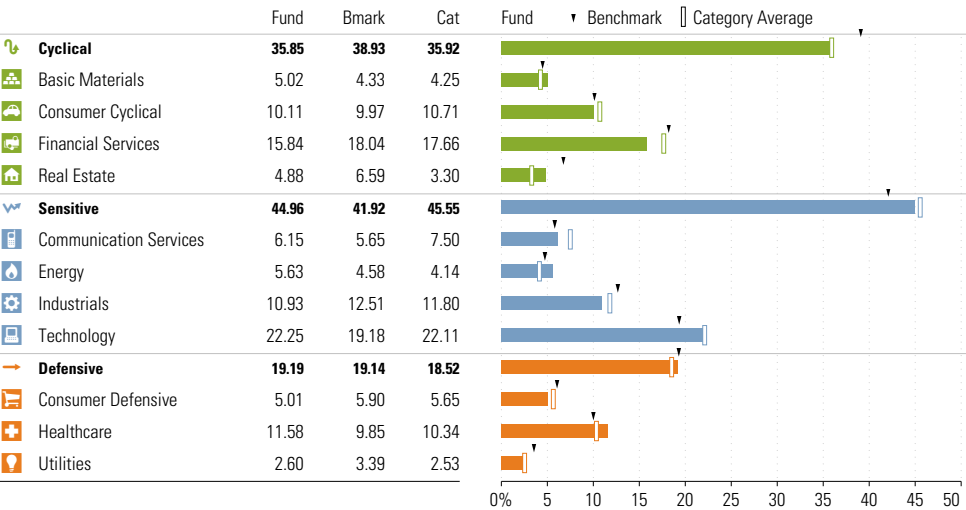
