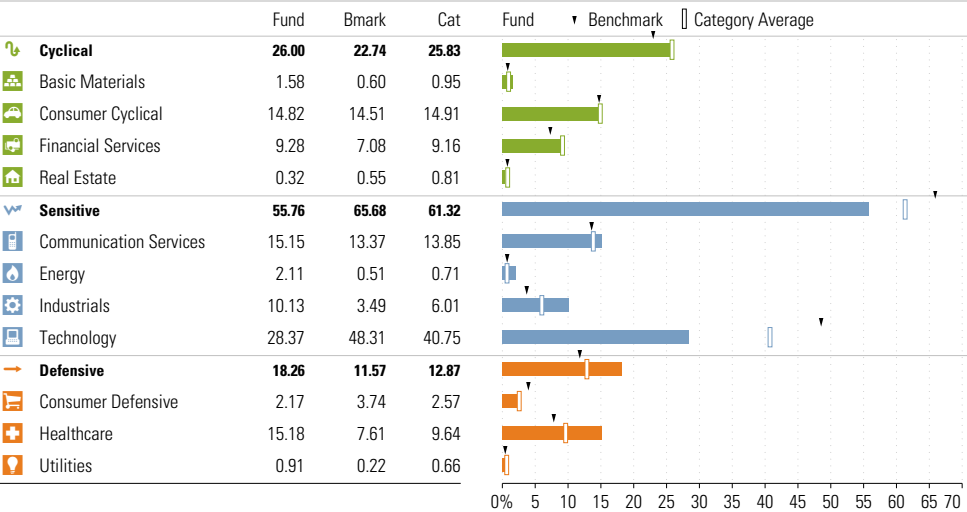

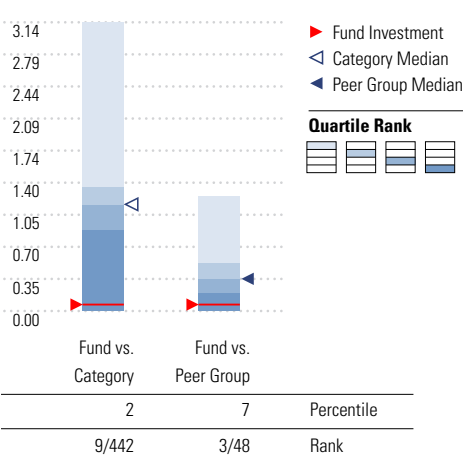

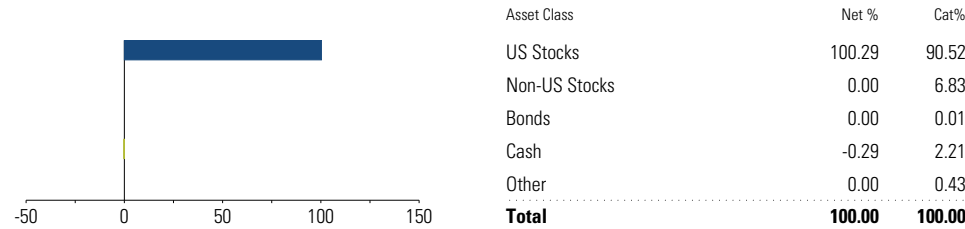

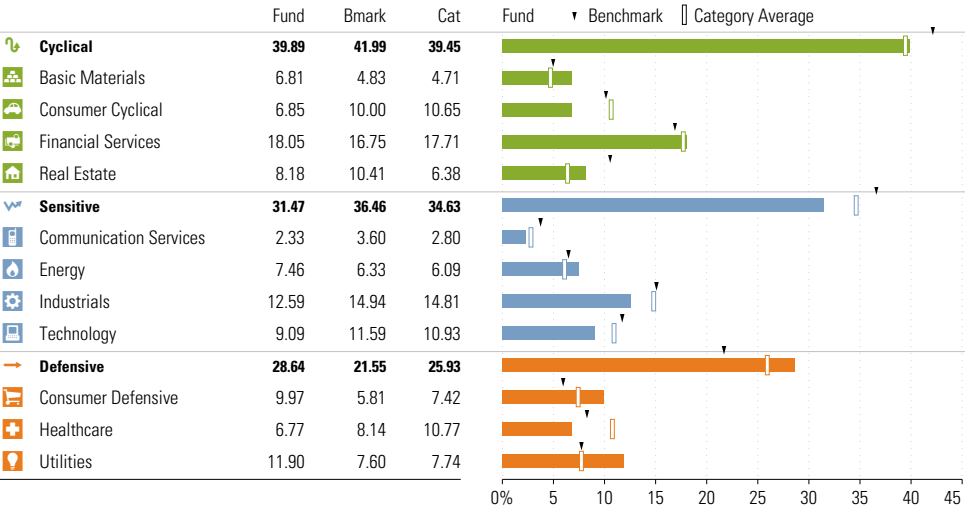
Style Breakdown

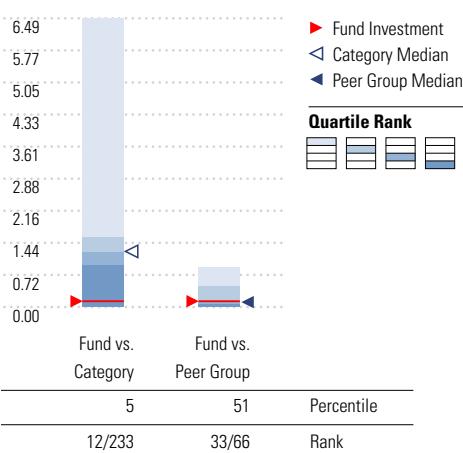

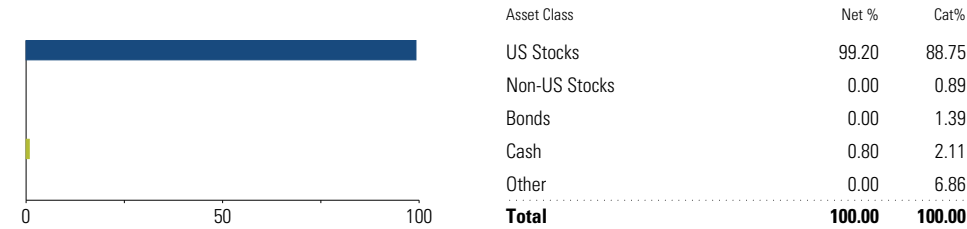

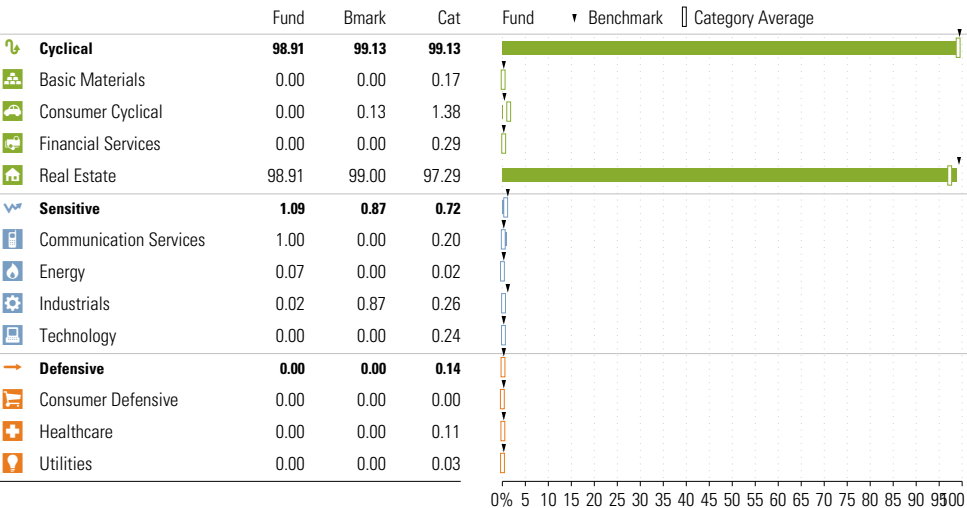
Style Breakdown

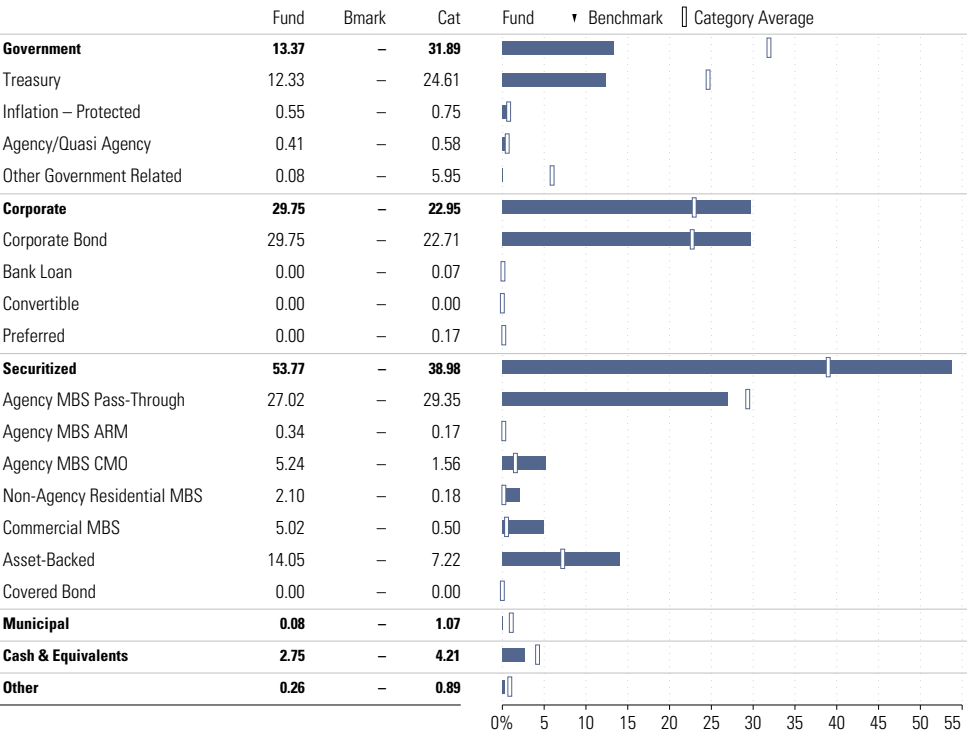
