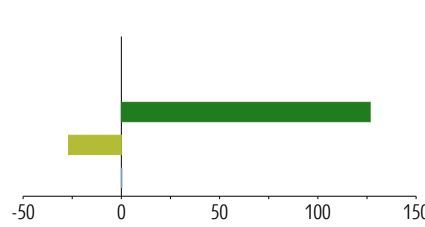

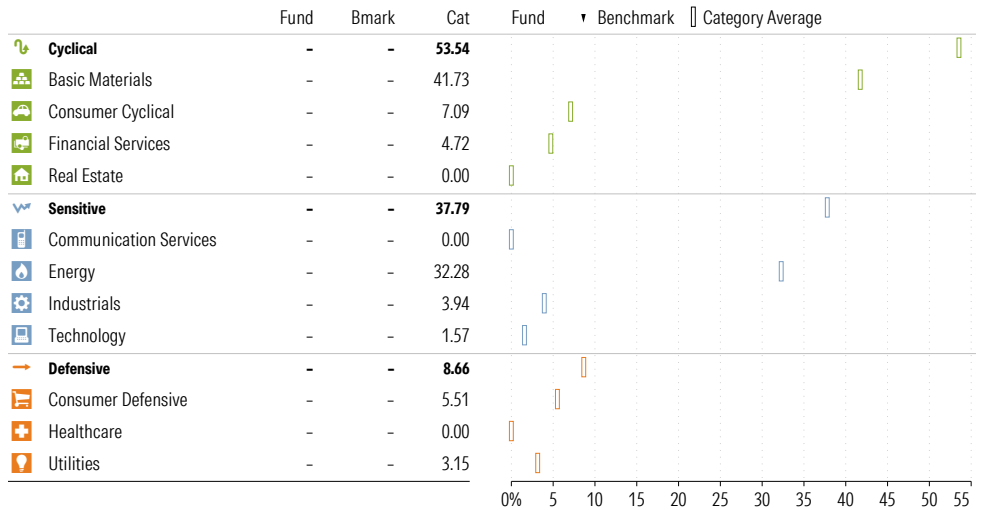

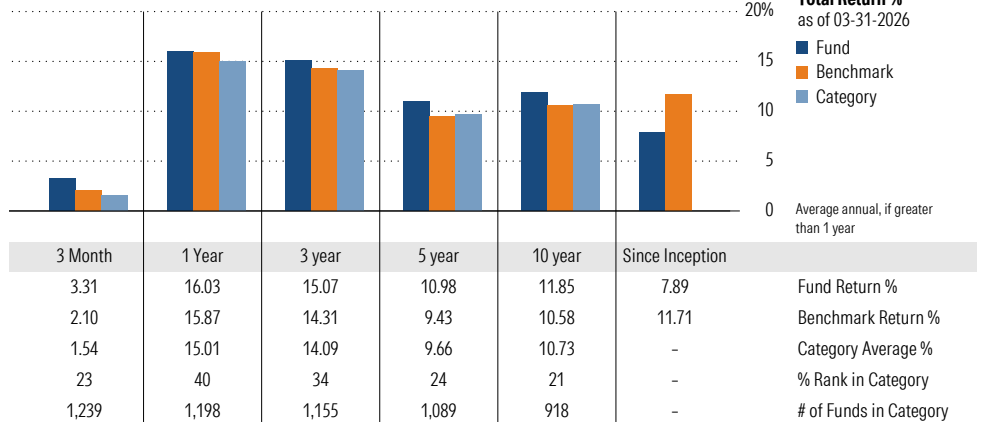

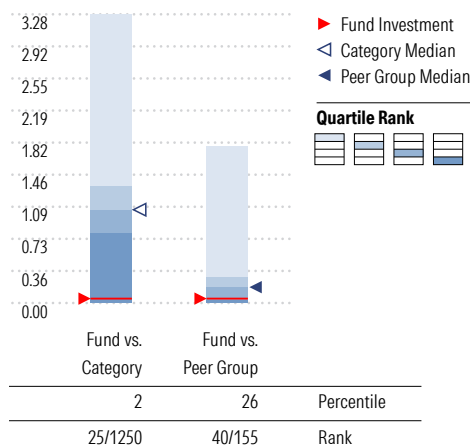
Growth of \$10,000

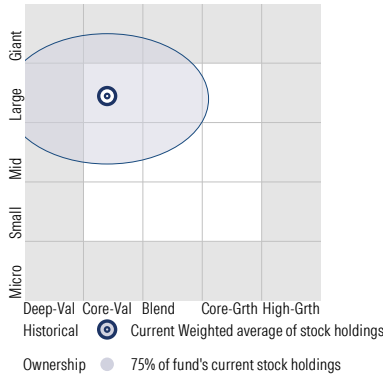

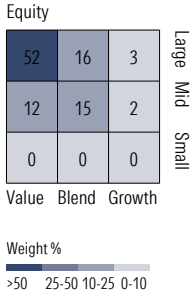

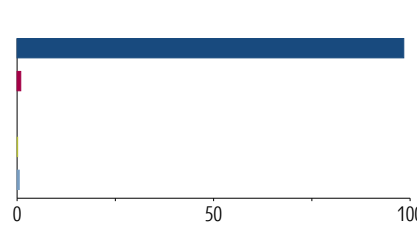

Style Breakdown

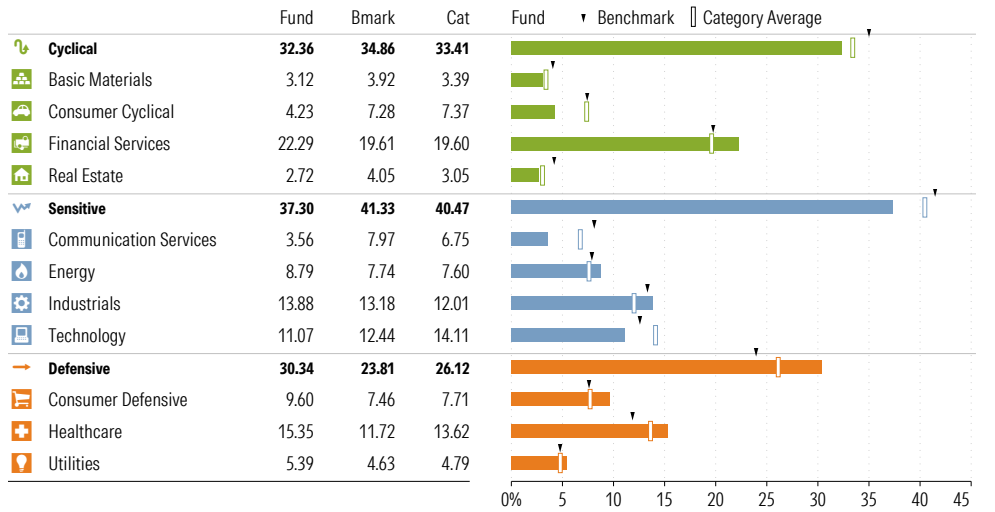


Asset Allocation as of 03-31-2026
