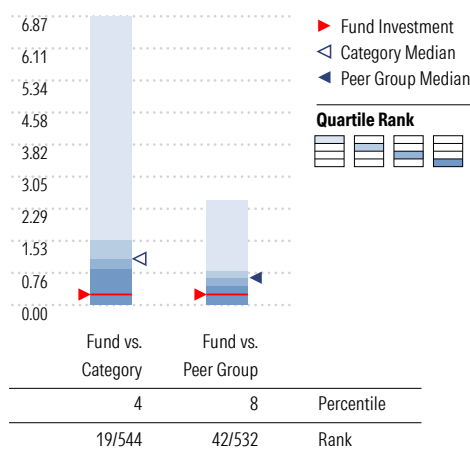

BlackRock plans to bring in Cem Inal from AB as his replacement; while Inal delivered competitive results on AB Large Cap Value, his mixed record across other mandates and the decision to hire externally introduce some uncertainty. 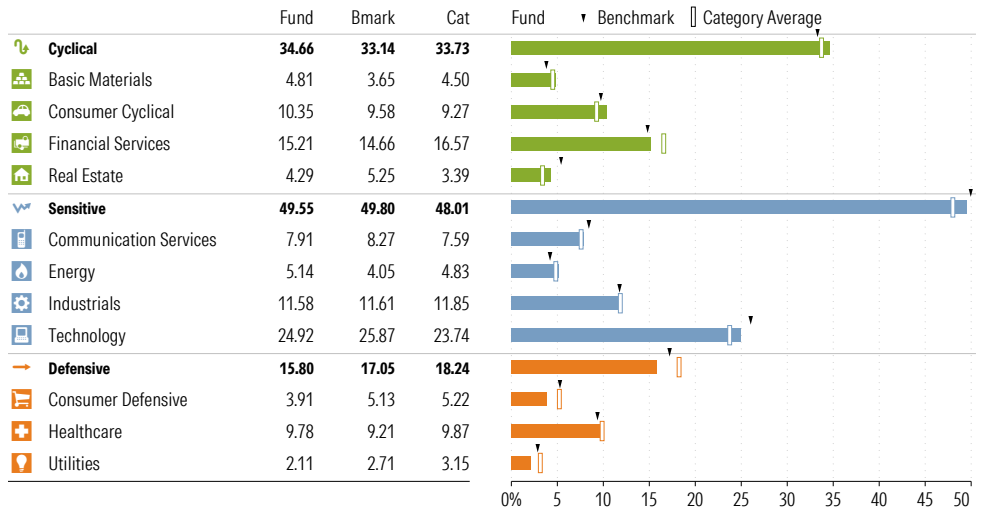

While the strategy's conservative approach has historically provided strong downside protection, such as top-decile performance in 2022's market pullback, it continues to lag in growth-driven markets and has underperformed even relative to other dividend-growth mandates. Growth of \$10,000



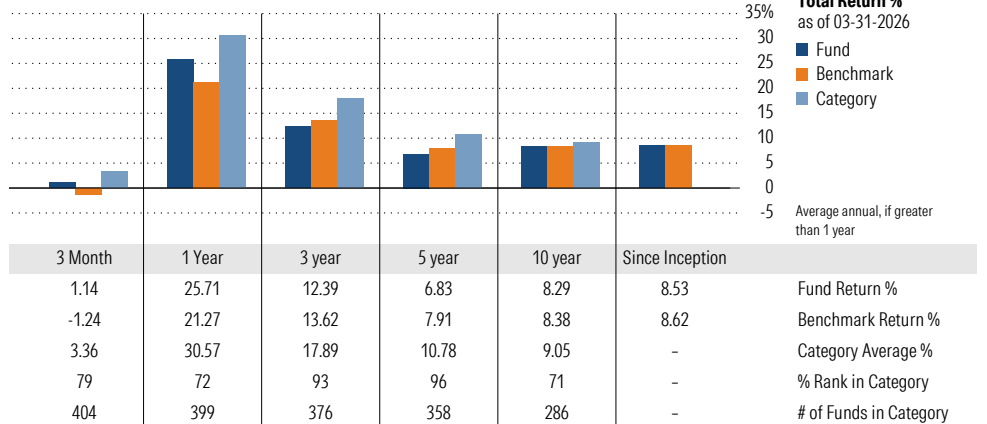

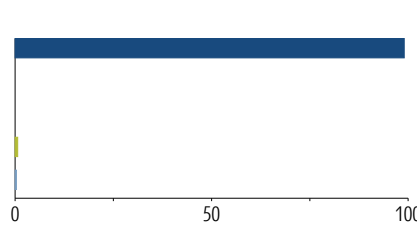
