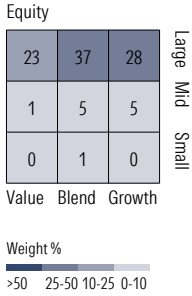

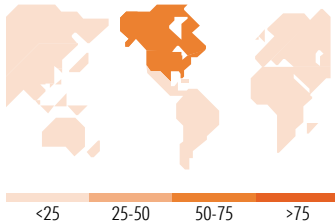

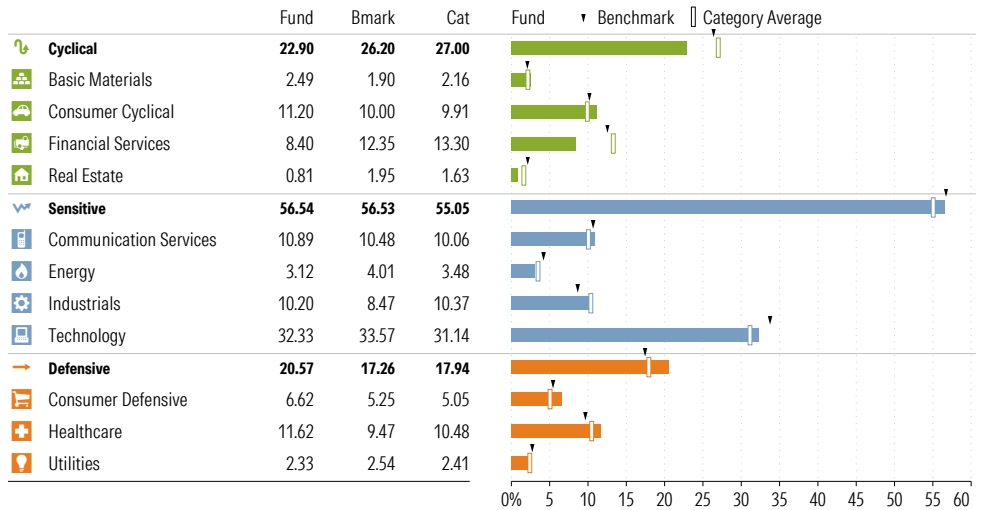
Asset Allocation as of 03-31-2026

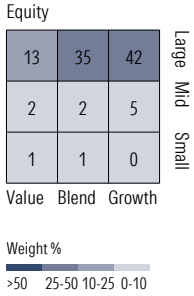

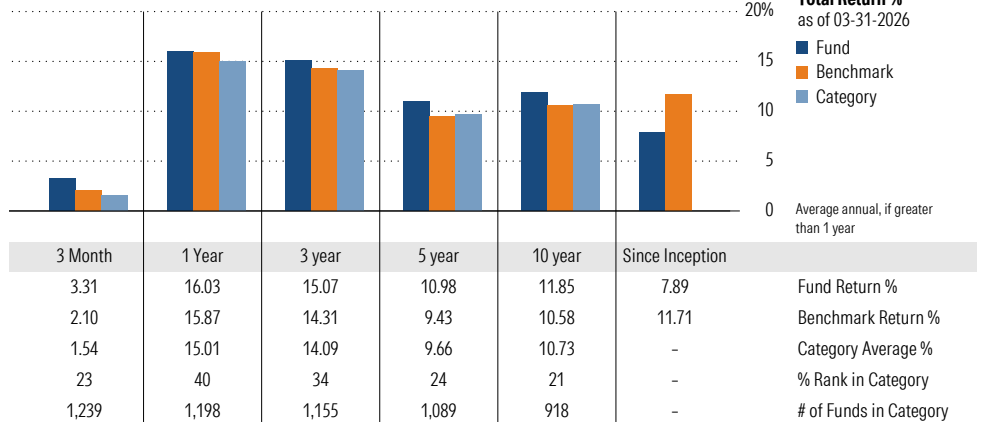

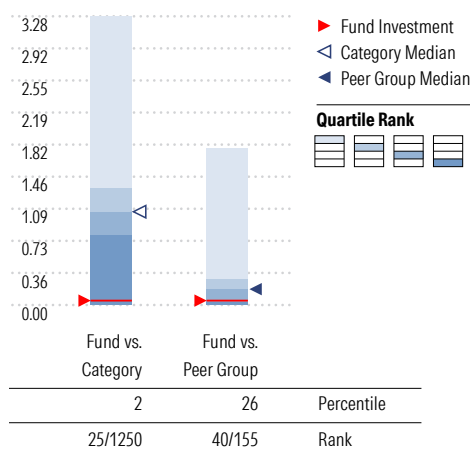

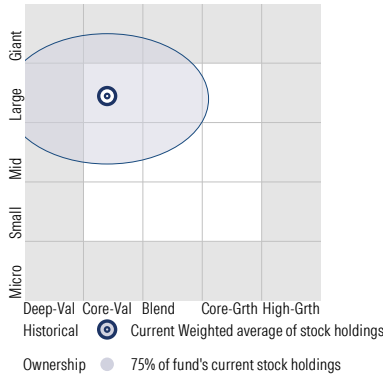

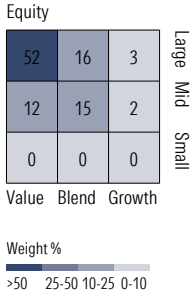

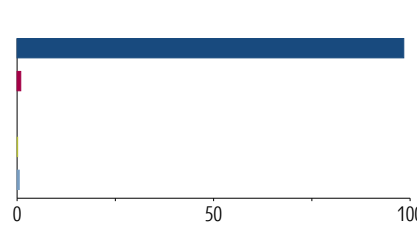

Style Breakdown

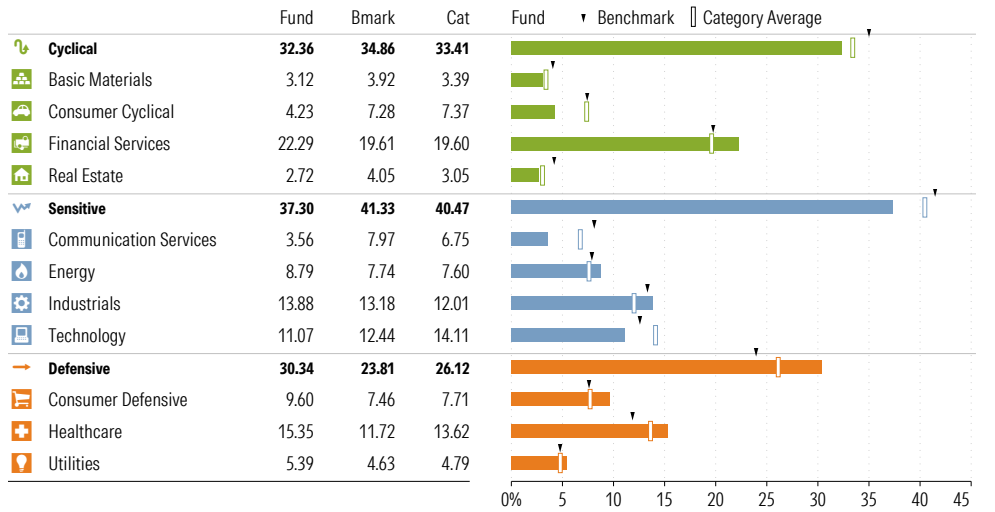


Asset Allocation as of 03-31-2026
