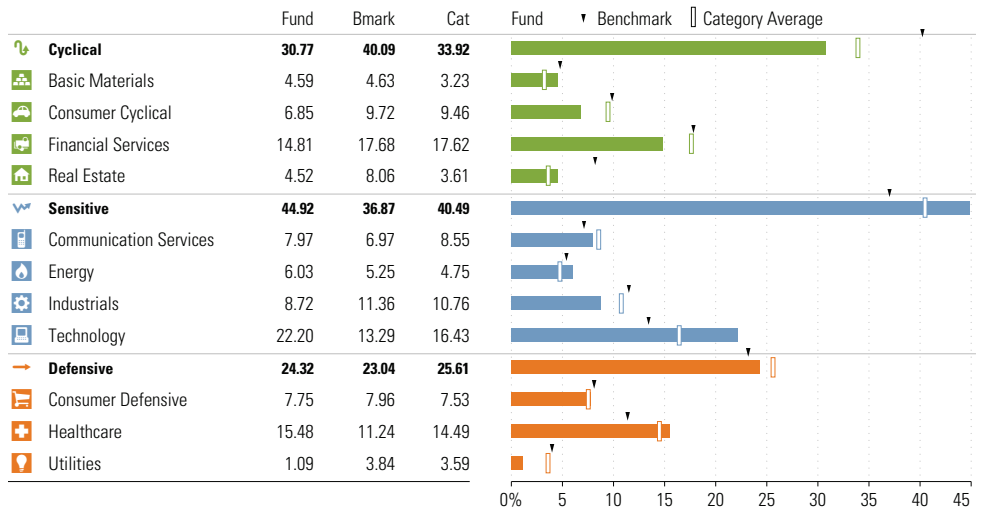

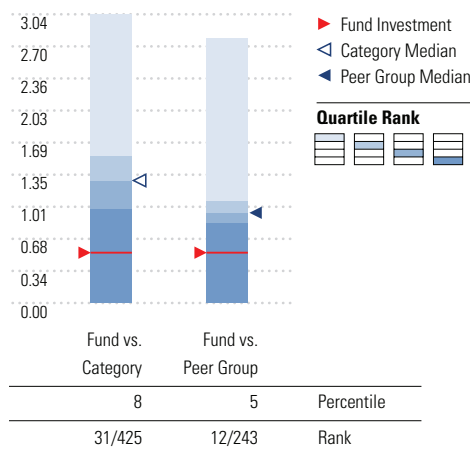

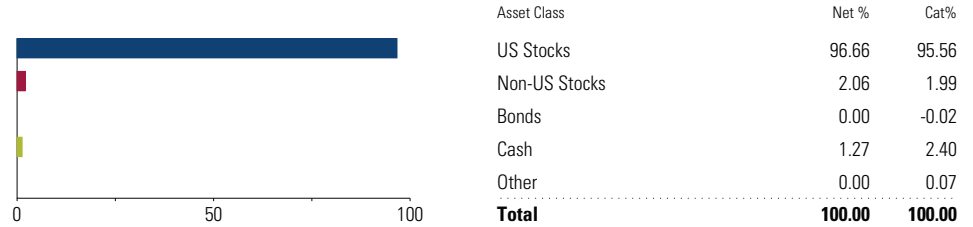

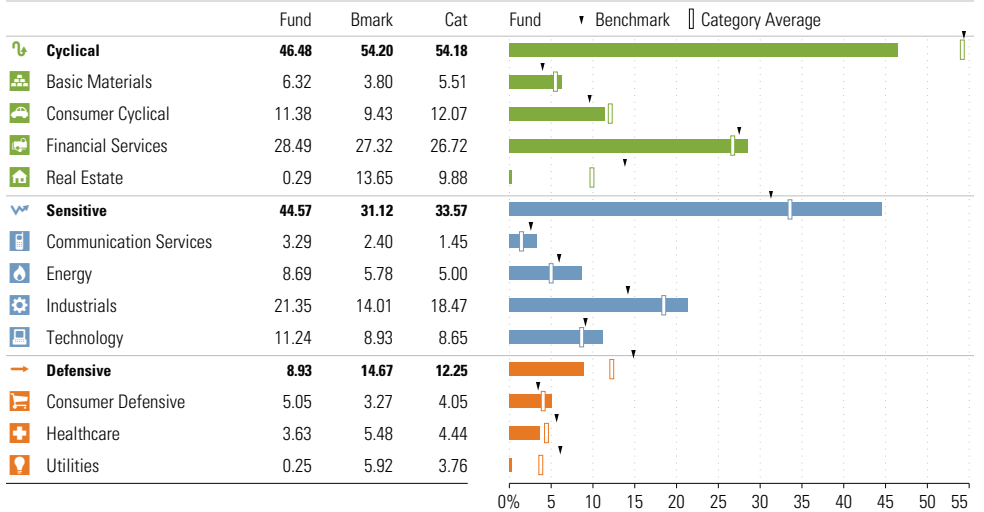

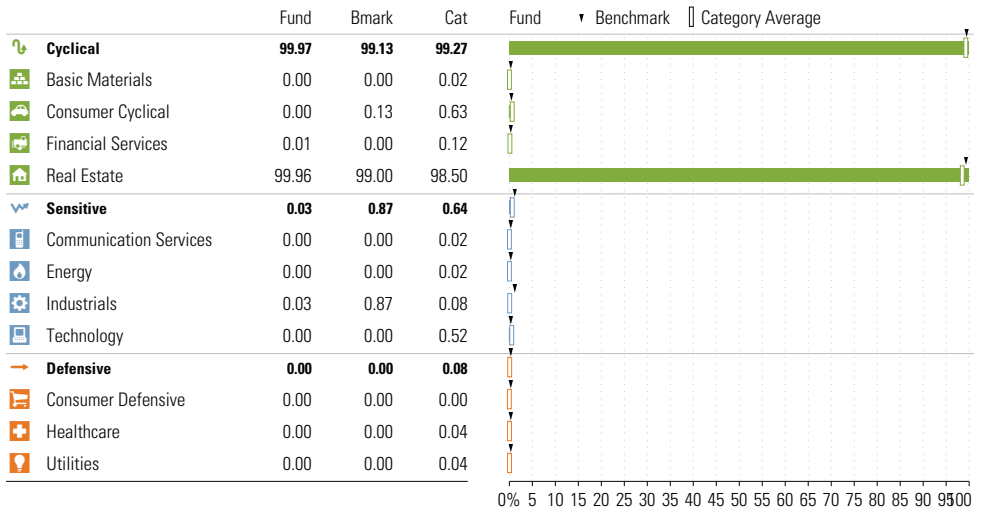
Asset Allocation as of 12-31-2019

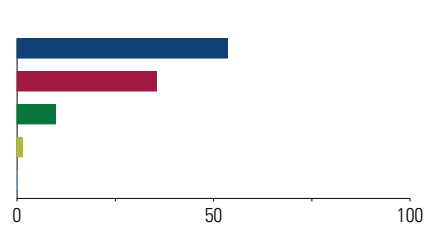

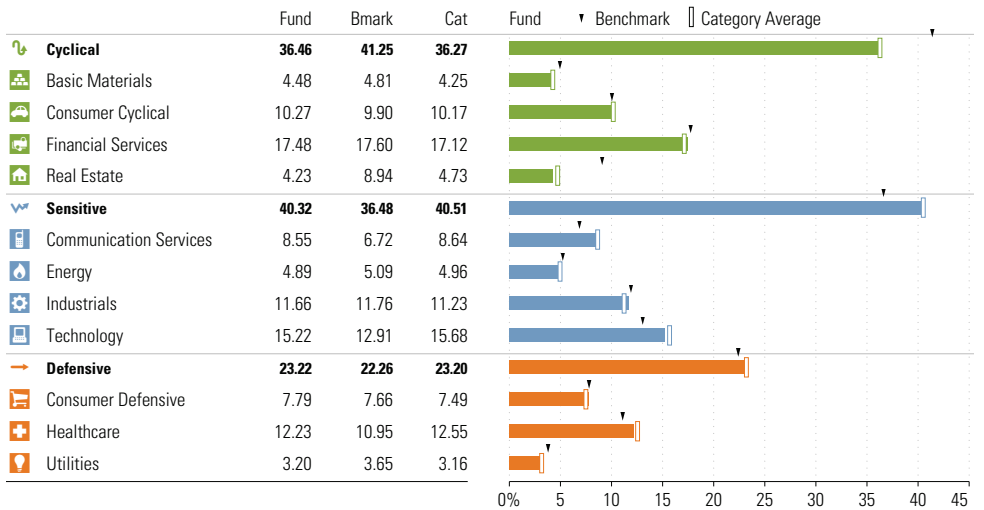

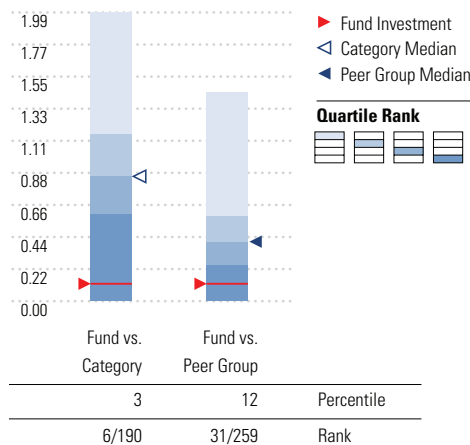
Growth of \$10,000

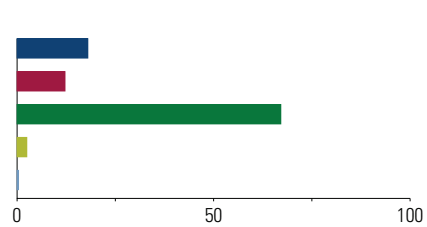

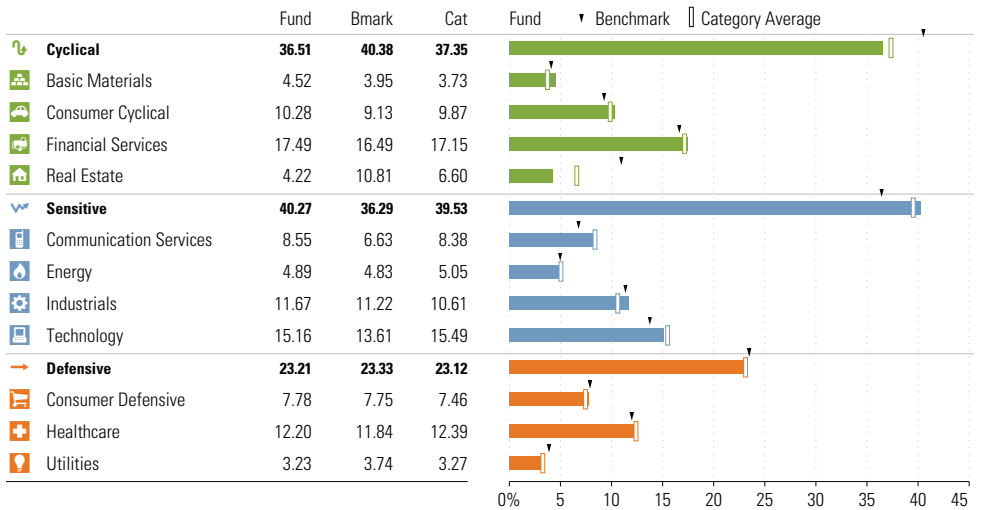

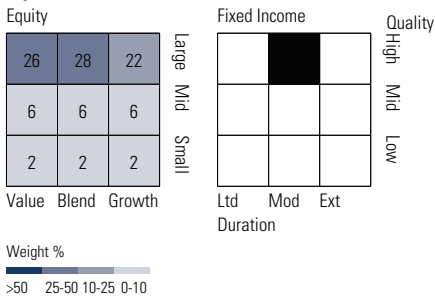
