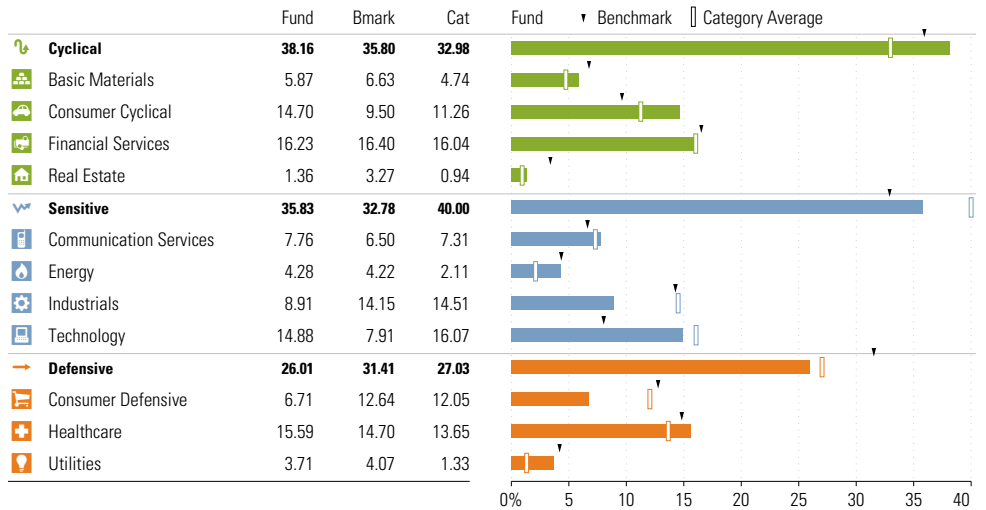

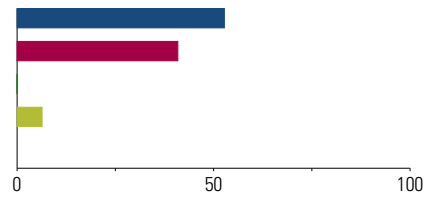

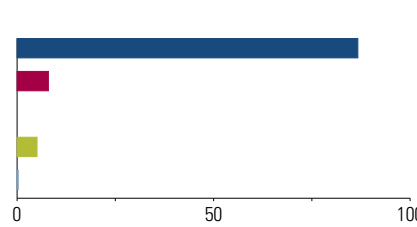

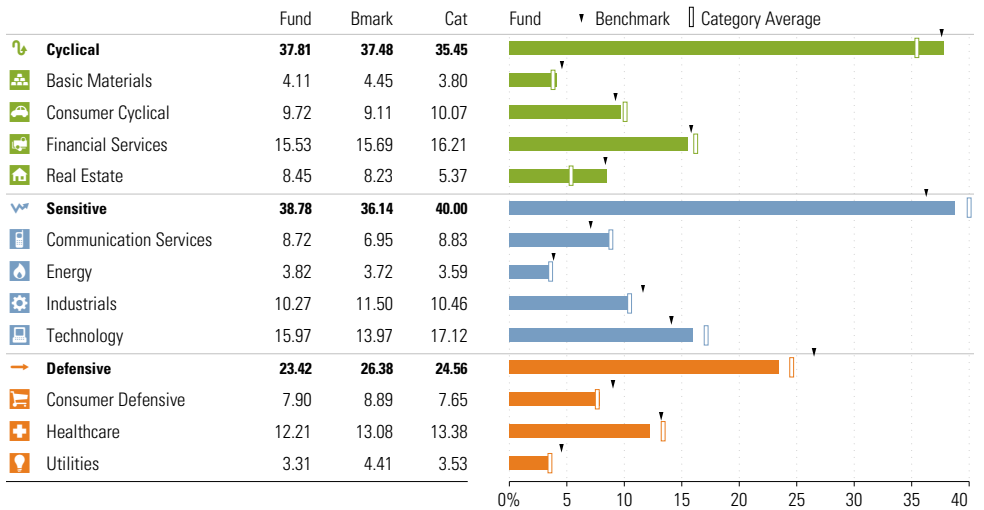


Asset Allocation as of 12-31-2020

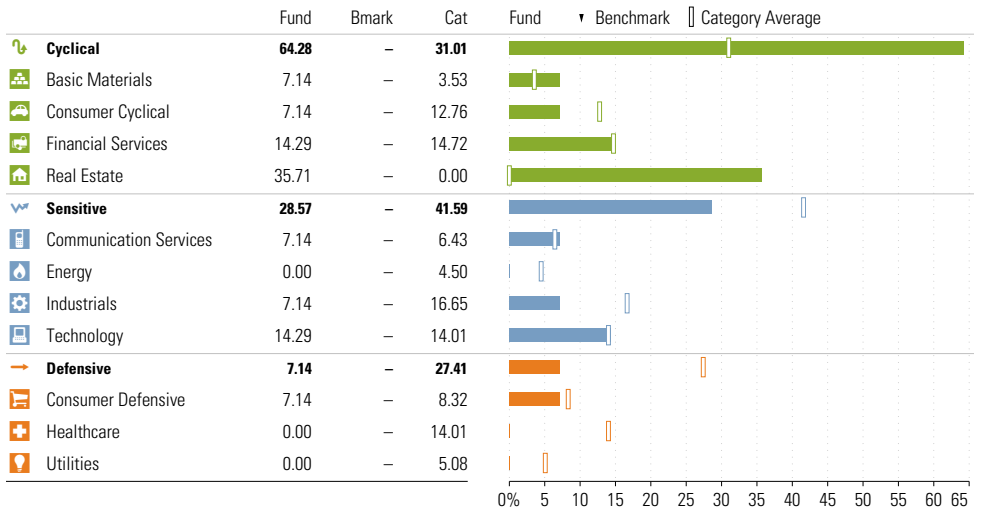


Asset Allocation as of 12-31-2020

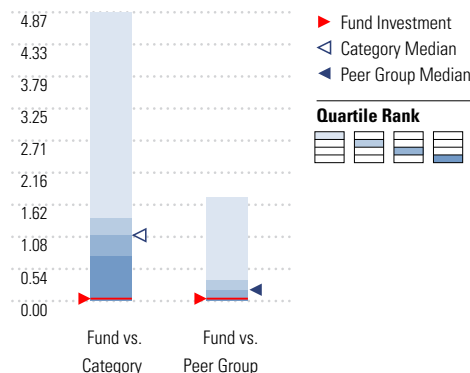

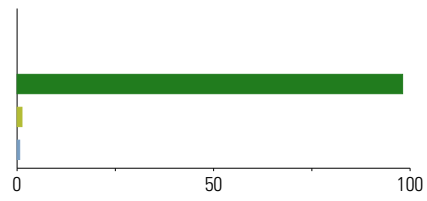

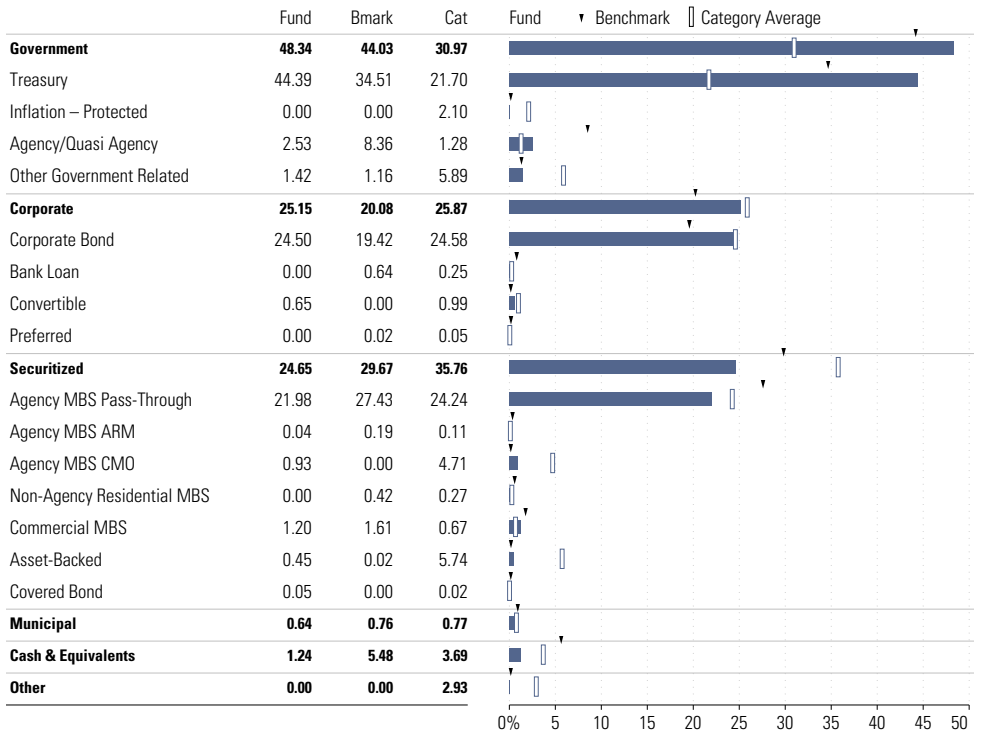

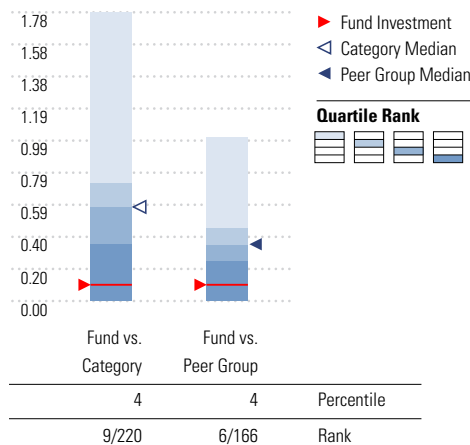
Growth of \$10,000

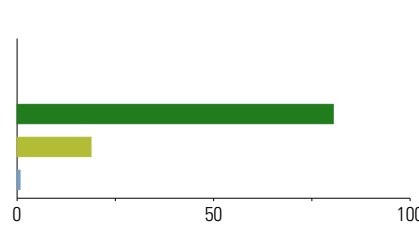

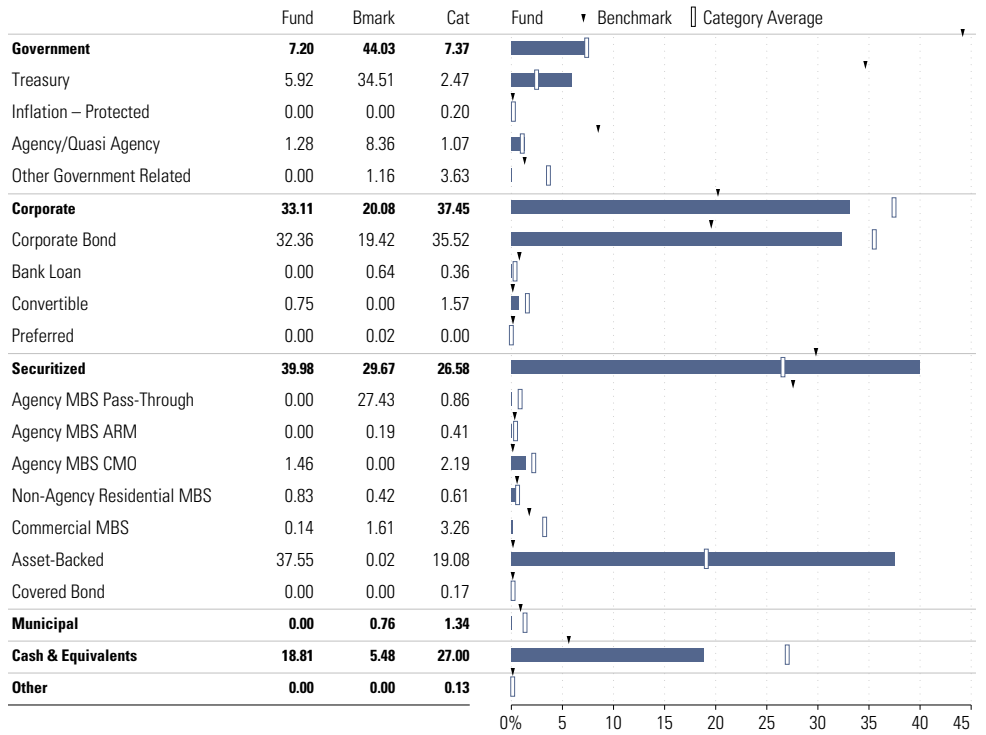
