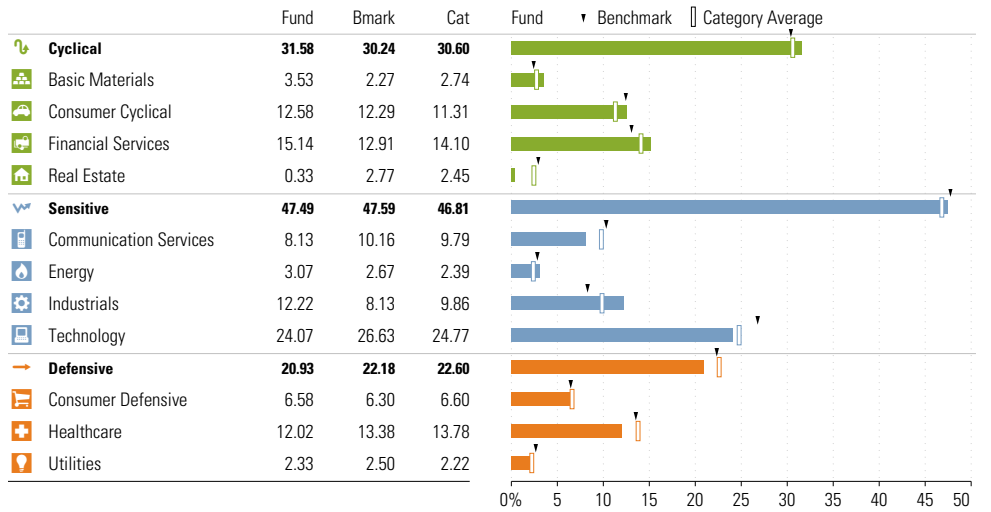

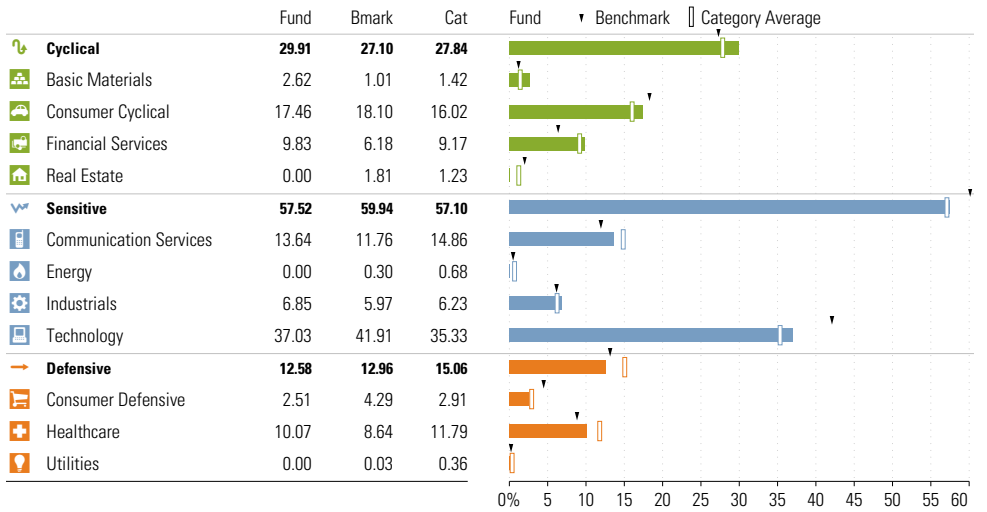

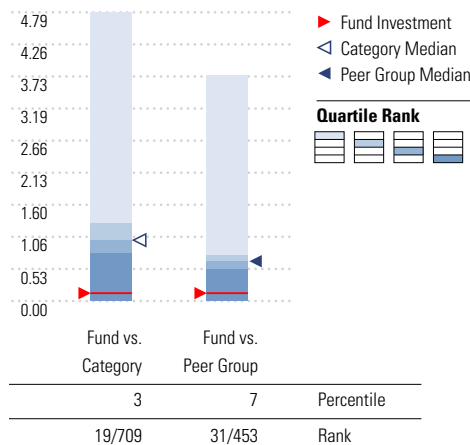

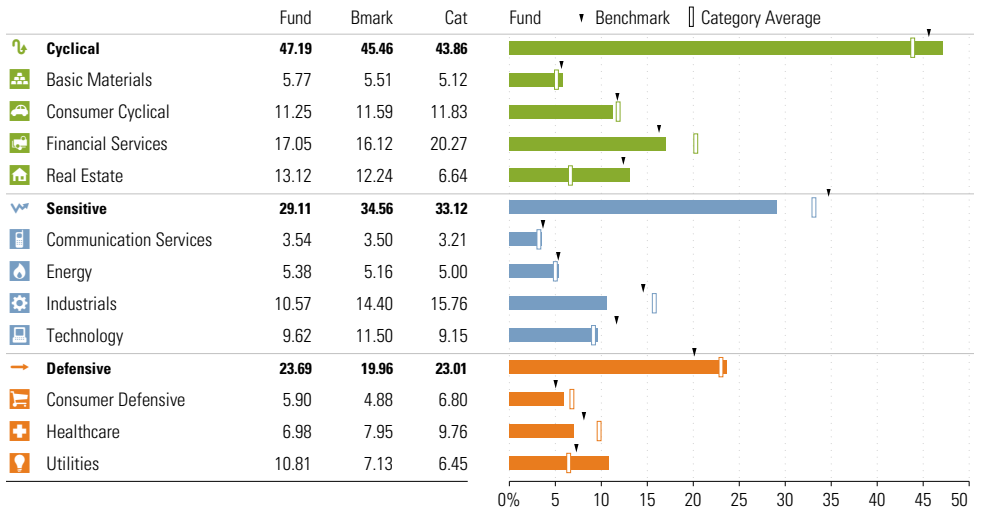

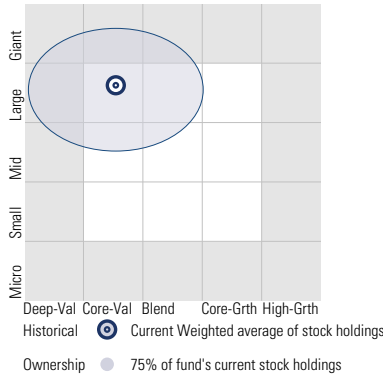

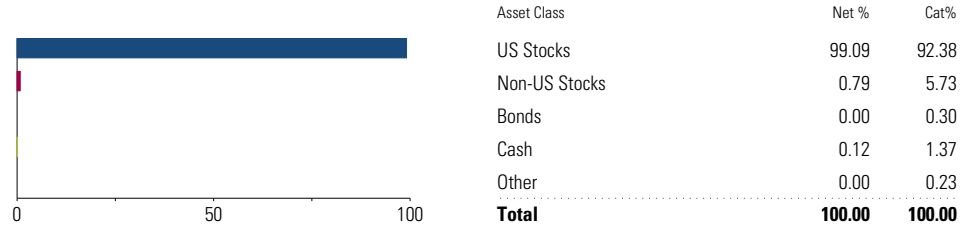

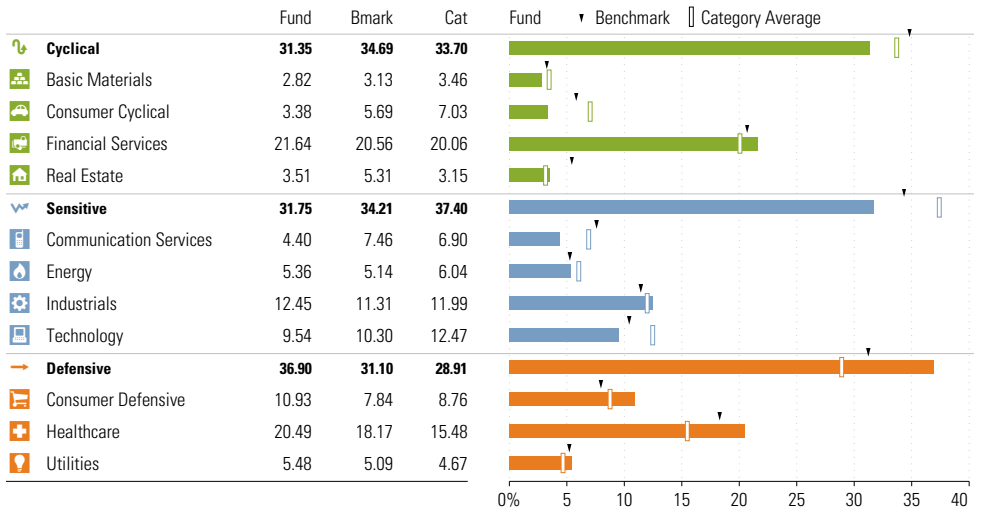
Style Breakdown
