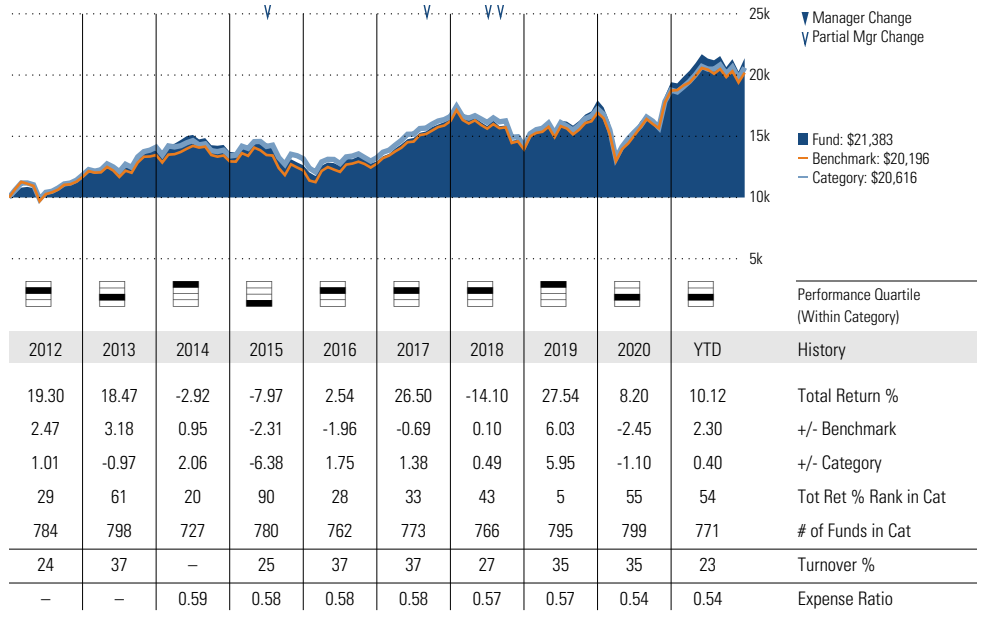

Growth of \$10,000



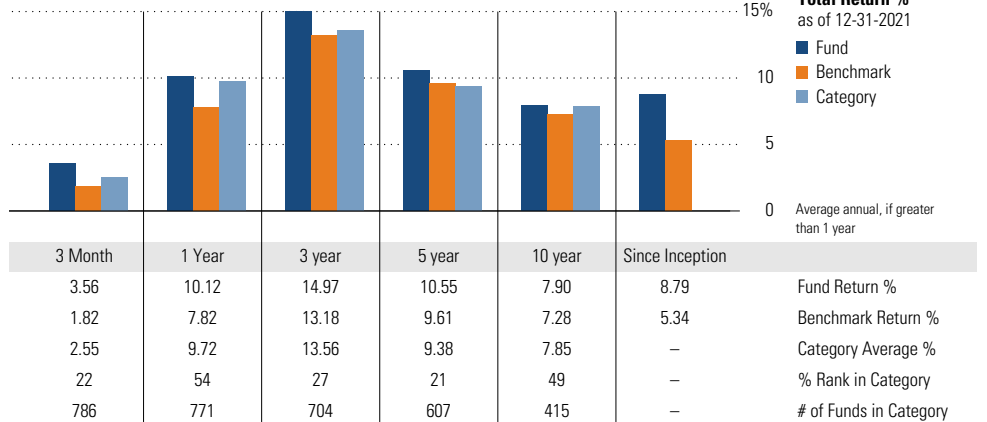

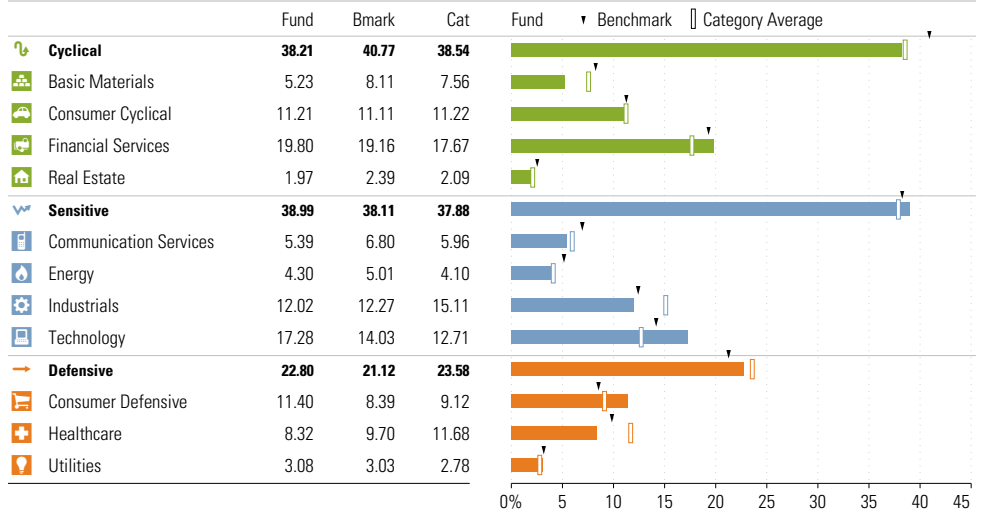

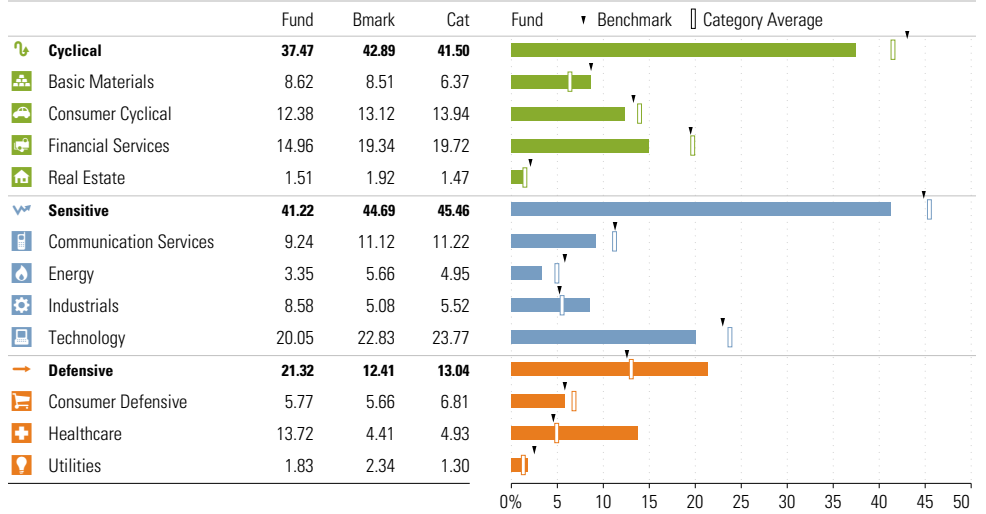

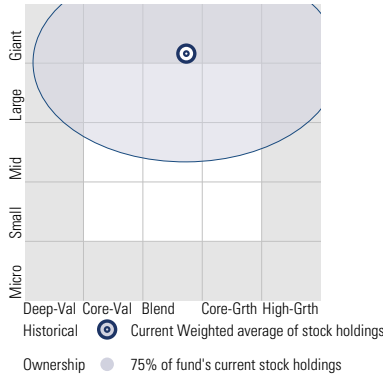

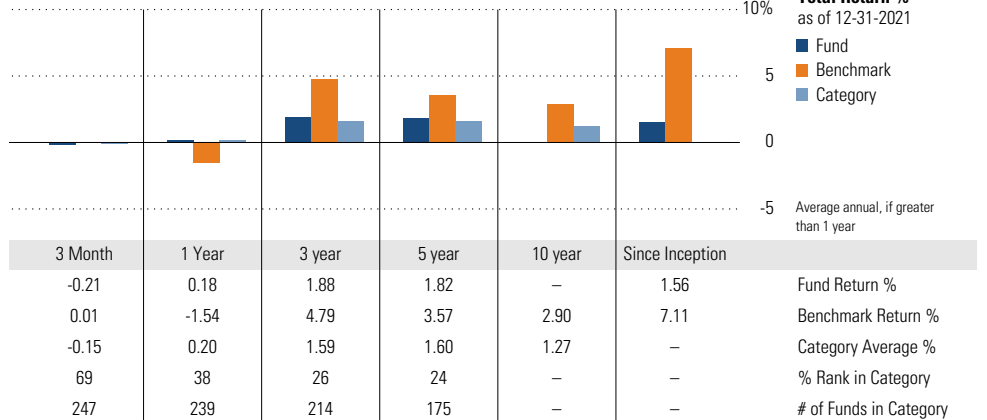

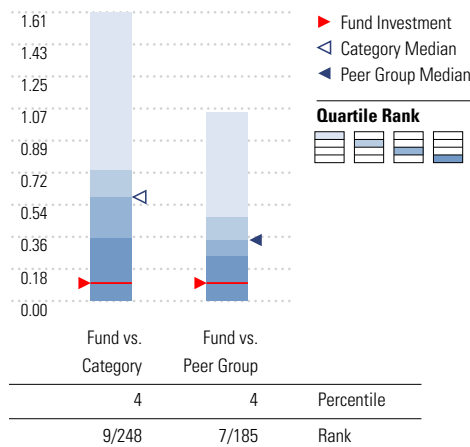
Growth of \$10,000

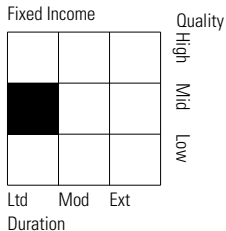

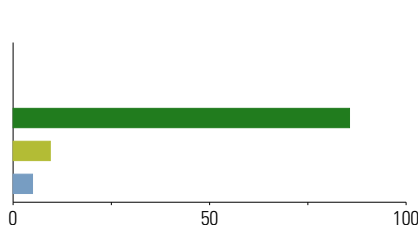

Asset Allocation as of 12-31-2021

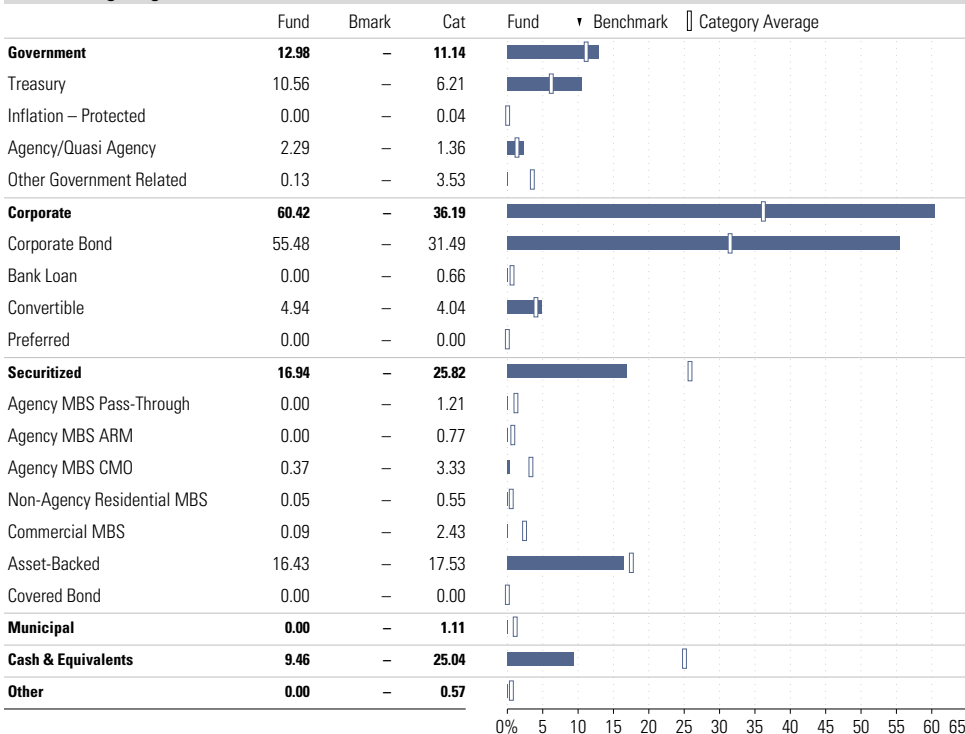

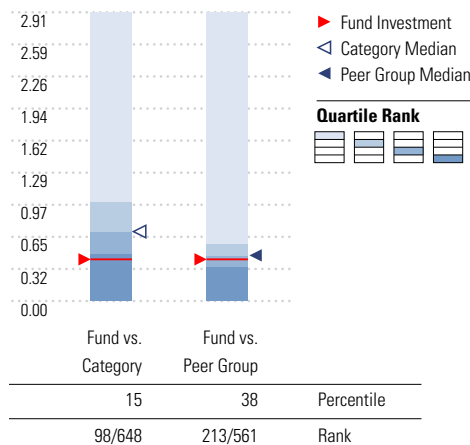
Growth of \$10,000

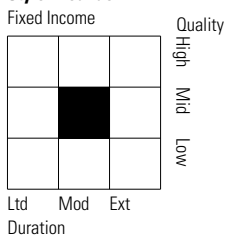

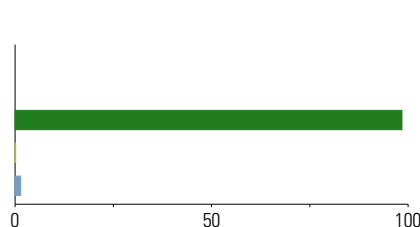

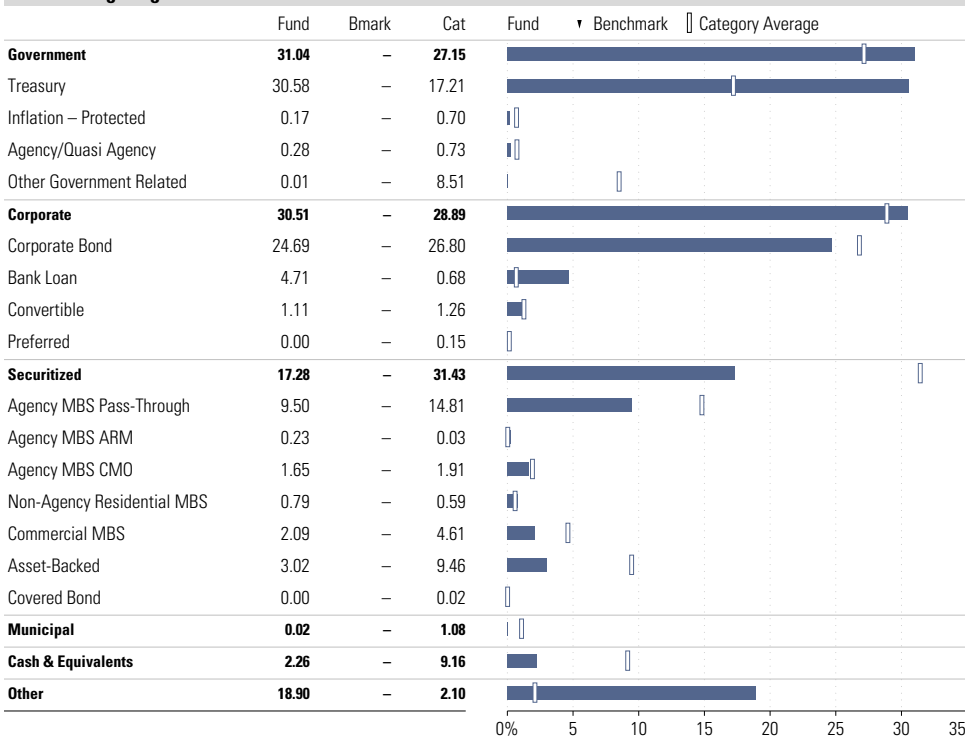
