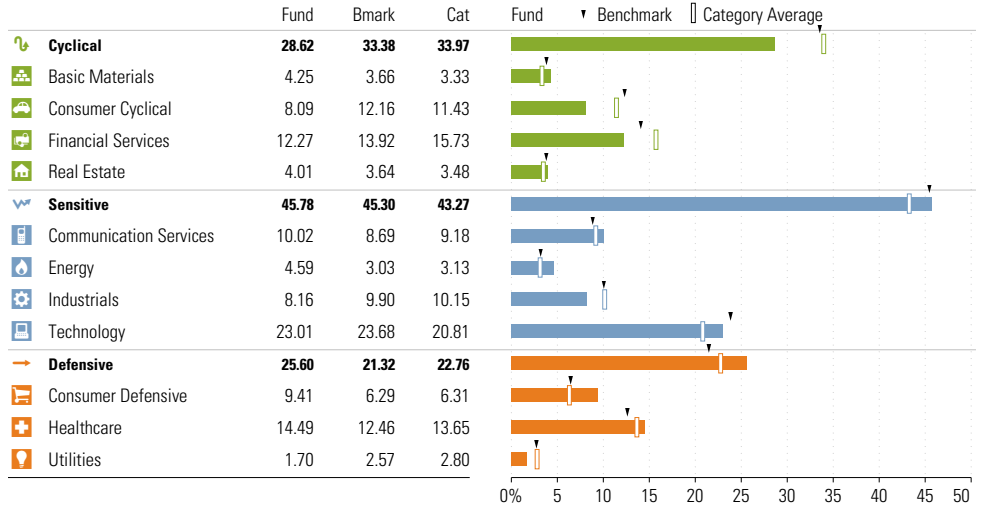

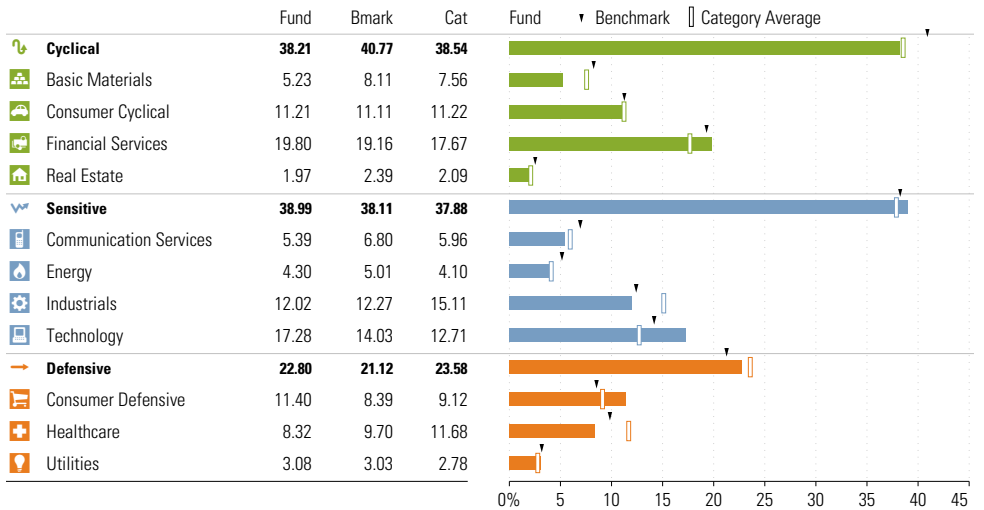

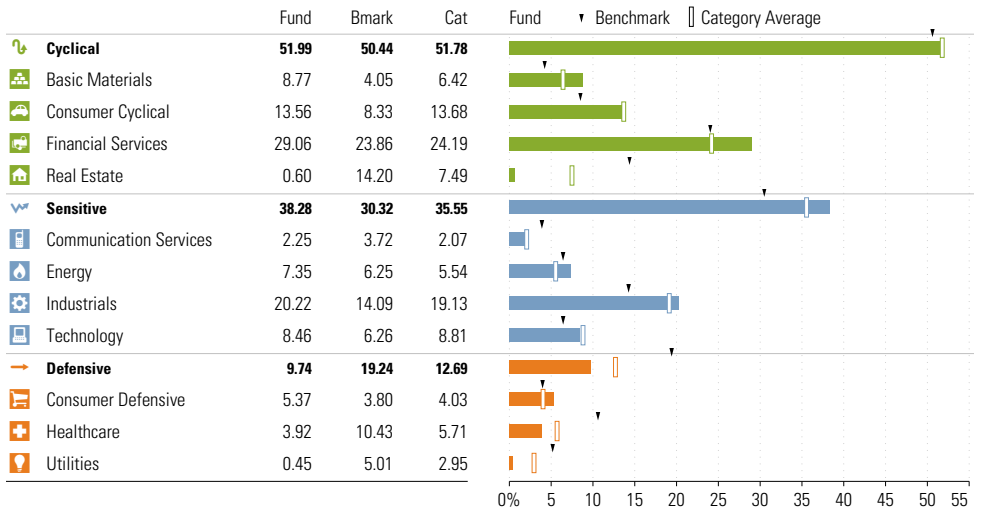

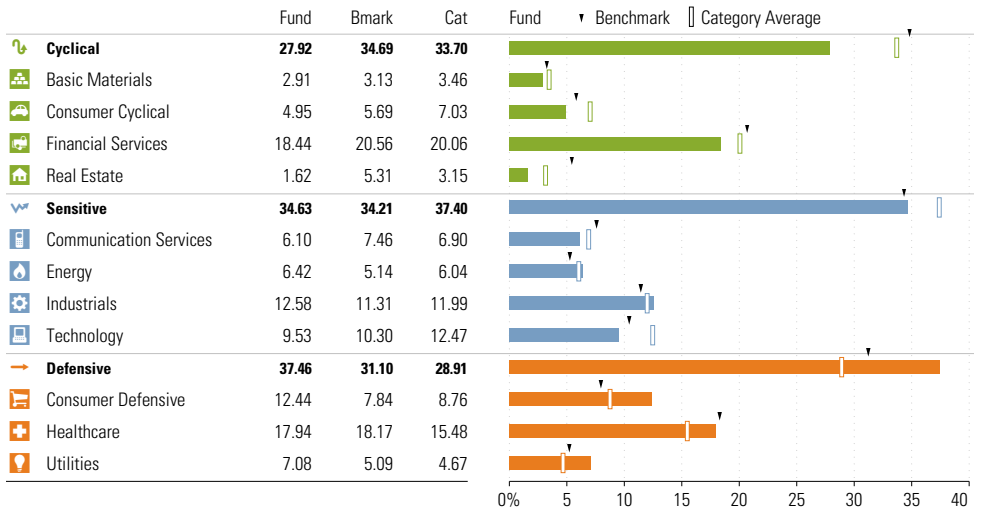

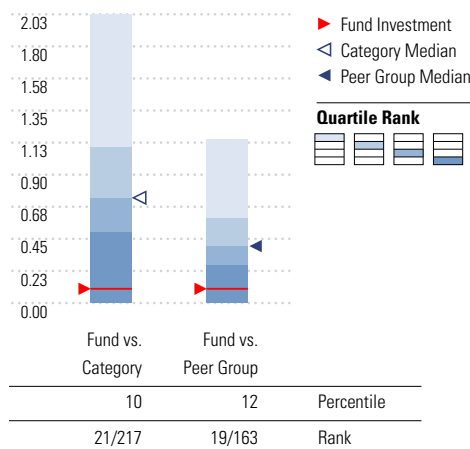

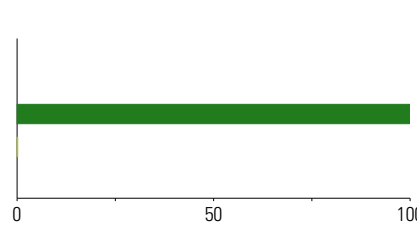

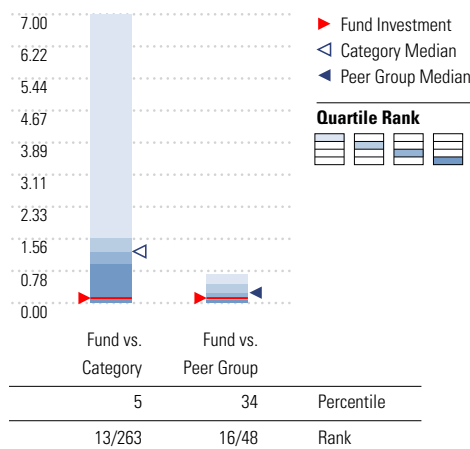

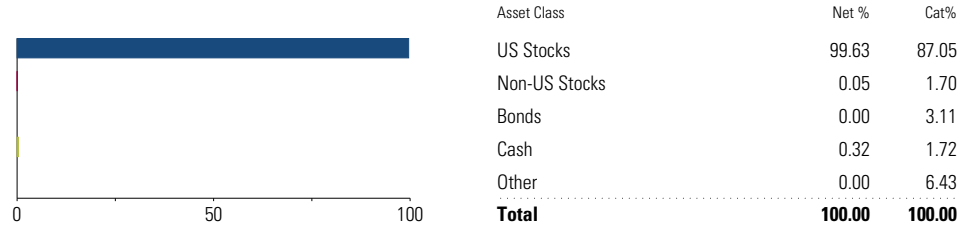

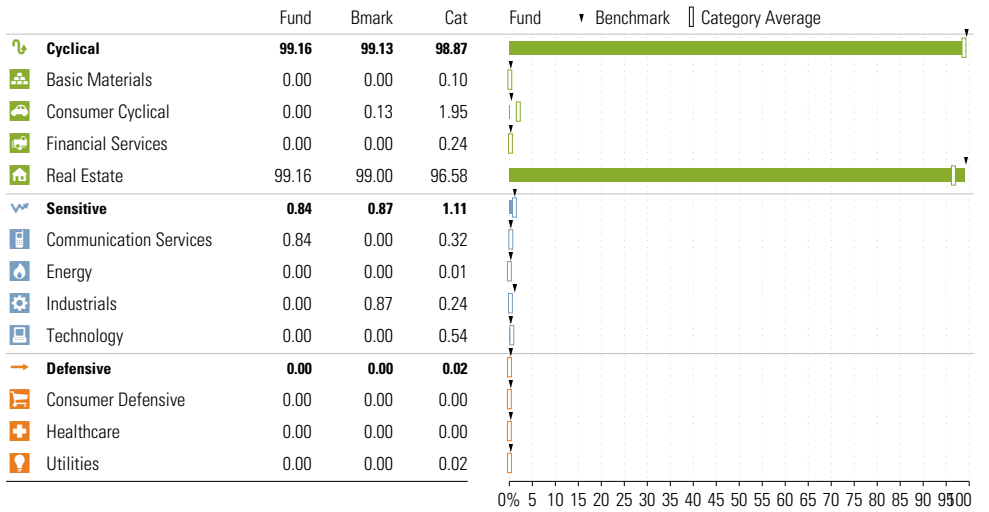
Style Breakdown
