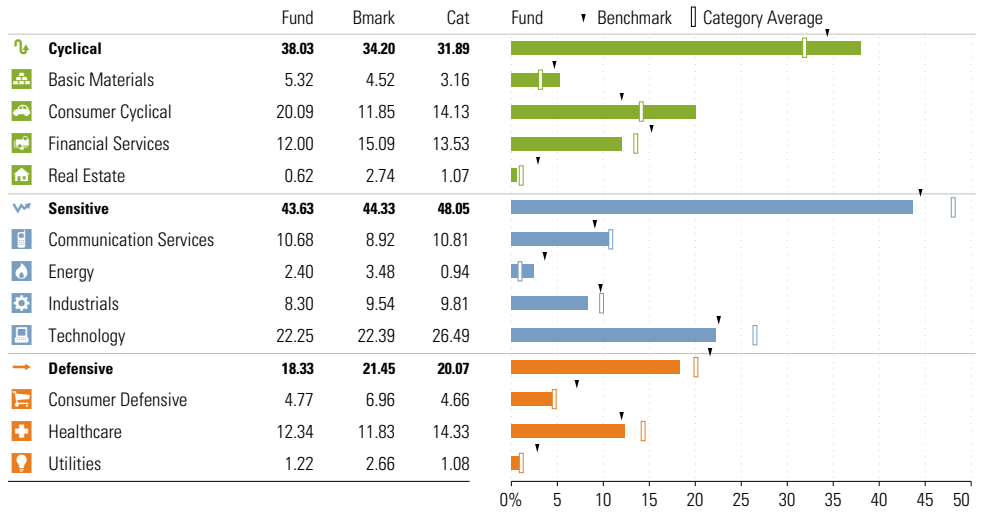

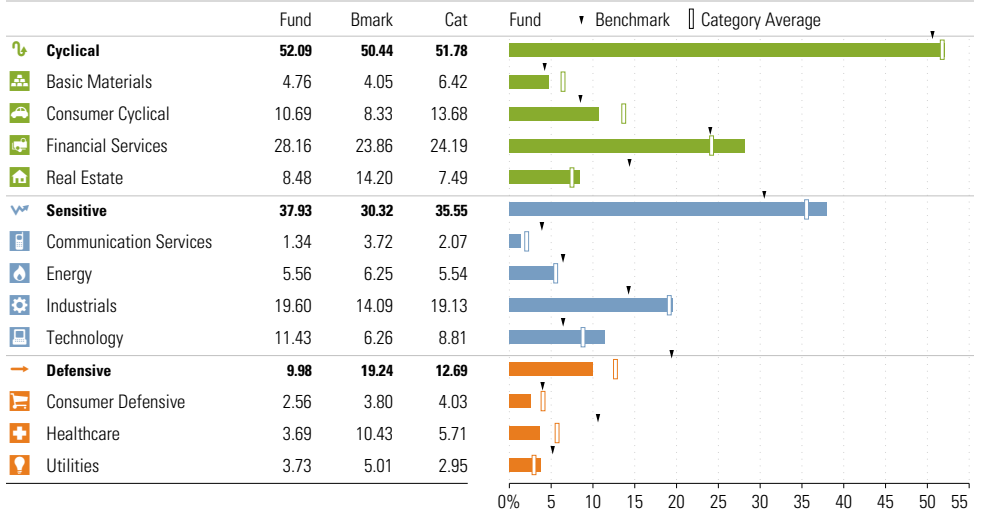

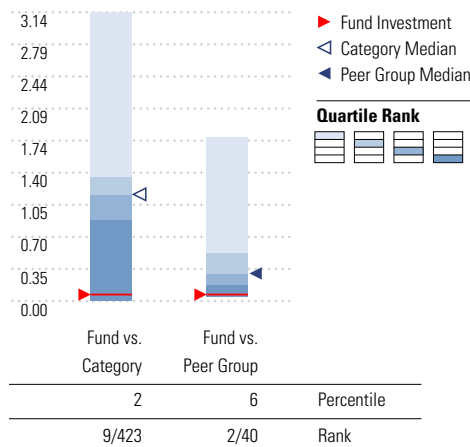

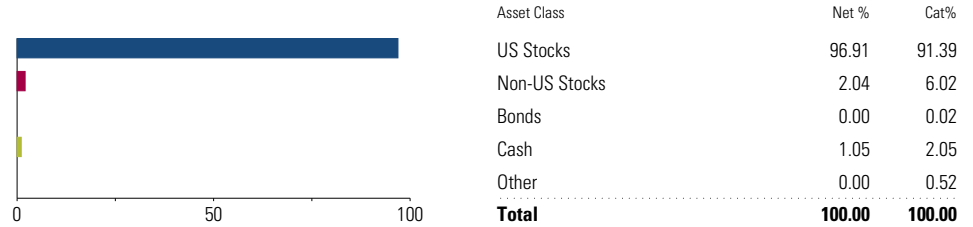

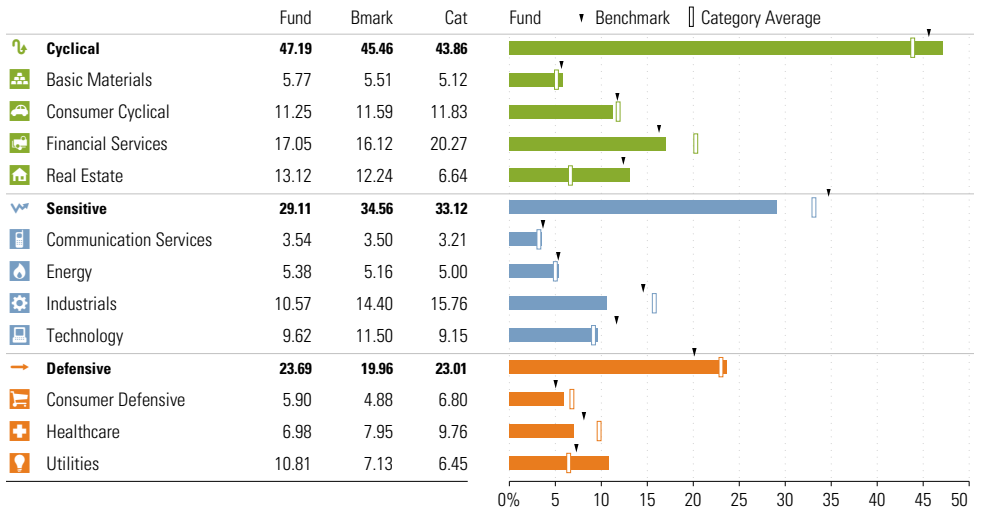
Style Breakdown

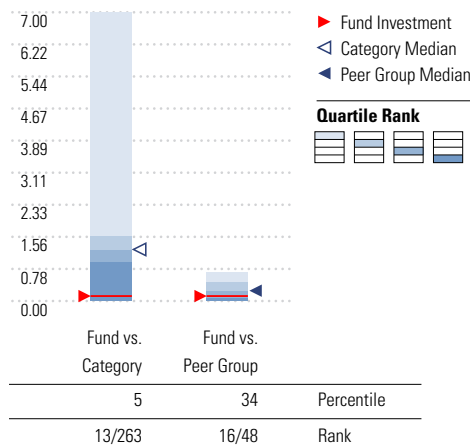

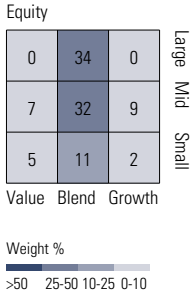
