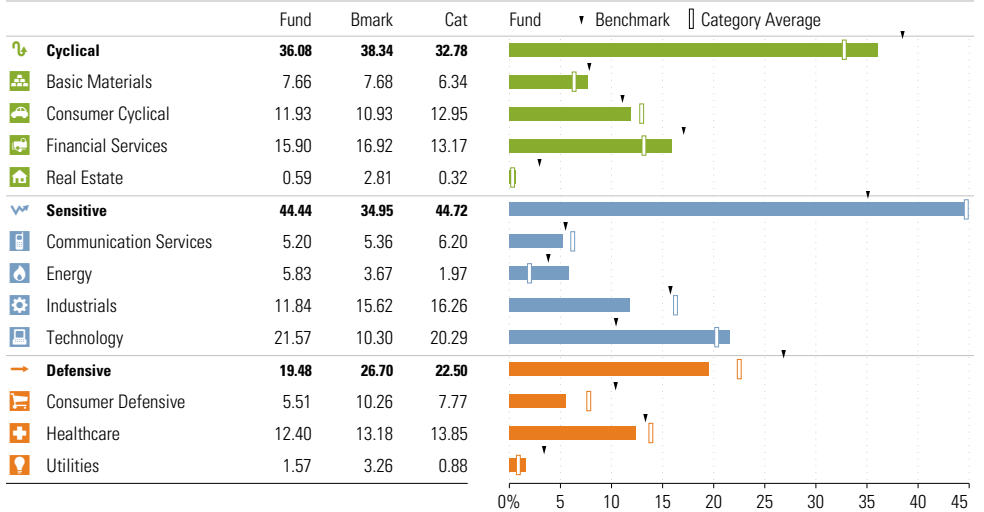

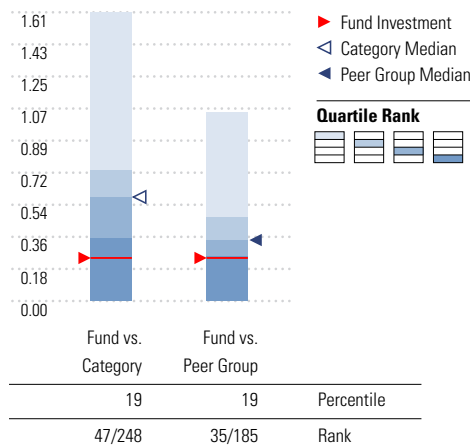

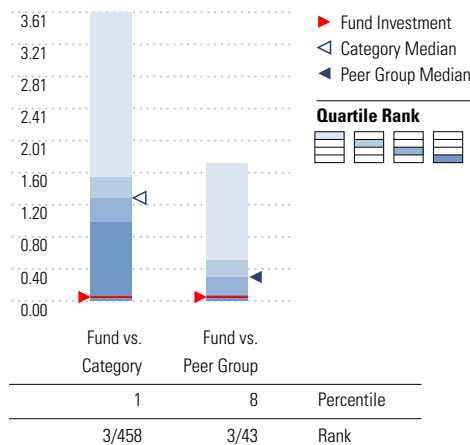

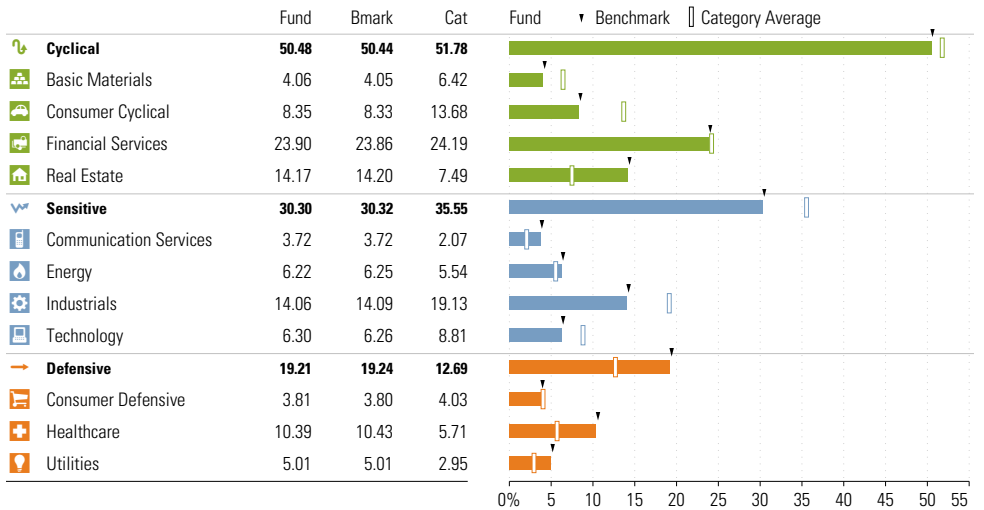

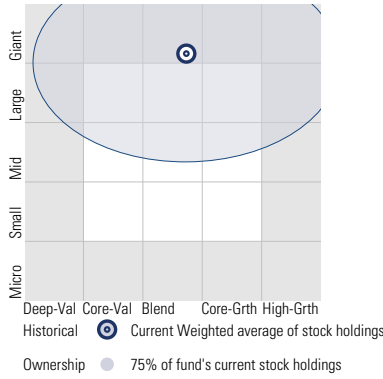

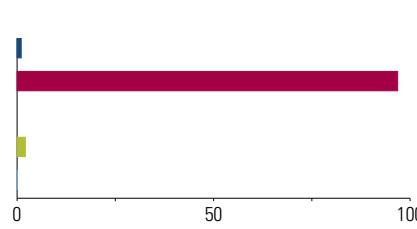

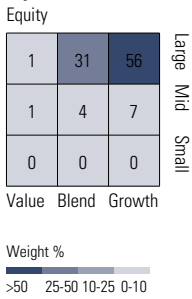
Asset Allocation as of 12-31-2021

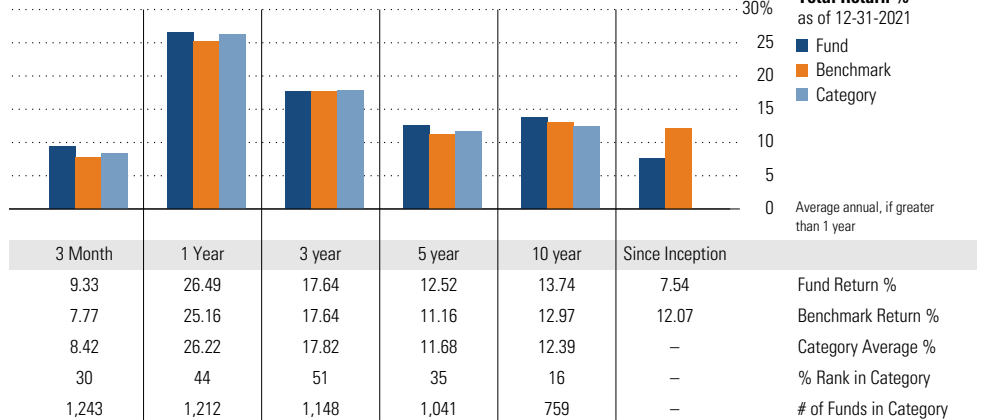

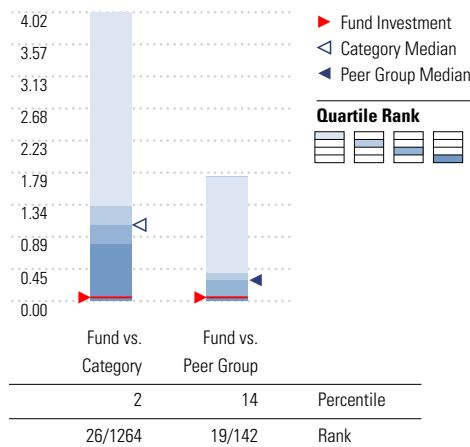

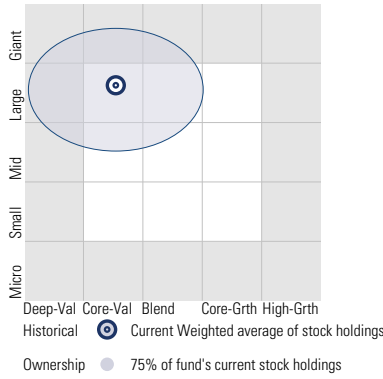

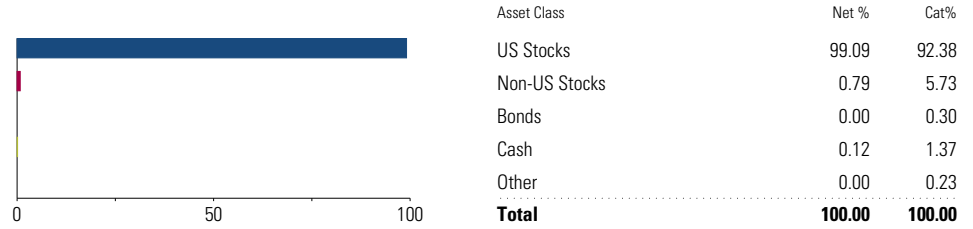

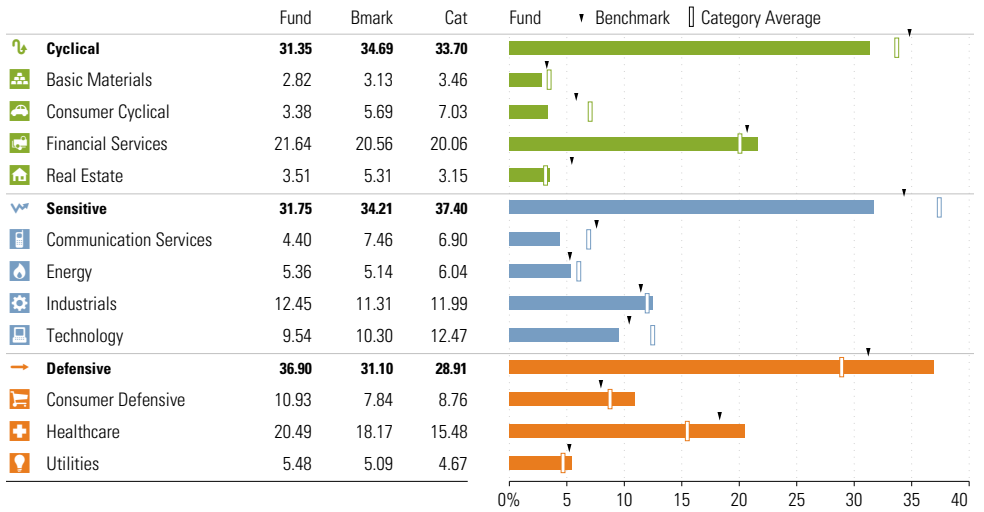
Style Breakdown
