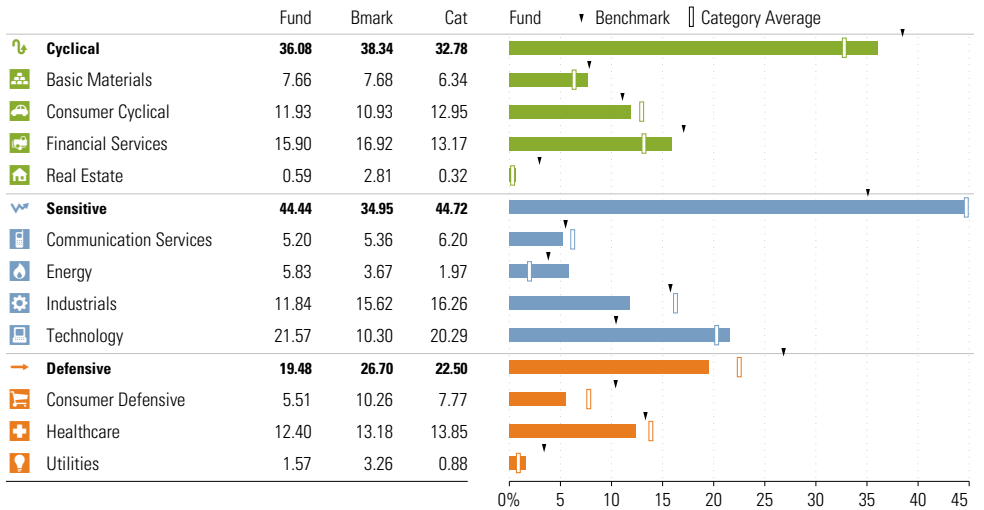

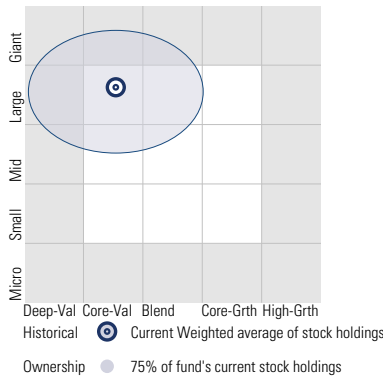

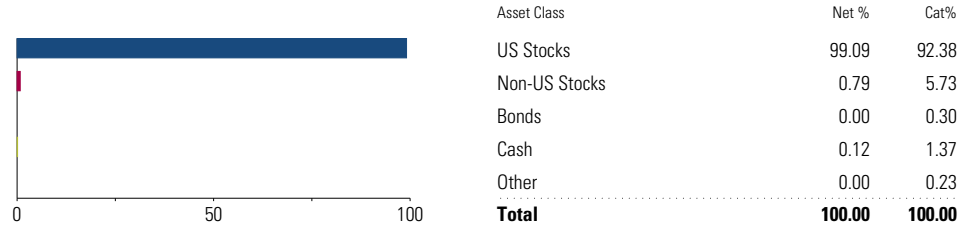

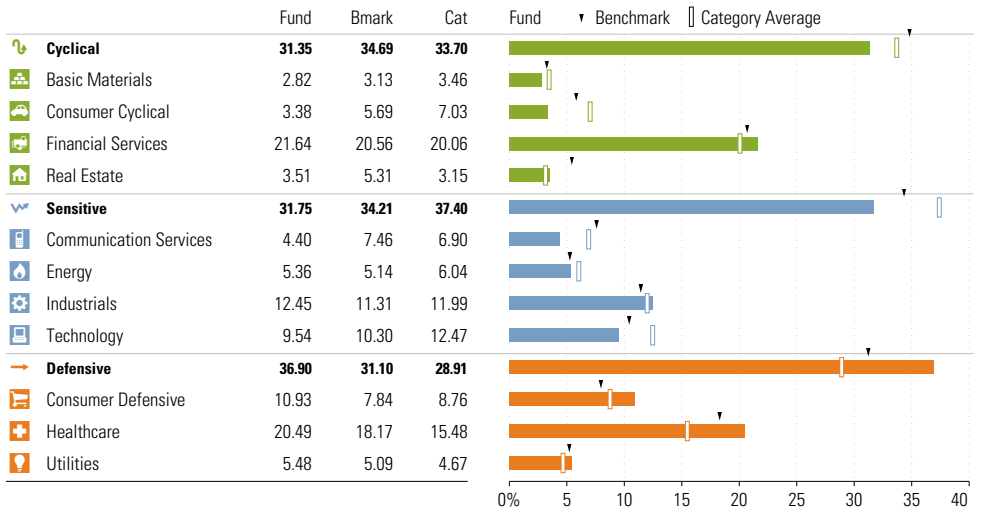
Style Breakdown
