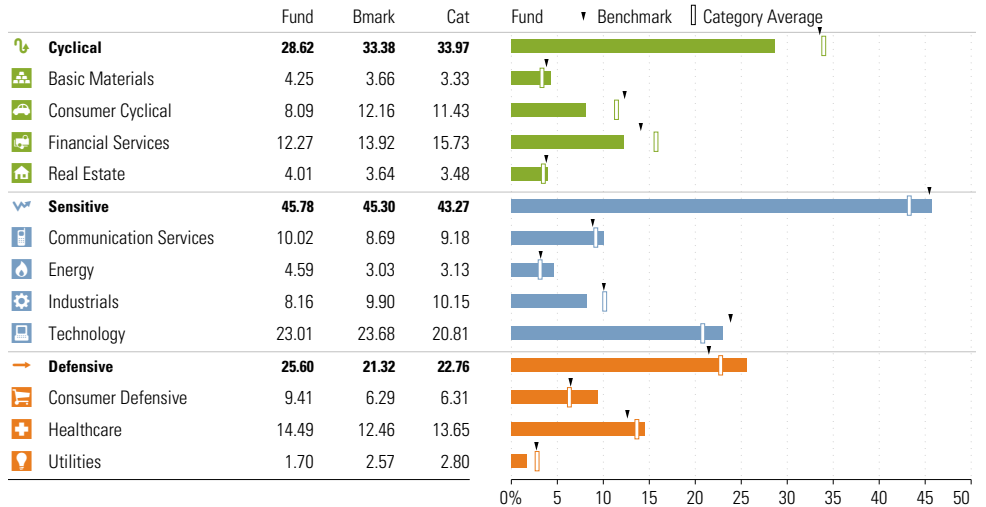

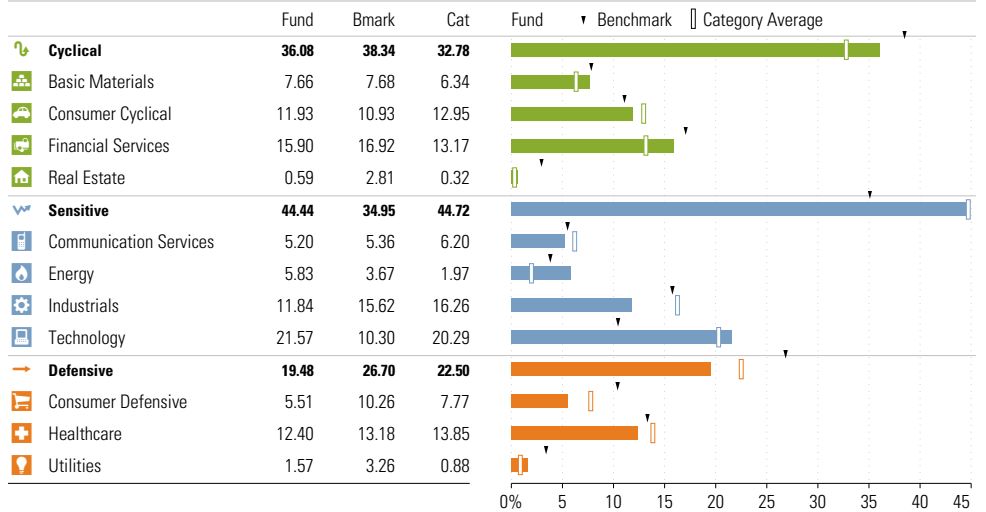

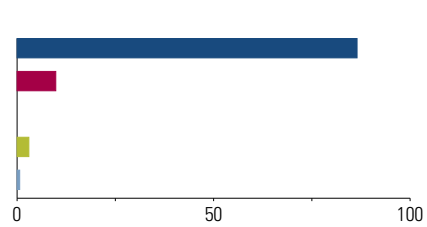

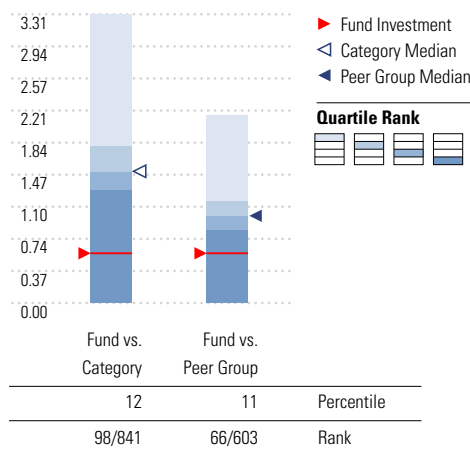

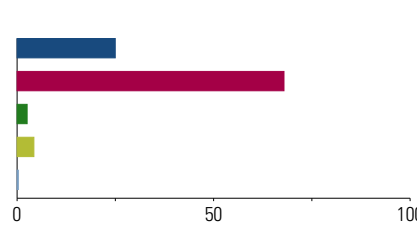

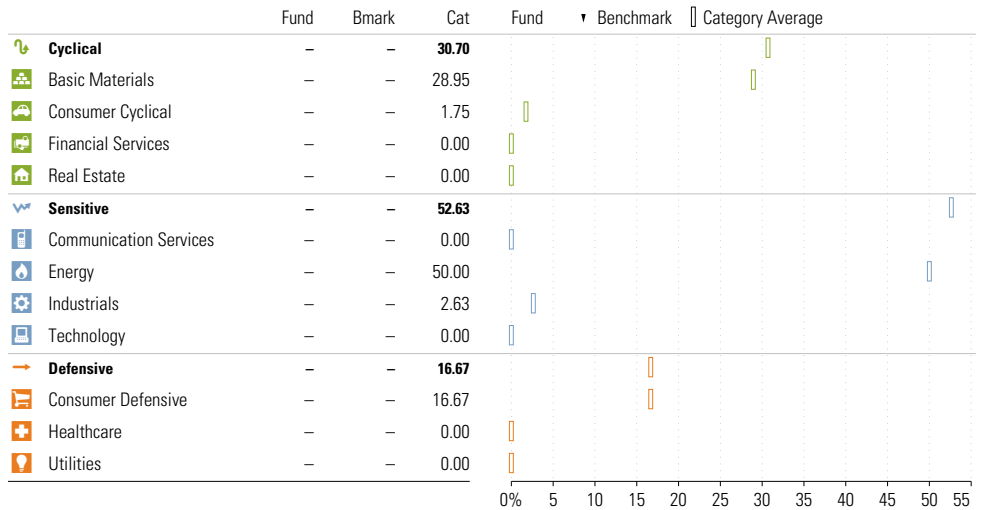

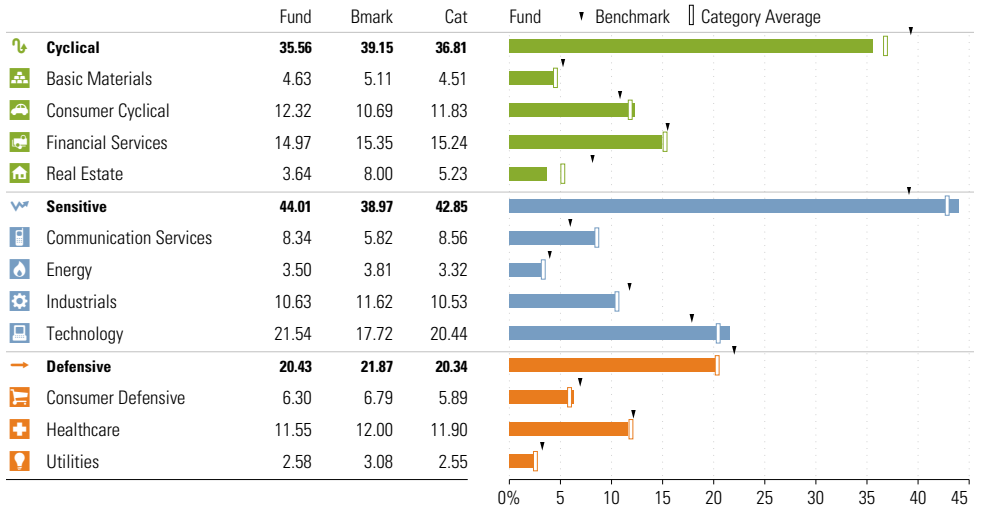

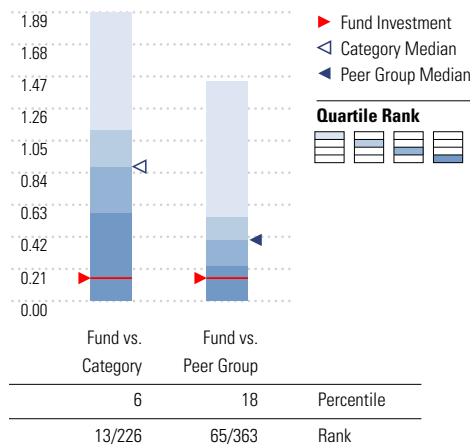

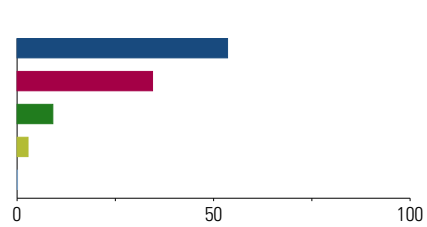

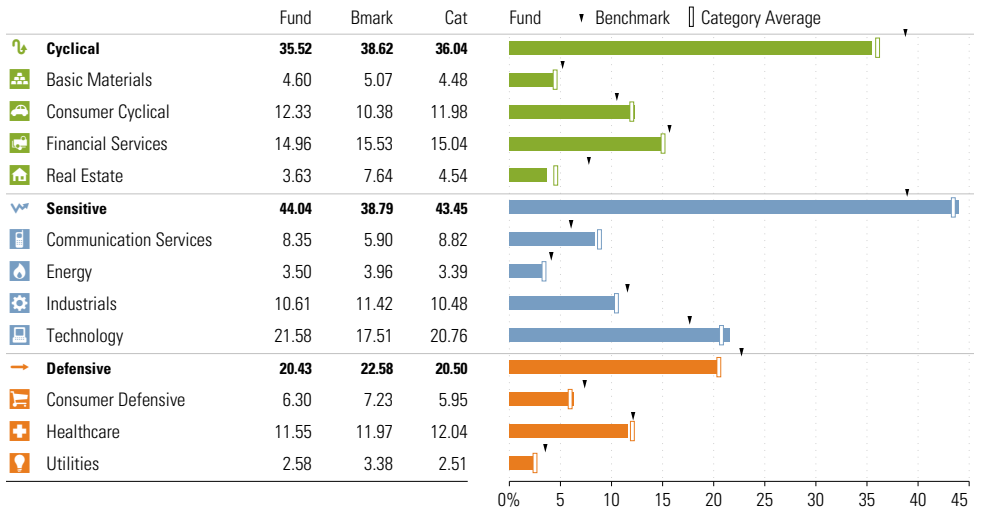

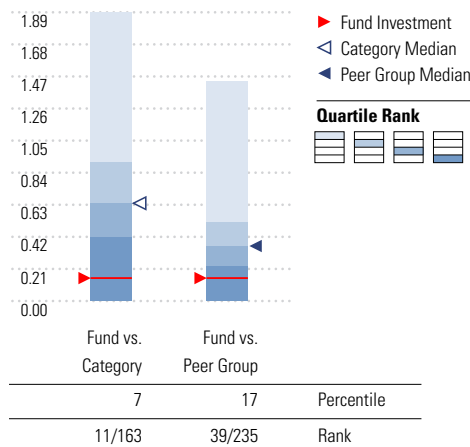

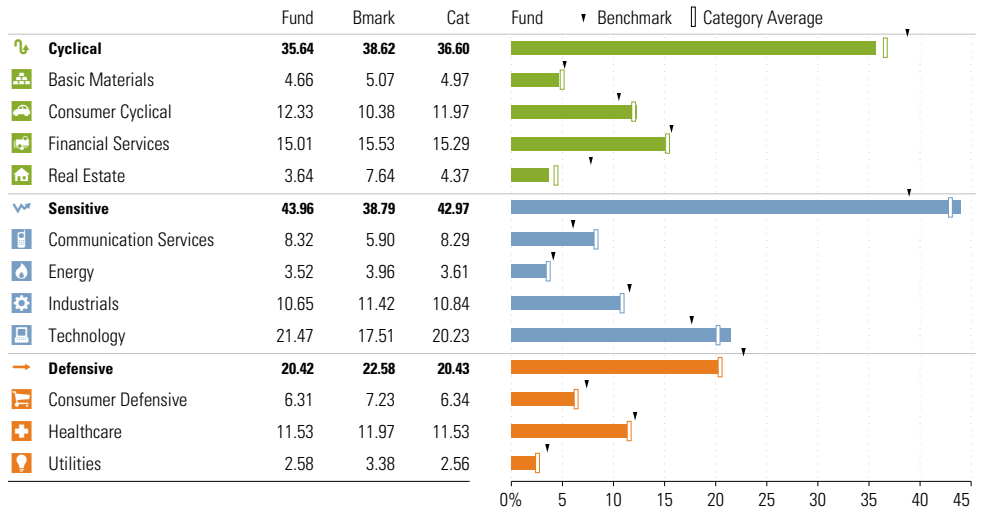

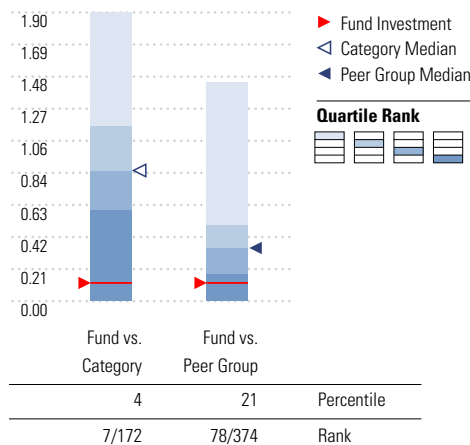

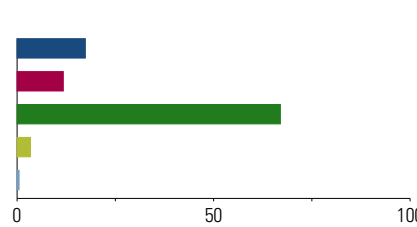

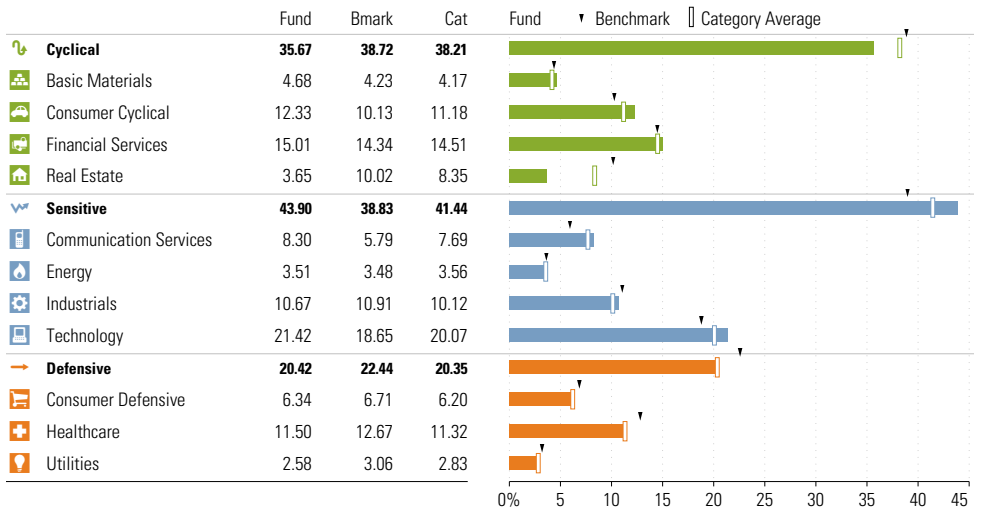

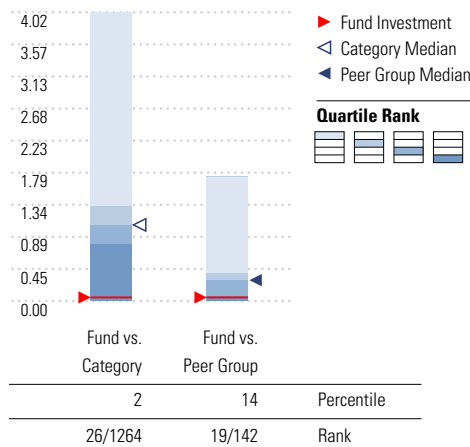

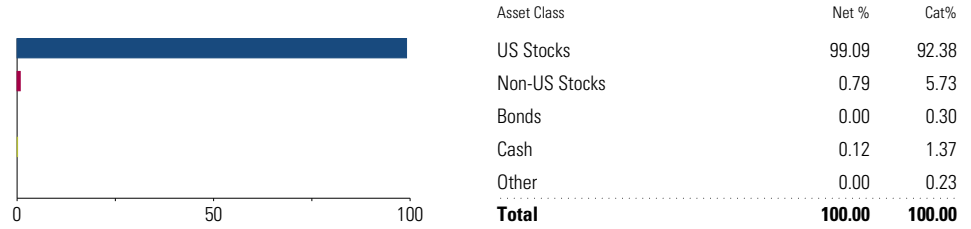

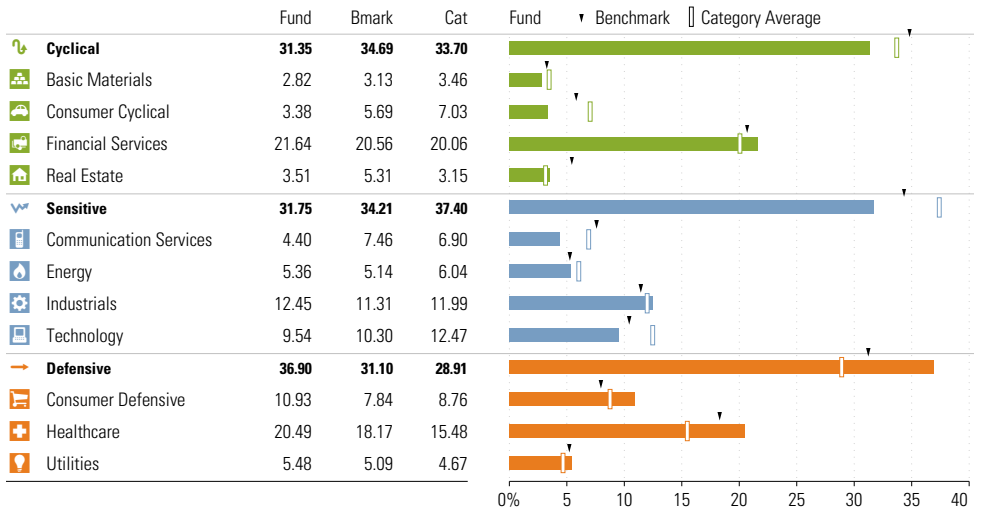
Style Breakdown
