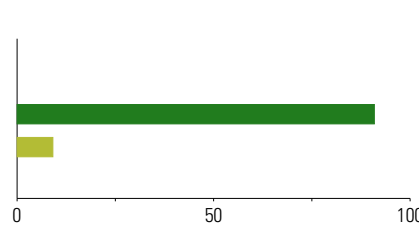

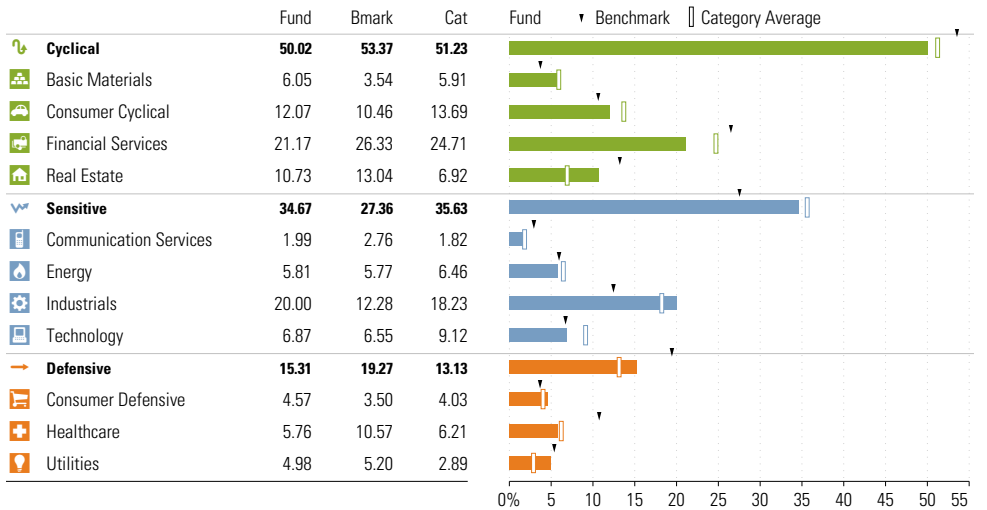

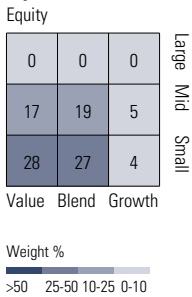
## Asset Allocation as of 12-31-2022

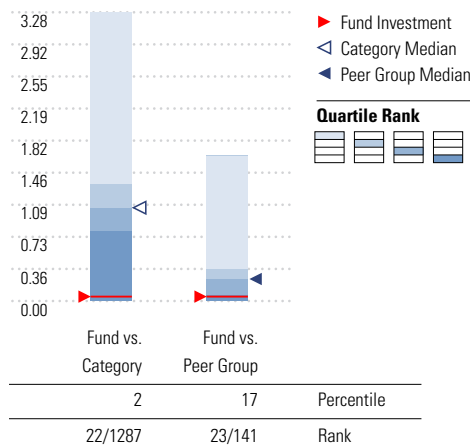

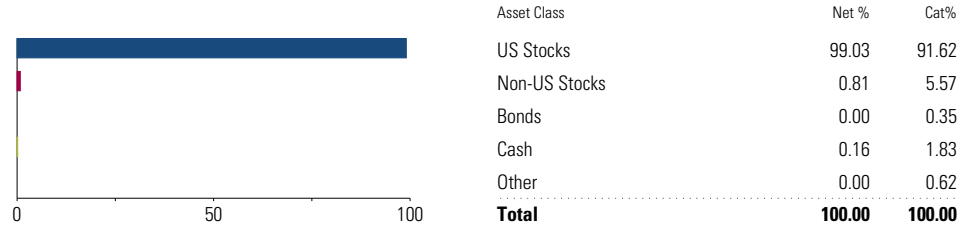
