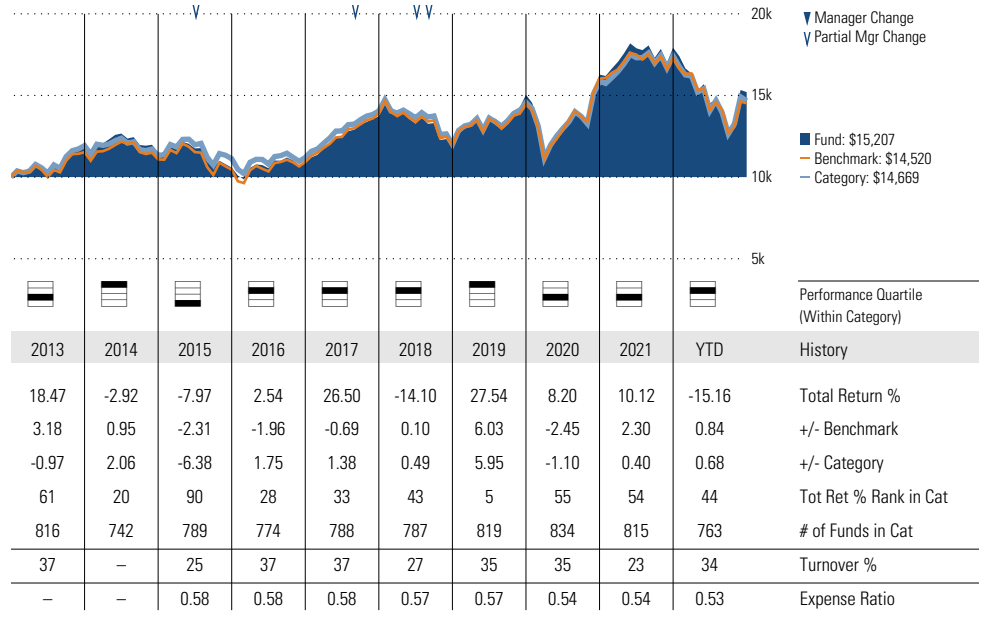

Growth of \$10,000



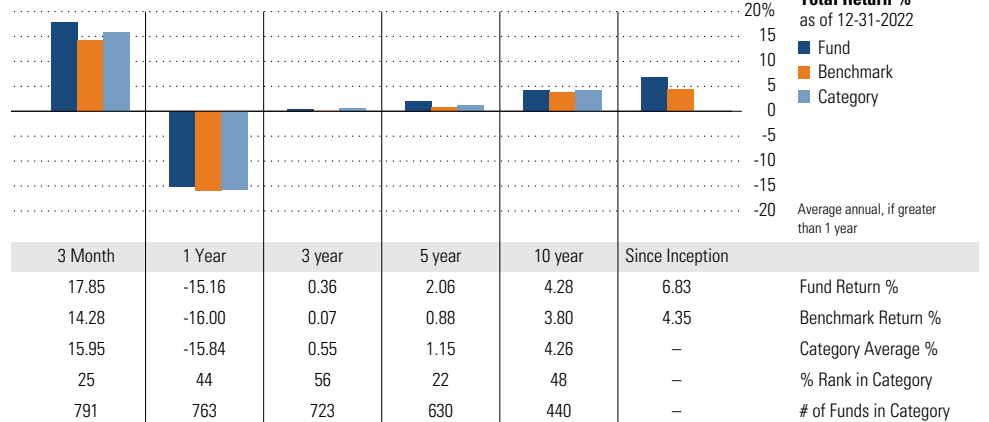

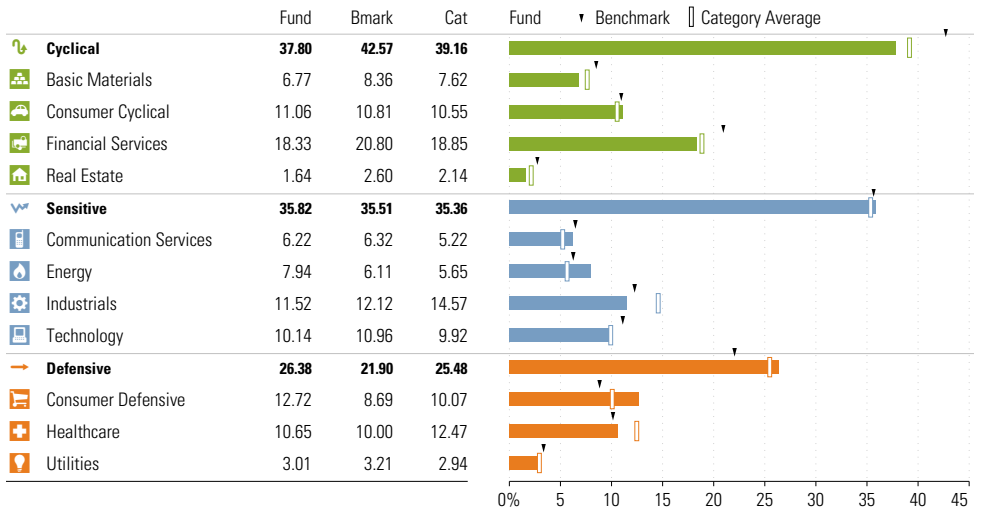

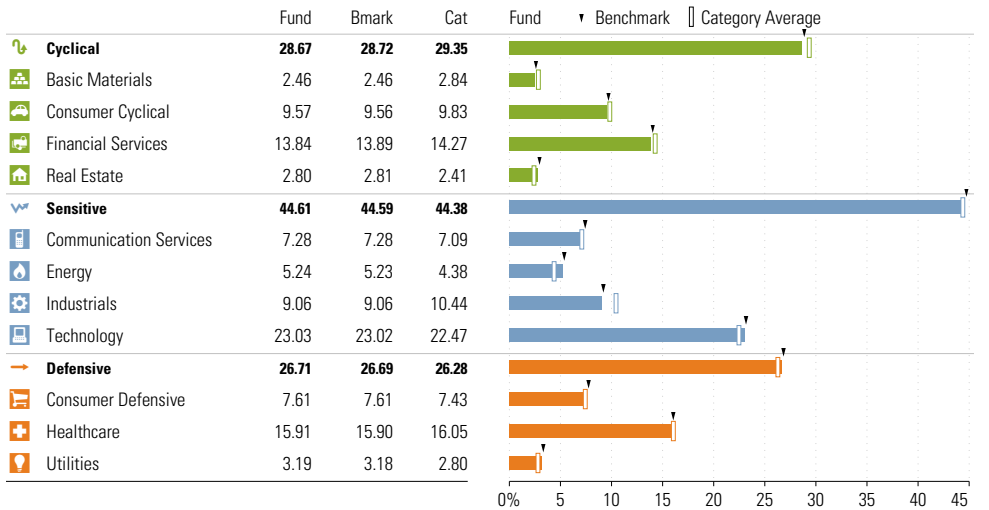

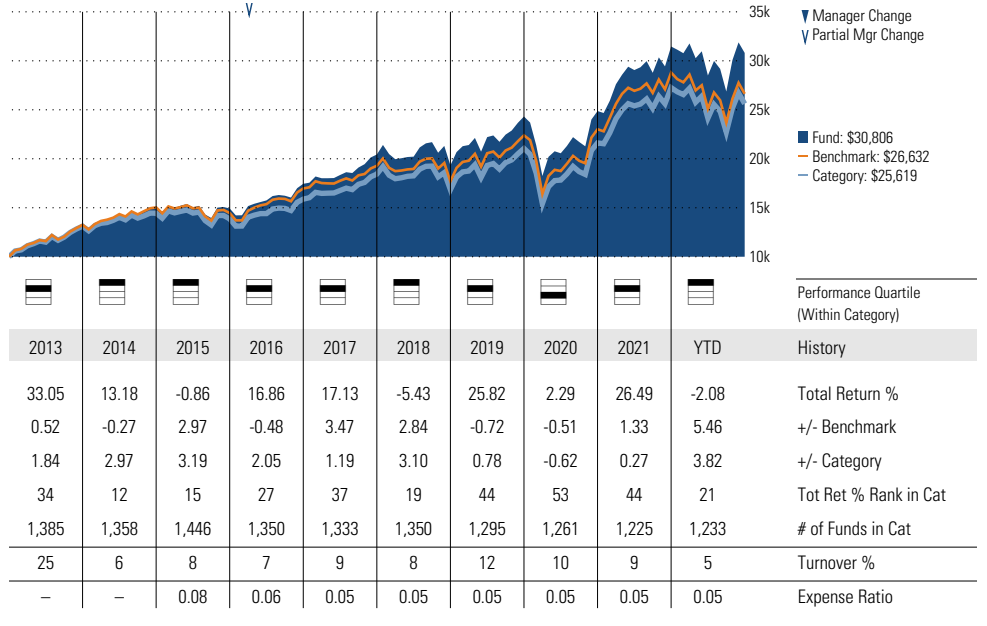

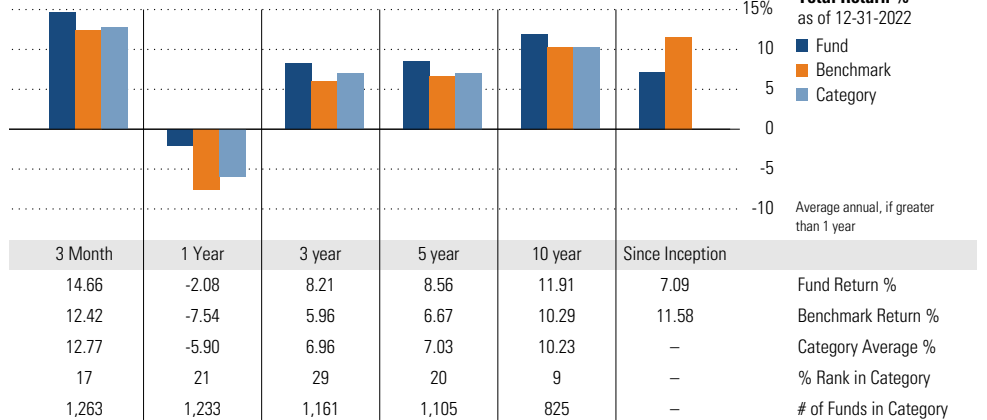

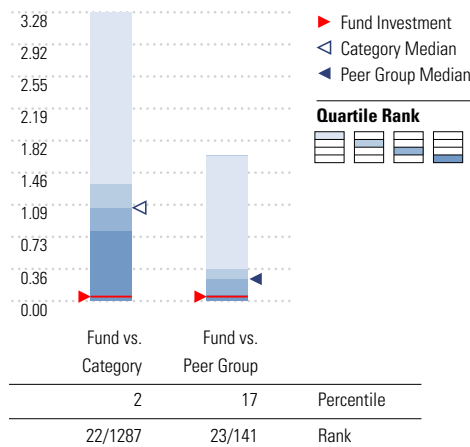

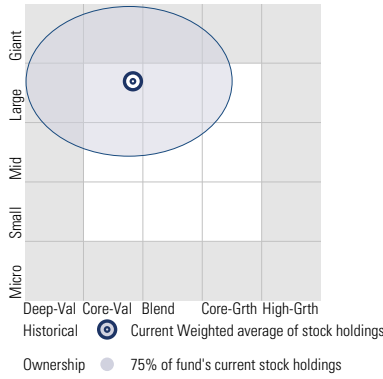

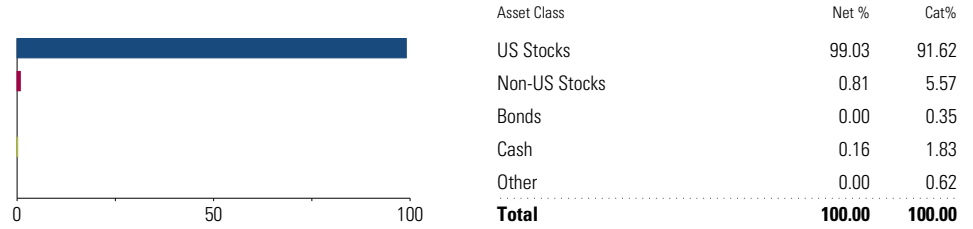

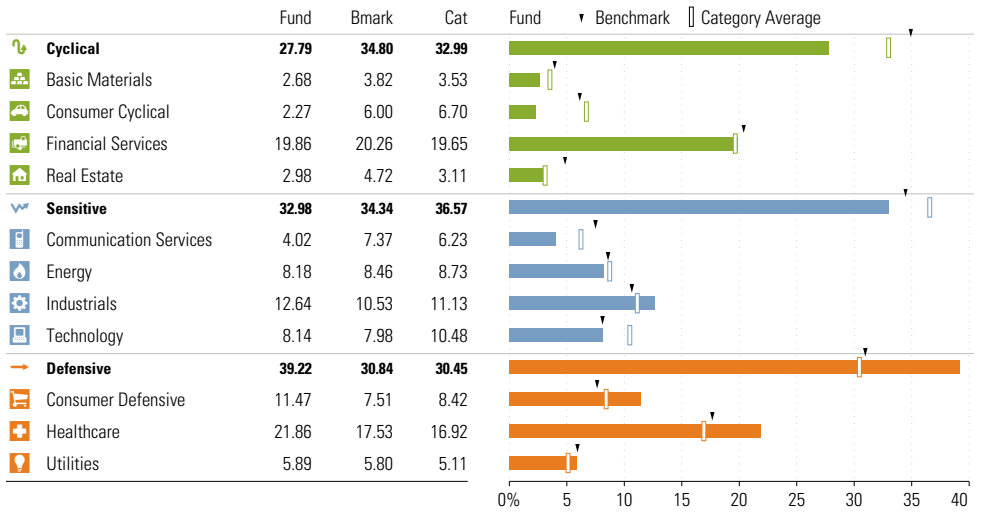
Morningstar Style Box™
