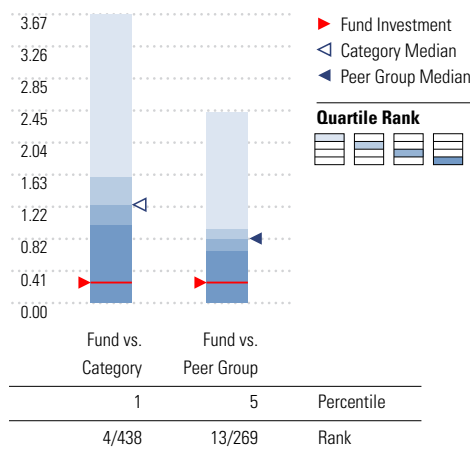

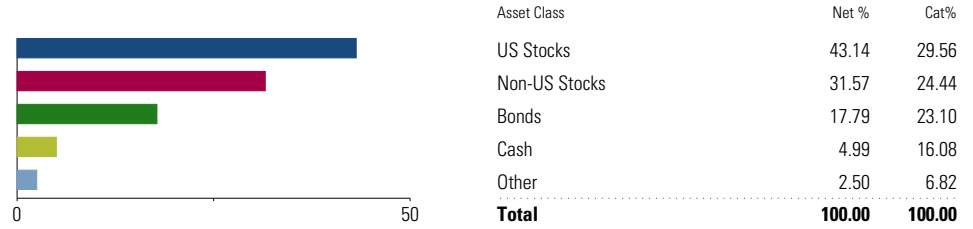

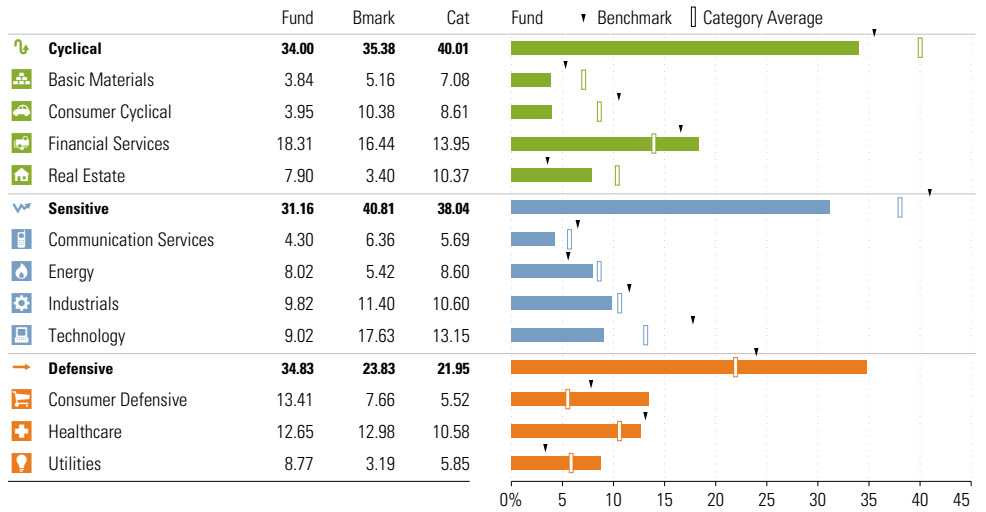

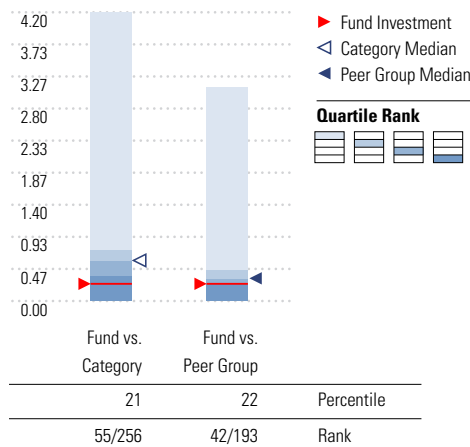

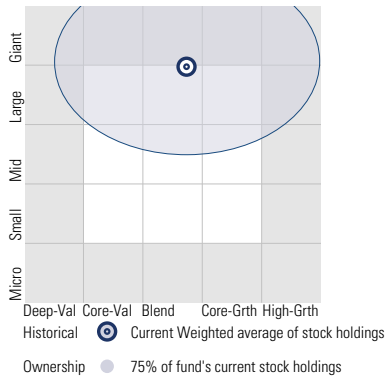

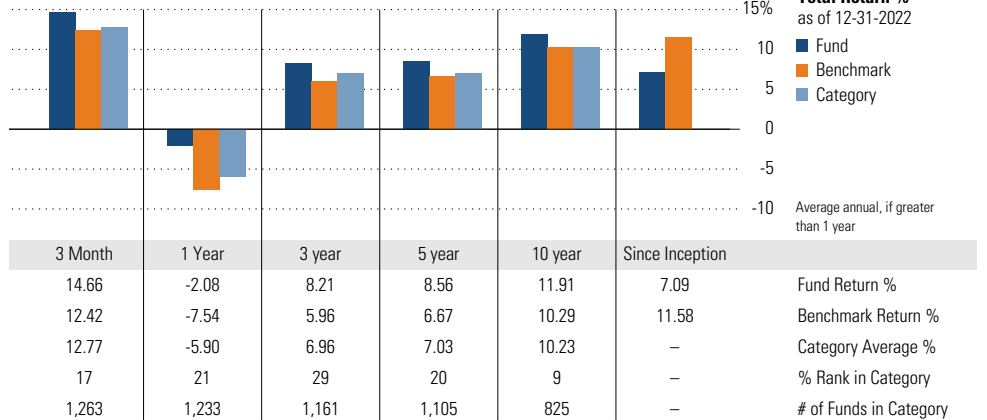

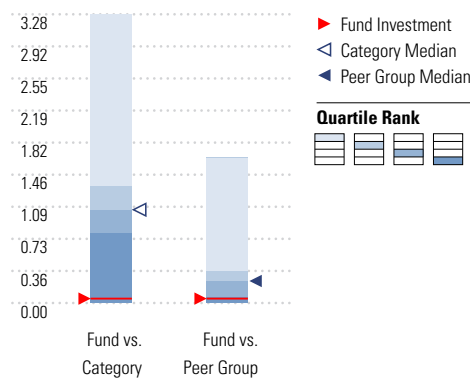

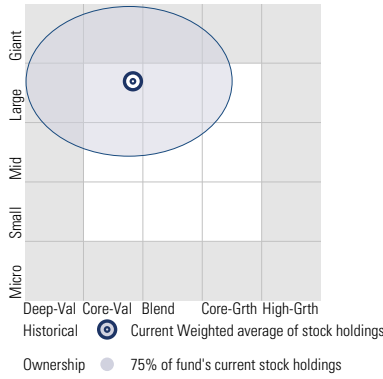

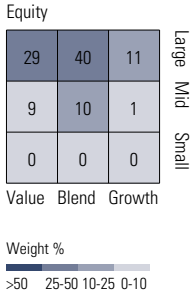

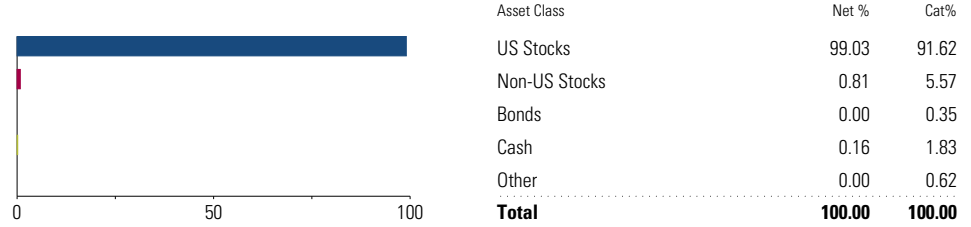

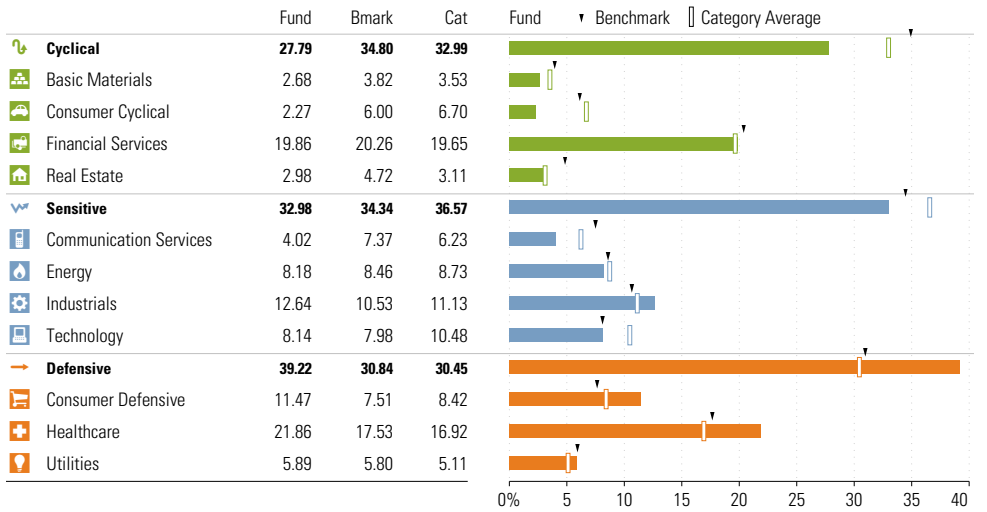
Style Breakdown
