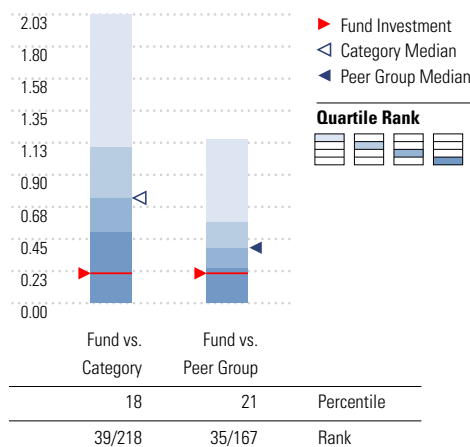

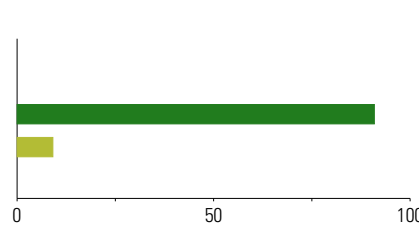

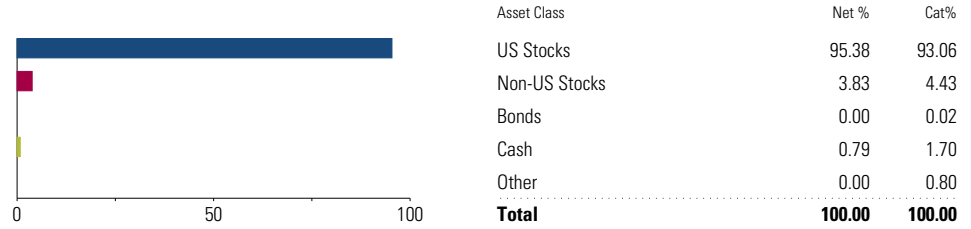

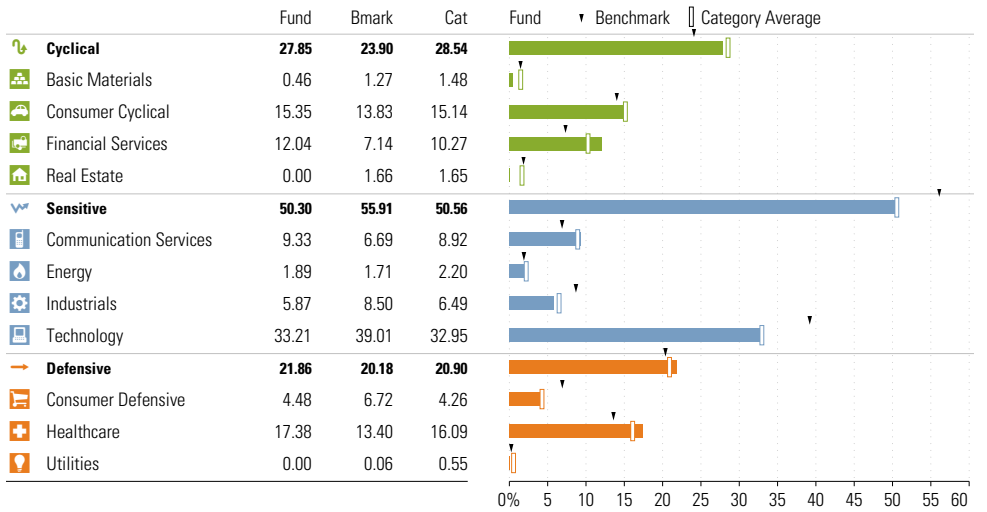

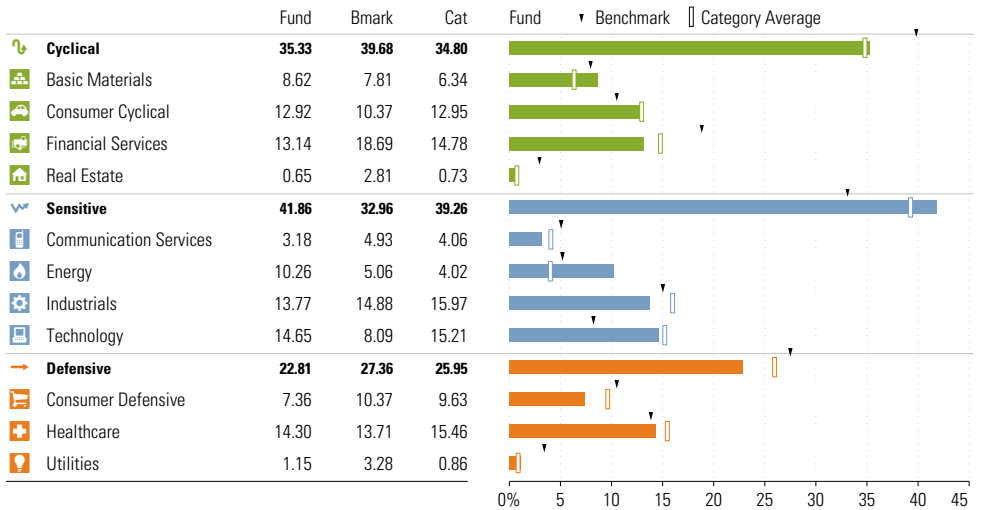

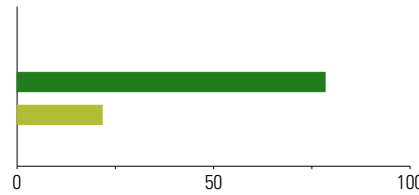

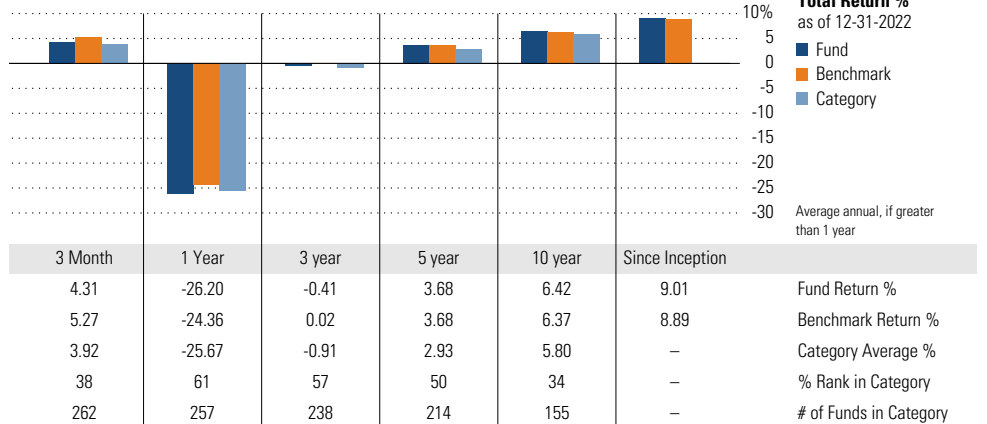

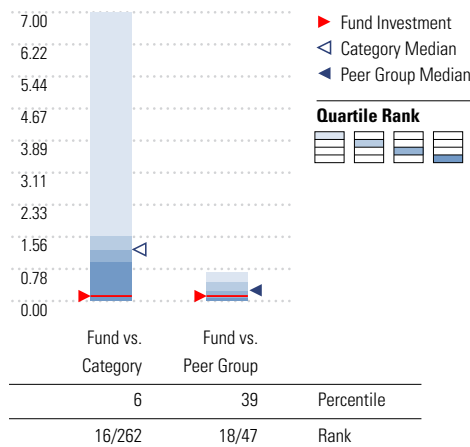

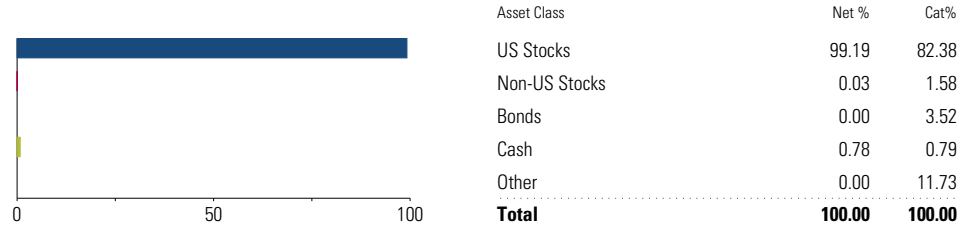

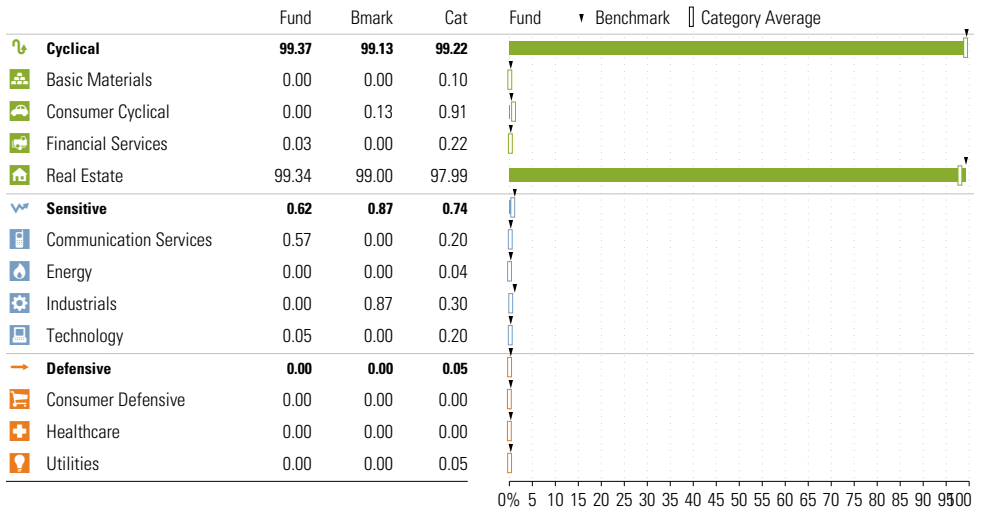
Style Breakdown

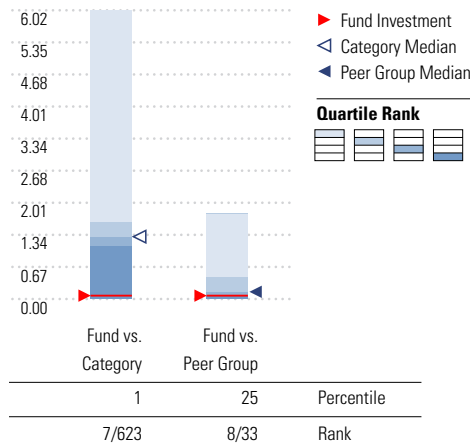

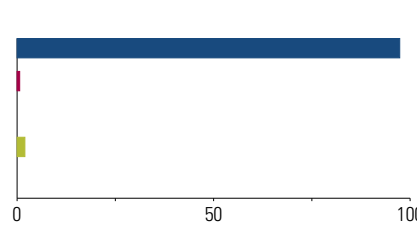

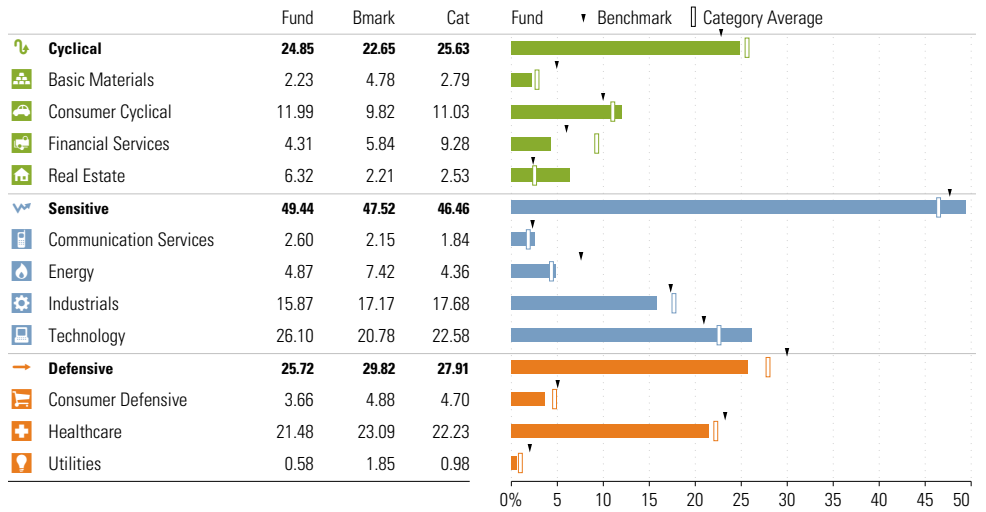
