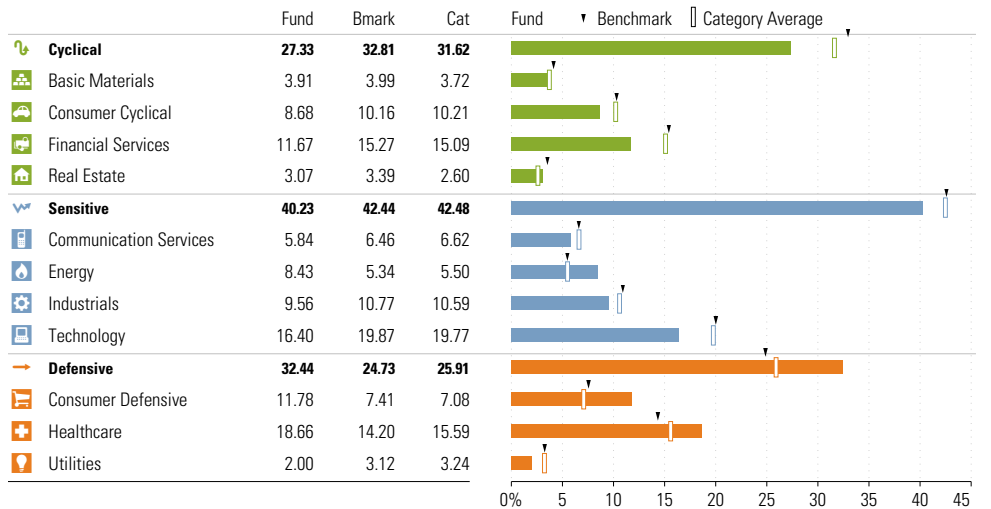

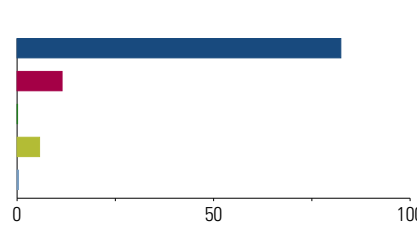

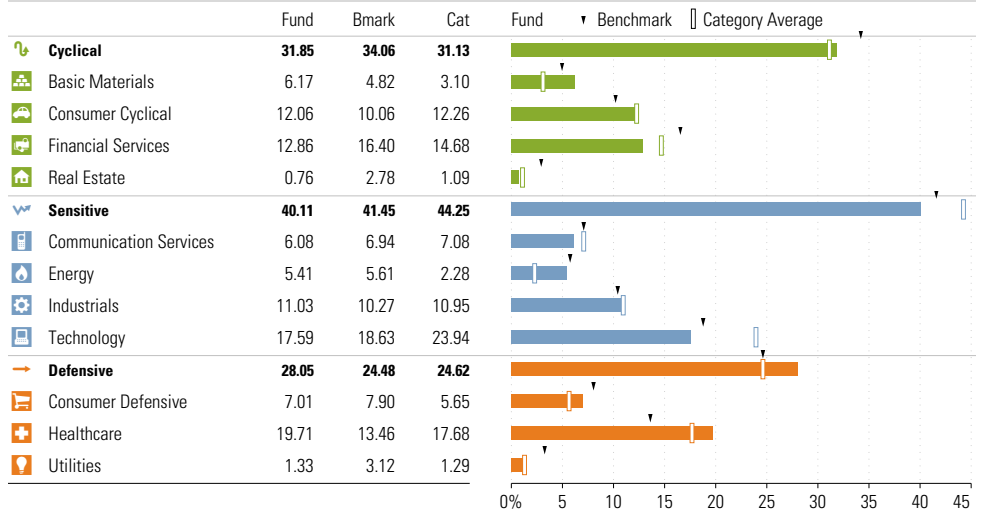

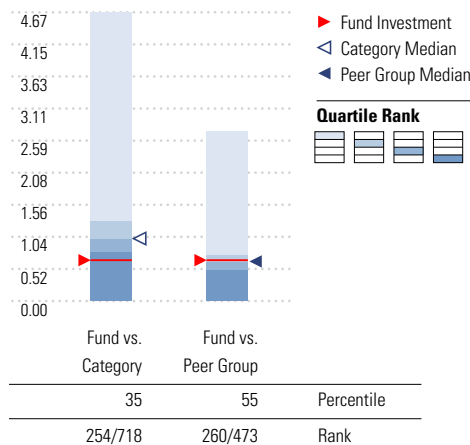

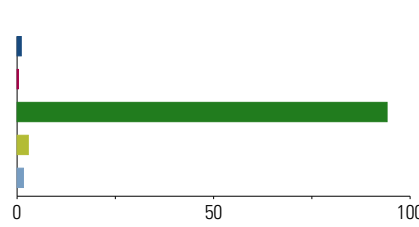

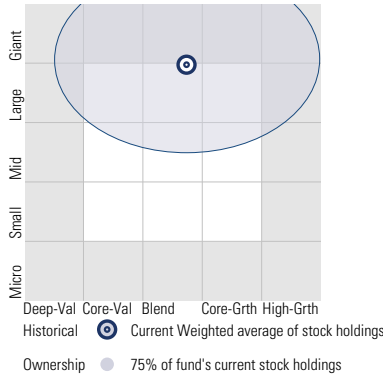

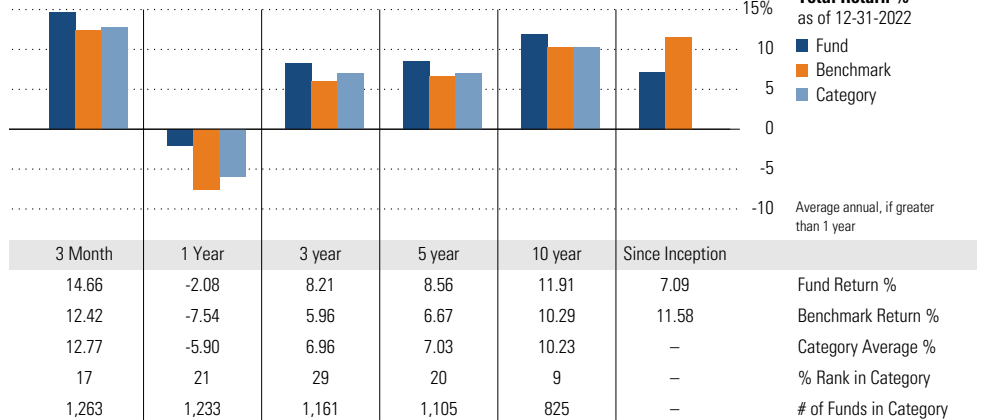

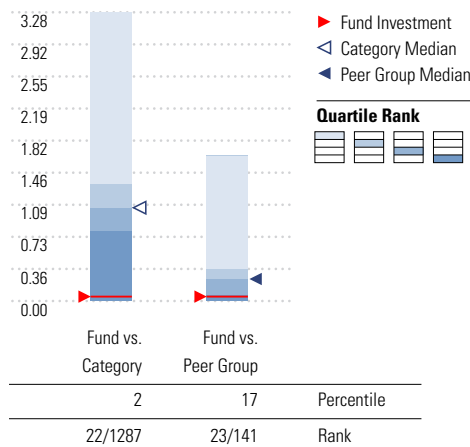

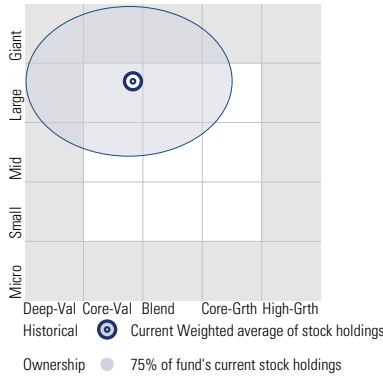

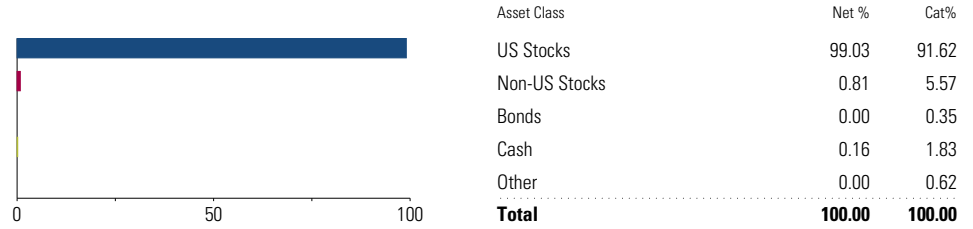

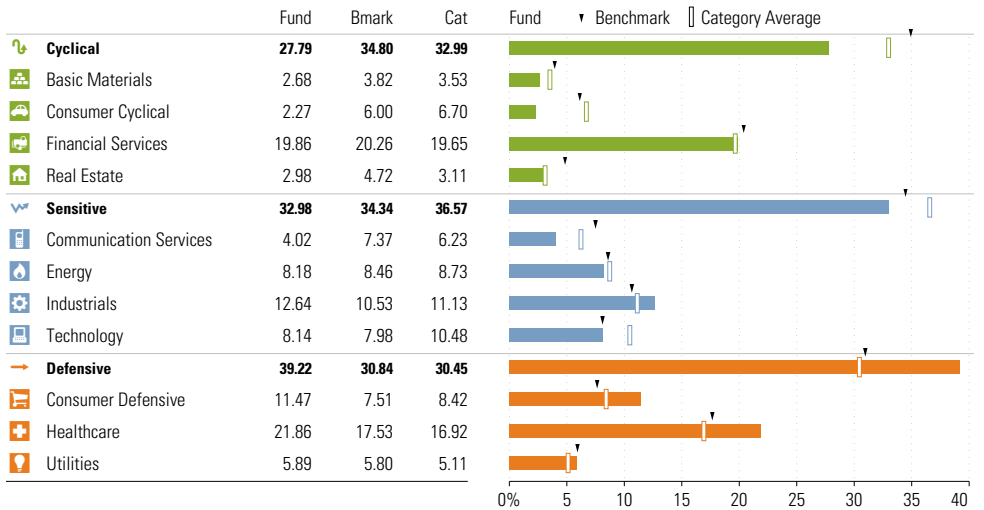
Style Breakdown

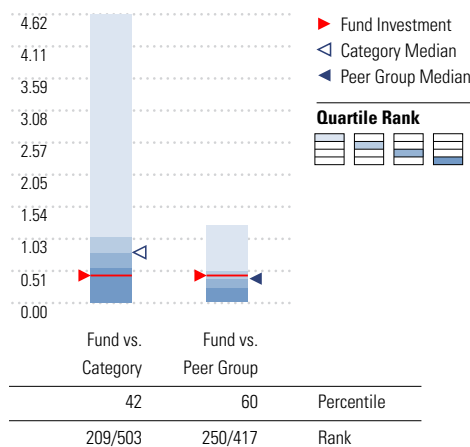

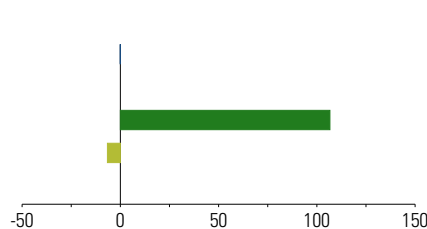

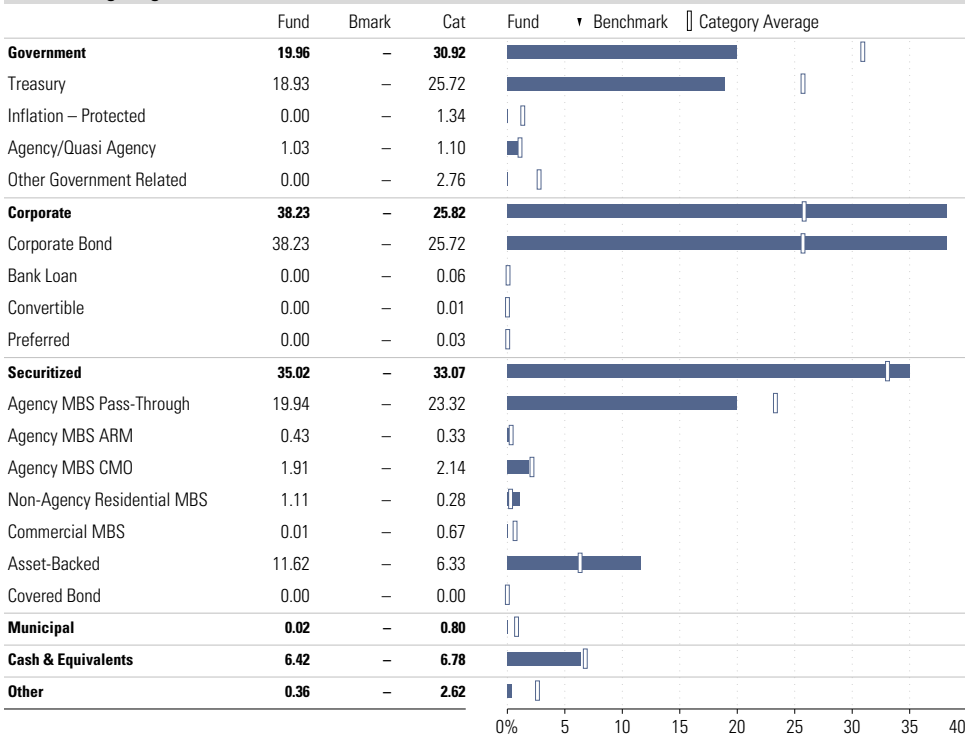
