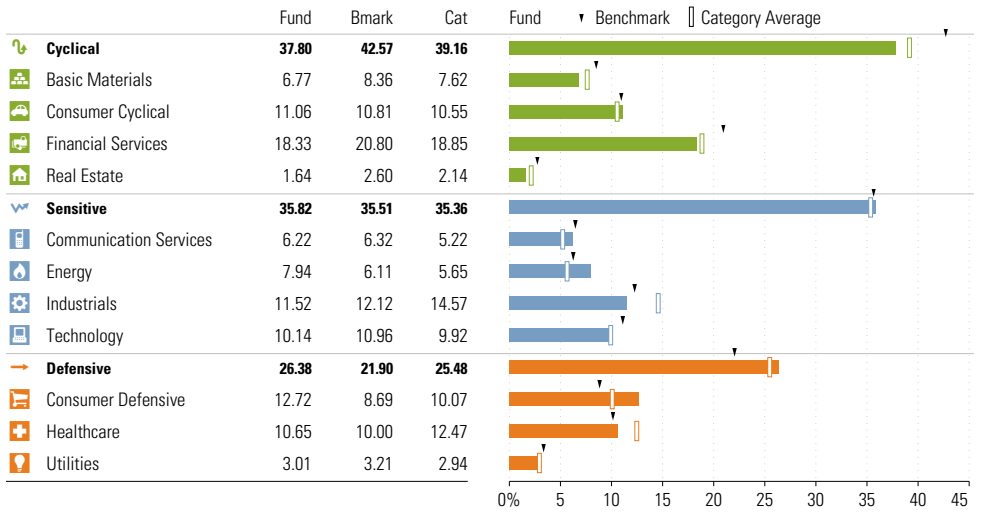

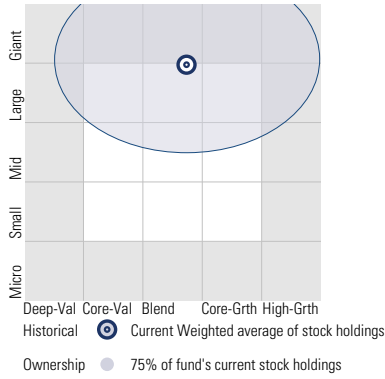

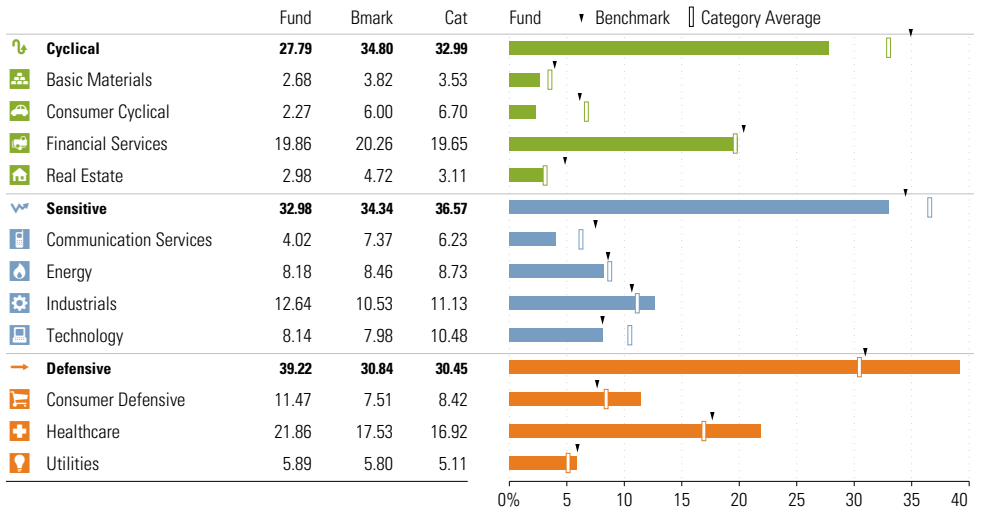
Style Breakdown
