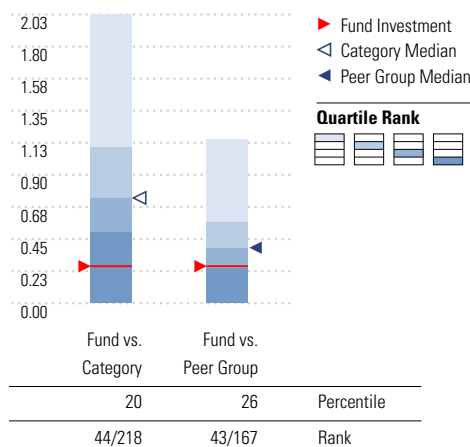

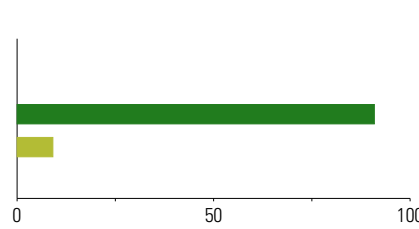

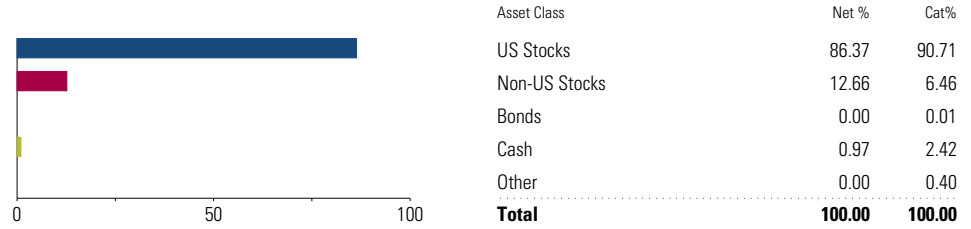

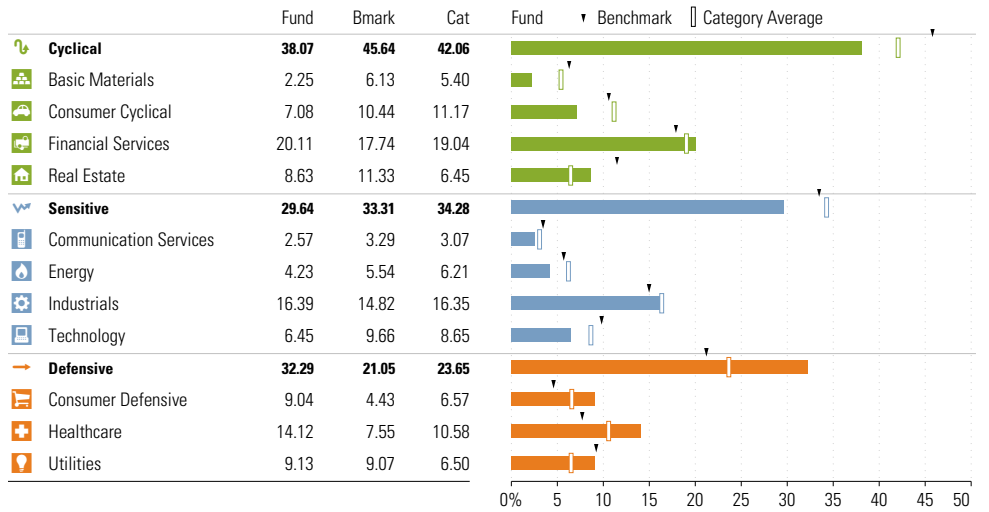

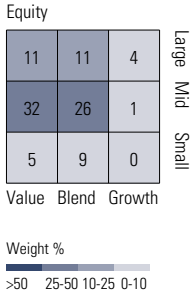
Asset Allocation as of 12-31-2022

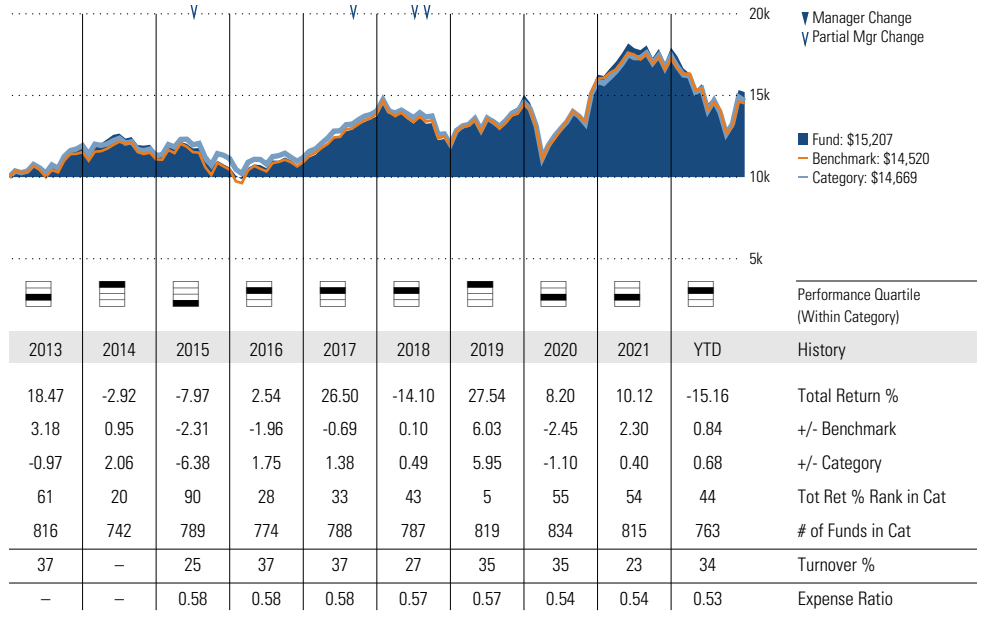

Growth of \$10,000



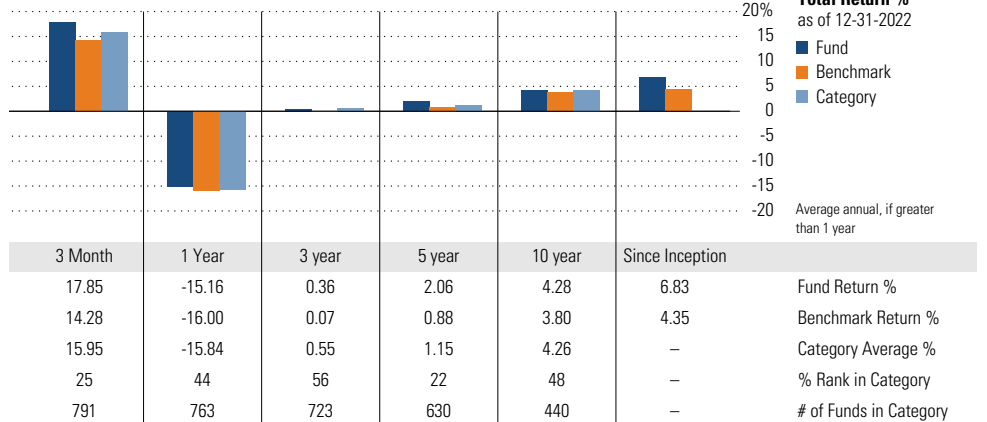

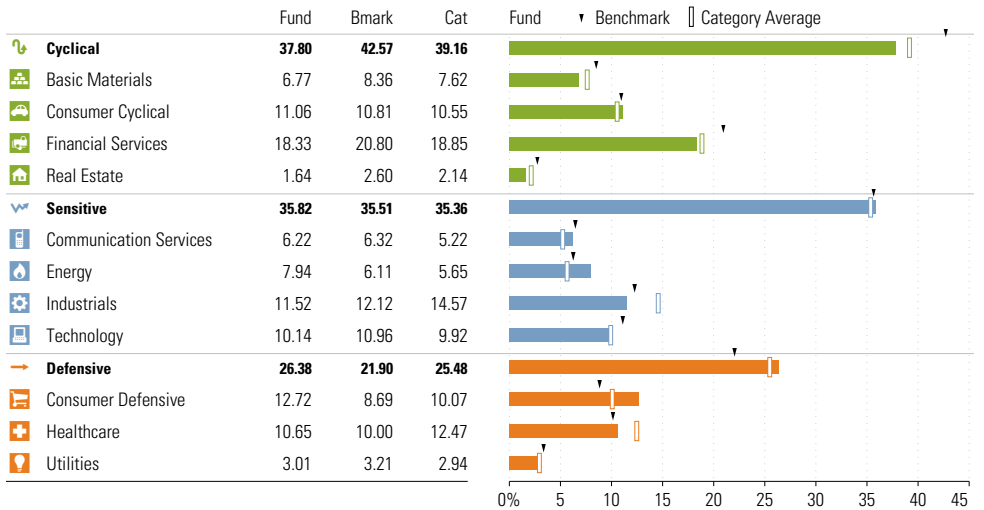

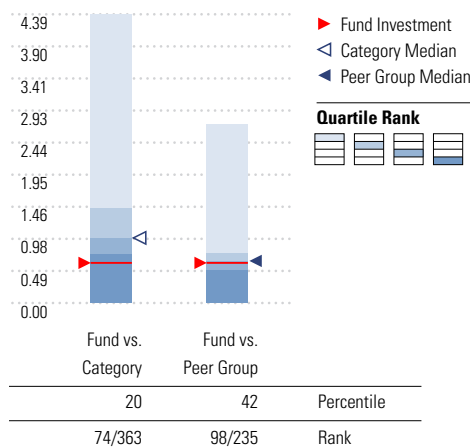

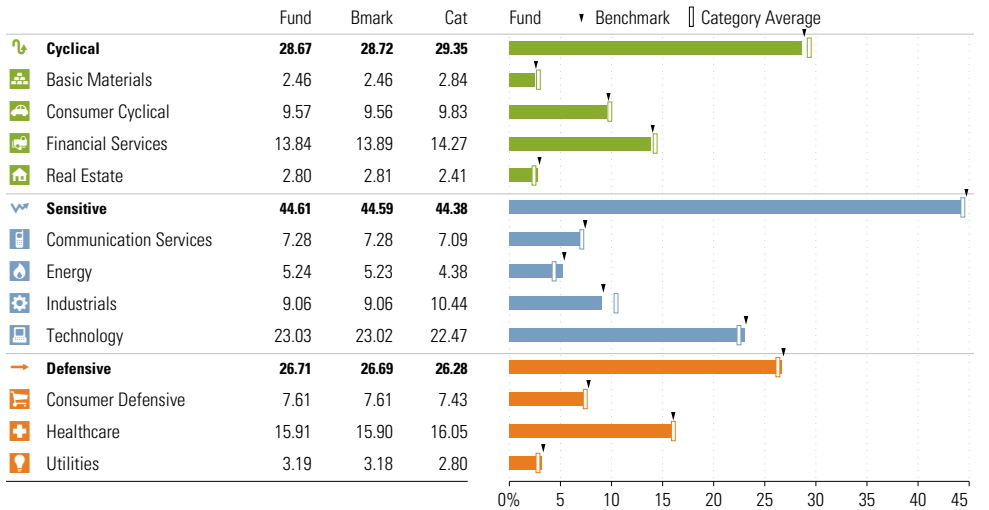
