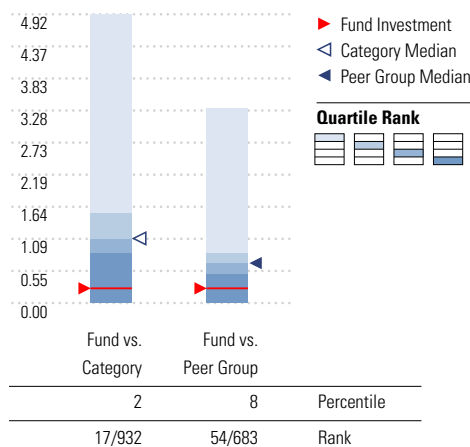

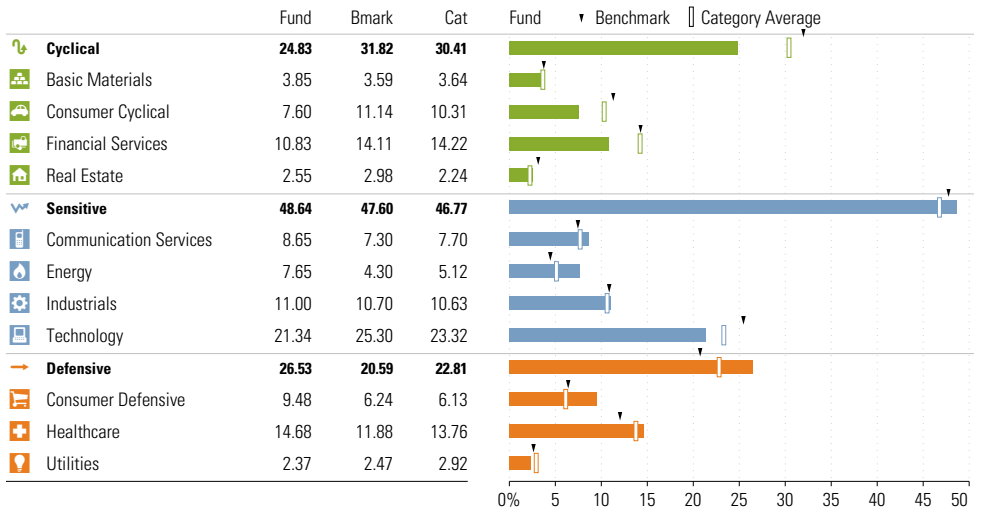

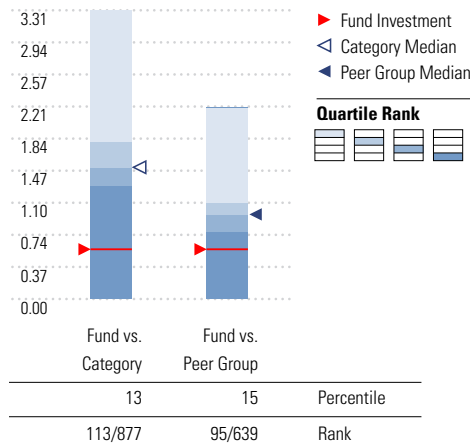

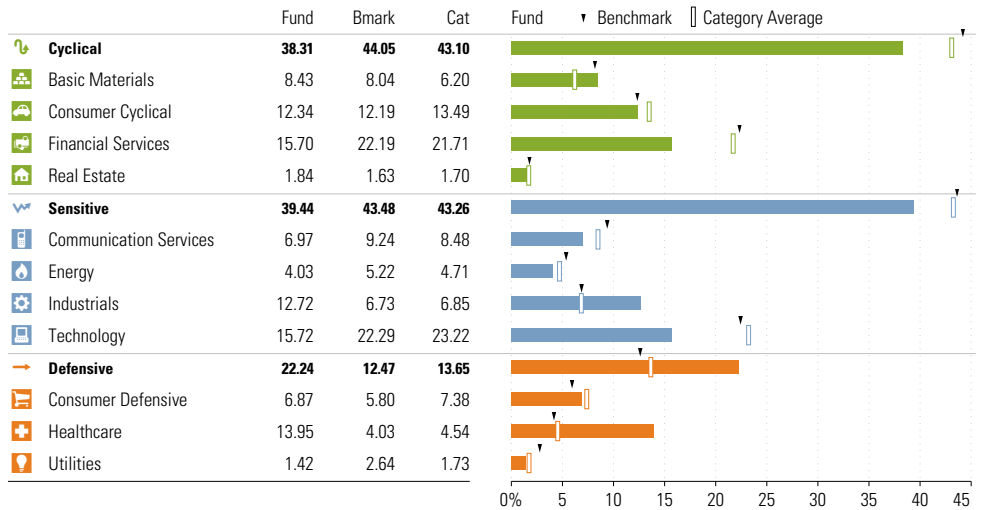

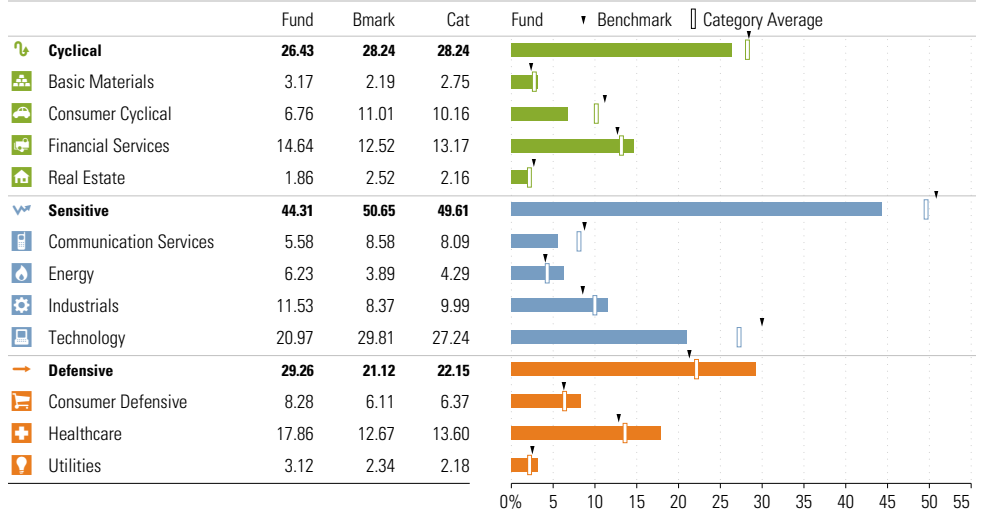

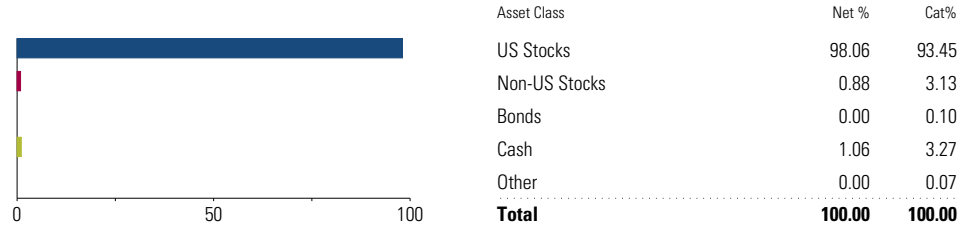

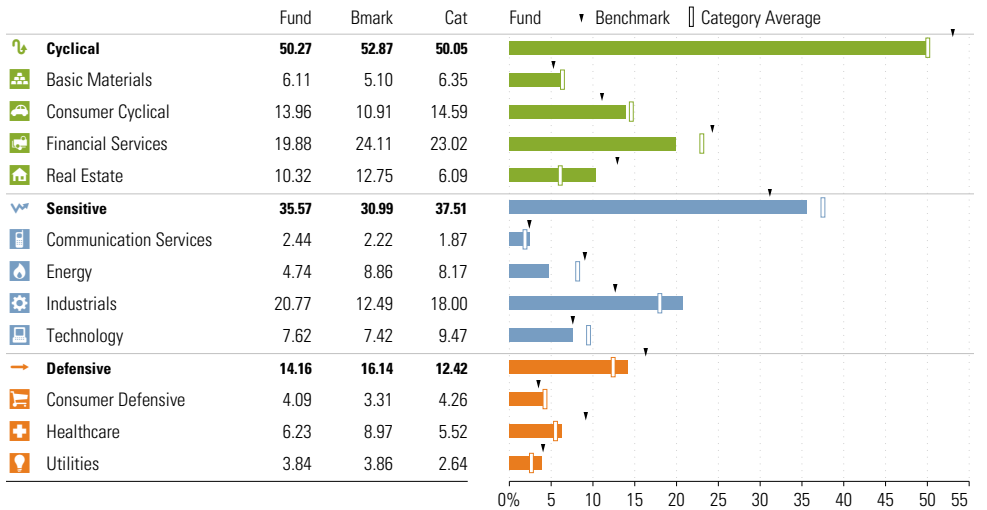
Style Breakdown
