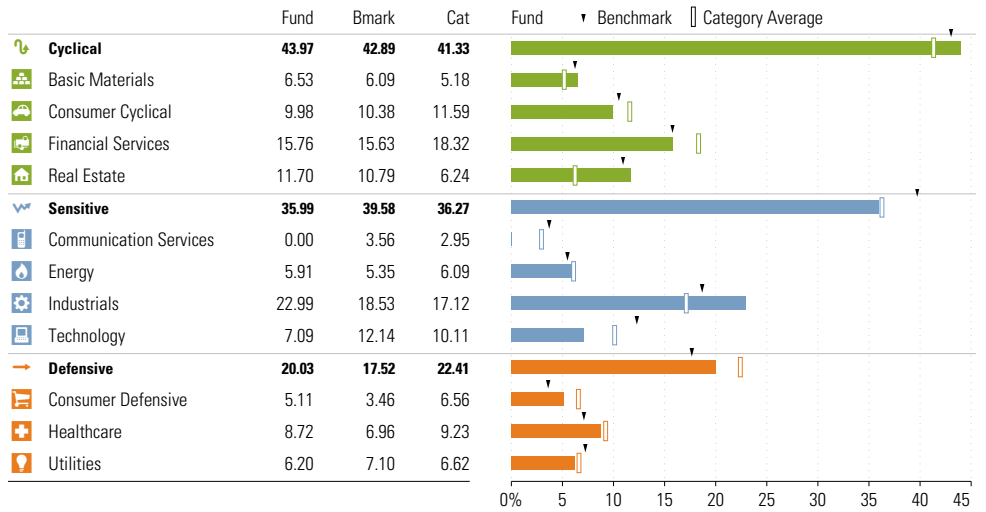

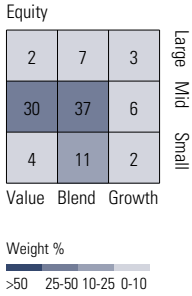
Asset Allocation as of 12-31-2023

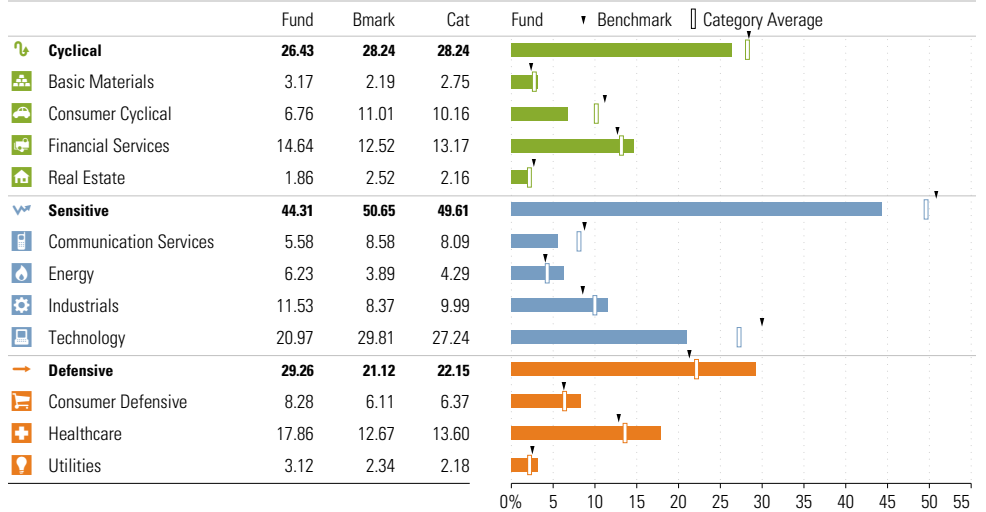

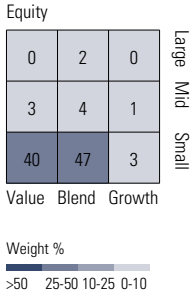
Asset Allocation as of 12-31-2023

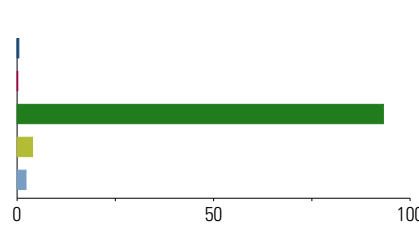

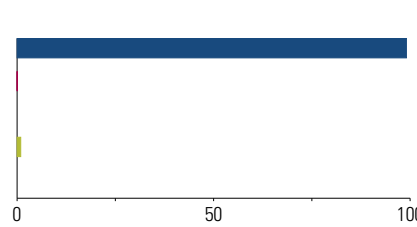

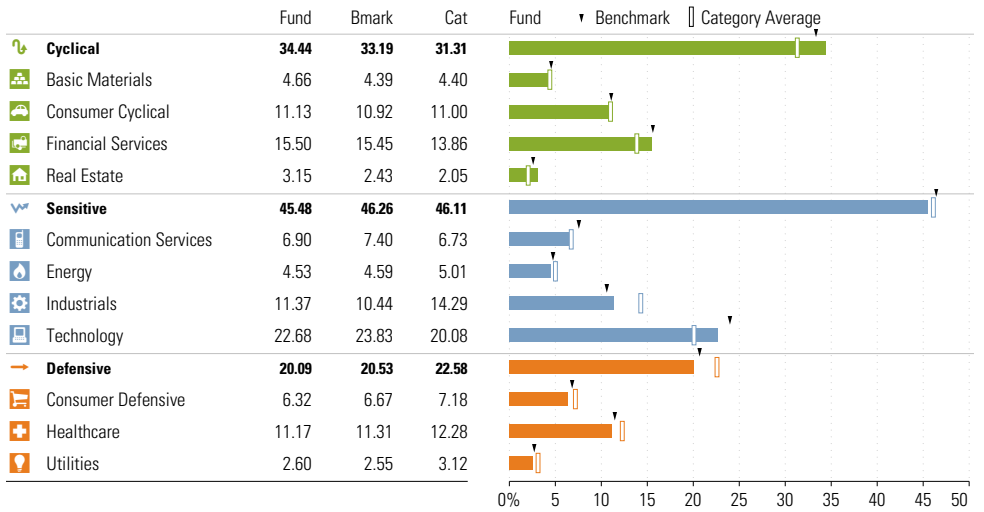
