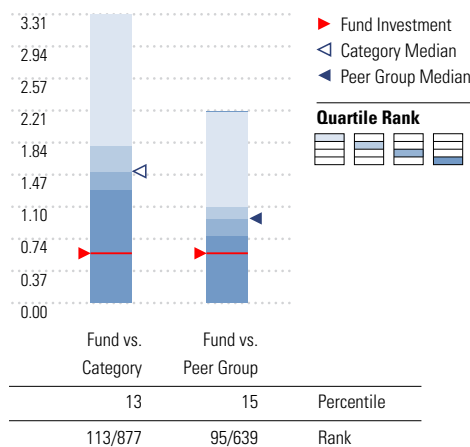

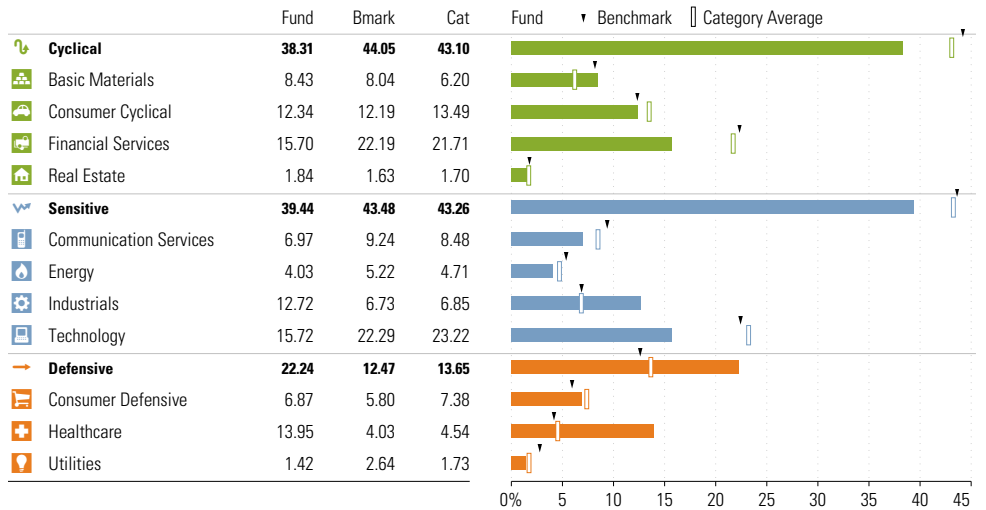

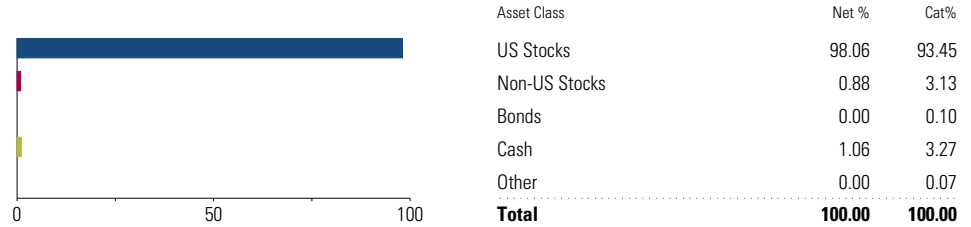

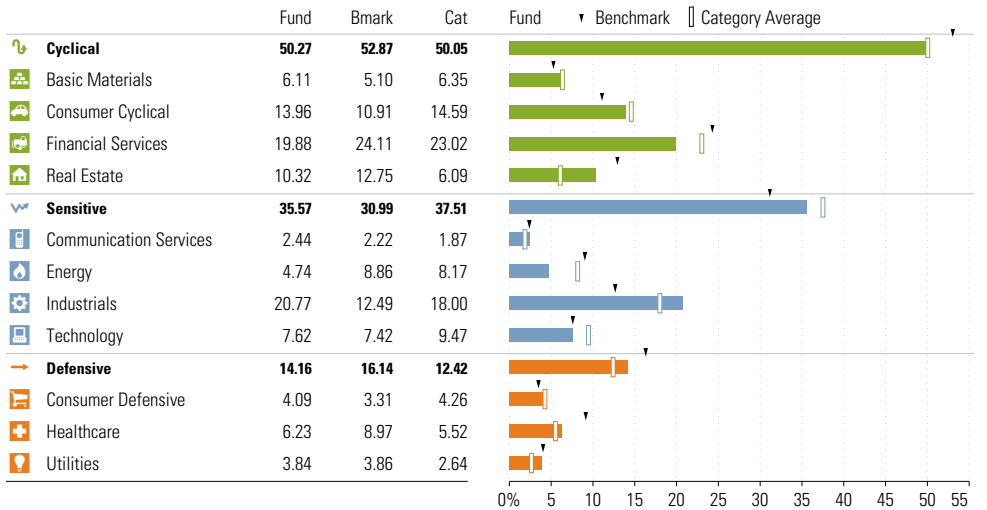
Style Breakdown

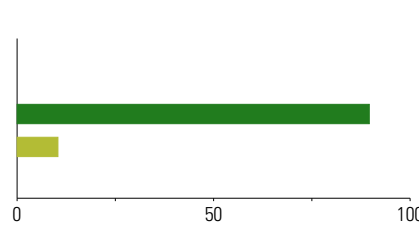

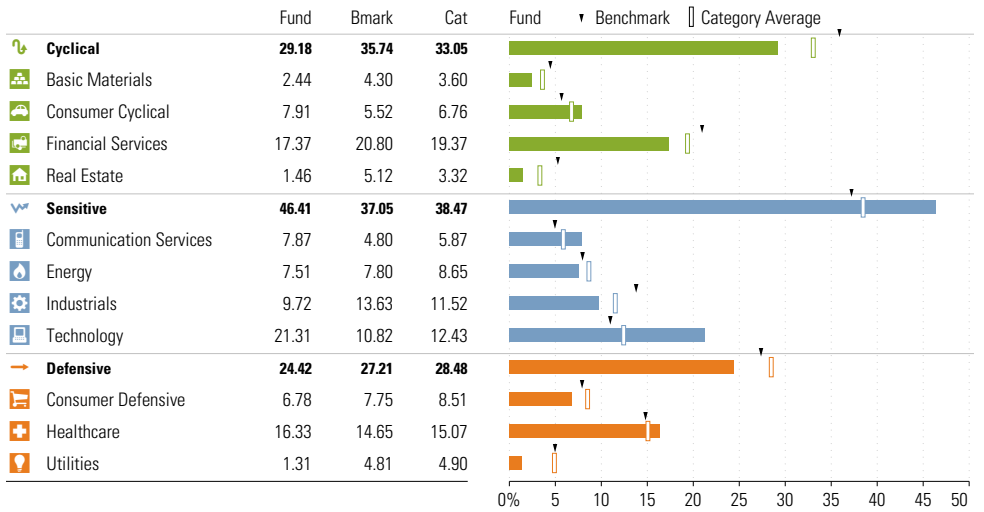
