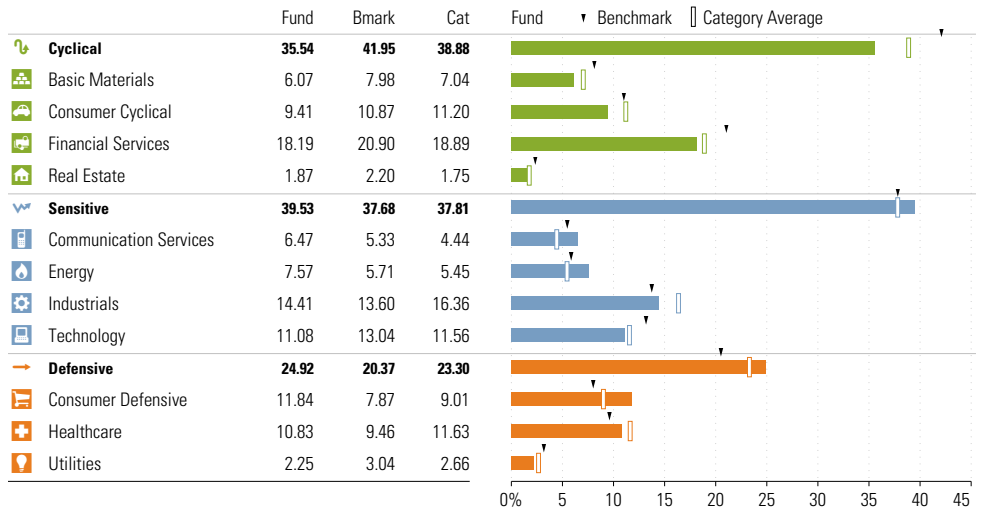

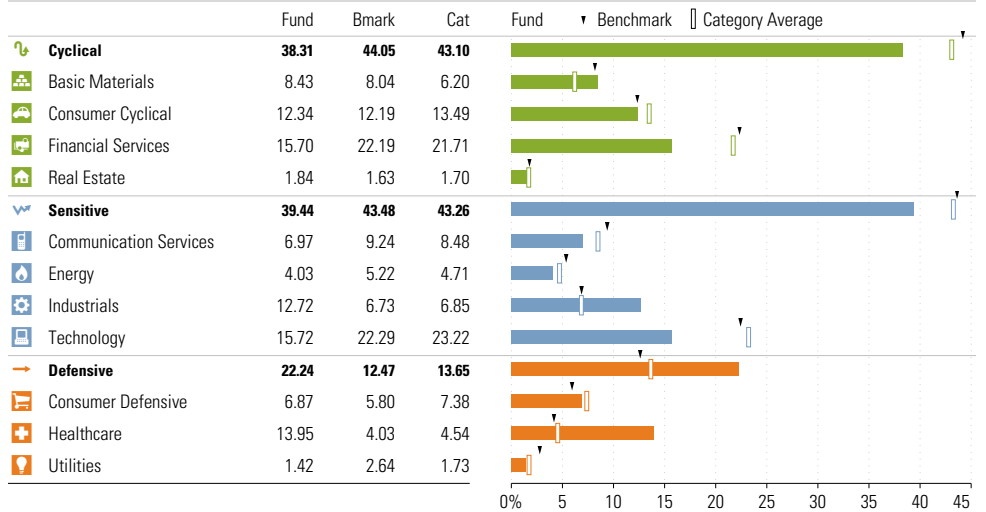

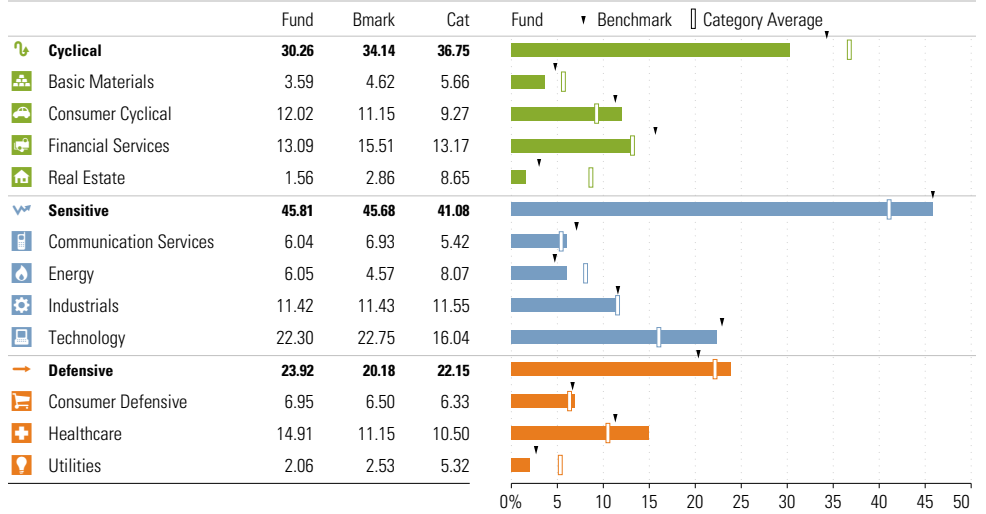

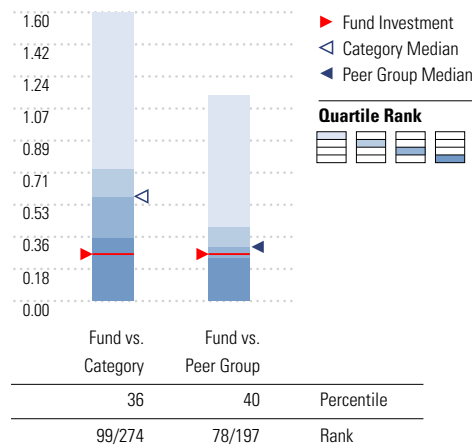

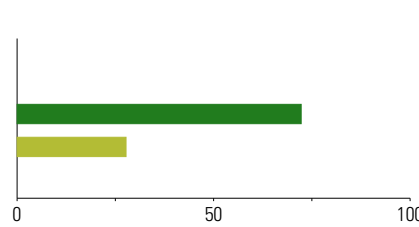

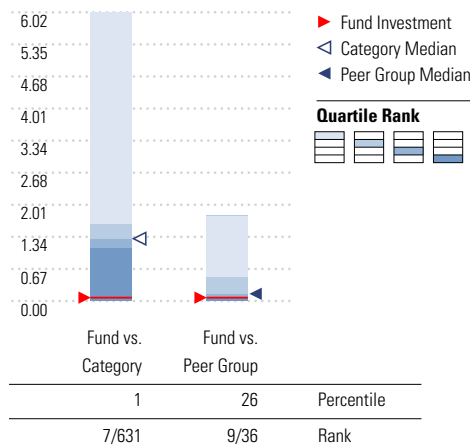

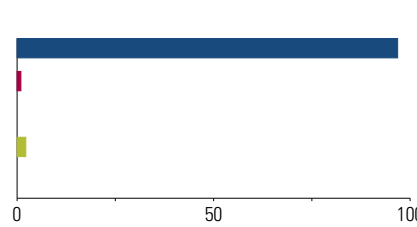

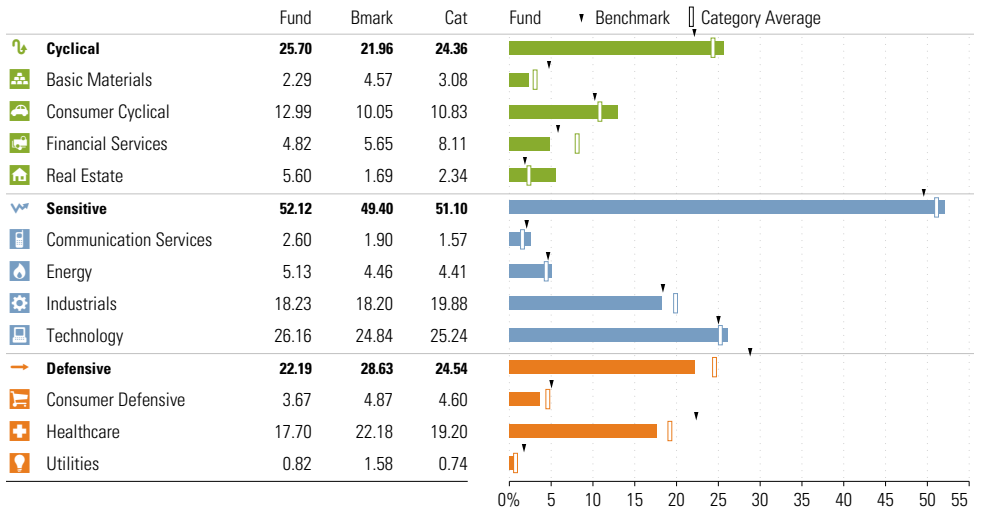

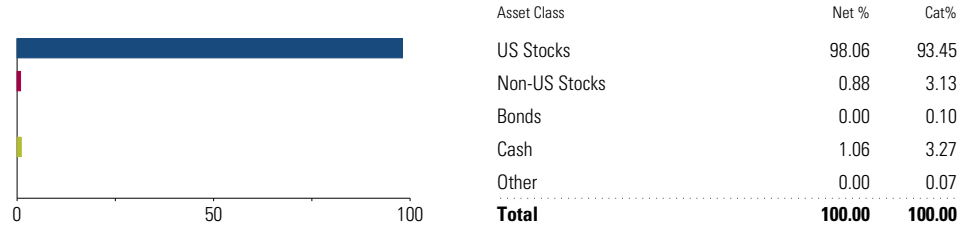

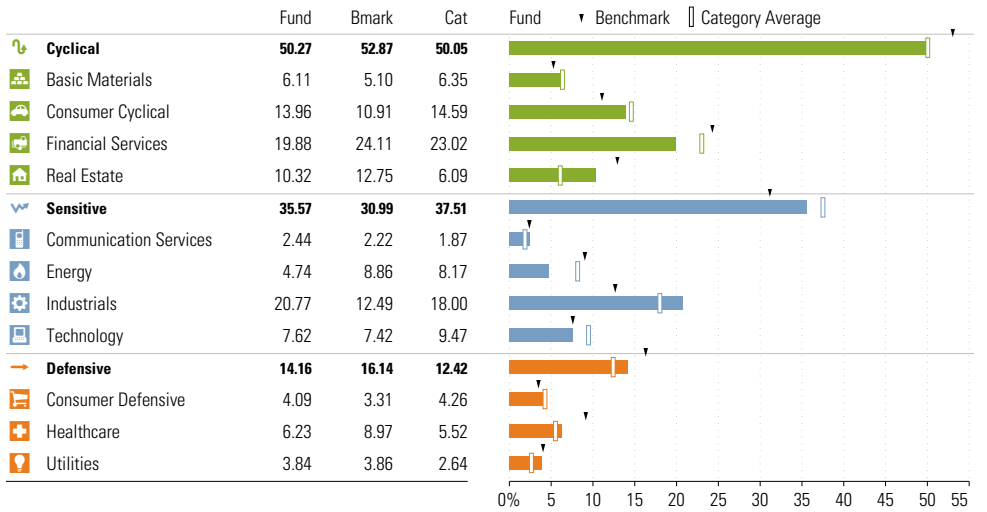

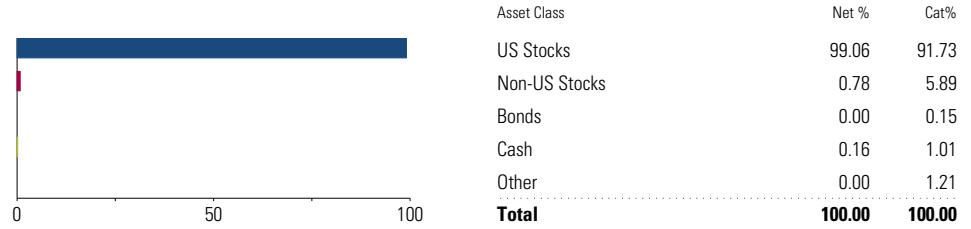

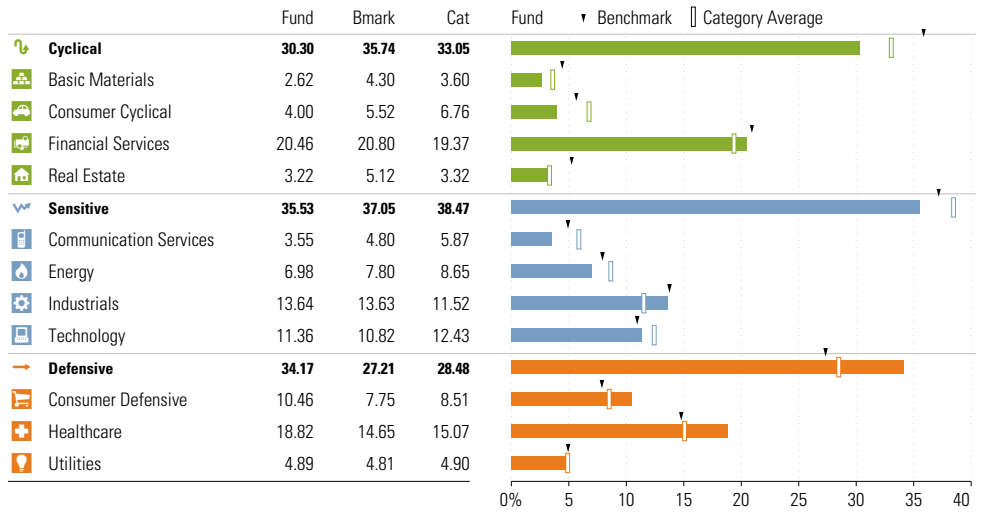
Style Breakdown
