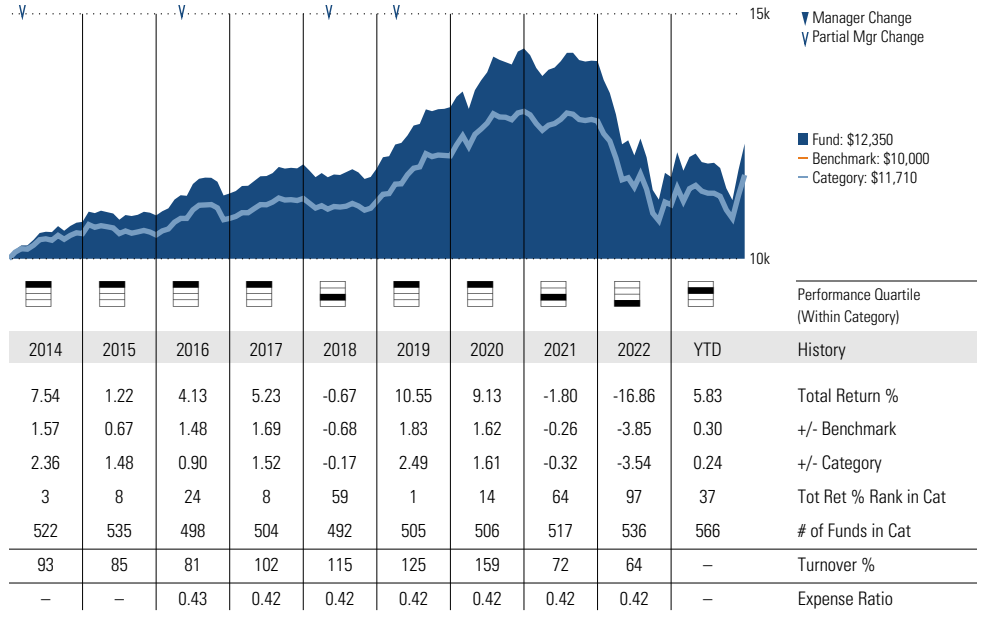
## Morningstar Investment Management LLC Analysis

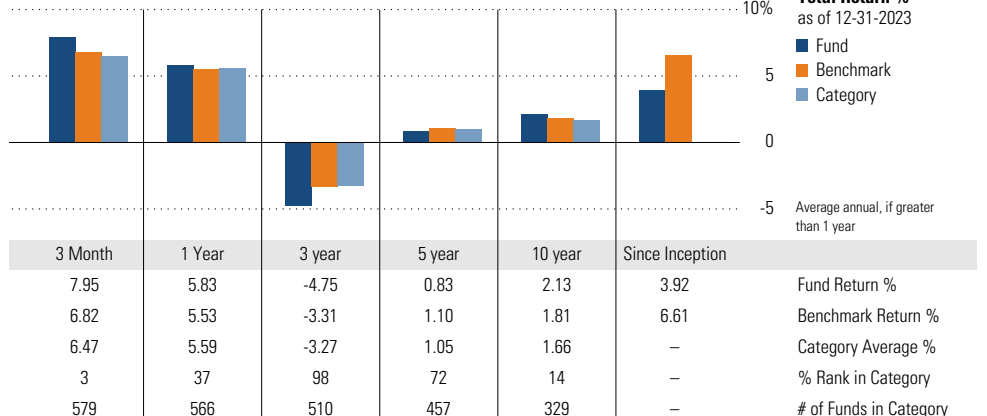

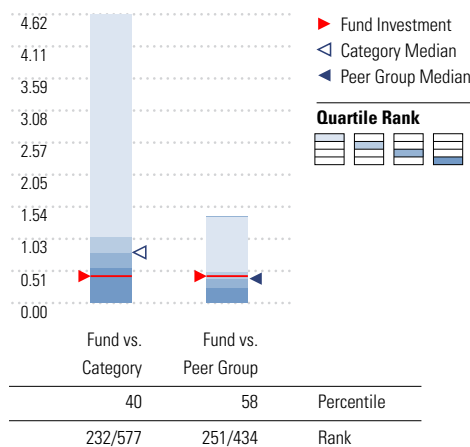

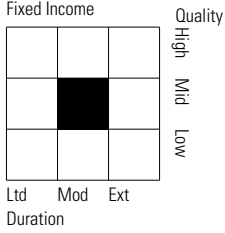

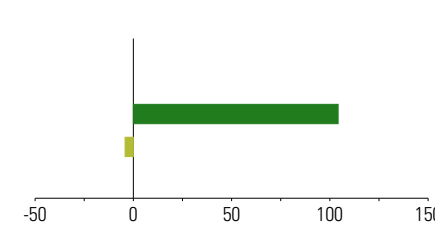

## Asset Allocation as of 12-31-2023

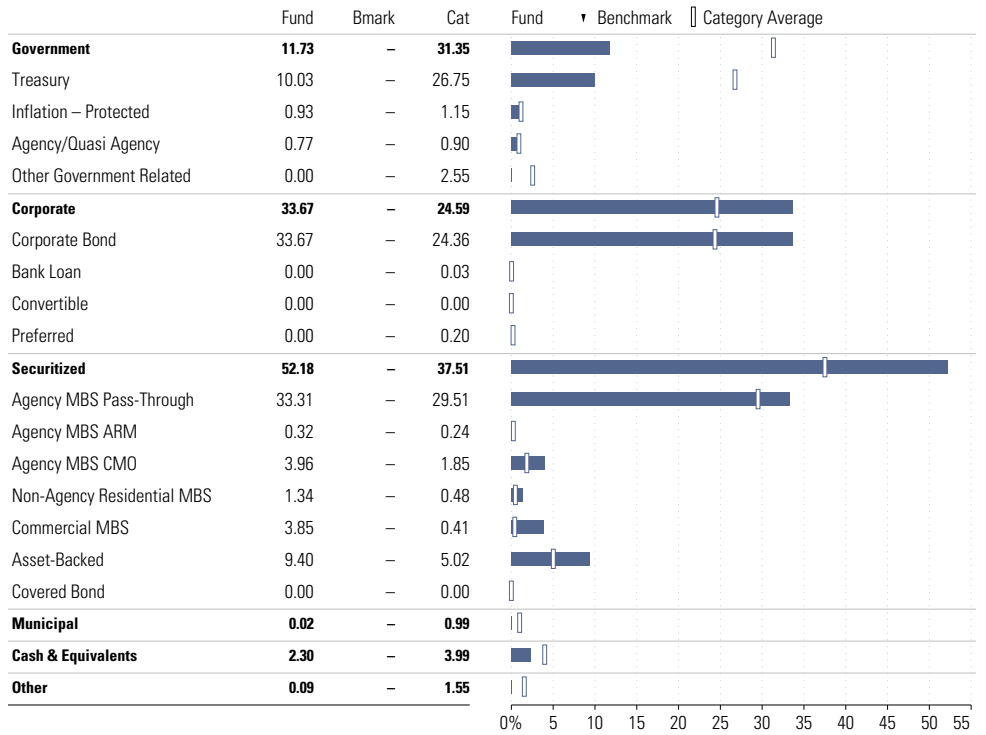
