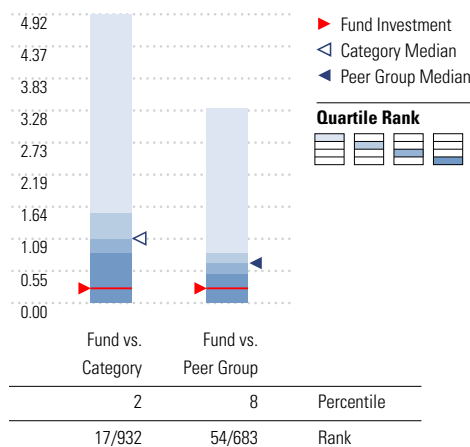

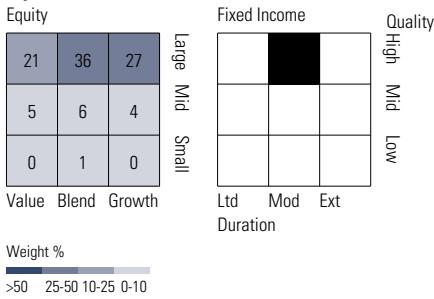

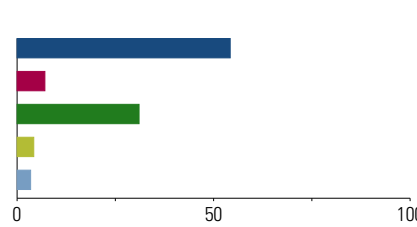

Growth of \$10,000



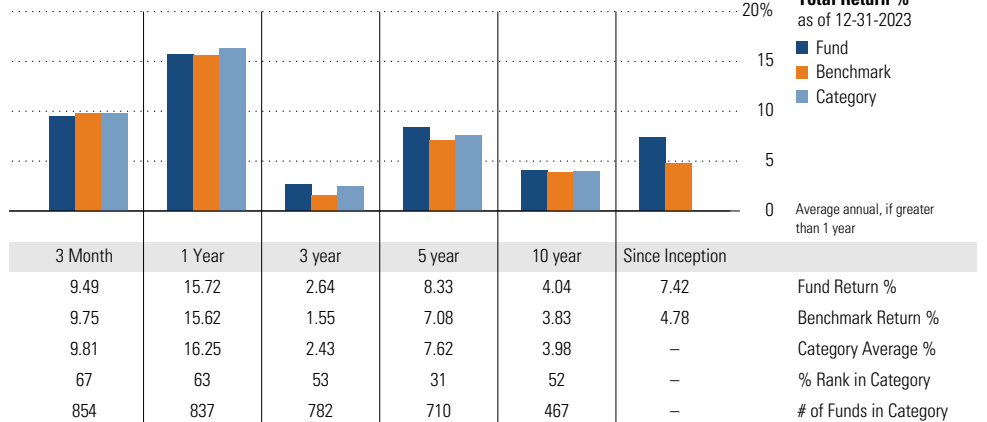

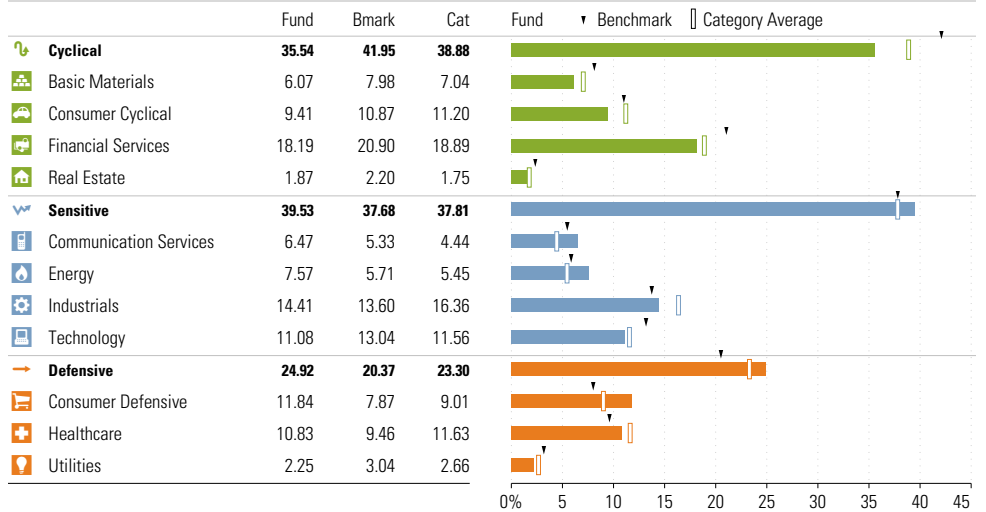

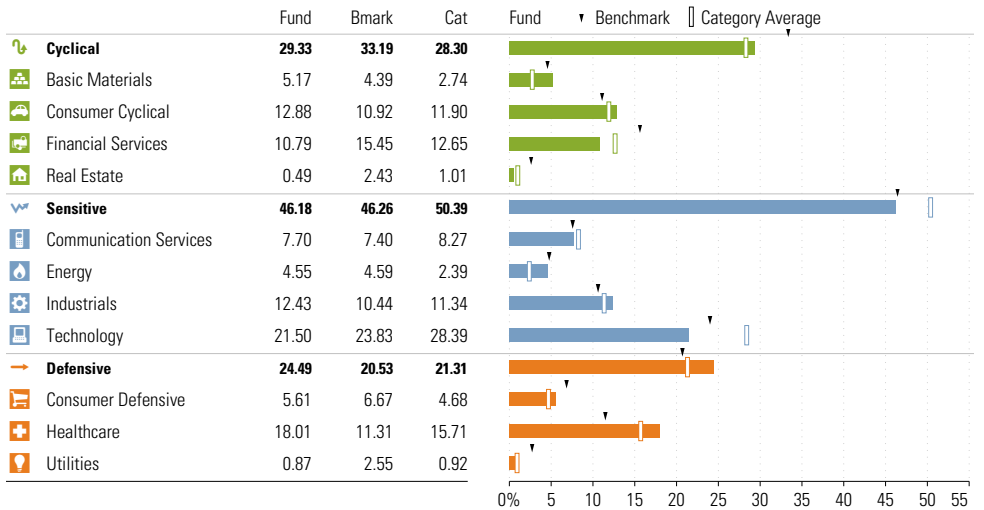

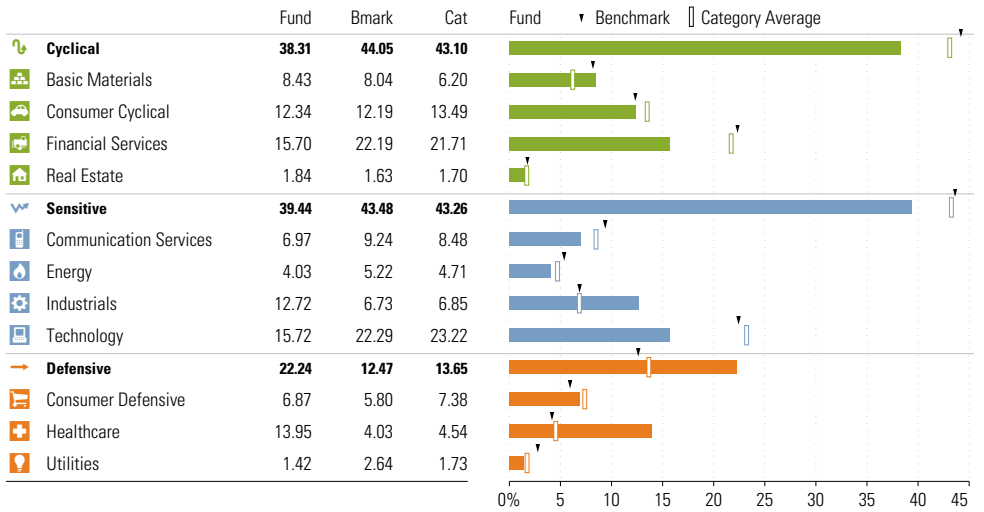

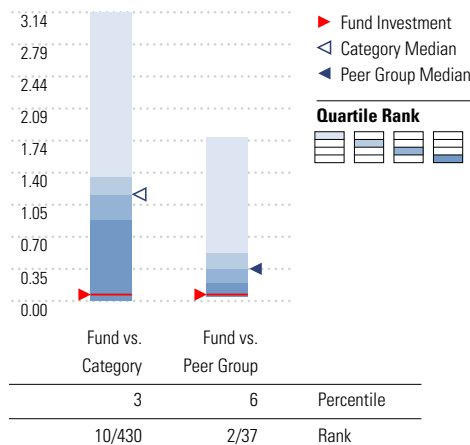

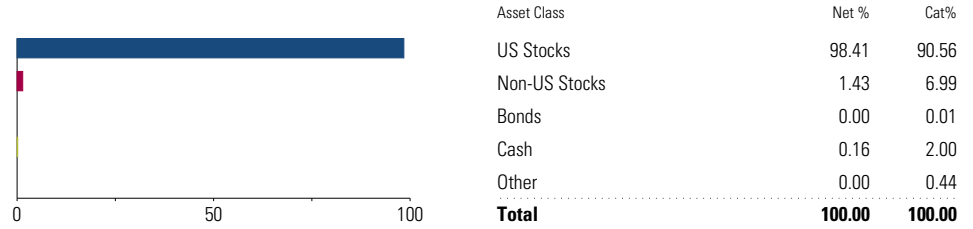

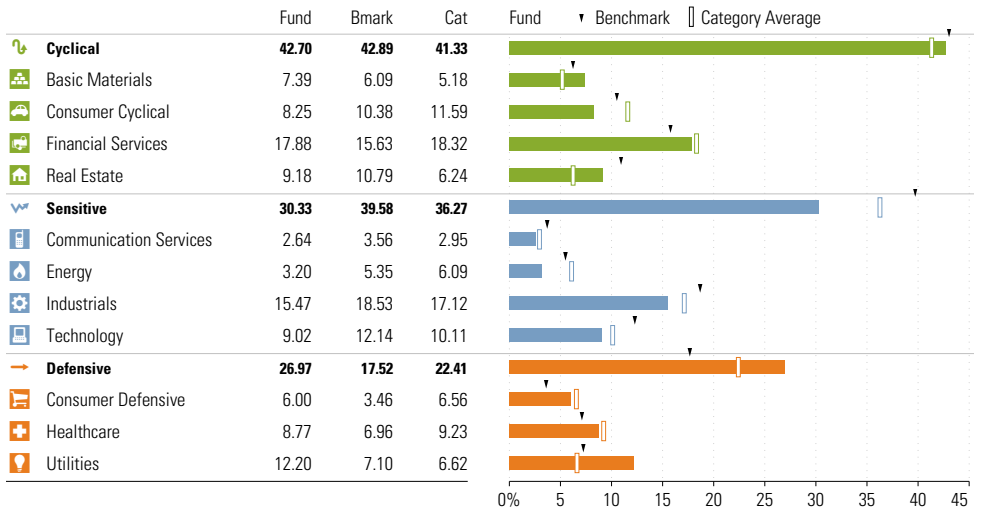
Style Breakdown

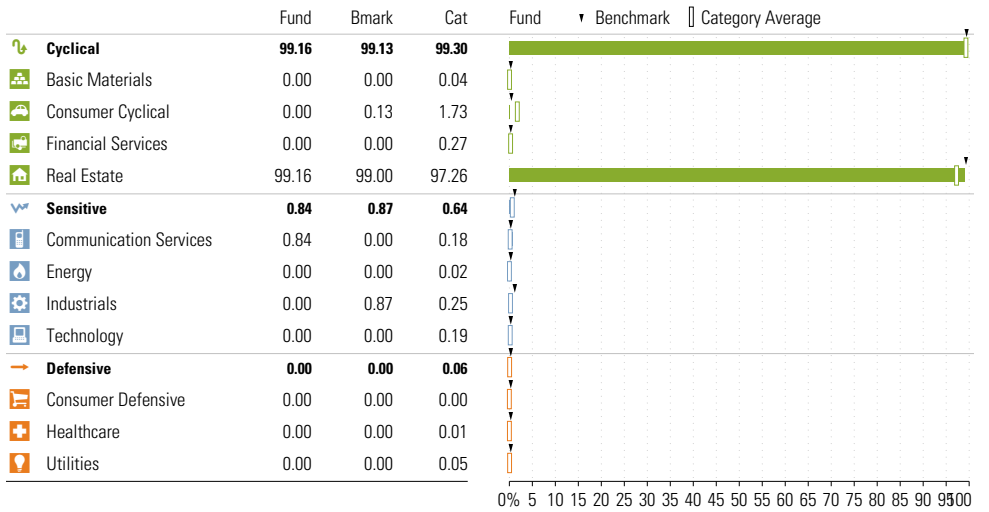

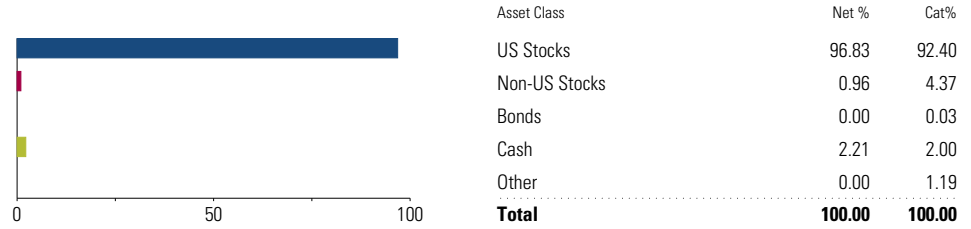

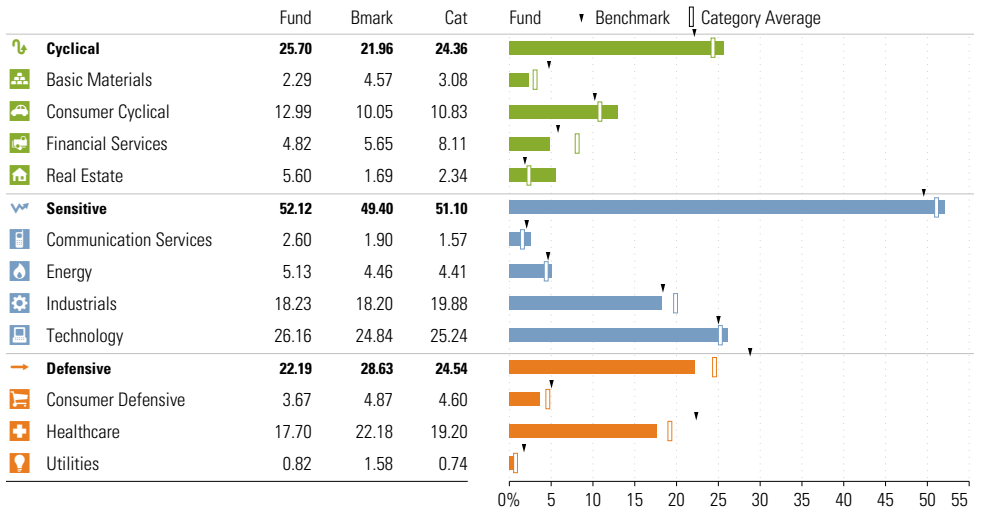

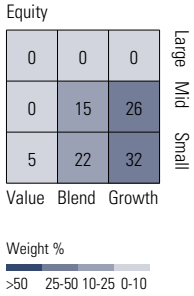
Asset Allocation as of 12-31-2023
