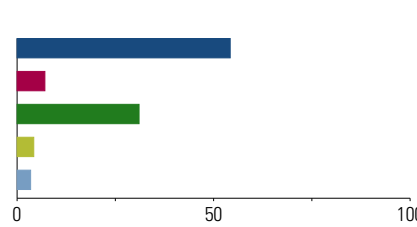

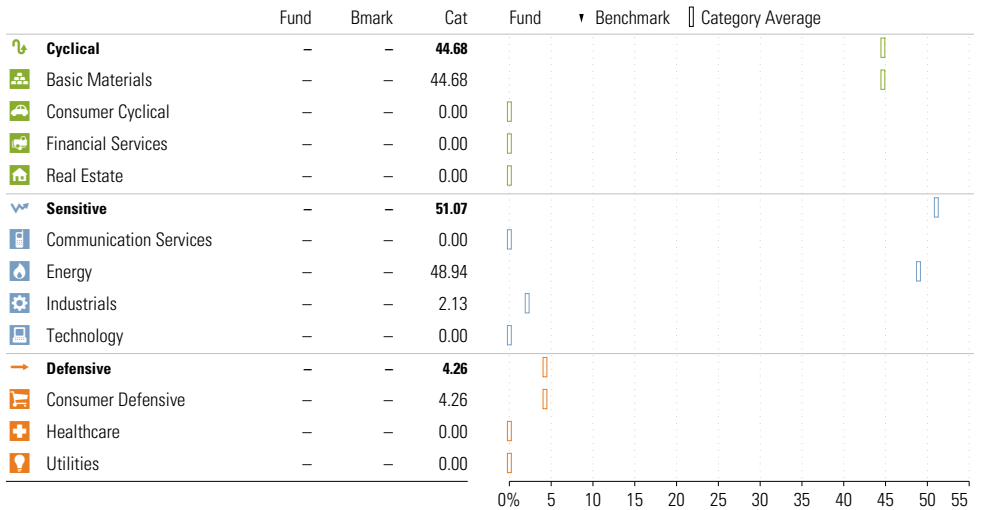

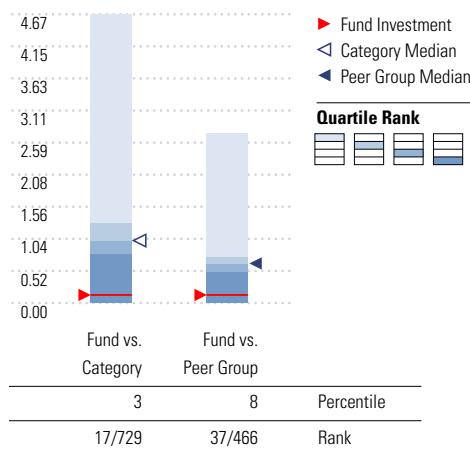

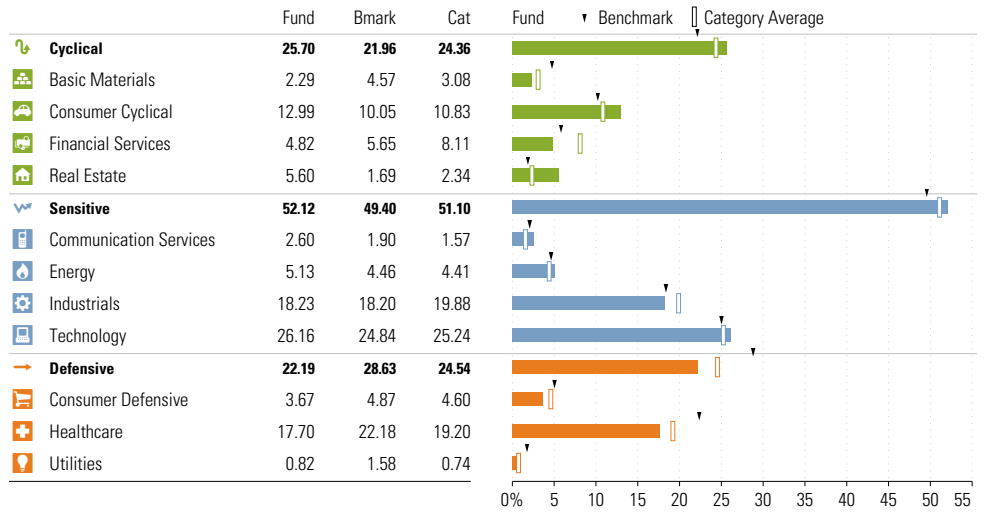

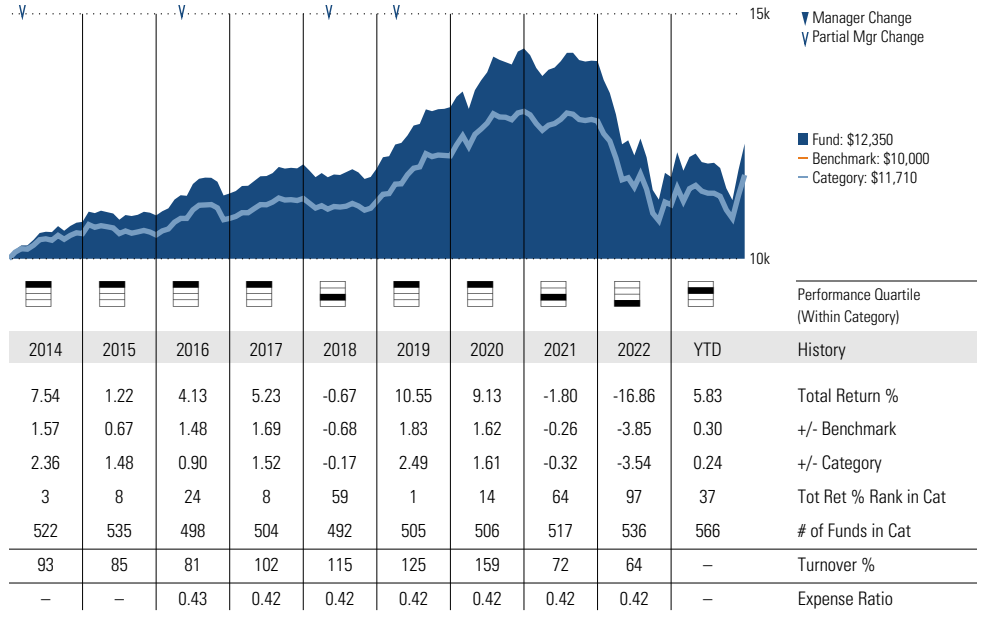
Morningstar Investment Management LLC Analysis

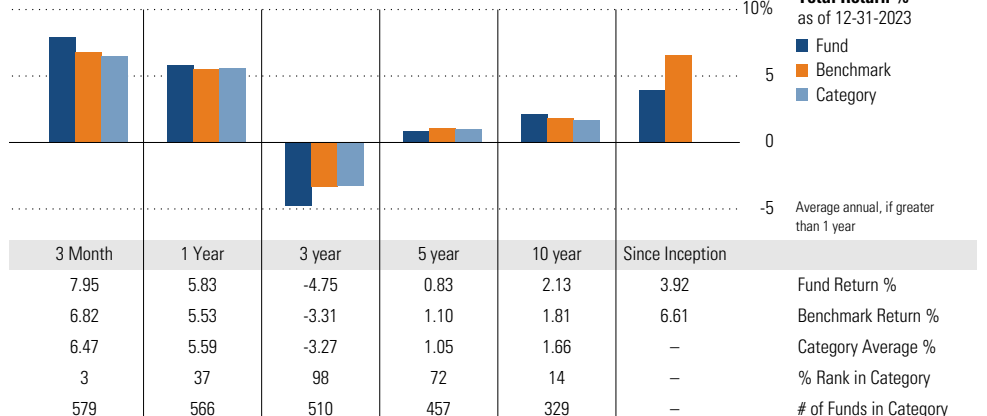

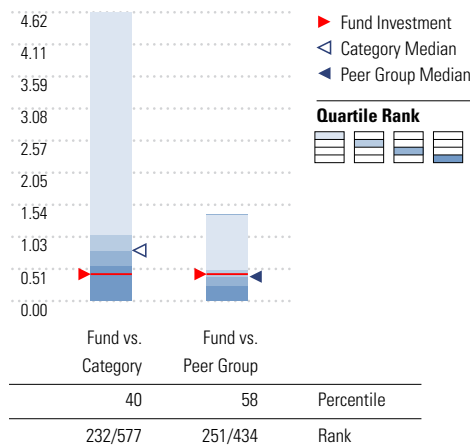
Growth of \$10,000

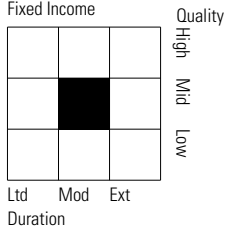

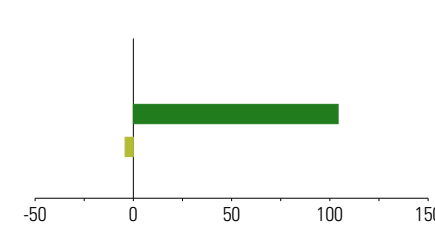

Asset Allocation as of 12-31-2023

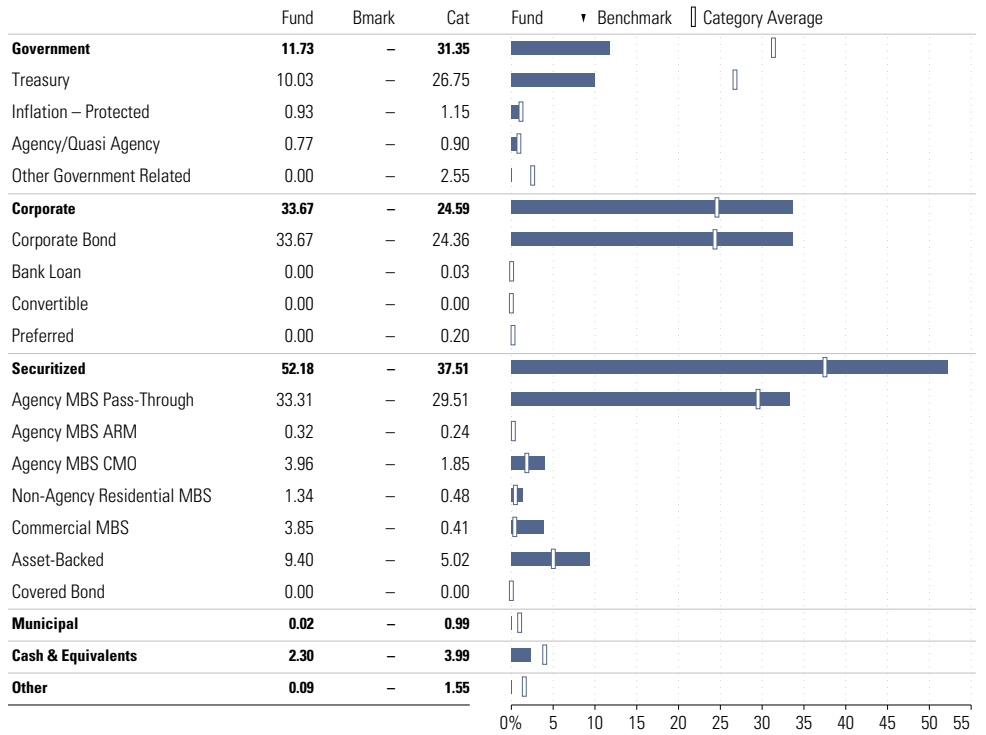
